Wiseburn Continues Moving Forward With New High School Project

During the most recent Wiseburn School Board meeting on April 30, the board approved the contractor for the new high school: Balfour Beatty Construction. Balfour Beatty has been involved with several school construction projects throughout the South Bay, primarily in Torrance and at Redondo Beach Union High School.

“They were [the best bid] and we have been working with them for the last couple of years,” Wiseburn Superintendent Dr. Tom Johnstone said. “We have been working with Gensler Architects, they are an international architect firm with a strong presence in the Los Angeles area but they are in Europe, Africa and in Asia. They are a very well respected firm.”

This brings the small and academically successful district one step closer to breaking ground on the high school it has worked arduously and diligently to open. The school, which will call 201 N. Douglas St. home, will consist of the three separate Da Vinci schools, Design, Science and Communications, with each school being assigned its own floor. Contractors are tasked to convert the once office building into a fully-functional high school while complying with the stringent State requirements for seismic safety.

“The plans were submitted to the division of the state architect last June 21, 2014. Those are just coming out now and we have already gotten approval on structural, which was a big obstacle since that building was built in 1981 as a commercial building and we are converting it to a school,” Dr. Johnstone said. “Schools and hospitals are the safest buildings in the state and that is costing eight to eleven million dollars just to do the seismic retrofitting but we got approval on that.”

Balfour Beatty, who also built the Brann Center over at Peter Burnett Elementary

School, has earned the confidence of Wiseburn administrators who are excited to move forward with the next step of the project.

“We also have the clearance from the State in terms of the Environmental Impact Report and the Department of Toxic Substances Control,” Dr. Johnstone said. “We have cleared all the hurdles and we also have a final agreement with the City of El Segundo with the aquatic center.”

The shared agreement will be between

El Segundo Parks and Recs and Wiseburn Unified School District will allow Wiseburn High School students to access one of the finest aquatic facilities in Southern California with a 54-meter pool with a warm-up pool next to it. The Wiseburn School District is still waiting on minor modifications regarding fire line safety. While such requirements are normally not difficult to fulfill for a one-story building, the schematics are more complex for a four-story building.

“That one is taking a bit longer but these are state requirements. We hope to have all that by mid June and we hope to start construction by mid August, later this summer,” Dr. Johnstone said.

The Wiseburn School District has undertaken several school construction projects in the past 13 years, including having rebuilt Anza Elementary School, Cabrillo Elementary School, Dana Middle School and the new construction

and modernization efforts at Peter Burnett Elementary. All of those projects were funded with bond money and state matching funds. The projects together cost an estimated \$80 million for which the district received about \$16 million in state matching funds.

“We always had this expectation back in 2010, when we passed the high school bond for \$87 million, that were going to get more matching funds,” Dr. Johnstone said. “We purchased the property at 201 Douglas in El Segundo and the property itself was \$46 million so that ate up more than half of the [bond] money, so we were going to be very dependent on State matching funds.”

However, when the district applied for state matching funds the state hadn’t passed a school facility bond since 2006 so the money for school districts ran out in 2013.

“The money we received for Peter Burnett was actually the last pool of money distributed,” Dr. Johnstone said. “We were blessed that there was a pool of money, \$89.9 million, that was charter school money so the Wiseburn Unified School District gave their eligibility to the Da Vinci Schools and the Da Vinci Schools applied for that; it was almost a miracle. Of the \$89.9, we received \$52.7.”

Not having to wait for state matching funds allowed the district to avoid incurring additional expenditures due to the yearly increases in construction costs. The district is now locked into current costs, which will be covered by the bond money and state matching funds already obtained.

“State matching funds, which we always knew we would get, are important because the State may not pass another bond until 2016 or 2018 and we would have had to wait,” Dr. Johnstone said. “In this case we don’t have to wait and we can start our project on time and on budget.” •

The Demands Of Tomorrow Are Facing Today’s Accountants

This potential for upward job mobility, along with the fact that the accounting field is expected to grow 13 percent between 2012 and 2022 according to the Bureau of Labor Statistics, makes the profession very appealing to recent graduates or seasoned accountants looking to advance their careers.

In order to fill the advisory role now

being asked of accountants, it is important for students to have the right education and skills to fit the part. 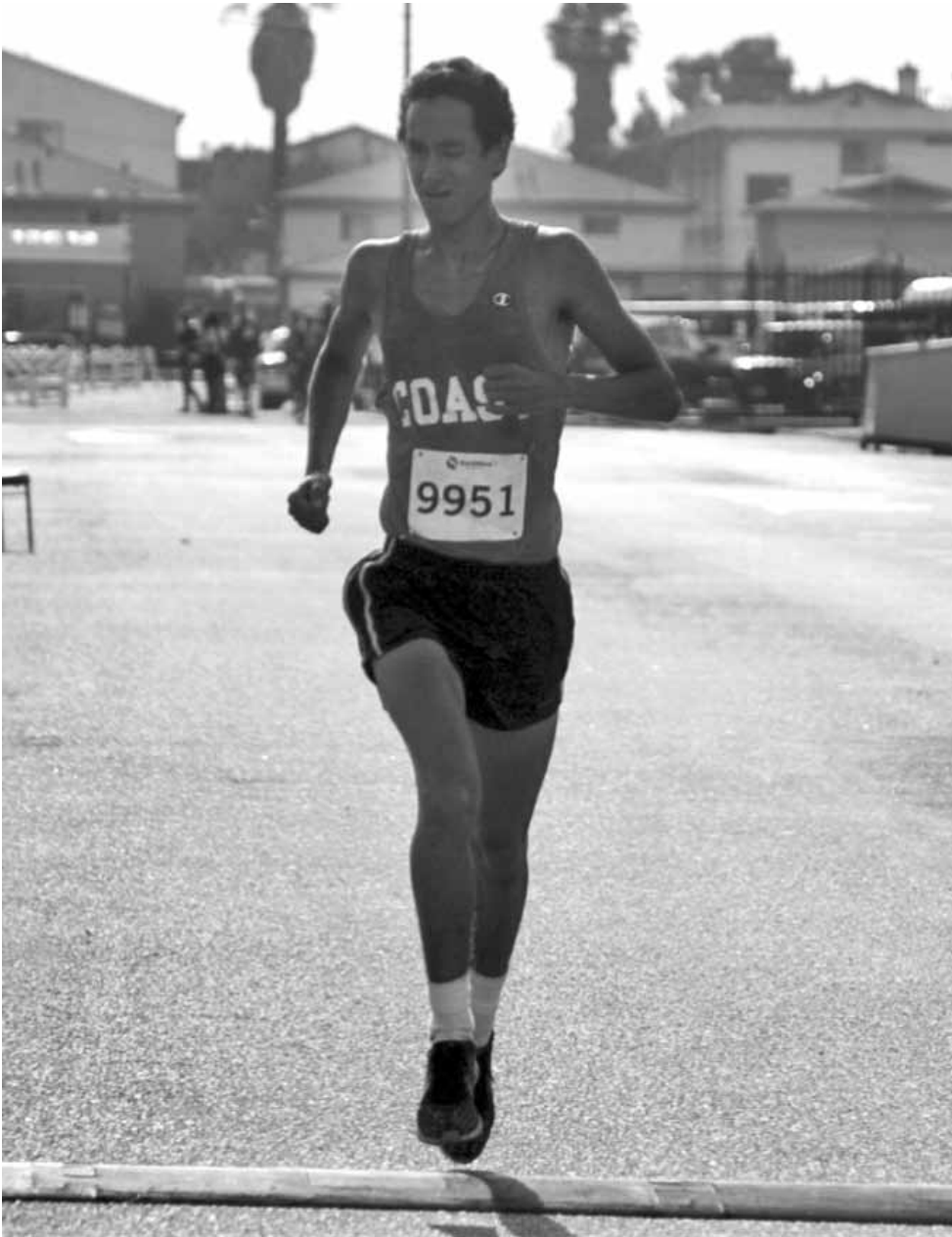

Varga, Seven-Year-Old Crum Capture Hawthorne 5K

Eighteen-year-old Daniel Varga and seven-year-old Megan Crum were winners in last Saturday's Healthy Hawthorne Mother's Day Five-Kilometer Run that finished at Memorial Park.

A few minutes after Varga, a Huntington Beach resident who is currently a key member of the Orange Coast College cross country and track teams, finished his 3.1-mile race at 16 minutes and 53.5 seconds, the seven-year-old Crum sped to the finish line timing 21:13.5, which inspired the fans.

Crum, who lives in Lake Elsinore, won by more than a minute over 37-year-old

runner-up Prado Gabriela, who was timed in 22:22.4. Placing third was 45-year-old Connie Pendleton in 25:18.5.

Taking fourth through 10th, in order, included 23-year-old Hawthorne resident Cristina Hernandez (25:43.4), Katherine Marquez (age 15, Hawthorne, 25:52.4), Gabriela Sandoval (age 23, Lawndale, 26:20.2), Lesley Gonzalez (age 15, Los Angeles, 27:04.5), Trutanie Bljazvica (age 21, 27:38.1), Yayzeth Espinoza (age 14, 27:38.3) and Yessenia De La Cruz (age 10, Hawthorne, 27:59.3).

Varga was able to capture the men's and overall race by 16 seconds over second place Juan Valencia (age 35, 17:09.5). Varga felt that the race was a little longer than the five kilometers. He felt that the 3.1-mile point was at a gate on the east side of the Memorial Center, meaning that it was about 200 feet away. Varga was a CIF-Southern Section Division I distance running finalist at Huntington Beach High School, where he graduated last year.

He currently runs the 5,000- and 10,000-meter runs at Orange Coast. His personal beat five-kilometer time is 15:36 and 10 kilometers is 33:15.

Finishing third was Alexander Santana timing 18:00.5. Placing fourth through 10th, respectively, were Dylan Highducheck (age 15, Gardena, 18:04.8), Alex Garcia (age 16, Hawthorne, 18:05.7), Abel Monter (age 18, Lennox, 18:26.7), Angel Santiago (age 50, Hawthorne, 18:34), William Feliciano (age 48, 19:11.6), Andrew Tovai (age 15, Hawthorne, 19:41.4) and Pablo Rodriguez (age 17, Hawthorne, 19:45.4).

There were approximately 2,000 runners in the race that was held in conjunction with the Hawthorne Health Fair.

CARDINALS EXCEL IN OCEAN MEET

Lawndale High's boys' track and field team had a strong showing in last Thursday's Ocean League Championships at Lawndale. In fact, sources were that the Cardinals, as a team, captured the meet as it edged Ocean dual meet champion Culver City. Scores were unavailable. The meet was marred by a few spurts of heavy rain.

Lawndale was led by hurdler Kean Cooksey who won the 110-meter highs at 15.72 seconds and the 300 intermediates clocking 41.52. Cooksey qualifies for the CIF-Southern Section Division III Prelims in both events, along with the 4x100 (second place, 44.51) and 4x400-meter (first, 3:31.15) relays.

Other runners on the Cardinals' winning 1,600 relay squad included David Broaster, Jacob Khiu and anchor Hassani Barrett.

Along with Cooksey, Justin Agurs, Nathan Sanders and anchor Barrett were on Lawndale's 400 relay, which was edged out by winner Culver City (44.43). The Cardinals also had wins from Jalen Walker in the long jump (20 feet, 11.5 inches) and basketball standout D'lano Beckles in the high jump (six feet). Lawndale, in fact, had first and third place finishes in the long jump and high jump as Bryant Perkinson was third in the long jump with a leap of 20-7.25 and Walker finished in that position at the high jump (5-8).

Lawndale had a second and third place finish by Anthony Gray (113-3.5) and Isaiah Lucas (109-4.5), in order, in the discus. Beverly Hills' Rashad Ysagillerrie won the event at 117-8.5. Broaster took second in the 800 timing 2:04.92. Santa Monica, which dominated most of the distance running events, had a one-two finish by winner Lucas Jackson (2:03.15) and runner-up Oliver Peake

(2:03.51), respectively.

Lawndale's girls were led by Ashley Calloway who was second in the shot put at 29-7. For Hawthorne's boys, Ryan McCoy had placed third in the 300 intermediate hurdles (43.77) and was fifth in the 110 highs (18.27).

The Cougar girls were sparked by Asia Allen who was third in the shot put with a toss of 29-4. El Segundo freshman Tatiana Willis won the event at 32-7.5.

In the Del Rey League Championships on May 6 at St. Paul High in Santa Fe Springs, St. Mary's Academy from Inglewood was led by Kyra Anderson who won the long jump (17-10) and finished second in the 100 hurdles with a very good time of 14.42.

The Belles' 4x100 relay team of Anaiah Brown, Aliyah Hale, Briana Shufford and Keshawna Myles placed second in 48.11.

In Friday's Bay League championships, Inglewood Morningside had a CIF-Southern Section Division III qualifying long jump of 20-10 for fifth place and its 4x400 relay team of Darrius Wilson, Jaylin Wright, Berry and anchor Torrey Allen finished third clocking 3:35.24. Redondo won the event at 3:25.04, followed by second place Mira Costa (3:29.19).

LAWNDALE STUNS EL SEGUNDO

Junior pitcher Tyler Bonsky pitched a three-hit shutout as Lawndale High's baseball team handed Ocean League leader El Segundo its first loss at 1-0 last Thursday at Lawndale.

The Cardinals scored the game's only run in the bottom of the first inning on a sacrifice fly hit by Salvador Mercado.

Lawndale, which improved to 2-6 in league and 10-11 overall, has some hope for a CIF-Southern Section Division III at-large playoff berth as it finishes its Ocean play at rival Hawthorne today at 3:15 p.m. •

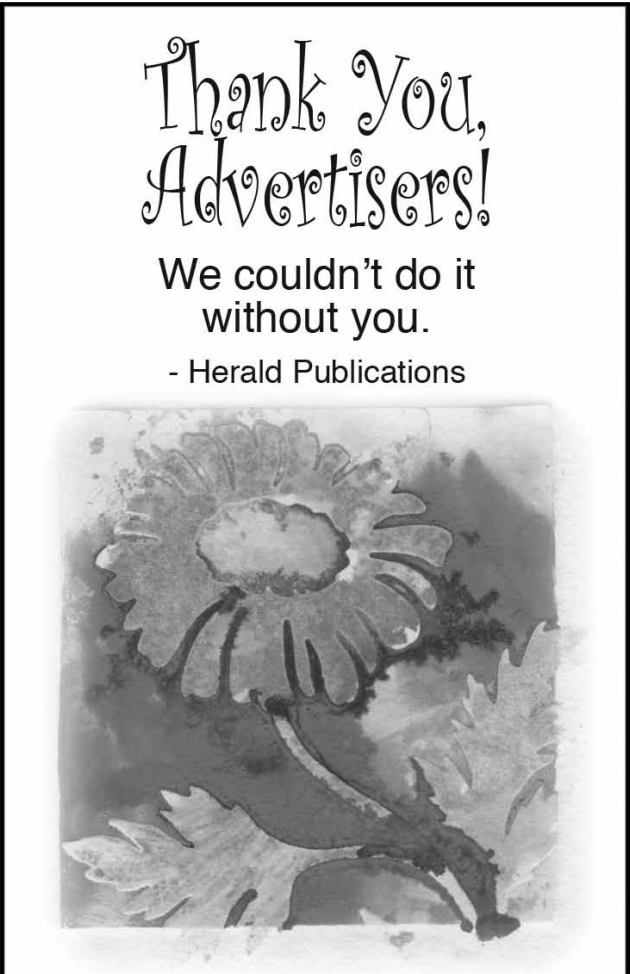

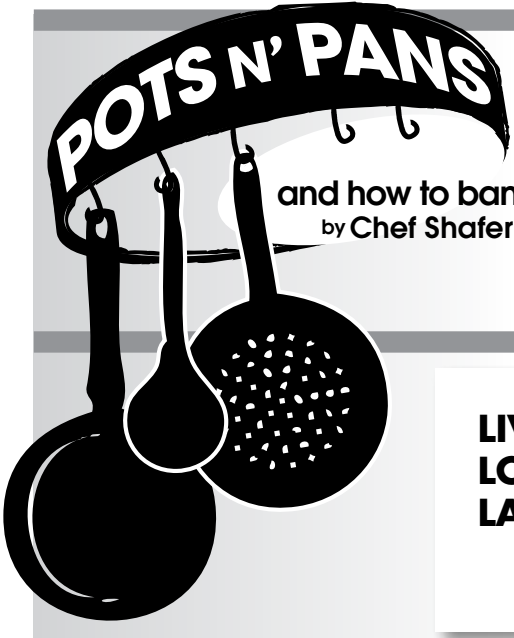
