Charter Reveals Plans for Time Warner Customers

The telecom carousel continues as Time-Warner Cable was sold to Charter Communications, leaving 1.2 million Southern California customers wondering how the transition will affect their TV, high-speed Internet and phone services and Dodgers baseball.

Time-Warner turned over its operations and cable and fiber-optic systems on May 18 to the much-larger Charter, which will now service the airport and South Bay communities. Charter says it won't be re-branding its trucks or equipment or making programming changes just yet, but changes are coming.

Time-Warner customers "won't see any immediate changes," Charter spokesman Justin Venech told the Herald.

"The branding on the bill, current services, and channel lineups will stay the same."

Charter will phase in programming changes "in the coming months," Venech said, without offering a specific date. The cable company will notify former Time-Warner customers about their viewing options once Charter migrates its Spectrum brand of programs and services to the Time-Warner cable systems in California and other states.

Charter says it has 25 million home and business subscribers in 41 states. The company promises faster broadband speeds, better video products and more affordable phone service to new and existing customers. As the deal closed, Charter promised more investment in the two companies' broadband network. The L.A. systems it acquired are all-digital.

The spokesman assured Time-Warner customers they can keep their existing cable TV service once Charter launches its Spectrum brand in the L.A. market.

"While we believe customers will see our Spectrum packages as more compelling and a better value, if a TWC ... customer likes the package they are currently in, they will

be able to stay in that package," Charter's spokesman said.

Former Time-Warner customers have to wonder how smoothly the changeover will go, given the sizable service problems that former Verizon Fios customers are experiencing with Frontier Communications. More than 1,250 customers as of last week had filed complaints with the Public Utilities Commission, according to a spokesman with the commission.

The Public Utilities Commission apparently heard enough complaints to get involved. It held a public hearing yesterday in Long Beach about the many complaints lodged against Frontier by its subscribers. The meeting opened with a panel discussion about the phone outages, then the commission took public comment to hear firsthand accounts of how loss of phone and streaming video have affected households and disrupted business operations.

Frontier had representatives at the hearing to assist with "customer service concerns," the commission said before the event at Long Beach City Hall. An internet search about Frontier customer complaints found hundreds from California, Florida, the Midwest and Canada.

A Redondo Beach customer of Frontier's left a comment on the web site pissedconsumer.com about losing phone service for nearly two weeks.

"Phone out reported the morning of May 9. Initial comment was action by May 12. Unacceptable, but it gets worse. Told a technician it would be out on May 14 by 5 p.m. No show. It's now May 21 and nothing from Frontier regarding solution to this problem. They can't (or won't) tell me what the likely problem is and they lie."

Frontier blames corrupted software inherited from Verizon Fios for the repeated outages across Southern California and in several

states. The telcom company promised state lawmakers last month it would correct the problems with slow internet speeds and service interruptions.

A Lake Elsinore reviewer explained that Frontier canceled a service call and re-scheduled it without checking with her.

"I have been on the phone with them multiple times due to not having internet service for last two weeks. They finally scheduled an appointment for a technician to come to my home then cancelled the day of and left an automated voicemail rescheduling the appointment for a day I would not be home," the customer wrote.

The Time-Warner sale to Charter is part of a shakeup of telecom ownership that started in July when AT&T U-Verse bought El Segundo-based DirectTV. Frontier in April, wrapped up the deal to buy Verizon Fios and its landline divisions. All three pay-TV providers compete in the airport and South Bay cities.

Charter quadrupled its number of Southern California subscribers and now services 1.5 million homes and businesses, according to published reports. Time-Warner customers will be relieved to know that Charter has contracts with the Los Angeles Dodgers for baseball, USC football and Lakers games.

South Bay cities are yet to hear from Charter about its plans for the future. A change to the federal telecommunications act in 2006 stripped California cities of their authority over local cable TV providers. However, cable companies and cities have business relationships for public-access TV channels, some resident complaints, and maintenance contracts.

Manhattan Beach has a five-year contract with Time-Warner Cable to maintain the fiber-optic cables for phone service, according to management fellow Kendra Davis. The new owners, Charter, have not contacted either

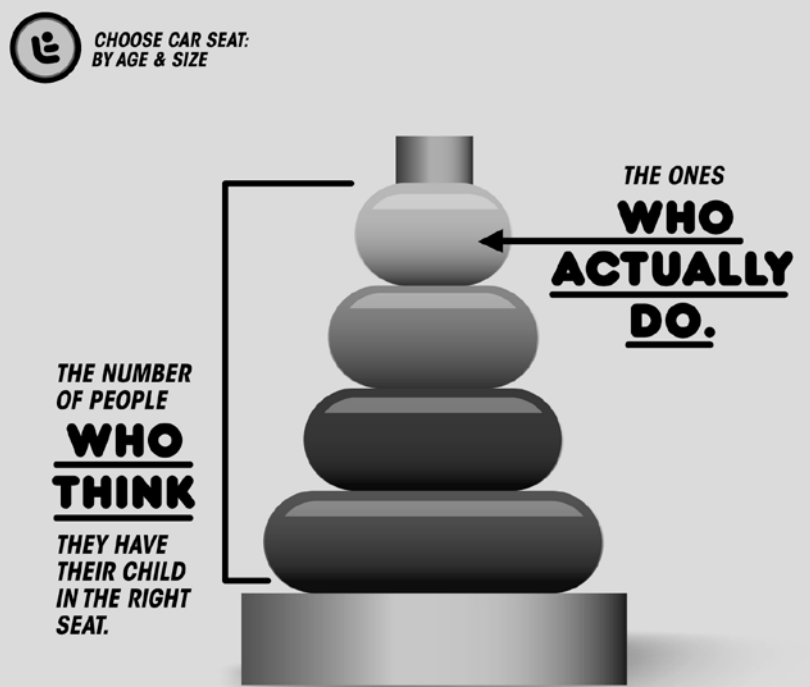

1. What tax deductions can I claim? Even if the expenses were incurred during the previous calendar year, the IRS allows businesses to deduct up to \$5,000 worth of certain start-up expenses in the year the business began (subject to limitations). In addition to these costs, corporations and partnerships are allowed to deduct up to \$5,000 of their organizational costs in their first year of operation.
2. Is my car mileage deductible? If you use your home as a place of business and consider it your principal place of business, car owners are typically allowed to deduct mileage costs from their home to business-related stops.
3. Can I deduct business travel expenses? When you are traveling away from your usual business location, you may be able to deduct ordinary and necessary expenses related to your work. These expenses include transportation costs, lodging, dry cleaning or

worn at work.
5. How does the Affordable Care Act (ACA) affect my taxes and deductions? The Small Business Health Options Program (SHOP) Marketplace allows for small business to purchase health insurance for their employees. If you pay at least half of your employee's premiums and have less than 25 full-time and equivalent employees with an average annual wage of less than \$50,000 (\$51,600 for 2016), you may be eligible for the small business health care tax credit. See the calculator at healthcare.gov.
Tax preparation is not one-size-fits all, and navigating credits and deductions makes them even trickier - especially for small business owners and individuals with more complicated tax situations. Filing a business return for the first time can be a daunting task, but it doesn't have to be. Animo Edges Rolling Hills Prep; Advances to Semis

During the regular season, the Rolling Hills Prep baseball team from San Pedro was a nemesis to Animo Leadership High of Inglewood. The Huskies won both games from the Aztec-Eagles for the Mulholland League championship. Animo finished second in league behind Rolling Hills Prep.

In the CIF-Southern Section Division VII quarterfinals last Friday at the Navy Field in Lomita, the Aztec-Eagles had their third shot at the playoffs' third seeded Huskies. Rolling Hills Prep started out with two runs in the bottom of the third inning but Animo came back with three in the top of the fourth. After the Huskies came back to tie the game at three with a run in the bottom of the fourth, the Aztec-Eagles pushed in the go-ahead run in the top of the seventh. Animo made it stand for a 4-3 victory and a spot in last Tuesday's Division VII semifinals against Academy of Academic Excellence from Apple Valley at the Urban Youth Baseball Academy in Compton. The winner moves on to Saturday's championship game at UC Riverside, beginning at 10 a.m. Academic Excellence proved excellent in its 3-1 upset win over second seeded Santa Clarita Christian in their quarterfinal last Friday.

It was a base hit by Adam Miranda that scored Sergio Orojel in the top of the seventh that proved to be the winner for Animo, which improved to 15-11 overall after going 9-3 in Mulholland play. Winning pitcher Steven Franco got Rolling Hills Prep out in order for the complete game victory. Orejel, a senior, used a mixture of fastballs, curve balls and splitters to catch the Huskies off guard. The Huskies ended its season at 22-2. Franco limited Rolling Hills Prep to five hits while striking out four batters.

"It was great," Franco said about his team's win over the Huskies. "Riverside is our goal."

Rolling Hills Prep started well. A double by Brady O' Neill scored a run and he scored, behind back-to-back singles by starting pitcher Austin Moe and Mitchell Moore. Moe was sailing along with a one-hitter through three innings but Animo finally got to him in the

fourth. The Aztec-Eagles tied the game on solo home runs by brothers Brian (junior) and Cesar (senior) Rocha. Later in the inning, Orojel singled home Saul Gutierrez to give Animo a 3-2 lead. The Huskies tied the game in the bottom of the fourth. The play came

on an error on an errant throw on a pickoff play at first base where the ball went deep to right field. Jake Hammond scored all the way from first. In the top of the seventh with Brady O' Neill on the mound in relief of starter Moe, Orojel singled. One out later

with Orojel at second, Miranda got a hit scoring Orojel.

"They (Rolling Hills Prep) could have planned it out," Animo head coach Sergio Garcia said. "We were the last team they wanted to play in the playoffs. Moe did a great job. After the third inning (when the Huskies took a 2-0 lead), I told the kids to stop making a big hit. I told them to just get those little plays."

The Aztec-Eagles were among the teams that made things hard for the Huskies in the playoffs. It is the third consecutive season that Rolling Hills Prep was eliminated in the quarterfinals.

"We had a great season, Rolling Hills Prep head coach Will Bougille said. "We went undefeated in league. Animo played hard."

In the second round on May 24 in San Jacinto, Animo crushed host San Jacinto Valley Academy 20-1. Franco had a big game hitting two home runs that included a grand slam and a three-run home run. He drove in eight runs as he also had a run scoring single.

The Aztec-Eagles will seek their second Southern Section title. They won the Division VII title in 2012.

ANIMO SOFTBALLERS GET ROUTED BY HUSKIES

The Animo Leadership softball team was not as fortunate as its baseball squad in last Thursday's quarterfinal against Rolling Hills Prep at Vincent Park in Inglewood. The Huskies crushed the Aztec-Eagles 19-0.

Rolling Hills Prep wasted no time on Animo. It scored 10 runs in the top of the first inning. The Huskies added two runs in the second, five in the fourth and two each in the fifth and sixth. With the loss, the Aztec-Eagles ended its season at 17-2 overall. Animo had a 10-8 first round win over host Connelly on May 19 in Anaheim and 3-2 against St. Monica Academy from Pasadena on May 24 at Vincent Park.

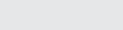

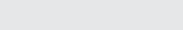

ORDINANCE NO. 2113
AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA, ADDING CHAPTER 9.43 TO TITLE 9 (PUBLIC PEACE, MORALS & WELFARE) OF THE HAWTHORNE MUNICIPAL CODE RELATING TO SKATEBOARDS, ROLLER SKATES AND NON-MOTORIZED OR MOTORIZED WHEELED VEHICLES

WHEREAS, it is well established that significant safety issues arise when skateboards, roller skates and similar vehicles are ridden on sidewalks and walkways in areas where people conduct business;

WHEREAS, near-miss collisions between pedestrians and motor vehicles on the one hand and skaters, skateboard riders and scooter riders are regularly reported to the City, and significant damage has been done to public property as the result of the of public property for skate, skateboard and scooter stunts, tricks and maneuvers;

WHEREAS, skateboard riders are provided a specific venue, the City's Skateboard Park, at which location individuals can recreate on skateboards in lieu of using the sidewalks and public or private property adjacent to the City Hall or in front of other businesses;

WHEREAS, the Police Department has observed that roller skating, skateboarding and use of two and three wheeled motorized and non-motorized vehicles has become problematic in and around the City including in public parks;

WHEREAS, California Vehicle Code Section 21967 authorizes cities to adopt rules and regulations prohibiting or restricting persons from riding or propelling skateboards on highways, sidewalks, or roadways subject to the provisions of Vehicle Code Section 21968;

WHEREAS, California Vehicle Code Section 21969 further authorizes cities to adopt rules and regulations prohibiting or restricting persons engaged in roller skating on highways, sidewalks, or roadways subject to the provisions of Vehicle Code Section 21968, and;

WHEREAS, a review of the City's existing municipal ordinances regulating the use of skateboards revealed the need to revise and update Title 9 - Public Peace, Morals and Welfare, to address contemporary skateboarding issues;

WHEREAS, the proposed additions and revisions to the existing Municipal Code provisions would provide the Police Department with specific regulations and authority to address unsafe skateboarding within the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HAWTHORNE DOES ORDAIN AS FOLLOWS:

SECTION 1. Title 9 (Public Peace, Morals and Welfare) of the Hawthorne Municipal Code ("HMC") is hereby amended to add a new Chapter 9.43 (Skateboards, Roller Skates and Non-Motorized Wheeled Vehicles) to Division IV (Offenses Against the Public Peace):

"Chapter 9.43 SKATEBOARDS, ROLLER SKATES AND NON-MOTORIZED WHEELED VEHICLES

9.43.010 Definitions
For the purpose of carrying out the intent of this chapter, words, phrases and terms used herein shall have their ordinary meaning, unless otherwise indicated as follows:

A. "Skateboard" is any platform of any composition or size to which two or more wheels are attached and which is intended to be ridden or propelled by one or more persons standing or kneeling upon it and which is intended to be propelled by motor, electricity, pushing, pulling, body movement, or gravity and to which there is not affixed any device or mechanism for steering.

B. "Roller Skates" or "in-line skates" including roller blades, shall be defined as any shoe, boot or other footwear to which one or more wheels are attached and which are propelled by body movement and contain no mechanism for steering.

C. "Skater" means any person participating in skate or skateboard activity.

D. "Non-Motorized or Motorized Wheeled Vehicles" means two or three-wheeled recreational scooters and bicycles that are propelled by motor, electricity, pushing, pulling, body movement, peddling, or gravity and that contain a mechanism for steering.

E. "BMX bicycle" shall be defined as any non-motorized two-wheel bicycle.

F. "BMX bicycle rider" shall be defined as any person utilizing a BMX bicycle.

G. "Hoverboard" means any motorized two-wheeled platform of any composition or size that is propelled by a motor or electric mechanism such as a battery, and to which two or more wheels are attached and which is intended to be ridden by one person standing in an upright position.

H. "Public Property" means public roadways, public sidewalks, alleys, public parking lots and other public property, including walkways, landscaping and methods of ingress and egress

to public facilities.

I. "Public skate park facility" shall be defined as any facility, structure or area in which skateboarding, in-line skating, roller skating and BMX bicycling is permitted pursuant to the provisions of this chapter, which is owned, operated and maintained by the City of Hawthorne and which has been designated as a public skate park facility by the City of Hawthorne.

9.43.020 Regulations

A. **Prohibition.** No person shall operate, ride or use a skateboard, roller skates and other motorized or non-motorized vehicles as defined above upon any public or private property within any zone of the City where notice of such provision has been posed and is clearly visible at a minimum of two entrances or the immediate area where such activity is prohibited.

B. **Skateboarding on Public Property.** Persons riding on skateboards, roller skates and other motorized or non-motorized vehicles as defined above shall comply with the following requirements and restrictions:

1. **Transportation Uses.** Roller skates, skateboards, bicycles and motorized or non-motorized two or three wheeled vehicles shall be used to travel from one destination to another. Loitering on public property for the purpose of performing skate, skateboard, bicycle or motorized or non-motorized two or three wheeled vehicle tricks and stunts is strictly prohibited.

2. **Skateboarding in the upright position.** Persons riding on skateboards, roller skates, or motorized or non-motorized two or three wheeled vehicles (other than three-wheeled bicycles) shall do so only in the upright, standing position. Using, pushing, propelling or riding on a skateboards, roller skates, motorized or non-motorized two or three wheeled vehicles (other than three-wheeled bicycles) in a sitting, prone, kneeling or lying position is prohibited.

3. **Traffic controls.** Persons riding on skateboards, roller skates, bicycles, or motorized or non-motorized two or three wheeled vehicles on public roadways shall obey all speed limits, stop signs, signal lights, and other traffic controls that govern right-of-way.

4. **Yielding to traffic in same direction.** Persons riding on skateboards, roller skates, bicycles or motorized or non-motorized two or three wheeled vehicles on public roadways shall ride close to the far-right edge of the roadway, and shall yield to vehicles approaching from the rear by moving to the right curb or shoulder

of the roadway.

5. **Uncontrolled intersections.** When approaching an uncontrolled intersection, persons riding on skateboards, roller skates, bicycles or motorized or non-motorized two or three wheeled vehicles on public roadways or public sidewalks shall yield to vehicles that are so near as to present a hazard and shall not cross the intersection at a speed in excess of ten (10) miles per hour.

6. **Manner of operation.** No person shall operate skateboards, roller skates, bicycles or motorized or non-motorized two or three wheeled vehicle recklessly or in such a manner or at such a speed as to cause or threaten to cause injury to himself or herself or to others, to create an obstruction or to present a hazard to the free use of public property by other pedestrians or motorists.

7. **Attaching to or towing by vehicle.** A person operating skateboards, roller skates, bicycles or motorized or non-motorized two or three wheeled vehicle shall not attach the same or himself or herself to any motor vehicle on the roadway. In addition, a person shall not knowingly drive a motor vehicle that is towing a person riding upon a skateboard.

C. **Skateboard Park.** A skateboard park has been developed for use by any person as set forth in Chapter 2.26B of this Code. Any person performing stunts, tricks or other maneuvers on a skateboard in any area outside of the Public Skateboard Facility shall be in violation of this section.

D. **Public Parks and Public Property.** The use of public parks other than the Public Skateboard Facility for recreational skating, skateboarding, bicycling or use of motorized or non-motorized two or three wheeled vehicles, including but not limited to the use of park facilities to perform tricks, stunts and other maneuvers for show or entertainment purposes is strictly prohibited. Public property may not be used to propel for tricks, jumps or other acts of skill on skateboards, roller skates or motorized or non-motorized wheeled vehicles except in locations specifically designated for such use.

E. **Exercise of Due Care.** Skateboards, roller skates, bicycles or other motorized or non-motorized two or three wheeled vehicles may be operated on the public right-of-way in order to travel from one destination or another only when exercising due care and giving proper regard for the safety of motorists, pedestrians and property.

9.43.020 Exemption

This Ordinance does not apply to wheelchairs or mobile devices such as four-wheeled scooters used by the physically disabled or impaired.

9.43.040 Penalty for Violations

A. It shall be unlawful for any person to violate or fail to comply with the provisions of this section. Any person violating the provisions of this section shall be guilty of an infraction and shall be subject to fines as established by the City Council as set forth in Hawthorne Municipal Code Section 1.22.030.

B. Where this chapter has been violated more than once in a 72-hour period by a juvenile, in lieu of a fine or imprisonment, the Chief of Police or his/her designee may impose an obstruction or to present a hazard to the free use of public property by other pedestrians or motorists.

C. When a skateboard, roller skates, or other wheeled vehicle as defined above is impounded, the parent or guardian of the juvenile shall be responsible for paying a fee of forty dollars (\$40.00) for processing and storing the item.

D. This section shall not apply to persons participating in any city-sponsored program, event or class in which use of the self-powered wheeled devices described herein are specifically authorized, permitted or required.

SECTION 2. Severability. If any section, subsection, phrase or clause of this ordinance is for any reason held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

SECTION 3. City Clerk. The City Clerk shall certify to the passage and adoption of this ordinance and shall cause its ordinance to be published within fifteen days after its passage, in accordance with Section 36933 of the Government Code.

SECTION 4. Effective Date. This ordinance shall take effect thirty (30) days after passage thereof.

Manhattan Beach or Torrance yet to discuss future plans.

“As of this moment, the City has not received any communication regarding changes that may result from the sale of Time Warner to Charter Communications but is hopeful that it will not result in a disruption of service for the City or its residents,” Davis said in an email to the Herald.

Charter Spectrum sent a letter last week to subscribers about the sale. City officials, however, say they learned from media reports and not the telecom companies themselves that the deal had closed. The Torrance manager of cable TV services also said that no one from Charter has contacted his office about the change of ownership.

“Because they are conducting business in our community, and their customers are our residents and businesses, they have a unique opportunity to gain insight to any local impacts,” Cable and Community Relations Manager Michael Smith said. “We can also be a resource in dispelling any incorrect perceptions as well as mitigate customer

service issues.”

Time-Warner's performance in Torrance was solid, based on the number of complaints taken by Smith's office. Time-Warner subscribers lodged 15 complaints in 2014, 16 in 2015 and just two from January through May of this year, according to Smith. The majority of complaints were about billing and rates, according to the breakdown he provided.

Time-Warner Cable and Charter are the only two cable providers in Southern California that show Los Angeles Dodgers games. Time-Warner took the lead in 2013 and signed a 25-year deal with the Dodgers. The Dodgers own SportsNet LA, but TWC is responsible for getting other pay-TV companies to use it.

Frontier, U-Verse and Dish Network subscribers were shut out again this baseball season because their TV service providers refused to pay the Dodgers' asking price to televise home and road games. There was talk that AT&T's deal for Direct TV would require the new buyer to televise Dodgers games, but that didn't happen. •
