Lawndale Council Packs Out City Council Chambers For Non-Agenda Topic

The Lawndale City Council met as usual on the third Monday, October 20, with an agenda that potentially was to be non-controversial, until the Council Chambers began to fill up with citizens who then were disruptive to the proceedings despite the instruction from Mayor Robert Pullen-Miles. The citizenry were present to protest what was described by some of those who spoke during the Public Communications portion of the meeting about the “firing” of an employee who worked at the Lawndale Community Center each day and interacted with the senior citizens during their activities. The speakers questioned the dismissal, asking for an explanation and for the re-hiring of that person. The mayor then requested that the City Attorney Tiffany Israel comment on the matter. The meeting gallery was told that the employee resigned and was not “fired” by the city of Lawndale, but also advised that the former employee was entitled to privacy about the matter and there would be no further comment by the City Council. The citizens were asked to not clap for each public speaker or to yell out during the proceedings, cheering or booing for comments made at the podium. However, the attendees continued with applause when a speaker concluded remarks and to ignore the calm request by the mayor. When the majority of the audience left the Council Chambers they did so during the Consent Calendar voting and were very boisterous

as they exited the chambers, lingering in the lobby of City Hall and on the outside steps, continuing to discuss the topic for which they all were in attendance. The City Council unanimously approved all items on the Consent Calendar agenda, including the contract services agreement with Data Ticket to process and accept payment for traffic tickets issued; a contract with Time Warner Communications for improved, dedicated internet access and Ethernet services between City Hall and the Metro City Yard connectivity; and to accept the bid from Malibu Pacific Tennis Courts as the contractor for playground equipment to be replaced at William Green Park’s playground. Measure R funding was approved as requested by the South Bay Cities Council of Governments Board of Directors, as well as for the Inglewood Avenue Widening Project at a cost of \$1,019,000 and extends the use of the Measure R funds for the project through June 2015. Street improvements on 156th Street, 153rd Place, and Rixford Avenue were approved for a bid from Kalban, Inc., in the amount of \$359,625.51 with a 10 percent contingency as well. Signage at the intersection of Manhattan Beach Boulevard and Hawthorne Boulevard will be inspected and directional views of the street signs will be corrected so each street is identified for the true street name. A resolution was approved confirming the Conflict of Interest policy for the deletion

of the Deputy City Manager position and the addition of the Director of Community Development to the list of designated employees of the city of Lawndale. The public safety report included the apprehension of suspects who were involved in a strong-arm robbery of a female victim from whom they stole her cell phone by force. The suspects were arrested and booked. Four suspects were arrested and booked for an attempted murder charge after a victim was shot on October 7 in the 4100 block of 160th Street. In addition, citizens should be aware of a scam being perpetrated in Los Angeles County whereby suspects are contacting individuals, pretending to be members of the Sheriff’s Department, accusing the victim of missing jury duty and requesting a fine be paid and that payment be sent via wire transfer or the purchase of a gift card. Citizens should know that the Sheriff’s Department will not contact anyone by telephone to collect a fine or contact citizens by telephone for any reason. Election Day is Tuesday, November 4 and citizens are encouraged to cast their ballot, either in person on that day or by Absentee ballot prior to Election Day. It is not a local election, but is a state and federal election for members of Congress, state propositions, and governor. The next meeting of the City Council will be held on Monday, November 3 at 6:30 p.m. •

Is Vision Loss Inevitable With Age? The Answer May Surprise You

(BPT) - Eighty-three percent of U.S. adults believe their eyesight will worsen as they age, no matter what preventive steps they take, according to a recent DSM Nutritional Products survey. While genetics and lifestyle factors do play a role for some serious eye conditions that cause vision loss such as age-related macular degeneration (AMD), years of proper nutrition may protect vision in the long term.

More than 2 million Americans age 50 and older suffer from AMD, and it is especially prevalent among Caucasian women. "You don't want to reach your 40s and realize that you're beginning to have vision problems," says Dr. Kimberly Reed, optometrist and Ocular Nutrition Society board member. "Following a few simple recommendations can help support your vision - and your family's vision - now and in the future."

Reed offers these tips for maintaining eye health and supporting vision in the long term:

1. See your Diet in Color

Many brightly colored fruits and vegetables contain lutein and zeaxanthin, two powerful antioxidants that research shows are beneficial in maintaining macular health. Intake of 12



mg per day of lutein and zeaxanthin offers the best protection, but only 10 percent of Americans are getting enough of these essential nutrients, according to the American Optometric Association. For weekly meal planning this year, choose colorful fruits and vegetables that provide these important antioxidants, like spinach, kale, and other dark leafy greens, as well as corn, peas, broccoli, and orange and red peppers.

2. Omega-3 Fatty Acids for Eye Health

A study published in the American Journal of Clinical Nutrition showed that people with higher intakes of omega-3 fatty acids

may experience a lower incidence of dry eye syndrome (DES). For patients who suffer regularly from dry eyes, omega-3 intake can significantly improve symptoms and increase quality tear production. Adults should get at least 1,500 mg per day of DHA and EPA either by consuming fatty fish, such as salmon, mackerel, and sardines, or taking high-quality fish oil and algae supplements. Be sure to check with your physician if you are taking medications that affect blood clotting before increasing your intake of omega-3s to this level. For women who are pregnant or nursing, DHA is an essential nutrient to

support infant visual development.

3. Remember your Vitamins and Minerals

An array of vitamins and minerals also play an important role in maintaining eye health. For instance, A and B vitamins perform many complex and critical functions throughout the body, including the eyes. And, according to a study published in Ophthalmology, vitamins C and E, which function as antioxidants, are also essential to eye health and have been shown to impact the progression of certain forms of AMD. Finally, zinc helps deliver vitamin A from the liver to the retina in order to produce melanin, a protective pigment in the eyes. Get your fill of at least five servings of colorful fruits and vegetables, as well as nuts and legumes, per day to obtain these essential vitamins and minerals.

Even when striving to follow an optimal diet, it's difficult to get the recommended amounts of essential vitamins and nutrients from food alone, so nutritional supplements can play an important role in maintaining eye health. Several products specifically formulated to support eye health and vision are available, so ask your eye health professional at your next appointment. •

agrees. “Get your child involved in creating the costume,” she says. “Look at ideas and decide on a budget together. This ensures your child is excited about their costume, especially when their friends tout the ones from the store.”

For more inspiration, try these quick costume ideas:

• Robot Costume

Needed: Gray sweat suit, one long aluminum dryer hose, two rectangular disposable foil pans, baseball cap, foil, colored markers, ribbon.

1. The foundation is a long-sleeve sweatshirt or undershirt and gray sweatpants.

2. Cut aluminum dryer hose in four parts. Place one on each leg over sweatpants for the legs. For arms, use ribbon attached to the hose with a stapler to connect the other two pieces across the child’s back. Put on like a coat, one arm at a time.

Cats and Dogs are Not A Risk Factor in Spread of Viruses

Lately, it seems deadly viruses have been dominating the news. Ebola has been seen in the United States for the first time. Enterovirus 68 is spreading across the country and causing serious illness in children. Long Beach has seen record numbers of West Nile virus.

A common question that comes up is whether or not our pets may be a risk factor in transmitting these serious diseases. The quick answer is: no they are not. As with many emerging and serious diseases, there is a lot of misinformation and lack of knowledge that can lead to fear. Let's review these diseases, put them into perspective and see where animals may play a role.

In West Africa, where Ebola is endemic, the fruit bat is the natural reservoir for the virus and dogs play an insignificant role in the transmission to humans. There is evidence that dogs in these areas can become infected with the virus by eating other animals that died of Ebola virus. However, there is no evidence that they develop disease. In an ongoing study in Africa, 27% of healthy dogs had serum antibodies to the virus but none had detectable virus in circulation. There is no evidence that dogs can shed the virus.

Enterovirus 68 has been seen locally in Southern California. There are over one hundred types of enteroviruses, which are single stranded non-enveloped RNA viruses that contain poliovirus, coxsackie viruses and echoviruses. Enterovirus 68 is a non-polio virus that was first discovered in California in 1962. The infection can be serious in younger individuals. It is not uncommon to see enterovirus infections in the fall. The symptoms in people are similar to common cold symptoms. Transmission is from person to person through respiratory secretions and stool. At this time, there is no evidence that cats or dogs can be carriers of this disease.

West Nile virus has been seen in increasing numbers in Southern California in the past several years. Long Beach is seeing a record

number of human exposures. Although one local death has been contributed to the West Nile virus, most people that are infected will make a full recovery. Unlike Ebola and Enterovirus 68, West Nile requires a vector animal. The vector is the mosquito. It seems ironic that in a time of drought in the southland the mosquito population would be a problem. However, it seems our storm drains and sewer systems are the problem: the mosquito population has been driven underground. The city is making every effort to mitigate the problem with mosquito traps around town. Dogs and other animals, other than the mosquito, cannot transmit West Nile to humans. Horses are very susceptible to the virus and should be vaccinated for the disease.

The news has sensationalized the latest viral outbreaks. It is important to put everything into perspective and continue everyday hygiene to prevent the spread of all kinds of diseases. Washing your hands frequently is the single most important thing you can do to prevent the spread of disease. Sanitize things like your phone, doorknobs and other objects people handle. Stay home if you feel sick.

Animals do play an important role in all kinds of human diseases. Fortunately, that role is of helping people and not spreading disease. Chickens are used as sentinel animals all around our city and county to monitor for West Nile. Dogs may play a role in monitoring for human diseases as well. At this time, there is no concern for our pets to become transmitters of Ebola, Enterovirus 68 or West Nile.

A Barking Dog Cannot Bite

It's been a long, long time since I had to sit like a chastened schoolboy listening to an arrogant lecturer preach about the error of my ways. But I could only clench my fists under the table and nod my head in agreement.

Yesterday, I lunched with a revered Chinese doctor from Shanghai, ostensibly to learn about the differences between American medicine and Chinese medicine. But that discussion quickly evolved into a lecture on the foolishness of America, and the might of China.

Appropriately, last week China passed the U.S. as the largest economy in the world, so kudos to them. Moreover, as Obama boasts of a 2% growth rate, China grows at 7% so we'll eat crow and listen to stories of our own ineptitude.

The doctor reminded me that a confident China does not fear (or respect) the U.S. because a "barking dog cannot bite." Since we are so busy doing the former we cannot do the latter. We engage in a bombing program in the Middle East, a strategy no military person believes can succeed, using weapons the government has already ceased manufacturing. All the while IS continues its surge as Iraqi forces abandon the fight, and no Middle East country will materially contribute to the effort to save themselves.

We squander our riches as Gaza wails about the consequences of the war it started and Guatemala demands we rebuild Central America or face unrestrained illegal immigration. We send 3,000 of our military into harm's way in West Africa to build

hospitals and clinics without knowing what causes the disease, and without staffing or supplies for those facilities. We allow 4,500 West African immigrants into the U.S. each month even as the World Health Organization predicts worldwide infection growth at the rate of 10,000 per week. We stare in wonderment as Chinese investors buy the Waldorf Astoria for \$2 billion, not realizing that China has simply traded that amount of U.S. currency it has in its treasury for a piece of irreplaceable real estate.

The Chinese, in turn, stare in wonderment at our decision to import low-skilled laborers from poor countries even as we require highly skilled and highly educated workers to compete on the world stage. The former drags the economy while the latter propels the economy; so we have chosen the former. We create technical marvels like Apple iPhones, but manufacture them in China where the technology can be replicated.

In the search for worldwide market share, Boeing sells its most technologically sophisticated planes to China in exchange for having parts built there. Chinese manufactured planes will improve on Boeing's products and cost it market share instead. China took advantage of Russia's economic straits by executing a monster oil contract on favorable terms, using Chinese currency as the source of payment, and thus undermining the importance of the U.S. dollar.

Everywhere now, an arrogant China sees a rival that has lost its way, a pathetic shell of its former self, reduced to merely a barking dog. How tragic. •

It's time for the big media outlets to focus on informing the public on how a person can become infected with the Ebola virus. 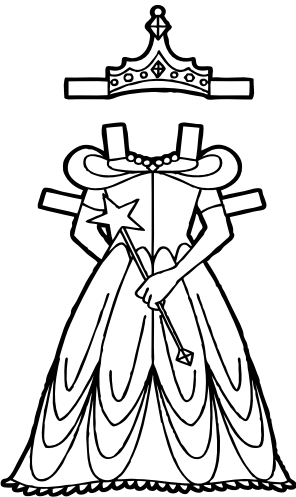
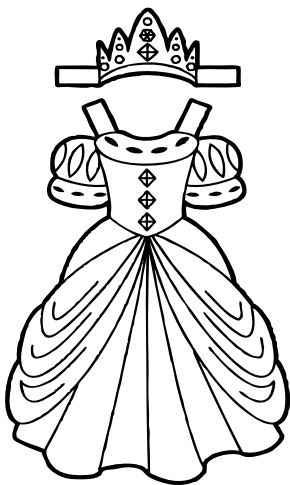

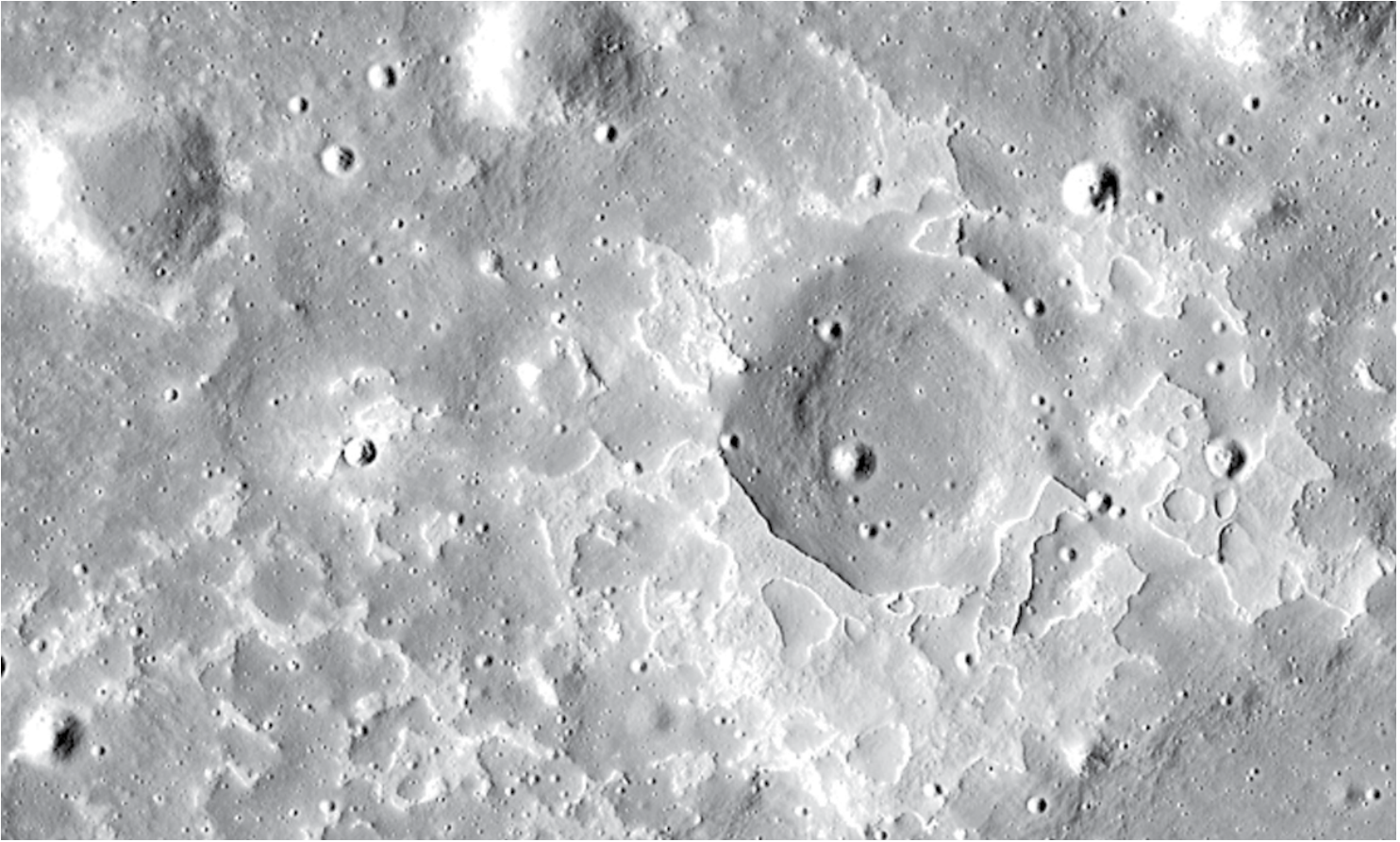

Partial Solar Eclipse Visible Here October 23

A partial eclipse of the sun will be visible across most of North America on Thursday, October 23, as the Moon partially obscures the Sun between 2:10 and 4:40 p.m. PDT. At eclipse maximum (3:29 p.m.) the Sun will be approximately half covered as the Moon passes in front of it.
Viewers should exercise extreme caution to avoid eye damage. NEVER look directly at the Sun except through specially designed filters or through welder’s glass. A good alternative to looking at the Sun is to look for crescent-shaped images of the eclipsed Sun on a sidewalk in the shade of a tree, naturally formed as the sunlight passes through tiny openings between leaves.
During the eclipse, the world-famous Mount Wilson Observatory in the San Gabriel Mountains above Pasadena will present a special eclipse-viewing event for the visiting public. Several telescopes equipped with filters for safe solar viewing, will be set up in the Observatory parking lot for the public’s enjoyment. In addition, the historic 150-foot solar tower telescope will be open so visitors can view the large projected image of the Sun throughout the eclipse.
The Observatory grounds are open to the

public from 10:00 a.m. to 5:00 p.m. daily from April through November. On October 23, the Observatory’s “Cosmic Café,” where visitors to this historic site can purchase fresh-made sandwiches, hot dogs, soft drinks, snacks and souvenirs, will also be open. “RECENT” VOLCANIC ACTIVITY SEEN ON MOON

NASA’s Lunar Reconnaissance Orbiter (LRO) has provided researchers strong evidence the Moon’s volcanic activity slowed gradually instead of stopping abruptly a billion years ago. Scores of distinctive rock deposits observed by LRO are estimated to be less than 100 million years old. This time period corresponds to Earth’s Cretaceous period, the heyday of dinosaurs. Some areas may be less than 50 million years old. Details of the study are published online in Nature Geoscience [http://www.nature.com/ngeo/journal/vaop/ncurrent/full/ngeo2252.html].
“This finding is the kind of science that is literally going to make geologists rewrite the textbooks about the Moon,” said John Keller, LRO project scientist at NASA’s Goddard

Space Flight Center in Greenbelt, Maryland.
The deposits are scattered across the Moon’s dark volcanic plains and are characterized by a mixture of smooth, rounded, shallow mounds next to patches of rough, blocky terrain. Because of this combination of textures, the researchers refer to these unusual areas as irregular mare patches. The features are too small to be seen from Earth, averaging less than a third of a mile (500 meters) across in their largest dimension. One of the largest, a well-studied area called Ina, was imaged from lunar orbit by Apollo 15 astronauts.
Ina appeared to be a one-of-a-kind feature until researchers from Arizona State University in Tempe and Westfälische Wilhelms-Universität Münster in Germany spotted many similar regions in high-resolution images taken by the two Narrow Angle Cameras that are part of the Lunar Reconnaissance Orbiter Camera. The team identified a total of 70 irregular mare patches on the near side of the Moon.
The large number of these features and their wide distribution strongly suggest that late-stage volcanic activity was not an anomaly but an important part of the Moon’s geologic history. •

- 1/2 cup seeded and diced cucumber
