Council Gets Earful From Union Members on Retirement Contribution Hike

A consent agenda item approving a two percentage point increase in the amount members of the Supervisory and Professional Employees Association (SPEA) bargaining unit pay into their secondary retirement program (Public Agency Retirement System, or PARS) prompted strong comments of protest during Tuesday night's El Segundo City Council meeting. City Recreation Supervisor and SPEA President Jesse Bobbett said he was "disappointed and shocked at the timing" of the increase, stating that it "further erodes the fragile morale" of the employees who have already taken prior pay cuts and that the "rush decision" will hinder future labor negotiations. He and several other members of the union questioned the validity of the financial numbers, maintained that they did not receive responses to requested information, and asked the Council to pull the item to allow City staff to work out a sustainable solution. Calling the increase a "travesty," Teamsters Local 911 business agent Jorge Sanchez noted the presence of "75 years of supervisory experience" sitting in the third row and stated that if the Council were to pass the item that "these folks behind me would simply decide to work somewhere else." Sanchez said he also heard that City Manager Greg Carpenter purportedly mentioned that if the employees don't like the situation, they can find other employment somewhere else. Carpenter later denied the allegation. "I don't run around City Hall... making statements that people should work somewhere else," he said. Earlier, Councilmember Marie Fellhauer commented that she herself would make the statement. "If you're not happy, then go elsewhere," she said. "That

being said, I want you here... But I don't believe in acrimonious relationships between unions and agencies... I'm okay with talking about it, but I don't like threats of, 'We're gonna leave ... "

The SPEA and the City entered into an agreement in 2008 to add PARS as a supplement to the existing CalPERS program. At the time, the employees shared the cost of the plan, paying one percent of their total annual pay with the City kicking in two percent. For the 2012 labor negotiations, the SPEA agreed that its employees would pay 100 percent of their contribution going forward (5.2 percent of annual pay at that point) and be responsible for any future increases. Additionally the plan had closed and was no longer available to new members. Then two months ago, staff received a new actuarial valuation for the plan that showed an increase in the City's projected costs over a 20-year period-hence spurring the need for an added payroll deduction for the SPEA employees to now pay 7.2 percent. City Attorney Mark Hensley added that staff had already implemented the increase in the current payroll since it was part of the 2012 agreement with the union--and that terminating the current plan would be complicated since already retired individuals are benefiting from it. Born December 10, 1921 on the kitchen table in his home on Sheldon Street, Floyd spent his entire life in El Segundo, graduating from El Segundo High School in 1939 among sixty-two other graduating seniors.

Floyd served his country in the United States Navy as an Electronic Technicians Mate and served aboard escort aircraft carrier Copahee before graduating from Loyola University in 1950 with a B.S. in Mechanical Engineering and graduating from Pepperdine University with an M.B.A.

A beloved member of the El Segundo community, throughout his life Floyd spent



his time spent as President of the El Segundo National Little League for three terms, President of El Segundo Babe Ruth League for two terms, District Director of Babe Ruth Baseball for Southern California and was named Mr. Baseball and Grand Marshall of the Annual Baseball Parade. Floyd was President of the El Segundo Sister City

Association for two terms and was a member for twelve years, visiting the city and helping to foster it's growth.

Floyd's jubilant attitude was a bright spot on his life, always willing to give a hug or a kiss. Floyd lit up any room he entered, always the life of the party and the man of the hour. There was always a line to talk to Floyd at any gathering, be it church, Mayor's Good

time on the El Segundo City Council and was Mayor from 1969-1970. He was Vice-Chairman of the Planning Commission, Member of the L.A. County Beaches Advisory Committee, Chairman of the South Bay Regional Planning Commission, Member of the South Bay Intercity Highway Committee and Vice Chairman of the El Segundo Fire Life Safety Committee.

A sixty-year member of the El Segundo Rotary Club, Floyd spent time promoting the message of the club and was President for two terms and took the club's motto "Service Above Self" to heart as he worked to better El Segundo.

A member of the El Segundo Education Foundation, Friends of the Church and United Methodist Church, Floyd received a PTA Honorary Service Award, the El Segundo Chamber's "Man of the Year" Award in 1970 and the El Segundo Rotary and El Segundo Chamber's "Lifetime Achievement Award" in 1995 as well as being named El Segundo "Senior Citizen of the Year" in 2006 and was inducted into the El Segundo High School Hall of Fame in 2007.



the decision would mean employees would have to make larger contributions in future paychecks to catch up.

'It's [PARS] a bad plan because you can't fill it in with new employees," admitted Mayor Bill Fisher. "[But] we can't just come out and say we're gonna cover that for you-not in the state we're in today ... "Later, Bobbett agreed it was a "bad deal for both sides" and that only 10 people will be able to use the plan out of 40 employees. "Our morale's gone-we've taken so many cuts, it's very hard," he said, adding that attempts to discuss an opt-out of the program several months back were "blown off" by the City.

In approving the item, Fellhauer asked to add a provision to meet with the union to look at ways to improve the situation for all parties concerned. While stating that she values these employees and understands the plight of those who won't be able to fully benefit from the program (due to being promoted, moving out of the department, retiring or working elsewhere), she issued a reminder that it's not all the City's fault. "This was your union that ratified it in 2012," she said.

Also on Tuesday, the Council approved a grant agreement with Chevron that will provide \$200,000 of funding towards economic and business development. Chevron's Lily Craig and Rod Spackman had approached the City several months back about applying for the grant. The monies will cover the period from now through the end of the 2014/15 fiscal year. Spackman noted that the funds will be key in the goal "to start to build a more

The Council additionally adopted a resolution supporting the California Office of Business and Economic Development's mission to increase the competitiveness of the state's business climate. The action came on the heels of a revelation from two local businesses that they received letters from an organization in Commerce, Texas aggressively pushing for them to relocate to that state. "They're actively coming after us," Mayor Fisher said of the attempts to poach businesses and the need for Sacramento to step up to counteract the effort.

During presentations, El Segundo Chamber of Commerce Executive Director Marsha Hansen announced the winners from the 2013 Holiday Parade. Best Use of Theme went to El Segundo United Methodist Church. Eagles Nest Preschool captured Best Holiday Spirit-Children honors, while 1-800 Got Junk/You Move Me did the same for the adult side of that category. 

Los Angeles World Airports Board of Air-

port Commissioners awarded a \$118 million contract for the construction of LAX's Central Terminal Area (CTA) Curbside Appeal Project to Myers & Sons Construction and J. Banicki Construction Inc., a joint venture.

The Curbside Appeal Project will provide a new, dramatically upgraded look for LAX with the installation of modern LED street lighting, wayfinding components and new canopies for Terminals 3 and 4. The project will also include traffic safety and roadway improvement measures including a second level (departures level) retrofit and traffic improvements to World Way South and Center Way.

These visual enhancements are currently on display at the Tom Bradley International Terminal, with the remaining CTA set to begin its transformation in Spring 2014. This much needed facelift to the city's gateway to the world will include aesthetic improvements to the terminal area including: the installation of custom-made art deco LED light poles similar to the lighting provided by the LAX's signature pylons; sleek, metallic silver canopies in front of Terminals 3 and 4 evoking the golden age of aviation; and a programmable LED light band running the length of the CTA and covering a portion of the outside upper roadway, which can play programed video graphics and display light shows, offering a world-class welcome to travelers and visitors alike.

For traffic functionality and safety enhancement, the Curbside Appeal Project will also involve retrofitting the second level roadway by removing and replacing expansion joint seals, repairing hinges, replacing the barrier rail, traffic signal work, deck drainage improvements and roadway striping, bearing pad replacements and traffic control signage. The World Way South/Center Way Traffic Improvements will create an additional lane from the World Way South transition to southbound Sepulveda Blvd., along with traffic signal upgrades and other related traffic flow defining measures throughout the entire CTA.

Construction is expected to begin in Spring 2014 and complete in 2015. Passengers should expect impacts due to the roadway construction and terminal re-facing. To mitigate the effects of this transition, LAX will be holding construction in phases. Traffic alerts will be posted regularly on LAX social media and on LAX's real time traffic map, http://www. lawa.org/laxtrafficmaps.aspx

This comprehensive enhancement is part of the on-going multi-billion dollar LAX Development Program, which is funded by operating revenues, capital improvement program funds, fees from airlines, passenger facilities charges and airport revenue bond proceeds. No money from the Los Angeles City General Fund will be used for the project.

Public Hearing on Autonomous Vehicles

Sacramento - On Tuesday, January 14, 2014, the California Department of Motor Vehicles (DMV) will hold a public hearing and provide an opportunity for public comment on proposed autonomous vehicles testing regulations at DMV's headquarters in Sacramento. The hearing, which will be webcast, begins at 10:00 a.m. in the Assembly Room of the Department of Motor Vehicles Headquarters, located at 2415 First Avenue, Sacramento. The proposed regulations governing the testing of self-driving and autonomous vehicles on California's public roadways were published in the Office of Administrative Law's California Regulatory Notice Register on November 29, 2013. The publishing marked the start of a 45-day public comment period, which ends on January 13, 2014. Public comment and ideas on the development of these vehicle testing regulations can also be presented during the scheduled hearing. A full text of the draft testing regulations is available at http://oal.ca.gov/ res/docs/pdf/notice/48z-2013.pdf, starting on page 1867. After the public hearing, DMV will deliver final testing regulations to the Office of Administrative Law for approval. Those regulations are anticipated to become final in the spring of 2014 and will then go into effect 120 days after approval. For the past year, the California Department of Motor Vehicles has been developing testing regulations as mandated by Senate Bill 1298 (Vehicle Code Section 38750). The regulations include requirements for testing vehicles, insurance, reporting and registration. In addition to the just-released testing regulations, the DMV is working on regulations that will cover the public operation of self-driving cars on California's roadways. Those regulations will be completed by January 1, 2015. aisle in order to better serve voters, regardless of party affiliation. Today I am doing something similar, but as a writer. As someone who has been in favor of President Obama's Affordable Care Act and has wanted to see it succeed, I have been disappointed at many of the problems that have been encountered with the new health care law. One of those problems, which is completely unacceptable, is that many Americans who had health coverage prior to the Affordable Care Act lost that coverage when the law took effect.

Last week Assemblyman and senior member of the Assembly Committee on Health Dan Logue--a Republican from Northern California--introduced Assembly Bill 1507 in an effort to solve the problem. AB 1507 will allow Californians who had their health plans canceled as a result of the Affordable Care Act to reclaim those plans at least through December of this year. Back in November, the Covered California Board unanimously voted that any health plans that covered Californians that did not measure up to federal health care guidelines had to be relinquished.

I am not sure who is on this board nor why they decided that this was a good idea, but that body struck out with this decision. The purpose of the Affordable Care Act is to create the market options necessary to provide health coverage to

because they don't meet the guidelines set by the federal government. That logic simply does not register with my simple mind. To be honest, it is embarrassing that a law meant to provide health coverage ends up stripping coverage away from people who were responsible and fortunate enough to afford their own health insurance.

Furthermore, we all heard the promise that people who were already covered and liked their doctors would be allowed to keep what they had in place. I understand that sometimes the things that we plan for don't turn out as we expected. So if the plan was to allow people with health coverage to maintain that insurance and it turns out that such a move would not be possible, at the very least these people should be given a reasonable grace period to find an appropriate solution. To automatically cancel or terminate the existing health coverage of people is simply wrong and goes against the intended goals of the Affordable Care Act.

Assemblyman Logue is proposing a logical solution to a problem that was created by lawmakers and for which people should not have to suffer. I hope that the State Assembly can get behind Assemblyman Logue's bill and pass it so that the State Senate can do the same. If these Democratic lawmakers really believe in health coverage for all, then this is the right thing to do. •



Is a Travel Team Right for Your Child?

So, your son or daughter is a pretty good little athlete. And, you're thinking you ought to move him or her up to a higher level of coaching and competition. So you consider coaches who insist on improving their players' skills not only on the playing field, but in the classroom and at the dinner table. The really good coaches tutor their players on how to sharpen their minds and eat healthier

a travel team. Should you do it? You'll get as many different answers as you'll have questions about a travel team.

It doesn't really matter which sport you choose because there's always a travel team waiting for your son or daughter. Travel teams are considered by design as a higher level of competition compared to what your traditional high school or recreational leagues provide. For the exception of maybe football, there's a travel team somewhere near you.

Baseball is at the forefront of travel teams these days, but there are others closing in fast. Basketball, softball, volleyball, lacrosse, water polo, hockey and soccer come to mind.

Hard to find 20 years ago, travel teams are now a fast-growing part of the youth sports scene that can be a very lucrative adventure for coordinators. Kids as young as eight years old travel across state lines to play hockey in games or compete in basketball tournaments. Travel teams that are locally based may spend an entire weekend at a tournament 50 miles away.

The way it works is most travel team coaches recruit their players from local leagues, parks, tryouts, newspaper ads or word of mouth. Inasmuch as this is done, most coaches already know the potential athletes they want for their team. Many of these coaches have prior experience either as a former player or volunteering at the same recreational league as coaches or as instructors.

If these coaches are instructing, it usually comes with a paid stipend. For example there are a number of former high school, collegiate or pro athletes earning a living providing private instruction to ambitious players. Parents won't give it a second thought about paying \$45-\$75 an hour for private instruction. The monthly tab for instruction and participation on a travel ball team can run several hundred dollars a month. Of course that dollar amount can be very diverse if you compare the different sports. It increases when you add in costs for tournaments and possible hotel stays.

There are some travel teams that have

to improve their bodies.

There are varying levels of travel teams. For example, in baseball there is a level for all-star-caliber players and a level for younger all-star-aspiring players. In basketball, it's more of a level of competition--especially when these athletes enter high school.

Basketball players looking to be noticed vie for positions on prestigious travel teams that are sponsored and head to tournaments out of state. In some cases, players change teams depending on what position is needed and potential playing time.

Lacrosse teams, like most other travel squads, host tryouts. One premiere team that does this is The West Coast Force, a lacrosse club team for players from California, Oregon and Washington and players who plan to attend college in those three states. There are various age group levels including U-23, U-19, U-17, U-15 and U-13.

There are a number of hurdles to get past when a player joins a club or travel team. This is where he or she is no longer sheltered from the possibility of failure or lack of participation. The next hurdle is the discovery that "travel teams" become an entire family commitment and that they soon lose the complaisant luxury they once enjoyed in the past. In some corners, parents and even some players view playing for a travel team as prestigious.

Playing in a city league or recreation league allows for participation by each player regardless of their skill level. Being part of a travel team does not guarantee playing time. You'll need to perform to a higher level of standards. Most players on travel teams are self-motivated and strive to be better to rise to the competition level.

When you enter the world of travel teams, no matter which sport, there are bound to be rankings of players and teams. Rankings, by any measure, are subjective and vary from coast to coast.

Teams enter showcase tournaments for a number of reasons. This is usually a gathering place for coaches, schools and scouts to watch

What's a Super Bowl With No Gold?

It was an uneven battle from the start. The "12th Man" of the Seattle Seahawks provided one more benefit than the San Francisco 49ers were able to acquire and that slight edge wound up costing the Niners the game. In a grudge match that lived up to its billing and more, the two teams battled back and forth at CenturyLink field in Seattle last Sunday night and took turns gaining momentum until something just had to give. In the end, it was the 49ers who did the giving. As San Francisco starting quarterback Colin Kaepernick threw the last interception of the game with 22 seconds remaining on the clock in the fourth quarter, it was clear that the Seahawks were the team that simply made more plays. In games of this magnitude, with the NFC Championship on the line, those are the teams who win. Despite any possible controversy involving missed calls by referees and despite all of the almosts and what ifs, the Seattle Seahawks will be moving on to the Big Apple to take on the Denver Broncos in Super Bowl XLVIII at MetLife Stadium in New York.

The last time that two number one seeds had reached the Super Bowl to face off against one another was in 2009 when the Pittsburgh Steelers met Kurt Warner and the Arizona Cardinals. Now, the top two seeds in the league will meet once again as Peyton Manning and his Broncos' top-ranked offense in the league will face off against Pete Carroll, Russell Wilson and the number one defense in the league as they lock horns on February 2 in New York. Seattle's victory didn't come easily, however. Before last Sunday, many believed that San Francisco, winners of eight straight going into the game, was the best team in the entire league. travel teams or individuals looking to be seen. There is a cost, and in many cases a huge bill, for families going to these tournaments. The price can be even higher if the showcase is for individuals competing.

There's also the burnout or potential injury factor when playing on a travel team. Some players compete on a number of teams during the week. For some sports such as basketball, volleyball or soccer, it may not have the impact that it does for a baseball or softball player. The reason simply is that baseball pitchers, and to a degree softball pitchers, have so many pitches they can throw in a week. Add to that the repetition of just throwing a ball and it can be tough on a young athlete's arm. It can lead to potential arm troubles and even surgery.

Two former Major League Baseball players had their own views of current travel ball teams, especially when it came to baseball. Hall of Fame second baseman Joe Morgan and 10-year veteran Don Buford were in town for a baseball gala event honoring Major League Baseball scouts at the Professional Baseball Scouts Foundation dinner held at the Hyatt Regency Century Plaza. Both Morgan and Buford were not your typical players that scouts were looking for since neither one was much taller than 5'7" and 160 pounds. Morgan said that he fought through adversity because of his stature. He says that travel ball teams have their place, but he doesn't believe that its the only place to be evaluated. "It's good in the sense that young ball players are competing against others trying to be better," he said. "You just need to play and the good ones will stand out at any level of competition."

Buford, who was elected to the USC Hall of Fame and the Baltimore Orioles Hall of Fame, is currently working with MLB's Urban Youth Academy. His views on travel ball somewhat mirrors his friend Joe Morgan's. "There's something to be said for bettering yourself, but at what cost?" he asked.

Buford noted that if he'd been given the

opportunity to play for a travel ball team growing up in Texas, he would have passed. He said that it comes down to priorities in life. If it meant not playing in a league with the guys he was close to and grew up with, it just wasn't for him. He added that parents these days are living vicariously through their sons and he has seen it first-hand at the Urban Academy. Buford also pointed out that even if a travel team had been available when his son was growing up, he wouldn't have allowed the youngster to play. His son Damon played nine years in the Big Leagues. "I would have wanted him to play with his friends to make them better," Buford said.

Former El Segundo great George Brett has said that if you're good enough, someone will notice you whether you're playing on a travel team or not. "Someone's going to discover you if you're good enough--itt doesn't matter where you play," said Brett.

A glaring example of this is when former El Segundo High School basketball great Joe make sure they pack any necessary medications. Make lists and start packing early to eliminate the last-minute rush.

If you're driving, make sure the car gets a tune-up before you leave. If you're meeting up with the grandparents to use their RV, remind them to have any necessary maintenance done before you arrive. Properly winterizing and preparing RVs, boats and other vehicles is important for a headache-free multigenerational trip ... and just good sense overall. Check with your insurance company to see if towing is covered under your plan in case the need ever arises.

5. Cherish Meal Time

"In many families, mealtime is when everyone comes together to share their days and reconnect," says Henning. "On a trip, this can be at a restaurant, picnic at the beach, or from the comforts of a vacation home. Stewart starred on arguably one of the school's most challenging teams. The Eagles went 0-22 in 1978, but Stewart averaged 29 points per game. He was named to the All-South Bay first team and was selected to the All- CIF-SS 'A' first team. He went on to play for a four-year college.

Finally, Phil Pote has been a Major League Baseball scout for over 50 years and was also honored at the Professional Baseball Scouts Dinner. He said he'd attend a showcase event where the players would be invited based on their geographical area. Most of these players were invited because of word of mouth and being seen by someone who thought they had talent.

So if you're still asking whether to play for a travel team or not, it comes down to what life lessons you're helping to teach your young athlete. Each former player did say the odds of getting signed to a professional contract are thin at best. To get to the Big Leagues are even weaker.

Hubble Peeks Through a Gravitational Lens

This image of Abell 2744 is the first to come from Hubble's Frontier Fields observing program, which is using the magnifying power of enormous galaxy clusters to peer deep into the distant Universe. Abell 2744, nicknamed Pandora's Cluster, is thought to have a very violent history, having formed from a cosmic pile-up of multiple galaxy clusters.

Astronomers previously observed Abell 2744 with the NASA/ESA Hubble Space Telescope back in 2011, exploring the cluster's history. They found that at least four galaxy clusters had crashed into one another to form Abell 2744, causing some weird and wonderful effects. This mix of cosmic phenomena, some of which had never been seen before, led to the nickname of Pandora's Cluster (http://www.spacetelescope.org/news/heic1111).

A mix of hazy elliptical galaxies and colorful spirals can be seen clumping together in the

center of this image. The effects of the cluster's gravity can be seen in the blue arcs and distorted shapes that are scattered across the frame, including galaxies that seem to be bleeding into the surrounding space. The arcs are actually the distorted images of galaxies far in the distance.

Abell 2744 is the first of six targets for an observing program known as Frontier Fields. This three-year, 840-orbit program will yield our deepest views of the universe to date, using the power of Hubble to explore more distant regions of space than could otherwise be seen, by observing gravitational lensing effects around six different galaxy clusters.

Gravitational lensing is a phenomenon caused by an object's influence on the space-time around it. All objects that have mass affect the space around them in this way, but huge clumps of mass like galaxy clusters do so more strongly. This causes light from more

distant objects hidden behind this makeshift "lens" to be deflected and bent, leading to a bizarre array of optical effects-for example, by creating mirror images of one galaxy, as well as smearing galaxies out into arcs, and creating multiple images of individual objects. This effect is one of the predictions of Albert Einstein's general theory of relativity.

Although Orest Chwolson (1924) and Frantisek Klin (1936) are sometimes credited as being the first ones to discuss this effect in print, it is more commonly associated with Einstein, who published a famous article on the subject in 1936. Swiss astronomer Fritz Zwicky, who worked at Mount Wilson Observatory, followed this up by suggesting in 1937 that the effect could allow galaxy clusters to act as gravitational lenses. It was not until 1979 that this effect was actually confirmed by observation.

As well as creating weird shapes, gravita-

tional lensing also magnifies the images so that astronomers can see more detail. This means that distant objects that otherwise would be too distant and faint to be seen become visible-something that the Frontier Fields program aims to exploit over the coming years.

Some results from this program are already starting to emerge, with Abell 2744 as the first target. In a paper submitted to The Astrophysical Journal last November, a group of astronomers detected a large number of distant, gravitationally lensed galaxy candidates-all viewed through Abell 2744. These deep surveys using massive galaxy clusters show that looking through cosmic lenses can be an effective and useful way to study the distant Universe.


