## Houston Joins West Basin Board, Hopes to Raise Awareness on Water Issues

There are very few things in life one truly cannot live without, but water definitely makes the shortlist. It is also something most people take for granted, with its instant and seemingly endless availability at the simple turn of a tap. But in California, a lengthy drought and other factors continue to threaten the future of this most precious resource. Engaging citizens about this issue is foremost in the mind of local resident Scott Houston, who this past November won a seat on the West Basin Municipal Water District IV Board of Directors. In addition to El Segundo, Houston also represents Culver City, Malibu, West Hollywood, Lennox, North Ladera Heights, Del Aire, Topanga, View Park and Windsor Hills.

West Basin provides drinking and recycled water to nearly one million people in 17 cities within a 185-square mile service area. It purchases water from the Metropolitan Water District of Southern California (MWD) and then wholesales the imported water to cities and private companies in southwest Los Angeles County. As part of this chain the City of El Segundo buys its water from West Basin, conveys it through its own water distribution system and then sends bills to residential and commercial property owners.

The West Basin Board sets policies for the District and develops a strategic plan to guide day-to-day planning and activities. Its mission includes a commitment to maintain high water quality; provide excellent customer service and active outreach to its 17 cities, eight retail water providers and many recycled water customers; and foster innovative planning and investments in water supply reliability and drought protection. "This position is important to raise public awareness of our water challenges, locally and regionally, while educating people on what they can do to help conserve water," Houston said. "West Basin's water recycling program hugely benefits the City of El Segundo, as approximately 50 percent of the City's water

use is recycled water—helping save millions of gallons of our drinking water."

An El Segundo resident for 14 years and also a current board member of Tree Musketeers, Houston noted that a prior four-year stint on the City's Capital Improvement Program Advisory Committee (CIPAC) spurred an interest in infrastructure issues that escalated after a tour of West Basin's local water recycling facility while attending the agency's Water 101 course. "I was fascinated by the recycled water production taking place right here in our backyard," he said. "I began studying our state and local water issues and also traveled to the Sacramento Delta and the Colorado River to see firsthand the infrastructure and conveyance systems that supply water to the region." These experiences—along with his political connections and a

useful professional background in business management, communications and manufacturing—prompted him to run for the District IV seat upon the retirement last May of long-time Director Ed Little (who passed away in August). Houston captured just over 45 percent of the vote, outlasting two other candidates.

"As a resident involved in our community for a number of years, I have relationships with our elected leaders and City staff that I know will be beneficial to my service on the Board," Houston said. "Because El Segundo is one of West Basin's largest water customers and our water recycling plant is located here in town, our agency is in contact and working with the City on a continual basis. As part of our ongoing outreach here, representatives

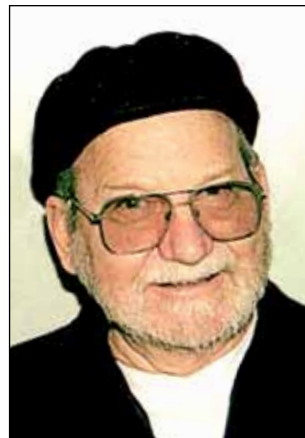

of the Center Street marquee. The vintage marquee at the front entrance to the school had become outdated with the influx of new technology. Monahan asked retired teacher Janet Reed, who taught for more than two decades at Center Street, to "spruce it up for us." Reed presented Monahan with what the principal termed "an amazing concept for a stained/glass mosaic with the image of a cougar cub under "Center Street School."

Said Monahan: "This work of art will beautify the entrance of our school for years to come as the playful, inquisitive cougar welcomes families to Center Street."

The final special presentation was made by Ed! Foundation CEO Carol Pirsztuk, who gave her monthly update on upcoming Ed! Foundation events, including the 2nd Annual

Guys Night Out, which will take place on Friday, March 6th, at Beach City Baseball; the Foundations 4th annual gala, set for Friday, May 15th on the grounds at Chevron Park; and the beginning of the Foundation's summer academy, which will run this year from June 15th thru July 17th.

The consent agenda portion of the more than two-hour meeting included the board consenting to three school assemblies, and two field trips.

The field trips will take place in late April. Students from the High School AVID program will travel south to take their yearly tour of college campuses to educate the students on possible options in pursuing their academic career, post-graduation. Five campuses, UC

of the District are communicating often with City officials and community organizations to discuss key water issues. I am committed to maintaining and further building upon West Basin's partnership with the City of El Segundo."

Looking at the most significant challenges facing not only West Basin but the region as a whole, Houston pointed to the fact that California is now in its fourth consecutive drought year—with over 80 percent of the state suffering from exceptional drought compounded by record-high temperatures. Additionally, the past year's snowpack was sparse and reservoir levels remain at an all-time low. "We can't stress enough how important it is to use only the water that you need," Houston said. "But even if the drought ends, our future water supplies will be continually challenged by a growing population, climate change and the need to provide more water to restore the environment."

To drive the message home, West Basin's Board early last year adopted a resolution declaring a drought alert. This came on the heels of Governor Brown's January 2014 Emergency Drought Declaration and stated goal to achieve a 20 percent water use reduction. "While West Basin is not imposing any water restrictions, the drought alert directs the District's 17 cities, unincorporated county areas and retail customer agencies to implement conservation measures to help extend and protect the water we have in storage that is used to meet the water needs in Southern California," Houston said. "We encourage residents and businesses in our service area to take advantage of the many free water efficiency programs we offer." Said programs include free rain barrels, weather-based irrigation controllers to help reduce water use, free landscape audits, and California Friendly Landscaping classes and rebates through the MWD (bewaterwise.com).

West Basin itself embarked on a Board-directed plan called Water Reliability 2020 to decrease the agency's dependence on imported water from the current 66 percent down to 33

percent in five years. The goal is to provide a more drought-proof and locally-controlled water supply to augment imported water. "Water Reliability 2020 will be accomplished by doubling the District's conservation and water recycling efforts and investigating the feasibility of adding ocean water desalination as a future water supply," Houston noted.

Even if conservation goals are met, don't expect the cost of water to go down anytime soon—or perhaps ever. "Unfortunately, water rates will continue to rise," Houston warned. "Water rates are driven by the increasing cost of labor, increasing cost of chemicals to clean the water, funds to maintain water systems—which in some cases the water systems can be quite old... Also new water supplies and systems to accommodate population growth, higher water quality requirements and the need to clean up contaminated water. Most of the causes of the increase in water rates are beyond local control." Elaborating further on these costs, Houston added that the City of El Segundo has already incurred the water rate increases. "The proposed rate increases for the next five years are simply pass-through costs that, even if protested by a majority of water customers in town, will still be paid for by the City regardless. So, protesting the rate increases will only shortchange the City of monies that could be used for other valuable services in our community."

To combat rising costs and reduce expenditures, Houston urged citizens to become more efficient with the water that is available by investing in low water use appliances, converting parts of lawns to California native gardens, only washing full loads of dishes and laundry, taking shorter showers, bringing cars to water recycling car washes, and turning off the water when brushing teeth or shaving. "A family in the United States uses about twice as much water as the average family in Europe," Houston said. "A different mindset is critical and I hope to get the message across." •

### The Other Side of the Coin

The line . . . the long line begins here at the figurative entry to America, and extends as far as the horizon and beyond. That line is comprised of people from all over the world, every ethnicity, every religion, every age and sex. They all stand patiently in line hoping for a chance to immigrate and participate in the greatest experiment in human freedom the world has ever known.

Their frustration, however, is that the line moves so slowly that many die before their turn for legal immigration comes, and that people who have ignored the law and cut into line are receiving the opportunities and benefits those in line are being denied. With faith that America will ultimately come to its senses and enforce its own laws, they hope their turn will come.

But what are those laws intended to do? We are, first, a nation of immigrants, so immigration is welcome. But as an established nation with its own customs and way of life, it needs to control the immigration process to prevent criminal elements and enemies of the state from entering. It needs to admit immigrants who wish to integrate into the mores and culture of this society, and to do so in numbers that do not destroy the foundation on which this nation was founded; because to do otherwise is to destroy the very basis for immigration.

The people in line must be astounded to find we do not enforce our laws. Millions of people refuse to wait in line, and simply crash through a weak border in

uncontrolled numbers. Few are deported. Many do not integrate into our society, but seek to superimpose on us the language and culture they had supposedly left behind. Newspapers, radio/TV shows, supermarket signs, voice mail systems, and voting ballots all evidence that superimposition. The children of the gatecrashers are rewarded with lower in-state tuition to universities. Crashers are rewarded with driver's licenses on the assumption they'd drive without a license anyway. Many illegal immigrants do not appear for scheduled immigration hearings and simply disappear into the system. Many receive Food Stamps and other social benefits, including Medicaid, welfare, and Social Security. Some work in the underground economy, paying no income taxes. Our government's justification for rewarding lawlessness is human compassion, but that reward comes at the expense of the law and at the expense of those waiting in the long line. If and when amnesty is approved and citizenship is granted ahead of those in line, it will be the ultimate betrayal of the rule of law.

Today, Americans find ourselves strangers in a strange land as our culture is changed by the sheer volume of uncontrolled immigration. Laws and its operational practices work in opposition to each other. All the while orderly applicants for residency and citizenship must wait in an endless line, their personal stories no more nor less compelling than the law breakers. To those in line, we can only offer our deepest apology. •

### Terrorists Attacks in Paris Should Give us More Resolve to Enjoy Life

Few times in my career as a reporter have I ever felt that my well-being was at risk. That isn't to say that I haven't engaged in activities that weren't dangerous, but few times did my fear levels rise. When the news of the tragic shooting at the Paris-based satirical magazine "Charlie Hebdo" made headlines, it was shocking, saddening and caused much reflection. Among the 12 victims murdered were 10 journalists, including the magazine's editor and two police officers. The attacks were the result of a well-calculated plan by criminals: well-trained terrorists who were determined to accomplish this massacre carried out these cowardice acts.

Despite the fact that these fellow journalists in Paris were killed in cold blood, I can honestly say that I am not afraid of ever losing my life while reporting. Granted I do not know where my career as a reporter will take me, death due to occupational hazard does not cross my mind. However, in this tragic moment for journalists around the world, I can't help but to also think about the two police officers that were murdered. Much like the officers killed in Brooklyn about a month ago, the two officers who were shot in the Bronx a few weeks later or the LAPD officers who were shot several nights before the New Year, the murdered officers in Paris left home that morning with plans to come home to their families.

Despite the daily risks that come with being a police officer, these men and women put on their uniform and go to work everyday just like you and I despite the dangers involved. There are thousands of people around the world who proudly entire

lifetime as law enforcement agents because it is their calling. Writing is my calling but unlike the men and women in uniform, I'm pretty sure that I would not be able to function properly if the daily danger in my profession equaled that of a peace officer. Yet, there have always been men and women willing to overlook these risks and work to make their city a safer place to live.

I love reporting as much as I enjoy writing and my writing skills keep me safe, tucked away behind a desk and in front of a computer. Interviews usually take place over coffee or in someone's office. That is worlds apart from the uncertainty that comes on a daily basis for police officers. So when I hear news of an officer of the law being attacked or murdered in the line of duty, it is heartbreaking. People become police officers because it is a calling; I know that there is no amount of money that would give me the courage to walk a beat or patrol a dangerous part of the city on a daily basis.

In the history of the written word thousands, if not millions, of people have been killed for what they have printed. Good or bad words and images have an impact on us all and in some cases, like what happened in Paris this, that impact can be deadly. Investigative reporters, war correspondents, crime beat writers are just some of the assignments that can get a reporter killed. 12 people were murdered because of the hateful and poisoned souls a few cowards armed with guns. So I pray for the victims, the families and every journalist and police officer working a beat; I pray for their safety and that we as a society have the courage to not succumb to terrorist. •

## Brown Rice Frittata with Bacon and Edamame



Makes 6-8 servings

### Ingredients

- 1 cup Minute(r) Brown Rice
- 4 thick cut bacon slices, cut into 1/2-inch pieces
- 4 scallions, thinly sliced (whites and greens divided)
- 1 cup frozen shelled edamame
- 6 eggs
- 3/4 cup sour cream, divided
- 1/2 teaspoon kosher salt

### Preparation

1. Prepare rice according to package directions.
2. While rice cooks, sauté bacon pieces in 10-inch ovenproof skillet over medium heat until starting to crisp, about 5 minutes. Drain off all but 1 tablespoon bacon fat, then add scallion whites and edamame (or if desired, use 1 cup frozen green peas) to the bacon in the pan and sauté 1 minute.
3. Add cooked rice, and sauté 1 minute. In a bowl, whisk together eggs, 1/2 cup sour cream and salt. Add egg mixture to pan, swirling gently to distribute mixture evenly throughout other ingredients. Cook undisturbed for 2-3 minutes, until edges look set. Then place pan in preheated oven until set in center, about 10 minutes.
4. Mix together scallion greens with remaining 1/4 cup sour cream. Serve frittata in wedges topped with a dollop of scallion cream. •

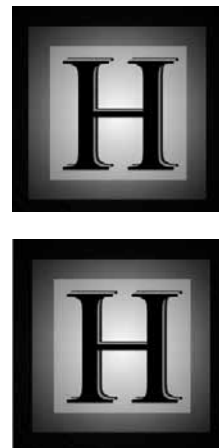

"I'll do everything I can to get ready to go to Seattle and play a great team," said Rogers. Certainly a tough task that awaits.

While the Packers remained unbeaten on the year at home this season (9-0 at Lambeau), the Seahawks will remain home after making quick work of Cam Newton and the Carolina Panthers to welcome in Aaron Rogers. No one wants to play in Seattle. The 12th man is precisely that. The Seahawks and quarterback Russell Wilson are 25-2 at home since he took over at quarterback for the team and 8-1 this season. In week one Marshawn Lynch had his way with Green Bay, rushing for 110 yards and two touchdowns as Rogers declined to pass in the direction of Richard Sherman all game long. If the Packers want to win, Rogers

will have to test the All-Pro cornerback this weekend in a game that will certainly feature two of the best all-around teams in the game.

There is obviously no telling who will win the championship games this weekend and advance to the Super Bowl, but the two games certainly look to be as exciting as the rest of this fantastic NFL season has been so far up to this point. All four teams are rolling at the right time and while journalists normally refrain from making predictions and simply dissect the action, I will take the road less traveled. Tom Brady will simply be too much for the Colts defense and Darrelle Revis and the Patriots secondary will have at least one big interception in a New England victory. Green Bay and Seattle will be a close one that comes down to the end. Ultimately, Marshawn Lynch will show why he is one of the greatest running backs in the league. The 12th man and that vaunted Seattle defense will also prove to be too much for an otherwise immobile Rogers as the Seahawks make it back to the dance for the second year in a row.
