City Council Updates Aquatics Facility Agreement with Wiseburn

During its first meeting of 2016, the El Segundo City Council authorized revisions to the settlement agreement with Wiseburn Unified School District regarding the joint use aquatics facility planned at the future Wiseburn High School site (201 N. Douglas Street). Among the provisions is a student enrollment cap increase from 1,200 to 1,600. In exchange for that concession, Wiseburn will now subsidize the annual aquatics facility equipment replacement reserve fund entirely—which could save El Segundo over \$1 million over 50 years, according to City Manager Greg Carpenter. The City will also commit up to \$1.8 million from its existing aquatics fund towards the facility construction cost, including an initial outlay of \$300,000 to fund the fee for design plans. Those monies won't technically be due until the State Architect approves and returns the plans. The City and Wiseburn will also seek outside funding to complete the project, currently estimated at \$10.6 million with Wiseburn committing \$6 million towards the total. Mayor Pro Tem Carl Jacobson indicated his desire to raise monies to replenish amounts taken from the aquatics fund so that the Urho Saari Swim Stadium (The Plunge) may be renovated.

The amended agreement also extends the deadline by which the facility must be completed, with the end of July 2018 the new date. However, Carpenter indicated it could be ready several months prior. With drafts

going to the State Architect as early as this week, plans could come back later this year in time to go to bid so construction can start in early 2017. The revised terms additionally include the "upgrade option" chosen by the Council last year, with a larger Olympic-size competition 54 x 25 meter pool, plus a four-lane shallow warm-up pool and other amenities to support major events and accommodate community needs.

Police Chief Mitch Tavera updated the community on the Active Shooter Program, which the department participates in cooperatively with other South Bay law enforcement agencies that will jointly respond in the event of any future occurrence. The presentation came in the wake of elevated concern about active shooter incidents such as last month's event in San Bernardino that left 14 dead and 22 others wounded.

Tavera explained that such incidents are unpredictable and evolve quickly. They involve one or more persons attempting to kill multiple individuals with no pattern or method as to choice of victims. Most incidents occur at "soft target" locations where there is limited security. In most cases the shooters commit suicide, are shot by police or eventually surrender if confrontation with law enforcement can't be avoided. The Chief warned that active shooting incidents are "no longer anomalies" and cited statistics that since 2011, events occur every 64 days compared to every 200 days prior. He added that "El Segundo is not immune" to such activity.

Tavera mentioned that local police officers have taken over 2,000 hours of training related to active shooter response, with 11 members of the department recently in refresher courses and annual classes continually scheduled. Over the past three years, the department made 24 presentations to businesses, schools and residents with plans for more in the future. Tavera also provided tips for people to be emotionally and physically prepared to deal with an active shooter situation—with the first option to run, find an escape route and leave belongings behind while keeping hands visible for police to see. If fleeing the scene is not possible, one should find a hiding place, block off entry and shut off cell phones or other noise-making devices. In lieu of the aforementioned options, Tavera told people to "fight" if their lives are in imminent danger and to do what they can to incapacitate the shooter in order to escape. He urged citizens to view an LA County Sheriff's Department video about surviving an active shooter (via the Police Department's website or at activeshooter.lasd.org).

Responding to residents who expressed concerns to her about rising crime in the community, Councilmember Marie Fellhauer asked Tavera about the Police Department's plan of action to address the matter. The Chief confirmed a further reduction in sworn personnel after a couple of officers recently left the department. He said he will have to pull some officers from special operations

Two El Segundo Schools Put on Lock Down

As we sat in Honors English at El Segundo High School reviewing vocabulary with Ms. Gerber Tuesday, the school was put on "Shelter in Place," also known as lock down. We didn't know why the lockdown was issued but we all knew immediately what to do. Follow instructions precisely. Images of Columbine, Sandy Hook and San Bernardino flittered through my already active imagination. After 10 minutes, we were released. When I walked home my Mom hugged me tight, relieved that a tragedy did not take place.

The lock down involved El Segundo High School (9-12) and Richmond Street School (K-5). The impetus of the lockdown was

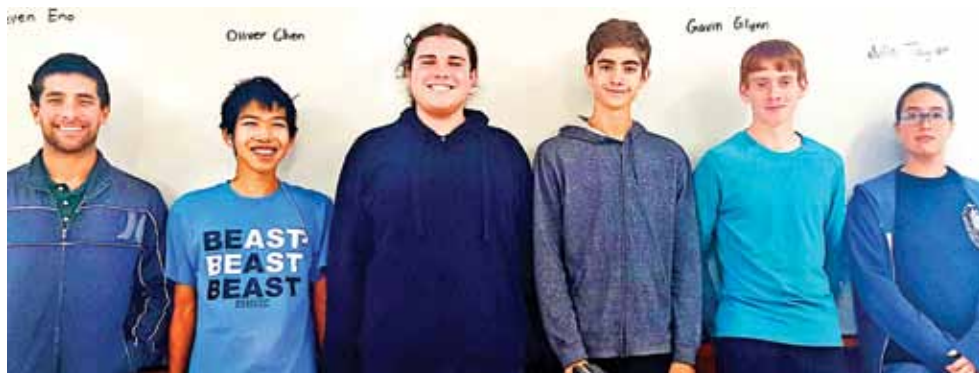
when El Segundo police officers responded to the 300 block of West Palm Avenue around 11:20 a.m. in pursuit of three burglars. A "Shelter in Place" was issued at El Segundo High School and Richmond Street School as the Police Department searched for the armed burglars that were believed to be in the vicinity. Officers apprehended two burglary suspects and were in pursuit of the third. The initial lockdown was lifted after 10 minutes, but was reactivated at 12:10 p.m. when more police activity related ensued. The second lockdown lasted 10 minutes.

During the lockdown, students were to remain in class until it could be confirmed the schools were no longer in danger. The lock down was

ESHS Engineering Invited to Hyperloop Competition

A team from the El Segundo High School Engineering Pathway Senior Capstone class has jumped into a nationwide competition to design a pod for the new Hyperloop transportation system. The Hyperloop, a high-speed ground transport concept first proposed by SpaceX and Tesla Motors co-founder Elon Musk in 2013, has the potential to revolutionize modern transportation. The team, called the HyperEagles, consisting of Oliver Chen, Gavin Glynn, Henry Smith, Luke St. Regis, and Julia Taylor entered the competition as

their Senior project. After reviewing the designs the competition has invited the team to attend the final design weekend on January 28-31 at Texas A and M.

More than 100 university teams from around the world will present their design concepts to a panel of judges on how to transform the Hyperloop from bold vision to reality. Top teams will move on to build their pods and test them at the world's first Hyperloop Test Track being built adjacent to Space X's Hawthorne, California, headquarters in June 2016. •

Going Back to Cali

If you had to start all over from scratch and pick an NFL team to root for, which would it be? For the first time in two decades, that decision will be made just a bit easier. The St. Louis Rams will move back to Los Angeles for the 2016 season, ending a 20 year drought of football in one of the biggest markets in America. Naturally, this doesn't mean that you have to become a Rams fan, but for the first time in a long time, the opportunity is there to get in your car, drive down the freeway, and tailgate outside of what will be one of the most immaculate NFL stadiums in the league come its completion in what is scheduled for 2019. After more than 30 months of deliberation, teasing, and over-thinking things, the league's owners voted 30-2 to send the Rams back to California. Ultimately, it was Stank Kroenke and his plan for a \$1.86 billion stadium in Inglewood that paved the way.

"It's been a long road, but we made it," the billionaire Kroenke said at his and the new teams press conference at the Great Western Forum last Friday afternoon. "We're happy to be here. It's quite a privilege. We're looking forward to moving ahead on this. Coming in here and being received like this is wonderful." The press conference turned into a boisterous rally near the site of the team's future home in Inglewood, where Kroenke was serenaded by chants of, "We love Stan." Meanwhile, in St. Louis, they were burning jerseys and taking down banners at the 'old' Edward Jones Dome. Kroenke is only looking forward now, though. The 300-acre development that he smartly bought years ago at the former site of Hollywood Park will not only fatten Kroenke's pockets even more so, but will also give football fans in Los Angeles a one of a kind experience not available to most other fans across the nation.

"We're going to bring Super Bowls here," Kroenke told the media at his press conference turned rally. "We're going to bring events like the Final Four. The Final Four hasn't been here in decades. They've already talked to us." Naturally, the location will be featured as a football stadium, but may just surpass the Staples Center as the premier venue in Southern California. Buy your land in Inglewood now while you still can. Kroenke's new stadium will seat 70,000 people with the ability to expand and sit 80,000. While the stadium is being built, the Rams will play in the L.A. Coliseum. The mayor of Inglewood, James Butts, has said that he has already written a letter to NFL commissioner Roger Goodell requesting the presently unnamed stadium in Inglewood be home to Super Bowl LV in February 2021.

So, will the Rams be the only team coming

to Los Angeles anytime in the near future? That fact is still unknown, but the San Diego Chargers have the option to move to Los Angeles and share the stadium with the Rams. Chargers owner Dean Spanos certainly doesn't like the idea of sharing and wants to put his own stamp on the L.A. area. Unfortunately for him, he didn't have the money or the smarts of Kroenke to plan ahead. Now, if he brings the Chargers to L.A., it will be as almost a little brother to Kroenke and the Rams. The Chargers have until March of this year to decide on a move if they want to join the Rams for the 2016 season and until next January, at the latest, to make a decision to come to L.A. at all. Should they decline and stay in San Diego, the NFL will give the organization \$100 million to build a new stadium. While the idea of a Carson stadium is dead and there will certainly not be three teams in L.A., the Raiders also still have a shot at moving to Inglewood. If the Chargers choose to stay in San Diego and the city gives them a new stadium, the Raiders will then have the option of joining Kroenke and the Rams in Inglewood. It seems to be the wish of Raiders owner Mark Davis to stay in Oakland, building a new stadium there (also with \$100 million from the NFL), but the city of Oakland doesn't seem to be keen on the idea of shelling out the money that it would take to do so.

Rams head coach and ex USC player, Jeff Fisher, seemed to have mixed feelings about the move. "We're leaving a great fan base," he said. "We're leaving some people who are very, very disappointed. I personally want to thank those people, the St. Louis Rams fans, who got to watch them win a Super Bowl." It's always hard saying goodbye, but what can be better than moving to bright, sunny Southern California? A location that will inherit a team that is seemingly on the rise. With one of the best defenses in the league, the Rams also feature star running back Todd Gurley and speedster Tavon Austin on offense. If they go out and get a quarterback, Los Angeles could be looking into buying playoff tickets at the Coliseum in the team's first year of inception.

It's hard to believe, but as this NFL season quickly comes to its completion, the anticipation for next season has already begun. In less than one year, fans from around all of Los Angeles will have the ability to root for and see a hometown team in person for the first time in 20 years. Distant memories of the old Rams and Raiders teams that played here in the past are either dim in your mind or completely non-existent to begin with. Kroenke and his new Los Angeles Rams are moving out to Los Angeles to enliven those memories and give us all the opportunity to root for a hometown football team once again. •

Lady Eagles Flying High after Historical Win

It's not often that an El Segundo high school team is involved in a historical win. You have to go back to last softball season when the Eagles defeated Orange Lutheran 4-3 in the Pioneer Valley Best of the West Tournament in Santa Maria. Orange Lutheran was undefeated and the eighth ranked team in the nation at the time. Or you could go back to the baseball team's 7-1 win over Beverly Hills on March 3, 2007 that gave head coach John Stevenson his 1000th career win.

Fast forward to the present when the Lady Eagles basketball team defeated Culver City 55-46 in a key Ocean League game. It marked the first time in 42 consecutive Ocean League games that the Centaurs had lost a game dating back to February 10, 2011, when they lost to Beverly Hills 45-37. Most if not all of the Eagle's roster were aware of the long streak and playing in front of a large home crowd they were eager to be the ones to halt it.

If this were a movie you could easily queue up the theme from, 'The Natural' and get the feeling that this was to be a special night. El Segundo's defense helped set the tone early on and their intensity only solidified their desire. But that isn't something new according to head coach Randy Kiehm who said the players have played at a different level this season.

The Centaurs had a size advantage and presence inside but they rely on their outside shooting to demoralize teams. Against the Eagles they made their first 3-point shot attempt by Amy Yoon but for the game they made just 5 of 25 attempts. It was the defensive pressure by Paige Endo, Hannah Nonoguchi and Makaela Bordieri outside and the inside play of Quinn Adams and Ani Finau that caused the Centaurs to shoot less than thirty percent from the field on the night.

It's been said that big time players play big in big-time games and that adage was certainly true for the Eagle's Paige Endo. Not only did one of the South Bay's most gifted players score eight of the team's 12 first quarter points but her defensive efforts even drew raves from the opposition.

El Segundo's 12-7 lead after the first quarter edged higher but the Centaurs' Kaily Tooke made consecutive 3-pointers to close the gap. EL Segundo responded with a highlight no-look pass from Endo to Ani Finau for a reverse layup just before halftime and a 23-19 lead.

El Segundo's ploy of slowing the game down and getting an open shot while taking Culver City out of their rhythmic game plan seemed to work. If the Eagles could complete their mission in the season they could get the

upset they'd been longing for.

Midway through the third quarter when the game was close Melissa Euyoque came up with the defensive play or plays of the game. She blocked consecutive shot attempts one by the Centaurs' Wendy Yoon and the other by Angel Morris. It turned into a three point play on the other end by Bordieri to give the Eagles a 35-31 lead.

The Centaurs wouldn't go away and tied the game at 36-36 early in the fourth period. The Eagles wouldn't blink and the intensity picked up on both ends. Endo's two free throws gave her team a four point lead. Finau then took a long pass after a steal from Endo to up the lead. One possession later after another steal by Endo and she found Finau open for an easy layup and a 46-38 lead. Quinn Adams kept the margin wide by sinking two free throws in the stretch and hitting a short range jumper later on.

El Segundo kept the pressure on and the Centaurs couldn't make up the nine point deficit and the Eagles came away with the win. Endo led all scorers with 26 points and nine assists while Finau had 12 points and nine rebounds while Quinn Adams had six points and 11 rebounds.

With the victory it set up a key Ocean League game against Hawthorne last night. The Eagles travel to Lawndale Friday night before hosting Santa Monica next Wednesday night and Beverly Hills next Friday night; both games are set for 6pm tip-offs.

The boys' basketball team defeated Culver City 70-47 in an Ocean League game. The Eagles used a smothering defense while providing an up-tempo offense to help take down the Centaurs.

The defensive inspired Eagles leaned on Josh Hessing on offense to take a 11-8 after the senior guard connected on back to back buckets and Justin Ostler made a 3-pointer to give their team a 14-10 lead. El Segundo ended the first quarter on a 6-1 run and led 20-11.

The Centaurs had their opportunities especially inside where they dominated the offensive boards but came away empty on most possessions. Hessing gave the Eagles a 15 point lead with four minutes remaining in the half. Eli Chaney free throw gave the Eagles their largest lead of the first half, a 41-23 advantage.

In the second half the Eagles slowed down the pace and the lead kept creeping up. Mike Lynch's jumper extended the lead to 51-30 and the Centaurs attempt at a comeback withered.

Hessing led all scorers with 16 points while Chase Ali-Watkins had 15 points. The free throw shooting by the Eagles has improved vastly over the season. Against Culver City

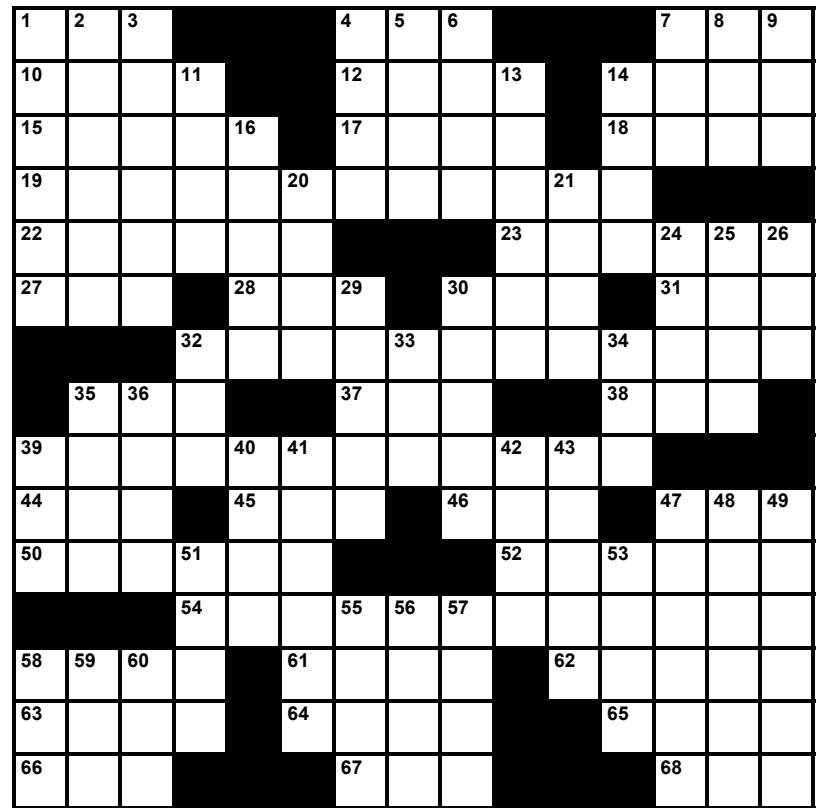

Classic characters from perhaps the greatest literary work of American literature, Huck-leberrry Finn and Tom Sawyer, have hit the big screen in a re-imagining that takes their mischievously-intentioned selves, keeps a driving plot about finding a mythic treasure and leaves the rest behind - to good-spirited, well-earned fun in the new film, *Band of Robbers*. This timeless twosome, trouble-making in their never-ending pursuit of adventure and hero-seeking recognition and glory, are leveraged here as modern-day treasure seekers that unite with their trusted merry men in hatching a plan of finding buried treasure. The fun that is had here is in feeling the familiarity of these good ol' boys that live so canonically in culture and giving them the slick young people's comedic treatment, working off a fine-tuned script and the work of a stellar cast makes for a worthwhile, enjoyable time.

It should be stated early there's not a whole lot that *Robbers*, truly, lifts from Mark Twain's classic novel or characters other than using the

self-affirmed misfit pirate pals

There's a streak of folksy, whimsy appeal here, which, with the feeling of it being a home-grown indie effort of true charm (along with its premise of a tight-knit group of friends on a headstrong crime spree of a less-than-thought-out scheme), most closely resembles Wes Anderson's winning feature debut, *Bottle Rocket* (1996). The difference is that it's entirely obvious that everyone here is looking to make themselves into a goofball for a good time and audiences should find themselves laughing at the number of jokes offered here. When Tom wrangles "the band" back together after Huck's first day out of the clink (for an unspecified, non-violent crime) and reveals a plan to steal the fabled Murrell's treasure, right off the bat

and deploy them to patrol. Tavera added that the department is "actively recruiting" new officers, but that the process takes 18 months to two years.

While not at liberty to comment about ongoing union negotiations and how that might impact morale and/or people potentially leaving for other departments, Fellhauer emphasized "it doesn't change the fact that they're [police officers] still doing their job when they're here. Our cops are amazing here in El Segundo." She attributed much of the crime increase to the AB109 and Prop 47 legislation that have put more criminals on the streets. Mayor Suzanne Fuentes added that the Council approved the hiring of three new officers during the summer strategic planning sessions. "As Councilmembers, we live here too—we all have the same concerns," she said.

The community will have to wait longer than usual to find out whom the Council members will select as the next Mayor and Mayor Pro Tem. Thanks to a state legislative change, those who vote by mail will now have up to eight days after the April 12 election to sign their ballot (or turn in an unsigned ballot statement) to the City Clerk's office if they neglected to do so initially. That means the City Clerk won't be able to officially certify the final results in time for the Council meeting that takes place one week after election—the date the Mayor and Mayor Pro Tem must be chosen, according to local municipal code. The Council will now have up to four weeks to make the selections in the future and will do so this year during the May 3 meeting. As a result, the current Council will preside over

the April 19 meeting with any new members waiting an extra two weeks to be sworn in.

On another election-related matter, the Council approved a language change on the ballot with updated instructions to vote for "no more than three" candidates for City Council. The amended text clarifies the fact that voters at their discretion can opt for anywhere from zero to three candidates.

Also on Tuesday, the Council approved a contract with Sierra School Equipment Company to refinish the seating in the Council Chambers and to install new carpeting—a project deferred for many years. Work will be done when the Council is not in session between March 16 and April 4. After that time, the Council will determine whether or not to paint the existing interior brick or drywall over it.

At the beginning of the meeting, the Council recognized the winning entries from last month's 52nd Annual Holiday Parade. On behalf of the El Segundo Chamber of Commerce, Parade Committee member Linda Johnson handed out trophies to Knights of Columbus (Grand Marshal's Award), El Segundo Women's Club (Best Use of Theme), El Segundo Recreation and Parks (Best Holiday Spirit-Children), Rotary Club of El Segundo (Best Holiday Spirit-Adult), El Segundo Youth Cheerleaders (Best Performers-Children), South Bay Coastliners (Best Performers-Adult), El Segundo Elementary Band (Best Musical Band-Elementary), Jane Addams Middle School "Mighty Marching Bengals" (Best Musical Band-Middle School), and El Segundo High School Band and Color Guard (Best Musical Band-High School). •

his monologuing is met with raised eyebrows and wry confusions, setting up the level of competency of all involved. The pact is legitimized by – you guessed it – a blood oath (though they compromise in not spilling any actual blood, in this secret meeting at Tommy Barnes' poker table in his "man cave"). The faces and talents enlisted here are truly where the comedy shines. It has the taste of *21 Jump Street* comic-firing and timing of every-line-a-joke (and mostly bulls eye's at that), uses some familiar faces and some not-so, in playing a winning hand. Kyle Gallner as Huck is a Jeremy Renner meets Rick Grimes a la *The Walking Dead*, where Adam Nee as Tom is as much as stand-out in a role that he knows so well. The geek-beloved Matthew Gray Gubler as Joe Harper, along with Hannibal Burress as Ben Rogers add a deep bench to the effort, with Burress (and "Greg...Knife") nailing every one of his scenes. Melissa Benoist and

Eric Christian Olsen also star as little-used Becky Thatcher, Tom's new partner on the day of the planned heist and Sid Sawyer, beloved detective who plays it maybe a bit too straight. Written and directed by brother filmmaking team Aaron and Adam Nee, *Robbers* went through many years of development (including an idea of it being a TV show) before finally having its world premiere at the LA Film Festival in 2015. One wonders what following that version of Huck, Tom, and company may have been like, and what many adventures they may have spun in and out of in sit-com fashion. But its final format of a ninety-five-minute feature film feels like the best use of its talent, sparing any over-indulgence in what could have flopped as a gimmick and succeeds as a send-up that breathes fresh life into an American classic. *Band of Robbers* is now playing at the Laemmle Playhouse 7 and On Demand. •

Spicy Chipotle Hummus Pasta

Prep time: 40 minutes
Cook time: 10 minutes
Serves: 6

Ingredients

- 1 pound penne pasta
- 1 teaspoon paprika
- 1/2 teaspoon oregano
- 1/2 teaspoon thyme
- 1/4 teaspoon kosher salt
- 1 pound boneless, skinless chicken breasts
- 2 tablespoons olive oil
- 2 garlic cloves, minced
- 1/2 onion (about 1 cup), diced
- 1 red bell pepper, diced
- 1/2 cup chicken stock
- 1 package Sabra Spicy Chipotle Hummus
- 1 bunch Swiss chard (about 6 cups), chopped

Preparation

1. Bring large pot of water to a boil. Cook pasta according to package directions. Drain. Meanwhile in small bowl, mix paprika, oregano, thyme and salt. Rub spice mixture over chicken breasts.
2. In large saute pan, heat olive oil over medium-high heat. Add chicken and cook 5-8 minutes per side, or until cooked through. Remove from heat and cut into bite-sized pieces.
3. Turn burner to low and return pan to stove. Sweat garlic and onions for 5 minutes, or until softened. Turn heat to medium and add red bell pepper. Cook for another 5 minutes, or until soft. Slowly stir in chicken stock and hummus to form a creamy sauce. Add Swiss chard. Cover and cook until wilted, 2-3 minutes. Stir in drained pasta and cooked chicken.

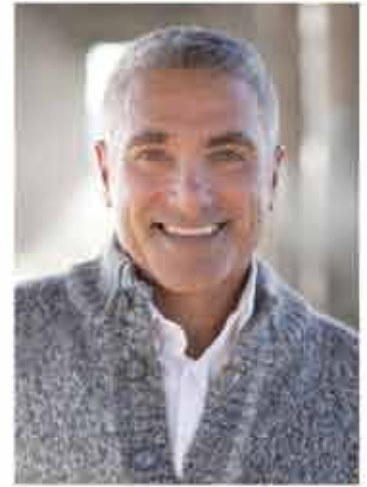
