## Bryan Grijalva Heals the Spirit

"We have three bodies," says Bryan Grijalva, a healer located in El Segundo. The bodies he describes are the physical, the emotional, and the spiritual. Bryan, in particular, works to heal and strengthen the spiritual body.

"Think of an apple. When you see an apple, the skin is the physical body. You can see bruises, abrasions, broken arms, bleeding," he says. The physical body is most often attributed to western medicine, able to be treated in hospitals by medical doctors. "When we look a little bit deeper into the apple, the meat of it, that's the emotional body." This body is best served by psychologists, psychiatrists, and therapists. Emotional trauma may be healed through these methods or fortified. "But then, there's the issue of the spiritual body, which would be like the seeds of the apple... that's where I specialize," says Grijalva. Your spiritual body, as he describes it, can have blockages that can manifest in mental or physical health issues. His job is to find those blockages and help facilitate healing from the innermost body.

How can these three bodies coexist, or can they? Grijalva says absolutely. "It's never 'in lieu of,' it's always 'in conjunction with," he says, positing that spiritual healing is just the third piece of effective healing. According to him, the connection between the three (physical health, mental health, and spiritual health) is important and can produce some amazing changes.

Grijalva himself is certified and practices over two dozen healing modalities. This ranges from simply talking to a client, to analyzing chakra charts, to exercising reiki to free up blockages and increase chi flow.

Grijalva explains that we all have an essence of energy and life that flows through all of our bodies for those who don't know

what any of that means. This is the chi flow. Sometimes we have traumas, physical, emotional, or spiritual, resulting in illnesses, struggles, or just generally feeling "off." Chakras, he explains, are essentially different energy centers in your body that correlate to certain nerve bundles and organs. Healthy chakras are open and balanced. Reiki is a type of massage in which the massage therapist doesn't actually touch the client, but channels energy through themselves and into the client. Clients report feeling warm or sometimes slight pressure when undergoing energy healing.

Despite his passion and experience, Grijalva was not always a spiritual healer. "I actually used to own an auto shop, and I was quite

## **Babe Ruth League Icons Honored**



The El Segundo Babe Ruth League has just completed its 66th season. In that time, the league has won five World Series championships and finished second or third two other times. The league, which is strictly filled with volunteers, has had several league presidents and coaches in those 66 years. Two volunteers have stood the test of time which started in 1979. Bob Motta and his late wife Kathy were honored in a dedication ceremony to name the score booth above the snack bar at Stevenson Field, the Bob and Kathy Motta Score Booth. Bob has been the league president 13 times and has served on the board in some capacity 14 other times. Bob was also honored with the Lefty Gomez Babe Ruth League Volunteer of the Year.

a feeder league to the high school and his selfless dedication to maintaining the infield at the high school. "I would ask Bob what was needed to maintain the infield." On any given weekend, you'd find Bob cutting the grass or watering the infield, and he did it because of his passion for giving back.

Bob's first love affair was with his wife, Kathy. "She had me at hello when we met in 1973 at her brother's birthday." They would be married over forty years and raise two children Rebecca and Ray.

Bob's second love affair was his passion for coaching baseball and to the youth of our community. As the story goes, Bob's brother Mark wasn't selected as a 13-yearold for one of the Babe Ruth League teams in 1979. At the time, there were no prep

Those in attendance to honor Bob included Mayor Drew Boyles and former Mayor Bill Fisher. Bob's family and Senior VP/National Commissioner of Babe Ruth League, Robert Faherty Jr. Players from the five World Series championship teams and the six teams from this season were all on the infield as Bob, his family, speakers and dignitaries sat in front of the pitcher's mound.

Lee Davis introduced Bob to the audience and what he's meant to the Recreation and Park's Commission. Bob is going into his fifth term on the commission. Mr. Faherty told the audience of Bob's selfless dedication to Babe Ruth League baseball and why he was honored with a national award from Babe Ruth League Inc. Dave Lubs had the honor of emotionally telling the community about Bob and Kathy's life story. El Segundo High School's athletic director Steve Shevlin praised Bob for his work with youth baseball and what it has meant to the continued success of all high school sports.

Craig Cousins, a member of the 1964 World Series championship team, introduced other players from the other four championship teams including from the 1969 team Ed Glotz and Stu Swiggum; from the 1974 team, Bob Gilbert, Bill Nusbaum, and Joe Dornblaser; from the 2002 team Tom Cook and Austin Meick and representing the 2013 team were Spencer Song, Joey Acosta, and Sean Emery. El Segundo high school baseball coach, Billy Traber, spoke on what Bob has meant to the continued development of baseball as

teams for those wishing to play but were not selected. The Babe Ruth League board would support and create a prep league if coaches were found. Bob, who did not play baseball in high school but was a student of the game, volunteered to be the coach, and thus Bob's 42-year journey begun.

Thus, Bob's two love affairs became a lifetime of passion, one for Kathy and his connection with youth sports being the other.

When Bob's son Ray entered Little League, he decided to coach at that level, and for the next eight years, Bob coached Little League teams and served in some capacity on the Little League board. In 1995 Bob returned to the Babe Ruth League, where he joined the Stars coaching staff until 2017.

For the past 27 seasons, Bob and Kathy have devoted their lives to the El Segundo Babe Ruth League. Bob as a coach or on the league board and Kathy at his side as the official scorekeeper. Mr. Faherty represented Babe Ruth League, Inc. to present Bob the Lefty Gomez Volunteer of the Year award. The fact that Babe Ruth League, Inc. has

happy," he laughs. During this time, his sister began to develop debilitating migraines. When medicine wasn't working, and she felt at a loss, he felt helpless. So he signed himself up for massage school to see if he could alleviate any of her pain. Massage school led deeper into energy studies and eventually holistic healing. Fifteen years later, he teaches classes out of El Segundo and sees clients regularly.

Grijalva is also what he calls a medical intuitive. This essentially means that with meditation, through a process called synchronization,

he can feel a client's pain in his own body. This helps him to empathize with his client and better understand where blockages may be occurring. Thankfully, he says, this is something he has largely learned to manage so that he isn't walking around feeling the pains of everyone around him in Los Angeles.

How does one know if this is a field they could enter? Grijalva says he believes these abilities are implicit in everyone, though some have to work harder at it than others. As for him, he describes feeling this from the time of childhood. "As a child, I was very sick all the time, but realizing it wasn't mine. It took a while to get a hold of it, and I do see a lot of sensitive children experience it quite a bit," he says. Part of his work is helping to teach children about empathy and helping adults sort out what pain is theirs and what is external. By realizing what is yours and what is not, he says, you can begin to open your mind and help others.

In the past year, a common issue he's dealt with during his consultations has been everything related to the pandemic and the lockdown. From loneliness to loss, his spiritual healing has been focused often on anxiety and depression lately, though he says every client is completely different and is treated individually.

With his studio, Sacred Circle, opening up again soon, he hopes to resume a practice of a monthly sound bath, which works to bring vibrations into the body, and can quiet

the mind or bring emotions to the forefront, depending on the kind of sound bath and individual reaction to different vibrations. He says that taking in other people's pain and constantly working through roadblocks and struggles can be very physically and emotionally exhausting. But on days he feels burned out and is ready to throw in the towel, he'll hear from a client who says that a huge problem they never thought they'd ever been able to deal with or cure is completely gone, and his dedication to the craft is renewed.

"That to me," he says, "that's worth more

than all the money in the world: to hear how someone has healed themselves or to have helped facilitate their healing." Grijalva's hopes that holistic healing will be more generally accepted in the future. "I'm not a doctor. I don't pretend to be. But there are so many things that are not medical or physical in nature; they're spiritual. That is what I'm trying to do: help people understand that we are spiritual creatures, and we can address our spiritual concerns in a safe and healthy way. Then we can really facilitate true healing." •

## Rise Again: Tulsa and the Red Summer Review: Bodies And Stories Were Buried-Until Now

## By Morgan Rojas for Cinemacy

Throughout history, the United States has been the home of dozens of racially-fueled massacres that were never brought to light. One of the most egregious atrocities is the 1921 Tulsa, Oklahoma race massacre which saw an entire community burned down by white mobs. Over 300 black men, women, and children were killed and dumped in unmarked mass graves, their possessions stolen and dignity affected for generations. In the documentary *Rise Again: Tulsa and the Red Summer*, now streaming on Hulu, documentarian Dawn Porter sheds light on this horrific tragedy and challenges our idea of what justice looks like today. Make America great again? For a large majority of

Tulsa Massacre victims and current Tulsa state officials, speak to the reality of what happened 100 years ago and how it is still affecting the black population today. It's uncomfortable to see just how dehumanizing the black community was made to feel at the hands of white people, but Dawn Porter educates viewers in a way that doesn't feel shameful or spiteful, just hopeful for a better future for all.

The term "Red Summer" was coined because the blood from black bodies flowed through the streets nonstop. Innocent black communities and individuals were targeted by white men who unjustly feared their jobs or lives were in danger, and were killed by the hundreds. Yet, these events have been



down the answers helps because the process of writing will help you clarify your thinking, and because it may be helpful to you in future conversations to have a record of your thought process.

First, you could have gone straight to your sister about this and let the chips fall where they may, but instead you chose to shoulder this burden, at least for a period of time. What is the thing that you are protecting by holding this secret? What does the fact that you have been able to hold this secret up until now say about what matters to you?

Which relationship is more important to you, and why: your relationship with your sister, or your sister's relationship with her husband? What do you need to do to tend to that relationship, and what are the potential costs of doing so, and are those costs worth it? (And sadly, there is always a cost.)

Next, what is the spectrum of possible explanations (not excuses) for what happened? Is the most generous view of your brother-in-law's behavior that perhaps it was a horrible, out-of-character, one-time mistake for which he feels genuine remorse? Good people do bad things all the time. Was this one of those times? On the other hand, was this incident totally in keeping with what you have seen and heard about him?

Finally, knowing everything that you know, if someone you cared about found herself in a situation where there was much uncertainty and seemingly no good options, how would you advise them to respond? Do that, and sleep well knowing you did the best you could.







The ordinance also defines the word "parkway" as the portion of property between the sidewalk or property line and the curb or roadway. Making the property owner responsible for maintenance of the parkway area is consistent with state law, which makes owners responsible for the maintenance of sidewalks, including a parkway between the property line and street line. (Streets & Highways Code §§ 5600, 5610.)

In addition, the ordinance makes the placement of garbage cans in an area other than in front of the premises occupied by the person depositing the same to be a public nuisance subject to citation by City Code Enforcement.

The proposed ordinance would limit the total number of cannabis retailer permits in the city to two and would establish a commercial cannabis business permit application procedure along with a point-based ranking system pursuant to which each application would be evaluated. 
The following Sunday, the Giltinis took their show on the road to San Diego and prevailed in a much tighter contest against the home team, winning 19-13.

Here are some of the rugby rules that I have discerned: Players can run and kick the ball but can only pass it backward. There are three ways to score:

- A team gets five points for scoring a "try," where the ball is grounded over the opponent's in-goal area, like the goal-line in the NFL.
- Two points are awarded to a team for a successful conversion. This is where a team can add further points after scoring a "try" by kicking the ball through the goalposts.
- A team can score three points if a penalty is awarded, and they successfully kick the ball through the goalposts.
- Three points are also given if a team does what is known as a dropkick, where a player drops the ball on the ground and kicks it through the goal post.

Rugby matches are played with 15 players on the field, with two halves of forty minutes and a 10-minute or so intermission. So, timechallenged (impatient) fans who do not cotton to spending four hours or so watching a Major League Baseball game, or waste 30 minutes viewing the final two minutes of an NBA playoff game, may appreciate the brevity of an MLR match, a contest highlighted by constant action.

As noted, there are 15 players on the pitch for each side. Some of the positions manned include a loose-head prop, tight head prop, a couple of flankers, #8, a scrum-half, a fly-half, an inside center, an outside center, a right-wing, a fullback, and the all-important hooker.

It is way past my nascent understanding of the sport to explain what each player's duties are, but suffice to say, each player's expertise is an integral component that meshes to build a successful team.

Time to meet your 2021 Los Angeles Giltinis...Well, two of them.

DTH van der Merwe is a Giltinis outside back/winger, a position he equates to the wide receiver position in the NFL. He goes by DTH, which are his father's initials. And he happened to be born on the same calendar day as his dad. Born and initially raised in South Africa, he moved to Canada when he was 17, where his rugby career accelerated. He played with the Canadian National team, as well as in a rugby World Cup in Dubai.

His sterling play on the pitch was spotted by a Scotland talent scout, which led to him begin a new sporting adventure, playing for 11 years in Scotland, Wales, and England.

When COVID-19 hit, DTH said that he was contacted by a former Canadian player who was associated with soon-to-be Giltinis head coach Darren Coleman.

DTH was pitched about setting up camp in Southern California and playing for the startpitch. He and his family, who live in Hermosa Beach, have not regretted their relocation. "We have fallen in love with the South Bay," DTH said. "We have lots of wheels spinning," he said, "in how we could stay here forever."

As a somewhat older player (35), DTH said he and his family are looking to a future in

he is a "qualified firefighter" and will probably be looking to pursue opportunities in

that occupation.

When asked how a rugby neophyte fan should learn about and embrace the sport, DTH noted that his father, back in the day, had acquired the book "Rugby for Dummies," a book that I should purchase. But DTH also touted attending a game at the Coliseum, as well as checking out the online feeds of MLR games that are available for free or dropping in to view a match on the Bally's Sports Network, which broadcasts contests each weekend.

Like all associated with the Giltinis, DTH embraces being an ambassador for promoting rugby to gain a foothold in America. "Spread the word," he said. "Why not give it a shot, and support the Giltinis?"

Which is a sentiment shared by his teammate, Dave Dennis. Dennis plays the "lock" position on the pitch, which he equates to the tight-end slot on an NFL offense. The Australian native said he "never thought he would end up in the South Bay." When his contract ran out while he was playing in England last year, Dennis, also 35, said he received a call from a Giltinis assistant coach, a former teammate,

trying to coerce Dennis and family to relocate to Southern California.

Again, the sales pitch worked. "Why not?" Dennis, who lives in Redondo Beach, said. "It was a good opportunity to enjoy everything that California has to offer and play some rugby."

Typically, professional expansion teams struggle during their first year, but not the Giltinis. And a lot of their success apparently stems from management selecting an internationally experienced head coach, Darren Coleman.

Dennis noted that Coleman has a stellar coaching resume, guiding teams that may have underperformed before his arrival at the top of the standings table. He said that Coleman's coaching style gets his team well-prepared for the next match, "but we also have a lot of fun."

When he is not rousting about with his family or speeding up-and-down the rugby pitch, Dennis says he enjoys cooking, as well as sharpening his skills on the local golf courses. He noted he forayed south two weeks ago to watch the opening round of the United States Open golf tournament. How good is Dennis on the course? He said he plays to a handicap of 8, "good enough to earn a little money from the boys" should friendly wagers be placed.

When asked to sum up a rugby match, Dennis said it is "15 guys running at each other, trying to score more points at the other end of the field. You bash the hell out of each other, and then go have a cold beer."

OK, so I am assuming that you still do not have a clue as to what a Giltini is? Well, it is an adult beverage named partially after/by club backer Australian entrepreneur Adam Gilchrist, who, I have been informed, made his fortune as a gym owner. The team's name, Giltinis, melds Gil with martini. Get it? And according to DTH, the beverage should be available this summer in local South Bay imbibing establishments. Gilchrist also happens to own another MLR team named after an adult beverage, the Austin Gilgronis, that plays off of the first three letters of his last name, as well as another adult beverage.

The MLR regular season concludes on the weekend of July 17/18. And if all goes according to plan, the Giltinis will continue their winning ways and glide into the playoffs. So, with the El Segundo-based LA Lakers and Kings long-ago dispatched from championship competition, you might consider taking the time to support a professional team who may bring another title to our jewel of a town.



## El Segundo Middle School Gymnasium Construction to Begin Fall 2021

As part of the El Segundo Unified School District's (ESUSD) Long-Range Facilities Master Plan, El Segundo Middle School (ESMS) is slated to receive an all-new \$19 million gymnasium on the north side of campus along Center Street. Groundbreaking is targeted for Fall 2021 and the new building is estimated to be completed in early 2023. This project is funded by Measure ES, which passed in November 2018 with the approval of 63.32 percent of El Segundo voters.

The ESUSD Board of Education decided on the location of the building and directed the architect to begin design in November 2019. The decision was memorialized in a formal Board action in April 2021. The selected gym location at the front of campus complements the current building layout, makes it more accessible for community users, enhances perimeter safety, and incorporates an improved parking plan in the same vicinity. It creates a physical education area that is separate from the classroom area and provides a sensible layout for indoor and outdoor physical education activities and the adjacent student activities courtyard. The addition of the gymnasium also allows for the physical education classroom space to be converted to two much needed new science labs. Changes to the currently planned gymnasium footprint are cost-prohibitive and are not under consideration.

El Segundo Middle School is the only middle school in the South Bay and most of Los Angeles County that is not equipped with a gymnasium, and ESMS does not have an indoor space large enough for the whole school population to assemble. This project will not result in increased enrollment and the new gym will be primarily used for ESUSD students and programs.

The scope of the project will include the gymnasium, two classrooms to be used by the PE program, boys' and girls' locker rooms, storage space, and a raised outdoor platform on the south side facing the new adjacent courtyard for performances/presentations and other student activities. To alleviate parking congestion, this project also includes an expanded parking lot along Center Street with 29 additional parking spaces for staff and visitors, and improved drop-off and pick-up traffic flow. There will be flexibility to use the new outdoor courts on the north side of campus for overflow parking during the rare occasion of large events.

ESUSD values green space and the development of this construction project examined different design iterations with the goal of maximizing usable green space. The net reduction of field space is 30 percent, regardless of the gym's location within available space on campus. The green space currently on the northwest side of campus will be transferred to the southeast side of campus. Adequate green space will remain for current wildlife use, and ESUSD plans to consider other areas to promote green spaces, landscaping, and gardens.

From a sustainability and efficiency standpoint, the building design includes infrastructure for solar panels and future energy savings. Other features include water bottle filling stations and water saving fixtures. There will also be a water run-off treatment system and bio swale. There will be no dedicated outdoor lighting for activities, but rather timer-controlled lighting in the parking lot and around the building envelope per code for safety. Lighting will be placed to avoid direct impact on the neighbors.

In 2015, ESUSD began a rigorous facilities assessment process with maintenance and operations, leadership at each school site, and the larger community. To build the district's Long-Range Facilities Master Plan (LRFMP), ESUSD conducted facility surveys, focus group meetings, school site interviews, formed a steering committee representing the diversity of our community, and hosted two rounds of town hall meetings. The development of the comprehensive LRFMP began in November 2015 and concluded with an amended Master Plan in July 2018, when it received ESUSD Board approval. The ESMS Gymnasium project plans were in consideration since the development of the Long-Range Facilities Master Plan in 2016. The planning process included four town hall meetings (advertised in the El Segundo Herald inviting the entire community to attend), and it was in those meetings and through surveys that decisions were informed. The gym construction project has been in design since November 2019 and covered publicly during Facility Advisory Committee and Board of Education meetings.

ESUSD intends to work with the community and school site neighbors to address concerns about the new facilities outlined in the district's Long-Range Facilities Master Plan where feasible. The District has and will continue to keep employees, parents and voters/community members informed of the milestones and progress on bond projects that will greatly benefit students for generations to come. ESUSD uses a variety of communication methods for facilities updates including Superintendent messages via email, articles in the El Segundo Herald, Town Hall Meetings, online presentations via Zoom/WebEx, surveys, social media, and email bulletins, as well as posting updates on the district website homepage via the "Measure ES" button at www.elsegundousd.net.
