City Employees Offered \$25k Bonuses for Year-End Retirements

The financial effects of COVID-19 are driving changes at El Segundo City Hall, where officials on Tuesday pitched an incentive program of \$25,000 for select employees who agree to retire by year's end. The early-departure program is voluntary, and the 30 eligible employees will have three weeks to make their decisions. If enough staff accepts the offer, it could lower the city's payroll until revenues rebound along with the local economy. El Segundo could reap a longer-term bonus, too. The city's pension contributions could decline as experienced employees leave, and replacements are hired. Public-employee pension costs are linked to service time.

Each employee who accepts the retirement offer will save El Segundo about \$15,000 during the current fiscal year - assuming the position stays vacant for at least four months. Chief Financial Officer Joe Lillio discussed several ideas with bargaining groups, management, and individual employees, and he reported the early-retirement incentive generated the most interest. With the City Council's support, the offers will go out immediately to 30 full-time employees eligible under CalPers rules to retire. The workers will have until November 25 to opt-in. They must sign a binding agreement to retire by December 31.

Rising pension obligations - due to changes in the funding formula for CalPers - are a concern for California cities and local governments. Lillio assured council members that filling the targeted positions with new employees can alleviate some of the pension-funding pressures facing El Segundo. According to a report for the City Council, the city is looking at up to \$600,000 in savings in future pension contributions if enough employees take the money and retire this year.

The report did not specify which jobs or staffers made the list. To be eligible, city

employees must have worked full time for at least three years, with 12 consecutive months of service back to November 2019. The program has specific eligibility requirements, which limit who can leave before 2021 and still cash out. Police and fire personnel aren't eligible because they are essential to emergency services under the rules. Neither will the city manager or deputy city manager, or the department directors be offered the deal - ditto for the police and fire chiefs, battalion chief, captains, lieutenants, and sergeants.

Care Manager Lauren Mahakian Truly Has the Touch of an Angel

Speak with some of certified dementia practitioner and elder-care specialist Lauren Mahakian's clients, and view some of the testimonials on her website, and a common theme emerges. Her clients consider her to be a godsend for her and her team's compassionate, effective, caring treatment of their aging relatives as they fight the battles of dementia, many of who have Alzheimer's disease.

her clients and families."

One of her clients calls Mahakian "an angel from Heaven" for her stellar work to aid and comfort elderly patients and provide their families with support and peace-of-mind. Dementia is defined as a general term for a decline in mental ability severe enough to interfere with daily life. Alzheimer's, a specific disease, is the most common cause of dementia.

Mahakian decided to open her residential care facility after visiting existing facilities and judging them as "not right." She noted that some residential care facilities seemed to be more about opulent appearance than serving the needs of the elderly. She said when choosing a residential care facility, clients should "not be blinded by the chandeliers. ...those chandeliers are not going to take care of your loved one."

Ron Kraft, whose wife has advanced Alzheimer's, and has resided in one of Mahakian's care facilities for the past two years, said, "she is remarkable. She knows how to handle dementia and Alzheimer's better than anyone that I have met, and that includes doctors." Kraft said Mahakian is sensitive to the needs of each client, which he said, "are all different, with different moods at different times." Kraft said his wife has had Alzheimer's for 15 years" and has never been more satisfied with her situation since Mahakian took over her care. "(Mahakian) is just a loving person."

She vowed to start her own facility and was successful in that venture in 2017, with Family Connect Memory Care in Torrance. At the time, Mahakian vowed to establish a residential home for the aging "that no one can come close to."

Mary Shimko, who has retained Mahakian to be her mother's care-manager, said, "Lauren has been instrumental in helping me get the resources needed to help (her mother) out. She has been wonderful," citing Mahakian as "extremely knowledgeable, and very available to

Debbie Pifer trusted Mahakian to care manage her elderly in-laws, as well as a special needs brother-in-law. Pifer calls Mahakian "the angel from Heaven, an incredible woman." Pifer said she was introduced to Mahakian in 2015 when looking for caregiving options. Pifer and husband Paul soon began working with Mahakian. Said Debbie: "Lauren is kind, compassionate, (with) extreme knowledge about elder care and vitality. Lauren today remains a close personal family friend, someone who came into our lives when we needed her most. We refer to her as our treasure beyond measure."•

Myra Katsura, who has known Lauren since 2017, said she was looking to get in-home assistance for her aging parents. She tried to convince her independent parents that they could benefit from in-home care, noting she had to take the car keys away from her elderly father. After her father had kidney failure, he was

Aaron Sorkin's *The Trial Of The Chicago 7* Reminds Us Why We Fight Back

In 1968, a mass of counterculture activists spearheaded a massive protest in Chicago's Grant Park, hoping to draw attention away from the Democratic National Convention and onto their anti-Vietnam War demonstration. To say their plan succeeded, is an understatement.

All eyes were on the "Chicago 7" after the protest sparked a riot between police and protestors, overtaking the city and leading to

is the protestor's battle cry "The whole world is watching!" That was true in 1969, and it's still true today. Here we are, in 2020, reliving eerily similar scenarios of unlawful police brutality, peaceful demonstrations turned into aggressive brawls, and a legal system than runs on bias (conscious or unconscious).

Sorkin said it himself at the drive-in screening I attended at the Rose Bowl: "This film will upset you. Anger you. But above all else, it will inspire you." It's no coincidence

political unrest (sound familiar?). Charged with criminal conspiracy and crossing state lines to incite a riot, the seven men and the trial that followed became one of the most infamous events in history. And with *The Trial Of The Chicago 7* (streaming on Netflix), the story comes to audiences by way of Mr. Courtroom Drama himself: Aaron Sorkin.

Acclaimed for his Oscar-winning screenwriting but here directing his second film, Sorkin assembles a top-notch cast of actors, including Eddie Redmayne, Sacha Baron Cohen, Jeremy Strong, Frank Langella, and Joseph Gordon-Levitt, plus short but sweet appearances by Kelvin Harrison Jr. and Michael Keaton, to name a few. To be expected in any Sorkin work, there is a lot going on here: from fast-paced dialogue to quick cuts that jump between archival footage and reenactments, *The Trial Of The Chicago 7* is sealed with the stamp of Sorkin. If you love his previous work, I won't have to sell you on this film. I know you'll watch it anyway.

A line that's repeated throughout the film

that the film's release is just weeks before the most important Presidential election of our lives, and if there is one takeaway from *The Trial of the Chicago 7*, it's this: every voice in our country matters, and has the potential to change the world—even it starts as just seven. •







The belt-tightening at City Hall was necessitated by the coronavirus's spread and the economic fallout from state and county measures to slow the infection rate. El Segundo is exploring other ways to meet its target savings on salary and benefits over the next nine months. The City Council on Tuesday revisited a reorganization plan that merges departments and eliminates several positions. The restructuring was introduced in mid-September as part of the 2020-21 budget-approval process.

Because the city's organizational chart is set by ordinance, the council needs to authorize proposed changes to the department names, their directors' responsibilities, and the salary ranges for those top management positions. A vote will take place at the next council meeting on November 17. If approved, the city's organizational chart would look like this:

- A Community Services Department would be created and combine the Library and Recreation and Parks departments. One director would oversee them, eliminating a director position.

- Park Maintenance would be folded into the Public Works Department.

- The Planning and Building Safety Department would become Development Services to reflect the emphasis on land-use services. That umbrella designation includes managing an affordable-housing fund and the city's overall affordable-housing efforts.

- Joe Lillio would become the city's chief financial officer and continue to oversee the Finance Department and the city's treasurer. Risk management responsibilities would fall under Finance. This department gains a risk manager who'll oversee the workers' comp and general liability programs for El Segundo.

- Information Services Department would be renamed to reflect the internal support it provides to El Segundo operations. The new name will become the Information Technology Services Department.

Six job titles would be deleted under the restructuring, resulting in one less director to oversee parks and programming. Six job titles and descriptions will be modified to

reflect the departmental name changes and, in some cases, the additional responsibilities. However, the salaries for five of the modified positions won't change, and only the deputy city manager could see a raise under the proposed reorganization.

City Manager Scott Mitnick wants to hire a risk manager who'll be tasked with reducing workers' compensation claims and general liability. The risk manager's monthly salary range is set at \$10,071 to \$12,085. Two librarian positions will be converted to create a library services manager to oversee day-to-day operations and a cultural arts coordinator position. The starting salaries are \$9,855 per month for the library post and \$6,468 per month to manage the 1 percent fee to support the arts in El Segundo.

In other business, the council approved a debt management and disclosure policy. State law directs local governments to have policies in place for issuing and managing debt. Adhering to a debt policy "helps to ensure the city's debt is issued and managed prudently to maintain a sound financial

position and creditworthiness," the item in the county packet read. Cities take on long- and short-term debt to pay for capital improvement projects or improve cash flow ahead of expected revenues.

Chevron awarded two grants for El Segundo business development and fire services, which the council gratefully accepted. The Chevron Social Investment Partnership Program approved grant applications of \$100,000 for continued economic development and \$215,900 for the fire department. The economic development funds will help El Segundo's economic recovery efforts as officials work to attract businesses and jobs to the city. This is the eighth business development grant from Chevron, which has supported El Segundo's business-development outreach with more than \$1.1 million since 2013. According to Deputy City Manager Barbara Voss, the fire department needed a rescue ambulance to replace one damaged by a vehicle fire in 2019, so the new Chevron grant money will reimburse the equipment-replacement fund. •

transferred to a skilled nursing facility, which, she said, is "pretty much the most awful place that I could imagine putting anybody in." She contacted Mahakian, who went to work to "bring my Dad home." Katsura said Mahakian and her staff made all the arrangements to return her father to his home, which "was the best thing in the world for him." She said that when her father died, Mahakian's team was present to do whatever they could. "I don't know what I would have done without Lauren and her crew," she said, noting how Mahakian's crew are still tending to her mother's care needs. "She is a real-life angel, with such a big heart."

Marilyn Garcia, who attends weekly Mahakian-arranged support groups, and moved her husband into a care home this March, said, "I have known Lauren for a year-and-a-half; and my husband has Alzheimer's disease. Lauren is responsive to concerns any of us have. We are part of her extended family. She is truly knowledgeable about memory loss issues and that how (those issues) affect the whole family. I do not worry about my husbands' care; I know that he is getting the best care. He likes where he is, is well taken care of; all of the employees

are very caring and very conscientious." Mahakian grew-up in Palos Verdes and graduated with a degree in Public Administration from the University of La Verne. In 2006, she interned with her older sister, renowned gerontologist Dr. Jane Mahakian, and began a journey in the field of "aging" that has led her to establish three separate care facilities, with a Westchester facility on the drawing board, set to open in 2022.

She started her business in 2008, a one-person endeavor, added a couple of employees, and now manages nearly 50 staffers tasked with providing stellar caregiving services to older South Bayans. Her companies boast uniquely trained staff to meet the sometimes-overwhelming needs of those with anywhere from moderate to severe cognitive impairment.

She also partners with local hospitals, as well as working with the USC Leonard Davis School of Gerontology. She offers unique services to those who have dementia, including a "Music and Memory" and "Stimuli" program. She was recognized as a South Bay HERO by Clear Recovery Center and Good Stuff Restaurants, selected from a worthy field

of nominees, a fete she said that was "really cool, very moving."

Her initial successful foray into the field of geriatric care allowed her to start Family Connect Memory Care in 2017, then Family Connect Boutique Care the following year, and then South Bay Memory Care in 2019, all licensed residential care facilities for the elderly and located in Torrance.

She said her facilities' goal is to "restore the dignity and respect for residents afflicted with dementia," while noting all of her businesses are continuing to do well, even with who have dementia of COVID-19 that afflicts the elderly at alarming rates.

If managing three dementia care homes is not enough of a challenge, Mahakian also continues to succeed with her care management and in-home care businesses. In this pandemic era, she is available to clients and staff 24-7, setting-up virtual meetings, supporting care providers and facility staff, and visiting clients outside their home, all while maintaining required social-distancing protocols.

She also holds weekly caregiver support groups in Ranch Palos Verdes, as well as

support groups in Los Angeles and Santa Barbara counties. In her "spare" time, Mahakian launched a podcast last year, "Unlocking the Doors of Dementia with Lauren," and earlier this year began penning a monthly column for the Palos Verdes Peninsula News under the title "The Alzheimer's Whisperer."

She espouses the mantra of helping families assure premium care for their loved ones by navigating the complexities of care management and housing so they can live their life to its fullest.

Some of you readers may remember a TV show that had a successful run on CBS back in the day, culminating a nine-year-run in 2003. Starred Roma Downey and was christened "Touched by an Angel." One of the episodes focused on one of the recurring characters, Tess, who was in the early stages of Alzheimer's disease and had to take up residency in a nursing home.

Well, that show may be out there somewhere in the loop of repeats available for viewing today, but, for the clients and families of Lauren Mahakian, they are still being..." touched by an angel." •





