Public Hearing Set For Public Input Regarding City’s Master Fee Schedule

Mayor James Butts and members of the Inglewood City Council approved to set Sept. 27, at 2 p.m., as the date of a public hearing to accept public comments regarding plans to amend the city’s Master Fee Schedule, based in the Consumer Price Index [CPI] for the Los Angeles Region-All Urban Consumers reflecting the June 2015-2016 time period.

“This adjustment for 2016 is the adjustment proposed by the City’s Department of Finance and is calculated on a CPI adjustment from June 2015 through June 2016 of 1.80 percent,” indicates the staff report signed by City Manager Artie Fields. “The attached Comprehensive Master Fee Schedule (Attachment No. 1) provides a list of all user fees which were previously transferred from various city ordinances, resolutions, and department policies to the City’s Master Fee Schedule.”

In order for a city to impose a raise in fees or charges, California Government Code 66018 requires that a public hearing take place in order for oral and written presentations to be made. The public hearing must be part of a regularly-scheduled meeting; and within no more than 10 days the local agency must make public all information detailing the cost [estimated cost] required to provide the service that requires the imposition of said fee.

As recent as October 2013 the City of Inglewood had not established a process by which it could update its user fees in a systematic fashion; hence, fees could only be updated and adjusted via ordinances, resolutions or through the electorate’s approval. However, that month the city council adopted Resolution No. 13-110 to set a master fee schedule that would streamline the process of annually reviewing and updating city fees with the adoption of the annual budget. The

city’s first effort to establish a MFS dates back to Sept. 18, 2007, when the council approved an increase to selected fees, but tabled the ordinance to establish a MFS, as well as other fee changes.

“There is no record of the last time that fees were modified citywide but selected fees have been modified on a case by case basis, as necessary, over the years,” states a staff report signed by Fields and presented to the council on Oct. 22, 2013. “Most City fees, including development fees, go directly into the General Fund and are used to cover a portion of the cost of city services and operations. Development fees are collected for projects related to physical development within the community such as building and/or infrastructure improvements. Those fees are authorized for a variety of services provided to individuals, businesses, and organizations that require City plan review and approvals, permits and the like.”

The notice for the public hearing will be for at least 10 days and must be published twice with a five day separation. With Sept. 13 being the meeting date that established the public hearing, Sept. 15 was set as the first day of public notice in a local publication. By Sept. 16 the city was required to provide fee data to the public and by Sept. 22 the second publication in a local paper must take place. With the public hearing set for Sept. 27, the staff report identifies Nov. 28, 2016 as the date to implement the new fees.

“The change in fees shall be effective 60 days after the final adoption of the council, unless passed as an urgency measure to protect the public health, welfare, and safety,” states the staff report.

Council Approves Resolution to Appoint Inglewood Representatives to

Governing Board of the Icrma

A recommendation to appoint Councilman Eloy Morales, Jr., City Attorney Kenneth R. Campos and Risk Manager Sara Nazir as City of Inglewood Representatives to the governing board of the Independent Cities Risk Management Authority [ICRMA] was approved by the city council.

“The City of Inglewood is a member of the Independent Cities Risk Management Authority (ICRMA) for General Automobile, Property and Worker’s Compensation Insurance coverage,” states the staff report signed by Campos. “ICRMA provides that the city council of each member city may appoint a member of the city council as the city’s representative to the ICRMA Governing Board and also authorize the appointment of an alternate representative, and a substitute alternate representative to represent the city’s interest in the absence of the city council appointee.”

ICRMA has 18 Southern California member cities, including the cities of Alhambra, Baldwin Park, Bell, Downey, El Monte, El Segundo, Fullerton, Glendora, Hawthorne, Hermosa Beach, Huntington Park, Inglewood, Lynwood, Manhattan Beach, Monterrey Park, Redondo Beach, San Fernando and South Gate.

Since 1980, under a Joint Powers Authority [JPA], ICRMA members have pooled their resources to support their individual self-insurance programs.

With the mission of developing risk management programs to efficiently control and finance members’ exposure to losses arising out of Tort Liability, Workers’ Compensation, and property ownership, the ICRMA has grown from five to 18 members. ICRMA’s Governing Board monitors eight programs and ensures that the partnership and program structures offer members the best benefits possible. •

ROCKET MAN

Hawthorne has a rocket company and now we have a rocket man. Eddie Braun, who was born and raised in Hawthorne and graduated from Hawthorne High School in 1979 did something last week that his hero failed to do. He jumped over the Snake River Canyon in Idaho. Braun grew up dreaming in Hawthorne and his hero was Evel Knievel. Eddie now resides in Manhattan Beach.

Here is the article concerning the achievement reprinted from the Idaho Statesman: “I wouldn’t be doing this if I thought it couldn’t be done,” stuntman Eddie Braun told the Idaho Statesman, shortly before pressing the button that would launch him in a steam-powered rocket a few thousand feet over the Snake River Canyon in Idaho. The vehicle he piloted is called Evel Spirit, a nod toward the late, great Evel Knievel. The legendary red, white, and blue stuntman famously attempted this exact same stunt 42 years ago, but failed. Braun succeeded where his idol did not. Estimates put Braun’s max velocity at 400 or so miles per hour. It took just four seconds of flight before it was time to pull the parachute. “I feel like the no-name, third-string quarterback of a junior-varsity team that just won the Super Bowl. My team got me there. I ran it into the end zone. We scored and won,” Braun said in a statement after the jump. Teamwork makes the dream work, as they say. Evel Spirit was designed and built by Scott Truax, son of the man who constructed the X2 Skycycle rocket-ship that was supposed to send Knievel over the canyon all those years ago. Truax claims Braun’s rocket was an exact replica of the one Knievel used in his failed attempt. But Braun is quick to admit Knievel could have completed his stunt. “I like to say I’m not doing something that Evel Knievel couldn’t do. I’m simply finishing out his dream. How many people get to finish the dream of their hero?”

A friend is more valuable than money. You can never put a price on great memories. We will miss his familiar call, “It’s time for Dodger baseball.”, and “Good evening everyone, wherever you may be.”

It was always a beautiful day for baseball when Vin was announcing.

Hawthorne Offense Falters in Loss to Banning

Hawthorne got off to a slow start but only trailed 13-7 at halftime. Banning scored 24 unanswered points in the final four minutes of the game for a 37-7 nonconference win over the Cougars last Friday. The Pilots got off to a fast start as sophomore running back Jokori Moe returned the kickoff 75 yards to the Cougars' 8 yard line. Banning senior running back Joe Villareal put the Pilots on the board first with 5-yard touchdown run.

After a Hawthorne drive stalled, the Pilots go up 13-0 in the first quarter on a Myles Porter 12-yard touchdown pass to junior wide receiver Fernando Corona. Hawthorne quarterback Andrew Kalinowski connected with senior wide receiver Justice Powers for a 32-yard touchdown to trim the lead, 13-7, in the first quarter.

Hawthorne put together a nice drive in the third quarter, however, the Pilots defense forced a turnover on downs in the red zone. The Cougars offense was held in check the rest of the game. Banning played tough defense, led by senior linebacker James Dempsey, who finished the game with six tackles including two sacks.

Hawthorne senior Carlos Jacobo intercepted a pass but the offense stalled once again. The Pilots marched down the field with a 7-play, 64-yard drive, capped by senior running back

Sultan Moala's 7-yard touchdown run. Moala ran in the two-point conversion, giving Banning a 21-7 lead in the fourth quarter.

After the Banning defense made another stop, Villareal scored on an 8-yard run, and Moala added a 3-yard touchdown to put the game away for the Pilots with just under three minutes left in the game. Villareal finished with 114 yards on 18 carries while adding two touchdowns. Jacobo led Hawthorne with five catches for 51 yards while adding an interception on defense.

Banning improves to 4-0 on the season while Hawthorne falls to 1-3. The Cougars will hit practice hard this week in preparation for their showdown with rival Leuzinger on Friday. Kickoff is set for 7 p.m. at Halcap Field. The Olympians lead the rivalry with an overall record of 9-2. Hawthorne is looking turns things around and a win against rival Leuzinger would give the Cougars momentum going into league play. Leuzinger defeated Hawthorne last season, 34-13.

LAWNDALE VS. LEUZINGER

Lawndale traded touchdowns with Leuzinger but the Olympians speed was too much for the Cardinals defense in a 36-28 loss last Friday. Sophomore running back Jordan Wilmore raced to a 50-yard touchdown to give Lawndale a 7-0 lead in the first quarter. Leuzinger strikes back with a 9-play, 80-yard drive, capped

by quarterback Kaymen Cureton's 24-yard touchdown pass to tight end Danthony Jones.

The Olympians offense didn't waste any time as senior Tariq Culpepper takes the handoff on a reverse and runs 55 yards for a touchdown, giving Leuzinger a 14-7 lead with 4:59 remaining in the first quarter. After forcing Lawndale to punt, Leuzinger marched down the field on a 10-play, 70-drive, capped by running back Daniel Carmicle's 1-yard run to give the Olympians a 21-7 lead in the second quarter.

Lawndale answered when junior quarterback Jalen Hamler hit wide receiver Jaylen Stewart for a 26-yard touchdown, cutting the lead, 21-14 going into halftime. After a Leuzinger fumble, Hamler floated a pass to senior wide receiver Hunter Williams, who out jumped the defender in the end zone, for a 5-yard touchdown, tying the score, 21-21 in the third quarter.

Carmicle added another 1-yard touchdown run to give Leuzinger a 28-21 lead with just under a minute left in the third quarter. Cureton extends the Olympians' lead on a 45-yard touchdown pass to a streaking Antonio Haygood. Carmicle punches in the two-point conversion to give Leuzinger the 36-21 lead with 7:24 left to play in the game.

The Cardinals added a late touchdown on Wilmore's 18-yard run but the Olympians defense held on for the victory over its crosstown rival.

Wilmore finished with 99 yards on 19 carries. Hamler completed 8 of 19 passes for 174 yards while adding two touchdowns passing. Carmicle finished with 90 yards on 18 carries for Leuzinger. Culpepper added 110 yards.

Lawndale (1-2) will look to bounce back when they host non-conference opponent San Pedro on Friday at 7 p.m. San Pedro is coming off a 25-6 win over Redondo Union last Friday.

INGLEWOOD VS. LOS ANGELES

Inglewood was riding high after a 64-0 drubbing of Blair. They were quickly brought back down to earth as Coliseum League L.A. High School gave the Sentinels a 50-0 beat down at L.A. Southwest College last Friday. The Sentinals running game was held in check all night, only gaining 49 total rushing yards.

The Romans jumped out to 14-0 lead in the first quarter. Inglewoods' offense continued to stall. L.A. added a touchdown to give the Romans a 22-0 lead at halftime. The Sentinels' defense was no match for the Romans as they gave up 28 points in the second half. Inglewood junior running back Tyaire Dunlap finished with 21 yards on 13 carries. Junior linebacker Demarc White led the defense with six tackles.

Inglewood (2-2) will look to get back under the win column when the travel to Pioneer today for a 7 p.m. kickoff. Pioneer (0-4) is coming off a 67-0 loss to Buena Park. •

Looking Up

Mars Rover Views Spectacular Layered Rock Formations

The layered geologic past of Mars is revealed in stunning detail in new color images returned by NASA's Curiosity Mars rover, which is currently exploring the "Murray Buttes" region of lower Mount Sharp. The new images arguably rival photos taken in U.S. National Parks.

Curiosity took the images with its Mast Camera on Sept. 8. The rover team plans to assemble several large, color mosaics from the multitude of images taken at this location in the near future.

"Curiosity's science team has been just thrilled to go on this road trip through a bit of the American desert Southwest on Mars," said Curiosity Project Scientist Ashwin Vasavada, of NASA's Jet Propulsion Laboratory, Pasadena, California.

The Martian buttes and mesas rising above the surface are eroded remnants of ancient sandstone that originated when winds deposited sand after lower Mount Sharp had formed.

"Studying these buttes up close has given us a better understanding of ancient sand dunes that formed and were buried, chemically changed by groundwater, exhumed and eroded to form the landscape that we see today," Vasavada said.

The new images represent Curiosity's last

stop in the Murray Buttes, where the rover has been driving for just over one month. As of this week, Curiosity has exited these buttes toward the south, driving up to the base of the final butte on its way out.

Curiosity landed near Mount Sharp in 2012. It reached the base of the mountain in 2014 after successfully finding evidence on the surrounding plains that ancient Martian lakes offered conditions that would have been favorable for microbes if Mars has ever hosted life. Rock layers forming the base of

Mount Sharp accumulated as sediment within ancient lakes billions of years ago.

On Mount Sharp, Curiosity is investigating how and when the habitable ancient conditions known from the mission's earlier findings evolved into conditions drier and less favorable for life.

Mars In Your Night Sky.

As soon as it gets dark enough to see stars, look a bit west of south and you will see three bright objects, fairly close together. The brightest of these is Mars, having a

slightly reddish tint. Above and to the right is Saturn, and nearby is a star, Antares in the constellation Scorpius.

This is a good chance to test your ability to tell a star from a planet: if it twinkles, it's almost certainly a star; but a planet's light will usually be steady, not twinkling. Distortion caused by the light passing through miles of windy atmosphere causes starlight to twinkle; the light from a planet, coming from a wider object, is less likely to be blocked by the atmosphere.

Over the next few days and weeks, Mars, Saturn and Antares will slip westward night by night until they are lost in the twilight. This happens because Earth is moving eastward in its orbit. Mars' orbit takes it eastward too, but since its orbit is twice as large as ours—it takes about two Earth-years for Mars to get around the Sun—it can't keep up with us.

Does all this celestial geometry boggle your mind? Not surprising—it took humanity at least 1,500 years, from Ptolemy to Copernicus, to figure it out! But it's a great exercise for our powers of reasoning and mental visualization.

Even though I'm missing a leg, I'm still pretty playful and I get along great with other dogs. I'm almost full-grown and I only weigh 15 pounds so I won't be a big guy but I do have a big heart!
