Council Awards Contract for Residential Sound Insulation Work

In a unanimous vote, the Mayor and Inglewood City Council approved awarding a \$1,810,000 dollar contract to Harry H. Joh Construction Group, Inc. to complete residential sound insulation work on 63 homes in the city.

Harry H. Joh Construction Group, Inc. presented the lowest bid, out of five bids, which were received. In addition to approving the contract, the council approved a 10 percent contingency fund for \$181,000, as well as adopting a resolution to amend the budget for the 2014-2015 fiscal year to include special expenses for a total of \$41,792 in noise mitigation funds.

The staff report presented indicates the City of Inglewood receives grant money from the Federal Aviation Administration and the Los Angeles World Airports in order to administer the Residential Sound Insulation projects.

All Residential Sound Insulation projects are carried out through construction contracts that are specific for residential structure groups. For the contract approved by the council 63 homes in the city will benefit from sound insulation. Of the 63 homes, 43 are located in District No. 1 while the remaining 20 are in District No. 2.

Furthermore, 24 of the targeted homes are single-family units while 20 are classified as duplex units and the final 19 homes fall under the multi-family unit classification. It is estimated that the average cost of the work to be completed on each unit is \$28,730. However, some of the bid's estimates "may differ due to the design specifications which reflect distinct characteristics such as the number of windows and doors, the age of the structure, and the type of construction or dwelling type" states the staff report.

The City of Inglewood developed and adopted a plan with the goal of completing

sound insulation, through the Residential Sound Insulation Program, of 1,000 homes during a 12-month period up until the program ends. Included in the project's scheduled tasks and work is the replacement of "existing windows and exterior doors with acoustic grade products, attic insulation, modifications of vents, baffles and other areas of transmission, as well as the installation of heating, ventilation, and air-conditioning systems" was stated by the city's staff report.

Harry H. Joh Construction Group, Inc. is an experienced contractor in residential sound insulation projects. Furthermore, the contractor has successfully completed previous Residential Sound Insulation projects for the City of Inglewood.

The agreement also incorporates a one-year term from the date of notice to proceed. In addition the contractor is required to perform all of the contracted construction work within 180 days. The agreement is very specific and includes contract provisions and specifications that met state and federal requirements, technical design details for every home to be serviced. With the contract awarded, construction staff will begin field measurement verifications, materials and supplies will be purchased and delivered, as well as having a project schedule approved. Actual construction for the project will begin within 20 days all of the above-mentioned actions having occurred.

POLICE DEPARTMENT TO OBTAIN NEW ITEMS, SERVICES FOR K-9 UNIT

A two-year agreement in the amount of \$25,000 was approved by the Mayor and City Council with Adlerhorst International. The agreement will allow the Inglewood Police Department to purchase several items and services necessary for the department's Canine Unit and it comes with a one-year extension option.

The Inglewood Police Department uses its Canine Unit during several investigations while officers are out on the field. Since canines improve the ability of officers to carryout "article and narcotics searches" in order to arrest suspected criminals, the services of the four-legged animals have become a valuable asset for the department. Up to date the department has the ability to deploy four canines, which are all assigned to the Office of Patrol Services.

The supplies and services to be supplied through the agreement include canines, training services, kennel services, bite suits, suit repairs and leashes. The most recent agreement between any vendor and the Inglewood Police Department expired in September and since then the department has been without a vendor for said services.

Adlerhorst International recently reached an agreement with the City of Palm Springs in order to provide services and products for that locality's police department. •

Childproof Your Finances

(BPT) - Whether welcoming a newborn, adopting a child or becoming a stepparent for the first time, bringing a child into your life means big changes - and a big impact on your finances.

According to the United States Department of Agriculture, parents of children born in 2013 will spend approximately \$245,000 - per child - on housing, education, food, clothing, child care and other expenses until the age of 18. - Birth defects affect one in every 33 newborns according to CDC statistics. Babies who live with birth defects may face lifelong challenges, so it's important to know if your health insurance covers pre-natal and neo-natal screenings, emergency delivery procedures and extended hospital stays.

- The Consumer Product Safety Commission reports that 44 percent of playground equipment injuries occur at home. Parents should double check their liability coverage to ensure it covers playmates who are hurt on their property.

- The CDC also reports that 46 percent of teens don't wear seatbelts when riding with friends, significantly increasing their risk of injury or death in an auto accident. Something as seemingly simple as a teen driving contract can hold kids accountable - saving money and lives in the process.

Take Action Now

Understanding the insurance implications of a new child can be tricky. Get a jump on preparations by exploring the following:

- Determine if paid maternity leave is

included in your health benefits. If you anticipate needing extra time off, a short-term disability policy might be helpful.

- Ask your employer about a flexible spending account that can be used to set aside pre-tax dollars to cover medical expenses and child care costs.

- Consider the impact on your auto insurance premiums if your expanding family compels you to purchase a larger vehicle. Shop rates and consider different models before you buy. Rates will vary depending on make, model, age of vehicle, etc.

- A new dependent means you should reassess your life insurance. Will your current level of insurance be enough to secure your child's future if the unthinkable happens to you? Consult with your insurance agent or use an online calculator to determine if you need additional insurance.

- Adoptive parents, stepparents and custodial guardians should also check with their health insurers to determine a new child's coverage eligibility. Life insurance policies, investment accounts and other financial accounts may need to be updated to reflect a new child as a beneficiary.

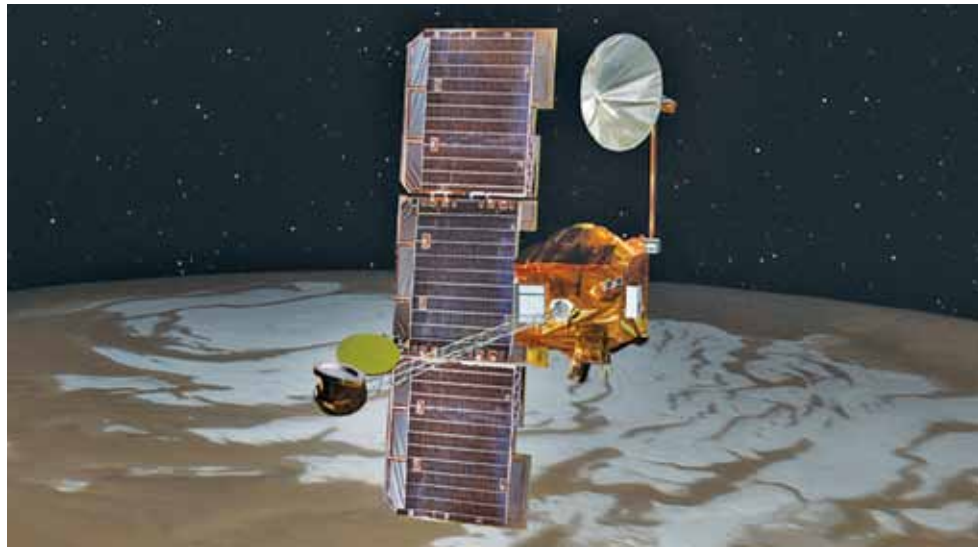

Mars Orbiter Sees Comet Flyby

The longest-lived robot ever sent to Mars came through its latest challenge in good health, reporting home on schedule after sheltering behind Mars from possible comet dust. NASA's Mars Odyssey was out of communications with Earth, as planned, while conducting observations of comet C/2013 A1 Siding Spring on Sunday, Oct. 19, as the comet flew near Mars. The comet sped within about 88,000 miles of Mars, equivalent to about one-third of the distance between Earth and Earth's moon. Odyssey had performed a maneuver on August 5 to adjust the timing of its orbit so that it would be shielded by Mars itself during the comet's passing, when computer modeling projected a slight risk from high-velocity dust particles in the comet's tail.

"The telemetry received from Odyssey confirms not only that the spacecraft is in fine health but also that it conducted the planned observations of comet Siding Spring within hours of the comet's closest approach to Mars," said Odyssey Mission Manager Chris Potts of NASA's Jet Propulsion Laboratory, Pasadena, Calif., speaking from mission operations center at Lockheed Martin Space Systems, Denver.

Three NASA Mars orbiters, two Mars rovers and other assets on Earth and in space are studying comet Siding Spring. This comet is making its first visit this close to the Sun from the outer solar system's Oort Cloud, so the concerted campaign of observations may yield fresh clues to our solar system's earliest days more than 4 billion years ago.

COMETS FOUND AROUND NEARBY STAR

A French team of astronomers at ESO's La

Silla Observatory in Chile has studied nearly 500 individual comets orbiting the star Beta Pictoris and has discovered that they belong to two distinct families of exocomets: old exocomets that have made multiple passages near the star, and younger exocomets that probably came from the recent breakup of one or more larger objects.

Beta Pictoris is a young star located 63 light-years from the Sun. It is only about 20 million years old and is surrounded by a huge disc of material—a very active young planetary system where gas and dust are produced by the evaporation of comets and the collisions of asteroids.

For almost 30 years astronomers have seen subtle changes in the light from Beta Pictoris that were thought to be caused by the passage of comets in front of the star itself. Comets are small bodies of a few kilometers in size, but they are rich in ices, which evaporate when they approach their star, producing gigantic tails of gas and dust that can absorb some of the light passing through them. The dim light from the exocomets is swamped by the light of the brilliant star, so they cannot be imaged directly from Earth.

To study the Beta Pictoris exocomets, the team analyzed more than 1,000 observations obtained between 2003 and 2011. The researchers selected a sample of 493 different exocomets. Some exocomets were observed several times and for a few hours. Careful analysis provided measurements of the speed and the size of the gas clouds. Some of the orbital properties of each comet, such as the shape and the orientation of the orbit and the distance to the star, could also be deduced. •

South Bay Cities Council of Governments: Providing Programs, Saving Money

While there are many benefits to autonomy, collaboration with one's neighbors can pay also major dividends. Such is the case when it comes to the South Bay Cities Council of Governments (SBCCOG)—a 19-year-old joint powers authority comprised of 16 municipalities (plus Los Angeles County) that work together to advocate for regional projects and programs they would be hard-pressed to implement through individual efforts alone. As just a few recent examples of its ongoing mission to protect overall South Bay interests, the SBCCOG negotiated with utility partners to assure policies and actions are fair to cities, advanced city sustainability programs, lobbied the Public Utilities Commission to put the spotlight on South Bay infrastructure reliability programs, and prevented the South Bay Highway Program (SBHP) from paying for a \$100 million Crenshaw Rail Project overrun.

The SBCCOG also provides cost-effective programs that save cities money now and in the future—with energy efficiency and transportation two of the major focus areas outlined in the agency's 2014/15 work program. On the energy side, cities working with the SBCCOG have realized significant general fund savings over the last five years through various utility incentives that also improve the environment by reducing greenhouse gas emissions. Just looking at the Herald Publications group of cities (El Segundo, Hawthorne, Inglewood, Lawndale and Torrance), those municipalities reported combined annual savings of nearly \$500,000 and reduced emissions by over 2,100 tons collectively as a result of SBCCOG collaboration. Other regional offerings include energy audits and advice, training, energy action plans, energy leader programs, holiday light exchanges, municipal direct installs, and quarterly reports so each city can monitor energy efficiency. Municipal direct install—a program for government and non-profit facilities that can cut energy costs by up to 30 percent through on-site energy audits and installation of energy-saving equipment—has already provided well over \$200,000 in combined upfront cost and annual savings for Hawthorne, Lawndale and Torrance. El Segundo and Inglewood also recently joined this program and expect to shave some of their yearly expenditures as a result.

Water conservation programs include Cash for Kitchens, California-friendly landscape training workshops, high-efficiency toilet exchanges, water reliability educational presentations, and water leak detection (El Segundo and Inglewood were two of four cities receiving grants totaling \$408,000 to address this issue). The SBCCOG also collaborates on climate action plans for the individual cities.

On the transportation side, the SBCCOG fosters the application and funding processes for \$906 million in Measure R (the countywide half-cent sales tax passed by voters) monies earmarked for the SBHP. This led to over \$5 million in Measure R monies allocated for completed transportation projects in El

Segundo (Maple Avenue to Parkview Avenue improvements), Hawthorne (Rosecrans arterial improvements) and Torrance (Maple at Sepulveda intersection improvements) over the last couple of years. In 2014/15, Measure R will subsidize \$25 million for 11 highway projects in Torrance alone, with another \$4 million-plus to cover nine total projects in El Segundo, Hawthorne and Lawndale.

Blending transportation and energy efficiency, the SBCCOG has put an emphasis on promoting the electric vehicle movement, with current programs in place for battery (BEV) and plug-in (PEV) cars and efforts to secure additional funding for PEV readiness as well as for an NEV (neighborhood electric vehicle) large-scale project and non-profit demonstration. The SBCCOG also orchestrated the Car2Go vehicle-sharing program now operating in El Segundo and Torrance. "The COG's interest in EVs and non-traditional transportation such as car sharing and NEVs comes from research showing that in the South Bay most trips—other than the commute trip to work—are less than three miles," said SBCCOG Executive Director Jacki Bacharach. "This makes them too long to walk and too short for transit. Also, while biking is encouraged, not everyone can bike... so other alternatives are of interest."

Bacharach, who oversees the SBCCOG's day-to-day operations and a staff of 13 employees plus several consultants, added that much of the organization's funding comes from grant dollars. "Another key area of success noted in our work program is that we leverage our dues with outside funding, raising 10 times the amount of funds from dues," she said.

SBCCOG also provides training and networking opportunities for city staff members, during which department heads meet to discuss issues of mutual interest and learn from one another. As examples, the new Social Media Working Group and the Senior Services Working Group recently launched. "Discussions at these meetings focus on what cities need to know and how they can do better for their constituents from working together," said Bacharach, who added that the SBCCOG's main networking event is its Annual General Assembly that is next scheduled for February 15 of next year. It is a full-day program with speakers and discussion periods. This year's theme is "A View From the Front Porch: Neighborhoods in the South Bay."

Individual Council members from each participating city serve as delegates (with alternates also appointed) who attend SBCCOG meetings. The list includes El Segundo Mayor Suzanne Fuentes, Hawthorne Mayor Pro Tem Olivia Valentine, Inglewood Councilmember Ralph Franklin, Lawndale Mayor Pro Tem James Osborne, and Torrance Councilmember Kurt Weideman. SBCCOG board meetings take place the fourth Thursday of each month (dark during February and November) at the South Bay Environmental Services Center at 20285 Western Avenue in Torrance and are open to the public. •

Hawthorne Can't Keep Up With El Segundo

After winning its first Ocean League football game over Beverly Hills on October 17, Hawthorne High's football team had an extremely stiff homecoming challenge from premiere El Segundo team that was unbeaten and ranked second in the CIF-Southern Section Western Division last Friday.

The Cougars started out doing everything they could in an attempt to pull off a major upset but the Eagles eventually proved overwhelming with a 67-21 rout. In the opening kickoff, Jamaal Neal quickly opened things off as Hawthorne took an early 7-0 lead with his 95-yard kickoff return.

El Segundo came back to take a 14-7 lead but, midway in the second quarter, Paris McDaniel raced 63 yards for a touchdown to tie the game at 14 for the Cougars, who fell to 3-5 overall and 1-2 in league.

From there, the Eagles (8-0, 3-0) dominated and scored their machine didn't stop until right before the end of the game. El Segundo finished off the first half by scoring three TD's in a period of just over three minutes for a 34-14 halftime bulge, behind the arm of highly prospect quarterback Lars Nootbar. He threw touchdown passes of 34 and 35 yards to Taz Tauaese and seven to Miguel Wagner-Bagues.

The second half saw the Eagles add two more TDs before Hawthorne scored its final touchdown with four seconds into the fourth period on a two-yard quarterback keeper from Marte Mape. El Segundo's two third quarter scores were a 92-yard run by Wagner-Bagues and Nootbar's third touchdown pass to Jackson Walz from 25 yards out.

The Eagles finished added three more TD's in the fourth period on a 15-yard run

by Tauaese, a 45-yard fumble recovery from linebacker Dwayne Polk and a four-yard run by Wagner-Bagues with 41 seconds left.

"El Segundo made the CIF (Northwest Division) finals last year," Hawthorne head coach Donald Paysinger said. "They are very good. We'll be all right."

McDaniel had a good game rushing for 218 yards and one touchdown.

Nootbar, who plans to go to University of Southern California but most likely for baseball even though he had offers for football, completed 11 of 22 passes for 288 yards and three TD's. Wagner-Bagues rushed for 207 yards on 18 carries.

"We had to deal with a couple of injuries," El Segundo head coach Steve Shevlin said. "Hawthorne came out great early. It was a test for us. We were hit with penalties. We had two touchdowns called back."

The Cougars hope for a good opportunity to get two league wins for the first time in 10 years as they host Peninsula Friday at 7 p.m. The Centaurs appeared to have a promising season until losing seven top players who transferred to other schools and have been left with a mostly young and inexperienced squad. Hawthorne has not beaten Culver since the 1990's but hope this will be the year. At Culver last Friday, the Centaurs (0-3 in Ocean play) were humiliated by Santa Monica 49-0.

El Segundo could have a showdown at home against Lawndale Friday at 7 p.m. This could be a good match between top quarterbacks Nootbar and the Cardinals' Chris Murray. At Beverly Hills last Friday, Lawndale rolled over the Normans 47-7.

CARDINALS ROUT NORMANS

Junior quarterback Chris Murray continued to prove dominant with 251 total yards as

Murray passed for 142 yards and rushed for 111 more that including beginning the Cardinals' scoring with a 72-yard run early in the second quarter. Murray passed for two TDs and ran for two more. Individual Swirled Pumpkin Cheesecakes



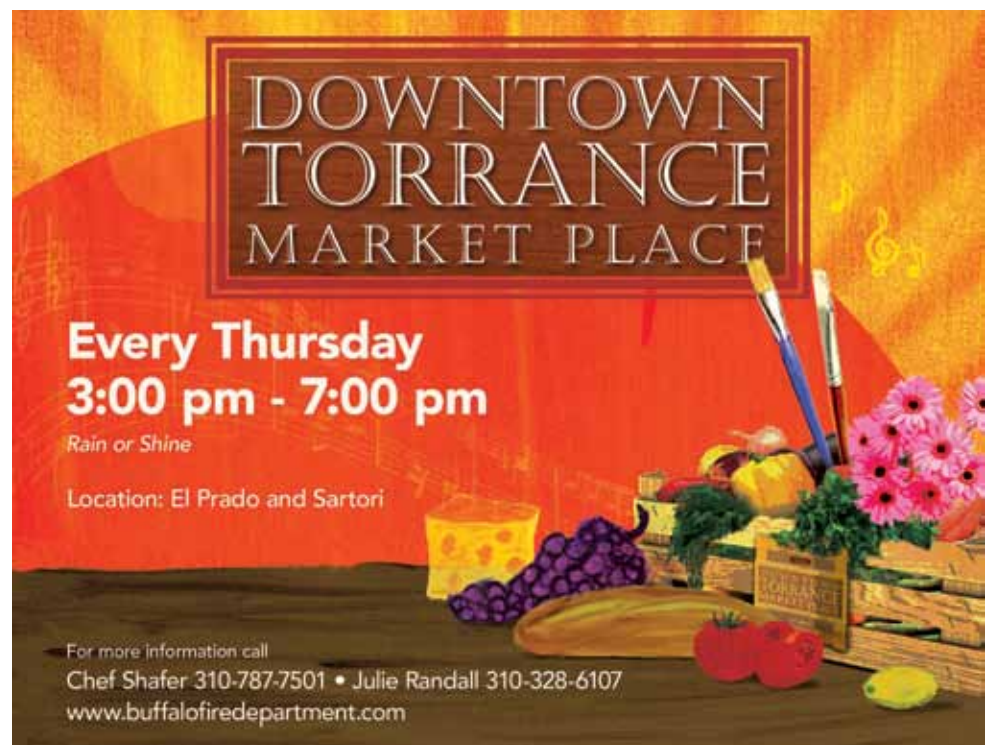
Ingredients

- 12 foil cupcake liners
- Nonstick cooking spray
- 2 pkgs. (8 oz. each) cream cheese, at room temperature
- 1/2 cup granulated sugar
- 2 teaspoons ground cinnamon
- 1-1/2 tablespoons all-purpose flour
- 1 teaspoon vanilla extract
- Pinch of salt
- 2 large eggs
- 1/2 cup Libby's 100% Pure Pumpkin
- 2 tablespoons Pumpkin Spice Flavor Nestle Coffee-mate Liquid Coffee Creamer

Preparation
