Closer to the South Bay Life Gets Better

If South Bay residents seemed distracted these past few weeks, it’s understandable. The run-up to the heavyweight presidential contest grabbed everyone’s attention and the knockout finish hasn’t let go.

The three-week-old transition of power unfolding in Washington has lived up to the Irish proverb, “may you live in interesting times.” While many of us were looking away, recent events occurred here at home that should give South Bay residents, their families and friends reasons to be thankful today. There are plenty of reasons to look forward to 2017. Here are just a few:

Boeing Co. announced it is moving 1,600 jobs to Southern California as part of a reorganization aimed at winning more contracts. The aerospace contractor by 2020 plans to move jobs from the Boeing plant in Huntington Beach to El Segundo, Long Beach and Seal Beach. The company will close down sites in El Paso and Newington, Virginia to operate its defense, space and security businesses more efficiently.

Relief from high gas prices is expected to continue and give Californians more disposable income next year. A new report by an oil industry watch group says that oil-producing members of OPEC aren’t expected to lower their daily output of crude oil anytime soon. The U.S. meanwhile has stockpiled oil reserves, adding to the glut of domestic oil that had driven crude prices below \$100 per barrel. Southern California motorists are paying under \$3 per gallon for regular unleaded—nearly \$1 less than they were paying 15 months before.

A majority of adults like their health care. A UCLA study published last week found that most adults between 46 and 64 say they like their health plans. Ninety-two percent of the people surveyed told researchers at UCLA’s Center for Health Policy Research they like their health plans so much that they wouldn’t change unless the premiums became too costly. The center’s director, Gerald Kominski, characterized the poll results as evidence that Americans don’t think their health care system is broken. They

are satisfied with their coverage, though they are worried about their costs. The poll based its findings on interviews with 400 men and women, according to UCLA’s health center.

The Dodgers are contenders. The Chicago Cubs got the monkey off their backs by winning the World Series for the first time in a century, so could the Los Angeles Dodgers be next? With their shortstop Corey Seager being named National League Rookie of the Year and with Manager Dave Roberts picking up the award for best skipper, the Dodgers head into the 2017 season with big expectations. They haven’t appeared in the World Series since they won in 1988. They got close this season, but couldn’t keep the highly-favored Cubs from reaching their destiny. L.A. has hosted victory parades for the Lakers, Kings, Sparks and Galaxy. It has been nearly 30 years since the city hosted a World Series winner, and the Dodgers have playoff experience that should help them get over the hump.

Crime rates are dropping. California is a safer place to live compared to 20 years ago, according to the state’s Attorney General’s Office. The violent and property crime rate is half of what it was in 1995. Recently, California’s violent and property crime rate started increasing after years of decline. Robbery and aggravated assaults were down in 2015, the latest reporting year. Fewer citizen complaints were lodged against police officers, whose jobs have become more dangerous. Nearly 10,000 officers were assaulted in the line of duty last year. Citizen complaints reached their lowest level since 1988.

Jobs are plentiful right now. The U.S. economy keeps growing, creating jobs for anyone who wants one. The nation’s unemployment rate in October was 4.9 percent, approaching what economists refer to as “full employment” for Americans who are in the workforce and willing to work. The best job prospects are in health care, professional and business services, and financial services, according to the U.S. Labor Department. The tight labor market means that personal wages

could start rising soon, economists say.

Tide turning on diabetes. This issue is a personal one for my family and probably for many of yours. November is National Diabetes Awareness Month and it brings a cautious, yet encouraging message that Americans are fighting back against this disease. The number of new cases has begun falling after decades of increases. The rate of serious diabetes-related complications, including stroke, heart attacks and amputations, has dropped.

More than 29 million U.S. adults have diabetes and one-fourth don’t even know it. Diabetes accounts for 20 percent of the country’s health care spending and is the leading cause of kidney failure, leg amputations and adult-onset blindness, according to the U.S. Centers for Disease Control. A decision made by Congress in 2010 could be contributing to the recent gains. Congress authorized the CDC to roll out its diabetes prevention program nationwide. A powerful endorsement followed this year when the U.S. Department of Health and Human Services started paying for Medicare recipients who take part in the program. Health officials are cautiously optimistic about the early gains and new research into possible triggers for diabetes.

The treatment options a decade ago were limited and that is changing, reports Dr. Drew Bremer, a top diabetes researcher at the National Institutes of Health. “As a field, we are evolving and going beyond looking just at glucose numbers and focusing on the entire patient,” he said. Dr. Bremer noted that there are eight classes of drugs available to diabetes patients, and research is ongoing to guide physicians in choosing the most effective new and old medications for controlling high blood-glucose levels. Patients and their families shouldn’t expect new therapies to appear overnight.

Researchers have even found a link between coffee consumption and warding off diabetes, though it’s not because of the caffeine, they say. More work needs to be done, but that preliminary finding should lift your mood the next time you visit Starbucks. •

LAWA Named Employer of the Year by Women in Transportation-Los Angeles

Women currently serve in over 50 percent of LAWA leadership positions, from departmental managerial roles to the executive level. LAWA also provides a variety of programs that encourage women to pursue careers in transportation, including its Gender Equity Program, which strives to foster a work environment promoting equal participation of women in leadership positions at all levels, especially in historically under-represented STEM areas. Its Gateways Internship Program offers college students salaried internships while they contribute new ideas and skills to LAWA’s airports. High school students also can work at LAWA through HIRE LA’s Youth Program, introducing students to aviation-based careers through paid internships.

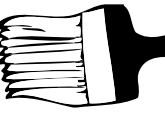

Cardinals Keep Rolling in Playoffs

When this year’s football season originally began, there were many questions about what head coach Travis Clark and his Lawndale Cardinals prospects would be. After a 28-3 win at South High in the very first game of the year, things looked good. A three-game losing streak soon followed, however, and Lawndale fans began to get nervous. An extremely young team seemingly only needed time to gel. After winning five of the last six games of the regular season, Clark has his team on a roll. A victory over West High two weeks ago in the first round of the CIF Southern Section Division 6 playoffs kept the team rolling. Now, with a 38-14 trouncing over Summit in the quarterfinals last Friday night at Lawndale, the Cardinals have a CIF championship on their minds.

In the first half, the football game between the Lawndale Cardinals and the Summit SkyHawks was like a heavyweight fight. Both teams were trading punches, attempting to get over on the other. With under a minute to go in the first quarter, it was Summit that landed a huge punch. A 35-yard touchdown pass gave the SkyHawks a 14-7 lead after a completed two-point conversion. That’s when Jordan Wilmore came to the rescue for Lawndale. Wilmore tied things up just before the end of the quarter, and despite a scoreless second quarter of play was ready to explode in the second half.

Summit star running back Stephen Carr looked to continue his magnificent season and make a case for player of the game when he began the second half with a 45-yard kickoff return. After Summit eventually punted, however, it was all Wilmore. A 23-yard run in the third quarter by the Cardinals running back set up quarterback Jalen Hamler’s 26-yard touchdown pass to get things going and give his team the lead. On their next possession, Wilmore broke free for a 40-yard run and later dove into the end zone to double up on Summit with a 28-14 lead just before the third quarter came to an end. “Wilmore was so motivated because of Carr,” Clark explained. “He watched a lot of tape of him.” Carr finished the game with 143 yards. Wilmore had 325 and four touchdowns.

“Carr is really good,” Wilmore explained. “But I want to be better than him.” It looks as if Wilmore proved his point. With the lead in hand in the second half, the Cardinals turned to Wilmore and the power running game. “We turned to our offensive line and put the ball in the hands of our sophomore running back,” Clark explained. It paid off. Summit was never able to get back into the game and as time ticked off the clock, the SkyHawks would remain scoreless throughout the second half. Wilmore capped things off with a touchdown in the fourth quarter to seal the deal for his team.

Hamler finished the night going 11-for-17 through the air for 138 yards and a touchdown. Ahmir Wilson totaled 53 yards and a touchdown. It was Wilmore who was the star of the night, though, and helped Lawndale (8-4, 4-1) advance to the CIF Southern Section Division 6 semifinals where it will take on the Paraclete Spirits and look for a chance to advance to this year’s CIF championship game.

HAWTHORNE

The Hawthorne Cougars struggled to get much going in a down year for their football team this season. A traditionally competitive Ocean League saw three teams battling it out for first place all season long. Hawthorne would finish in fourth place and while head coach Donald Paysinger and his team saw losses come in bunches, their victories proved to be dominant and gave fans hope for the future.

Paysinger and the Cougars had trouble coming out of the gate this year. A 35-21 loss to La Canada to open the season was followed up by a 42-0 blowout win over Rivera in which starting quarterback Andrew Kalinowski threw for 110 yards and three touchdowns. Following their first victory of the season, however, Hawthorne would fall victim to a three-game losing streak that led into the beginning of league play. Coaches often say that the start of league play is like the start of a new season. Hawthorne won its first two games over Beverly Hills and Santa Monica respectively and looked like a brand new team. Unfortunately, the Cougars’ hopes of turning their season around would be dashed after yet another losing streak. Hawthorne (3-7, 2-3) fell in its last three games of the year to take a fourth place finish in the Ocean League Standings and miss out on this year’s playoffs.

INGLEWOOD

The Inglewood Sentinels remained competitive in an extremely aggressive Bay League behind head coach James Sims early on this season. The year was really a tale of two halves. The first half was before league play started, while the second half was post-league-play competition. Before league, Inglewood put together some nice wins. A 34-7 victory over Angelou to start the year gave the Sentinels some momentum. A 64-0 blowout over Blair and a 22-19 win over Pioneer soon followed.

Once league play began, though, Inglewood looked like a completely different team. Ultimately, however, it was USC that broke free, shook the Bruins off and ran away with a victory. In what was still a relatively exciting game, the Trojans came away with a 36-14 win.

A pair of players attempted to make themselves household names in the first half. For the Bruins, it was Jordan Lasley. Lasley caught two first-half touchdown passes from starting quarterback Mike Fafaul, one of which got the Bruins out to an early 7-0 lead. Lasley took a mid-range, dump-off pass 56 yards for a touchdown in the opening moments of the game, much to the delight of the home crowd at the Rose Bowl in Pasadena. The Trojans would respond when Ronald Jones got his fantastic night started with a one-yard TD plunge to tie things up at 7-7. To the Bruins’ and Lasley’s credit, they stuck with the game plan. The wide receiver beat Adoree Jackson early in the second quarter for his second touchdown of the night to give the Bruins the lead once again at 14-7.

Unfortunately for UCLA, that was the last lead of the night that they would enjoy. It wasn’t long before the Trojans would get rolling. That would happen on the wheels of their running back, Jones. Jones took the ball, busted through the seam and ran for a 60-yard touchdown that not only tied the game, but proved to be the turning point on the night. Not long after, De’Quan Hampton scored the first of his two touchdowns on the night to give his team the lead. USC never looked back. It was 23-14 at the half and by the end of the third quarter, the Trojans had pretty much put things away with a 30-14 advantage.

UCLA managed all of its points in the first half before being completely shut down by the USC defense. “It was just a really tough and humbling night,” Bruins head coach Jim

five of their last six games.

The Trojans, on the other hand, are riding high after their victory--not only because they put a whooping on their biggest rival in history, but also because they have finally put a horrid beginning of the season behind them and remain in contention for a Pac-12 South title. “We still need a little help, but now we’ve set our mark at 7-2,” USC head coach Clay Helton explained. The Trojans will finish the regular season off against Notre Dame this week. They’ll need to win that game and have Utah beat Colorado--a team that lost at USC last month.

Trojans quarterback Sam Darnold passed for 267 yards in the 86th meeting between the two teams. Jones rushed for 121 yards and two touchdowns. USC has now won seven games in a row and has claimed the Victory Bell for the second consecutive season. The Trojans have now won 14 of their last 18 meetings with Bruins and the all-time series now stands at 46-31-7 in favor of USC.

The Bruins are headed for their final game of the regular season versus Cal and for the most part can’t wait for the season to simply be over. Despite a tough defense that continues to fight in every game, UCLA simply doesn’t have the firepower on offense, especially after starting quarterback Josh Rosen went down with a shoulder injury that ended his season. USC, on the other hand, simply keeps getting better under Helton. Darnold explains that with their new head coach there is “a shift in culture that you can sense now.” Darnold, Jones, and Hampton highlight a powerful offense that seems to have really found itself toward the end of the season. It may be too late to win the Pac-12 South and advance far enough up the standings to have a shot at this year’s playoffs, but the Trojans will try to prove their point and make an impact in their last game of the regular season this week against Notre Dame. •

Wireless Home Phone Devices Offer Savings And Mobility

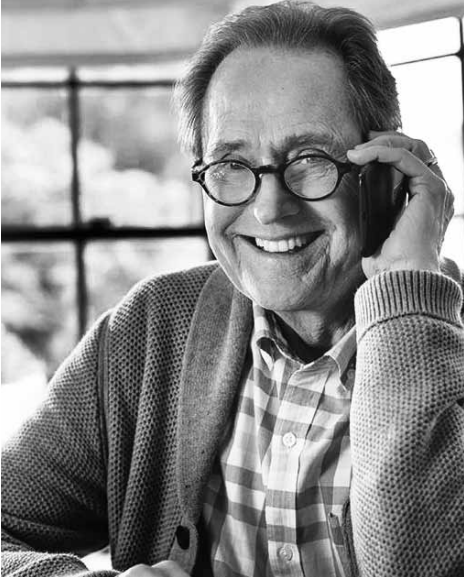
(BPT) - It seems more and more of us are “cutting the cord” these days, moving away from hard-wired connections to cable TV, internet service and more. The freedom to go wireless offers options that we couldn’t have imagined just five or 10 years ago - you can stream movies on your phone while sitting in the backyard, or do a Google search as you wait in line at the grocery store.

The last bastion of hard-wired service, the good old home telephone, is undergoing this transformation as well. Cellular providers now offer devices that let you turn your traditional home phone into a line on your cellular account. You keep your home phone number, and even continue using your existing home telephone. But you’re no longer required to stay tethered to phone jacks - nor do you have to keep your home phone at home.

Small Device, Simple Setup

Wireless home phone service is offered under various names - usually Wireless Home Phone or Home Phone Connect. It allows a regular wired telephone to connect to cellular networks as if it were a mobile phone.

Connections are made via a small device you can place almost anywhere in your home. It’s about the size of a wireless router, and contains the necessary electronics to provide voice-only telephone service to your phone from one or two jacks on the back of the unit.



It also has a small radio antenna and a transceiver for the wireless side of the connection.

The only plug-ins required are your phone (or its charging base) into one of the rear jacks, and a power cord. Most wireless home phone devices also include LED indicator lights on the front to show signal strength and indicate waiting voicemail messages.

Savings On Landline, Long Distance

If you already have cellphone service, you can add wireless home phone to your account for the cost of purchasing the device (expect

to pay around \$50), plus the cost of adding a secondary line for the service, which can be as little as \$10 per month.

With most carriers, you’ll simply share the airtime minutes on your existing monthly cellular plan with your home phone line. Nationwide coverage is also a feature of most cellular calling plans, so in addition to your redundant landline service, you eliminate the need for a long distance carrier. There are even special rates just for seniors: for instance, Consumer Cellular, which specializes in service to users over 50 years of age, offers no-contract, post-paid plans at discounted rates to AARP members.

If you don’t currently have cellular service, you can still convert your landline to mobile simply by ordering a wireless home phone device, then signing up for a monthly service plan that covers the number of minutes you’re likely to use each month.

Never Miss A Call - Anywhere You Go

Wireless home phone service redefines the meaning of “home.” The device is completely portable, so your service is, too; you can make and receive calls anywhere you have access to a cellular signal and an electrical outlet. Set it up anywhere you want in your home - you’re no longer restricted to locations near a wall jack.

Perhaps more significantly, you can take

it with you to a second home, a hotel or even a campsite and still receive calls made to your home telephone number, if cellular reception and a power source are available. It also works well with home phones that have additional handsets. By connecting the wireless home phone device to the base of your primary cordless phone, it becomes accessible to your other cordless extensions, giving you even more calling flexibility.

Making The Cut

Like any cord cutting measure, wireless home phone service isn’t necessarily for everybody. Your telephone service becomes completely dependent on a cellular signal - if, for instance, the nearest cell tower experiences an outage, you’ll be unable to make anything except emergency calls. There’s also no data signal on the line, so wireless home phone devices can’t be used with medical monitoring devices or fax machines.

But if you’ve been seeking a way to cut the costs of your landline service while also keeping your longtime home telephone number, it offers a practical and affordable solution. You save on monthly service, eliminate long distance charges, and the portability offers true modern luxury, especially for “snowbirds” or retirees who travel frequently. It’s a nice way to make yourself feel at home - wherever you go! •

RESOLUTION NO. 17-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA DECLARING ITS INTENT TO VACATE STREET EASEMENTS ON PORTIONS OF RAILROAD PLACE, CABLE PLACE AND FLORENCE AVENUE; TO EXEMPT THE VACATIONS FROM GOVERNMENT CODE SECTION 65402; AND SETTING THE TIME AND PLACE FOR A PUBLIC HEARING ON THE PROPOSED VACATIONS AND PROVIDING NOTICE THEREOF.

WHEREAS, pursuant to Division 9, Part 3, Chapter 3 of the Public Streets, Highways, and Service Easements Vacation Law, Streets and Highways Code Section 8300 et seq. ("Street Vacation Law"), the City of Inglewood ("Inglewood") is authorized to vacate street easements when the street easements are unnecessary for present or future purposes; and

WHEREAS, the City has received applications from Los Angeles County Metropolitan Authority ("LACMTA") requesting that Inglewood vacate certain portions of Redondo Boulevard, Cable Place and Florence Avenue to accommodate the construction and future operation of the Crenshaw-LAX Light Rail System; and

WHEREAS, prior to adopting a resolution of vacation, the Inglewood City Council is required by the Street Vacation Law to set a public hearing at least 15 days from the adoption of this Resolution of Intent at which time the City Council will receive evidence and testimony concerning whether those portions of the streets easements to be vacated are necessary for any present or future public use as streets easements and whether the vacation is in the public interest; and

WHEREAS, it appears that Inglewood may not have a present or future use for those portions of Redondo Boulevard, Cable Place and Florence Avenue that LACMTA has requested be vacated; and

WHEREAS, Government Code Section 65402 requires that the Planning Agency of Inglewood make a determination that the vacation of street easements is in conformity with Inglewood's General Plan prior to vacating the street easements unless the Inglewood City Council finds that such vacations are exempt from the Planning Agency determination pursuant to Government Code section 65402 (a)(3); and

WHEREAS, Inglewood intends to vacate its street easement in that portion of Redondo Boulevard particularly described in Exhibit "A" and depicted in Exhibit "A-1", which exhibits are incorporated herein as if set

forth in full; and

WHEREAS, Inglewood intends to vacate its street easement in that portion of Cable Place particularly described in Exhibit "B" and depicted in Exhibit "B-1", which exhibits are incorporated herein as set forth in full; and

WHEREAS, Inglewood intends to vacate its street easement in that portion of Florence Avenue particularly described in Exhibit "C" and depicted in Exhibit "C-1", which exhibits are incorporated herein as set forth in full.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Inglewood does find and determine as follows:

SECTION 1. That the hour of 2:00 p.m. on Tuesday, December 6, 2016, in the Council Chambers of City Hall, One Manchester Boulevard, Inglewood, California, is hereby fixed as the time and place when and where all persons interested in or objecting to the proposed vacations may appear before the Inglewood City Council and offer evidence in relation thereto. However, in the event the City Council meeting of December 6, 2016, is not held, the aforementioned public hearing for interested persons to object to the proposed vacations shall be automatically rescheduled to occur at the next regularly scheduled City Council meeting at the same hour and location.

SECTION 2. That the proposed street easement vacations involve the disposition of unused right-of-ways and thus are exempt from the Planning Agency determination pursuant to Government Code section 65402 (a)(3).

SECTION 3. That the Inglewood Director of Public Works is hereby directed to cause notices of said hearing on the vacations to be posted as required by the Street Vacation Law and specifically Streets and Highways Code sections 8320(b) and 8323.

SECTION 4. That the City Clerk is hereby directed to cause a notice of the hearing to be published in accordance with the Street Vacation Law and specifically Streets and Highways Code sections 8320(b) and 8322.

BE IT FURTHER RESOLVED that the City Clerk shall certify to the adoption of this resolution and the same shall be in full force and effect immediately upon adoption.

PASSED, APPROVED, AND ADOPTED at a regular meeting of the City Council of the City of Inglewood, California, this 15th day of November, 2016.
