Inglewood Police Department Invites Community To Stuff The Trailer

The first-ever Inglewood Police Department "Stuff the Police Trailer" event is in full swing and Inglewood residents are being asked to join the effort on Saturday, Dec. 5 from 6 a.m. to 6 p.m. on Grevillea Avenue, between Regent and Queen Streets.

"In the spirit of the upcoming holiday season, the Inglewood Police Department is sponsoring its initial "Stuff the Police Trailer" event," state the IPD press release. "This event is geared to assist needy families who are experiencing difficulties during this holiday season. It is a time where we invite the community to come out and "Stuff the Police Trailer" with new and unused unwrapped toys."

Members of the IPD and Santa Claus will greet individuals donating toys during the all-day collection event. Since Nov. 27 unwrapped gifts have been accepted at the IPD Station located at One W. Manchester Blvd., in the lobby area. Gifts will be screened and delivered to select Inglewood families that have been determined to be in need, so that parents can provide gifts for their children.

"Every holiday season there are thousands of families across the United States who experience some hardship that prevents them from having an enjoyable holiday season," states the press release. "By participating in the "Stuff the Police Trailer" event, we can do our part to help needy families within the Inglewood community."

Art Consultant Selected To Commission New Public Art Plan

Inglewood Mayor James T. Butts and members of the city council approved the Hollywood Park Casino Phase I Public Art Plan

presented by art consultant Tiffany Lendrum. Lendrum, the principal of Lendrum Finer Art for the commissioning of the new artworks, will include a variety of artworks and artists dedicated to using different mediums for their work.

"This event is geared to assist needy families who are experiencing difficulties during this holiday season."

Phase I of the project's art plan will allow the developer to contract the artists for the commissioning of artwork. The cost for the approved phase is set at \$225,500 and so far will include a large ceramic flower bouquet and vase on an exterior pedestal [by artist Matt Wedel], as well as a series of site-related still frames on alumni created by Inglewood artist Michele Asselin. The developer is also proposing the purchase of undated works of art from Los Angeles' artist's Zoe Crosher series "Out the Window," which includes six panels of lighted photographic prints highlighting airplanes as observed when looking out of a window. Also being considered is the purchase of photographs taken by James Welling between 1998 and 2001.

"The developer, Hollywood Park Casino Club Investors, LLC, hired Fine Art to create a phased public art plan for the Casino," indicates the staff report signed by Parks,

Recreation, and Library Services Director Sabrina Barnes. "They are proposing to meet the City's private percent for art requirement through a multi-phase public art plan to address the multiple parts of the development which may include publicly accessed water features and a professional sports stadium."

Based on construction valuation of the new non-residential private structure, as well as other non-residential project, when a project will cost no less than \$250,000 in the City of Inglewood the developer is mandated to provide 1 percent of the development's value to public art. The developer may meet such a requirement by paying an "in-lieu fee" or by incorporating artwork into a development project. Based on the multiple partnerships needed for this large-scale project, an incremental approach to the public art plan was required.

"The developer has full commitment and control of the architectural enhancements of the Hollywood Park Casino, a 21 and over gambling facility," states the staff report. "The public art for the Casino's Phase I Art Plan will be at the entryway, visible to the general public, and works on paper for the interior walls accessible only to adult audiences."

Featuring commercial, residential and recreational facilities on the same site and under the same development plans, makes The Hollywood Park Land Company project is one of the largest projects in the city's history. The former site of the Hollywood Park Racetrack and Casino, will begin with the construction of a new casino and will include a valuation of public art in the amount of \$491,870. •

El Camino College Journalism Program Wins National Awards

El Camino College’s journalism program won several national awards at the recent Associated Collegiate Press (ACP)/College Media Association (CMA) convention in Austin, Texas.

The Union, El Camino College’s student newspaper, was selected as Newspaper of the Year in the less-than-weekly category in Associated Collegiate Press competition with other two-year colleges. The newspaper was honored for editions overseen by former editors-in-chief Matthew Simon and Jessica Martinez.

Martinez also received ACP’s second-place award for Reporter of the Year and first-place honors from CMA for Best Online Infographic. Now a student journalist at New York University, Martinez was an El Camino College Presidential Scholar.

Eugene Chang was given CMA’s third-place award for editorial cartooning, and the campus magazine, Warrior Life, received ninth place in ACP Best of Show judging.

ACP recognized the Union earlier this year when it was named a finalist for one of college journalism’s premier honors, the Pacemaker Award.

The Austin convention, which drew about 2,000 journalists and advisers, offered hundreds of sessions, keynote addresses, hands-on workshops, special events, critiques and a trade show.

In addition, The Union won a total of eight awards from the Journalism Association of Community Colleges at a recent awards ceremony at Fullerton College. A co-third place in newspaper general excellence was awarded, as well as a third place for the magazine “Warrior Life.”

Former photographer Amira Petrus and current editor-in-chief John Fordiani won second place in the magazine photo essay category. Fordiani and photo editor Jorge Villa also won fourth and second place, respectively, for their sports action photos. Longtime cartoonist Eugene Chang won second place for his artwork, and former editor Jessica Martinez won third place for her informational graphic on the history of the school’s football stadium.

The Union, which is run by students enrolled in Journalism 11 - Newspaper Publication, has been a leader in community college journalism since it began publishing in 1946. •

Tax Tips For Newly Married Couples



(BPT) - In most parts of the country, the months of June, August, September and October are the most popular for weddings. Whether recently married or anxiously counting the days until you tie the knot, there are some important tax implications that you and your spouse can’t afford to overlook.

“In between the flurry of wedding planning, dress shopping and bridal showers, few engaged couples stop to think about how getting married will affect their income taxes,” explained TaxAct spokesperson, Shaunna Morgan. “While it’s important to understand the tax consequences, keep in mind that you can still do your own taxes. TaxAct, a leading DIY tax solution, asks simple questions about life events like marriage to guide you through the tax implications and help you get all of your deductions to maximize your refund.”

Name Changes

Your name(s) and Social Security number(s) are critical elements of your tax return. Both identifiers must exactly match the information the Social Security Administration (SSA) has on file. That means if you legally change your name after you get married, the SSA needs to know about it.

To get a Social Security card with your new name, you’ll need to provide proof of identity, such as a marriage certificate, fill out an application and either mail it or deliver it in person to your local SSA office.

You’ll want to do this long before you file your income tax return.

New address

If you’re moving, remember to report your new address to the Internal Revenue Service (IRS). The fastest way to make the change is to complete Form 8822 available on the agency website at www.irs.gov.

New Filing Status

Once you’ve said, “I do,” you’ll have the option to claim one of two filing statuses on your tax return: married filing jointly or married filing separately. If you and your spouse each earn an income, you might consider running the numbers to determine if you have a lower combined tax by filing

one way versus the other. Some tax software packages do the calculations for you so it’s easier to make an informed decision when selecting a filing status. TaxAct Deluxe, for example, gives users a Joint vs. Separate Analysis report that does all the calculations so you can see your estimated refund amounts for each filing status. For many couples, married filing jointly results in lower income tax liability.

Keep in mind that no matter when in the year you get married, you are considered married for the full year. Even if your big day is December 31, you will have a married status in the eyes of the IRS for the entirety of that tax year.

Changing Your Tax Withholding

Any time you have a life change you should revisit your Form W-4. Getting married is definitely one of those times. If both you and your spouse work, you’ll likely have a higher combined income, which may put you into a higher tax bracket. In order to ensure the right amount of tax is withheld from your paycheck, you’ll want to update your Form W-4 to ensure you aren’t having too much or too little tax withheld.

Affordable Care Act

Premium Tax Credit

If you or your spouse receive health insurance through a government-sponsored marketplace and receive advance payments of the premium tax credit to help offset the cost of your premiums, you’ll want to review your coverage after the wedding, and notify the marketplace of your newly married status. Reporting this change will help you avoid having too much or too little premium assistance paid and ultimately, help you steer clear of owing additional money or getting a small refund when you file your taxes. If you elect to keep your coverage “as is,” separate from your spouse, or wish to add your spouse to your coverage, you should notify the marketplace of your special changes in coverage. If you elect to go under your spouse’s health plan, be sure to cancel your marketplace coverage. •

Film Review

Peggy Guggenheim: Art Addict Tells of One of Modern Art’s Biggest Influencers

Spending time surrounded by art in Los Angeles has been an increasingly popular cultural activity lately. With the opening of the new contemporary art museum, The Broad, in Downtown LA, the millennial generation is seeming to put a bigger significance on experiencing art in person (but whether or not this is just for social media purposes is a topic for another day). The El Segundo Museum of

the film was based off of. Director Lisa Immordino Vreeland uncovered the recordings between Peggy and Jacqueline in Weld’s basement and upon hearing the tapes, knew Peggy’s story had to be visually told. The interview with Weld would also be the last Peggy ever gave before her death and Vreeland treats the significance of these tapes with the utmost respect and care when executing the film. Art, appropriately called an “Art Laboratory”, is another example of the community’s demand for a creative outlet. From Submarine Deluxe comes the documentary *Peggy Guggenheim: Art Addict*, a colorful biography about one of the biggest influencers in art history, the notoriously unconventional grande dame, Peggy Guggenheim.

Everyone who knew Peggy loved her for her eccentricity and uniqueness. An heiress to the Guggenheim family fortune, Peggy often called herself the “black sheep” of her upper-class family. She loved being the center of attention and even shaved off her eyebrows as a teenager in rebellion to her perception of society’s pressure on young women at the time. Peggy reveals her tragic upbringing, which included the death of her father when he drowned aboard the Titanic, to her biographer Jacqueline B. Weld in audio tapes that were long thought of as lost, but thankfully have been found, for audiences to enjoy. These tapes went on to become the subject of Weld’s 1986 biography, “The Wayward Guggenheim,” and from which

transports the viewer back to bohemian Paris in the ’20s and into the fast-paced lifestyle of a young Guggenheim.

The “who’s who” of the avant-garde world, including Marina Abramovic and Larry Gagosian, the art dealer who owns the Gagosian Gallery chain of art galleries, reminisce about Peggy and the life-changing contributions she made to the art world. From giving Jackson Pollock his first break to being credited as one of the first galleries to mix European and American art, Peggy’s candidness and vulnerability while talking to Weld are both inspiring and heartbreaking.

Peggy Guggenheim: Art Addict is just as abstract, colorful, and spectacular as Ms. Guggenheim herself was. The film will leave viewers with a sense of wanderlust and admiration for a woman who helped define the art world as we know it today. A nonstop ride with constant surprises, *Guggenheim* premiered at the Tribeca Film Festival earlier this year and is now playing at the Laemmle Playhouse 7 and the Sundance Sunset in West Hollywood. •

Hawthorne Captures Harbor Classic

Hawthorne High's boys' basketball team began its 2015-16 season well by winning the Harbor Thanksgiving Classic with a 63-57 victory over Central City Value High last Saturday at Los Angeles Harbor College.

The Jaguars (2-1) started off with a 20-13 first quarter lead before the Cougars (3-0) bounced back to outscore Central City 20-12 for a 33-32 halftime lead. Hawthorne outscored the Jaguars in each of the next two periods to put the game away.

Last Friday, the Cougars won a shortened game over Animo Venice 47-24. The contest ended late in the third quarter due to the ejection of the Animo Venice head coach because of receiving his second technical foul.

Leading 28-21 at halftime, the Cougars pulled away by outscoring Animo 19-3 in the third period before the abrupt end of the contest.

Hawthorne began the tournament with a 64-47 victory over Mayfield on November 25.

Devin and Christian Brown keyed the Cougars in the games but stats were unavailable.

Hawthorne hosted Manual Arts yesterday, and visit always tough Compton, which placed fifth with a 54-51 win over Inglewood in the Redondo Pacific Shores Tournament on Saturday, next Tuesday at 7 p.m.

Inglewood Splits in PAC Shores: Inglewood High's boys' basketball team finished in sixth place in the Redondo Pacific Shores Tournament after a 54-51 loss to Compton last Saturday.

The game was close most of the way but the Tarbabes (3-1) were able to finish out on top of the fifth place final.

Terrell Gomez led the Sentinels' balanced scoring attack with 15 points, followed closely by D'Angelo Smith with 14 points and Jordan Bell with 13.

In a fifth place semifinal contest on Friday, Inglewood rolled over Bay League foe Rolling Hills Estates Peninsula 67-44.

After a close first quarter, the Sents proceeded to outscore the Panthers 40-20 in the next two quarters to pull out to a 23-point (52-29) lead. Inglewood continued to have a commanding

lead from there.

The Sentinels were led by Smith with 23 points and 13 rebounds. Jordan Bell added 15 points and eight rebounds and Gomez contributed 14 points and eight assists.

In the championship quarterfinals on November 25, Inglewood faced a very good but shorthanded Long Beach Poly team. The Jackrabbits, who lost in the championship finals to host Redondo 64-49 on Saturday, led most of the game but the Sents kept it close and even had a few ties and brief slim leads.

Poly, though, was able to pull out a 62-59 victory over Inglewood.

Chandler Hunter led the Sentinels with 17 points. Bell chipped in 13 points and Gomez had 11. The Jackrabbits were led by a game-high 23 points from Zafir Williams.

Poly, though, was without three key players due to a combination of injuries and one who was not yet eligible. Once those players are back, the Jackrabbits will be expected to be much harder to beat.

On November 23, Inglewood began the tournament by defeating Hart High from Newhall 73-62.

GIRLS BEGIN SEASON

Like the boys, the girls' basketball season is underway. Hawthorne began its season last Friday in the Downey Classic, losing to the host team 52-34.

The Lady Cougars resume the tournament through this week.

Hawthorne hosts Compton in a non-league game next Tuesday at 6 p.m. The Cougars play in the Artesia Tournament against Buena Park on December 15.

Hawthorne also vies in the Larry Doyle Orange County Tournament where it opens in December 26 against defending CIF-Southern Section Division IIAA champion Redondo.

The Cougars' first league game is at home against Santa Monica on January 13.

Lawndale is currently playing in the highly competitive Redondo Battle at the Beach Classic where it opened Tuesday against Peninsula. The Cardinals play today against CIF-L.A. City Section power Narbonne at 5 p.m. and Friday versus Cerritos Valley Christian starting at 2 p.m. The finals are on Saturday.

Morningside, a one-time power that has not enjoyed much success lately, is under first-year head mentor Chika Ogoko and hopes for big improvement from its 4-20 season, including 1-9 in the Bay League mark from last season.

The Lady Monarchs begin next Wednesday in the Norwalk-John Glenn Tournament. Morningside starts the Bay League at Peninsula on January 13.

Next Tuesday, the Sentinels will take on defending CIF-L.A. City Section Division I champion Palisades next Tuesday in the St. Monica Tournament in Santa Monica.

More Than A Million Americans Are Unaware They Are Infected With A Potentially Life-Threatening Virus

(BPT) - After receiving blood transfusions in 1979 during the birth of her last child, Mary Lambert, a human resources professional and former teacher, thought her health ordeal was over. Little did she know that, due to those transfusions, she had become infected with the hepatitis C virus (HCV).

In fact, Mary didn't have any indication that she was suffering from chronic hepatitis C, a potentially life-threatening viral infection, until she tried to donate blood in 1993, nearly 15 years later. Mary didn't experience any symptoms for more than a decade and was unaware that HCV was slowly damaging her liver, ultimately leading to liver scarring.

What is HCV?

Unfortunately, stories like Mary's are not uncommon. HCV, the most prevalent chronic blood-borne infection in the United States, affects more than 3 million Americans and causes approximately 15,000 deaths each year.

HCV is the number one cause of liver failure and liver-related death and a major cause of liver cirrhosis and liver cancer. HCV is also associated with a variety of other conditions, including diabetes, thyroid disease and kidney

disease.

As in Mary's case, HCV is often a "silent disease." However, when symptoms occur, they can include fatigue, joint pain, nausea, vomiting, fever, loss of appetite and abdominal pain. The good news, however, is HCV can be cured - meaning the virus is undetectable in the blood when checked three months or more after completing treatment.

Who does HCV affect?

Baby Boomers, or people born between 1945 and 1965, are disproportionately affected by HCV, accounting for three out of four people with the virus. Among other ways, HCV can be spread via contaminated needles (from tattoos, needle sticks or intravenous drug use). In addition, before the availability of widespread screening of the blood supply in 1992, the virus was often spread through blood transfusions (as in Mary's case) and organ transplants.

Why is screening so important?

Like Mary, up to 75 percent of those infected with HCV are unaware they have the virus. Because of this, testing for HCV is vitally important. Scientific advances in the last few years have resulted in treatments that are shorter

and more effective than in previous years, thus making a cure possible for more patients.

Who should get tested?

The U.S. Centers for Disease Control and Prevention (CDC) recommends the following people get tested for HCV:

- Anyone born from 1945 through 1965
- Anyone who received donated blood or organs before 1992
- Health and safety workers who have been exposed to blood on the job through a needle stick or injury with a sharp object
- Anyone born to a mother with hepatitis C
- Anyone with certain medical conditions, such as chronic liver disease and HIV or AIDS
- Anyone who has injected drugs, even just once or many years ago
- Anyone with abnormal liver tests or liver disease
- Anyone on hemodialysis

How do you get tested?

Physicians use a blood test called a hepatitis C antibody test to determine if a person has been infected with HCV. If the results come back non-reactive, or negative for antibodies, the person does not have HCV. If it is reactive,

or positive for antibodies, the person has been infected at some point but does not necessarily have the virus at that time. A second blood test, called an RNA or PCR test, is needed to confirm if the person is currently infected with HCV.

What should you do if you have the chronic hepatitis C virus?

If both tests indicate a person is infected with HCV, it is important to consult a hepatitis C specialist to discuss the opportunity for treatment and to potentially be cured.

Mary recently finished taking a treatment regimen that has made the virus undetectable in her blood. She is hopeful that she will get the official word (three months after the end of treatment) that she is cured. "I had pretty much given up hope that there could be a cure for me," Mary said. "But there are more HCV treatment options available than there used to be." She encourages anyone who thinks they may be at risk to ask their doctor to be screened and, if diagnosed, seek care from a hepatitis C specialist.

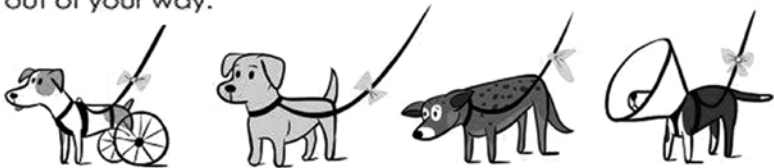

Apple, Gouda and Farro Salad



Makes 6 servings as a side dish, or 4 servings as a meal

Ingredients

- FOR THE SALAD**
- 1/2 cup roughly chopped walnuts
 - 6 cups mixed greens
 - 1 large apple, core removed and thinly sliced
 - 6 ounces Arla Dofino(R) Gouda cheese, cut into cubes
 - 1 cup cooked farro
 - 1/3 cup dried cranberries
- FOR THE APPLE CIDER VINAIGRETTE:**
- 1/4 cup olive oil
 - 1 1/2 tablespoons apple cider vinegar
 - 2 Teaspoons honey
 - 1 Teaspoon Dijon mustard
 - 1 Teaspoon minced shallot
 - Salt and freshly ground black pepper, to taste

Preparation

1. First, toast the walnuts in a small skillet over medium heat, stirring frequently. Cook until the walnuts turn brown and smell toasted. This will take about 5 minutes. Transfer to a small bowl to cool.
 2. Place the greens in a large bowl. Top with sliced apples, Gouda cheese cubes, farro, dried cranberries and toasted walnuts.
 3. To make the vinaigrette, whisk together the olive oil, apple cider vinegar, honey, mustard and shallot. Season with salt and black pepper, to taste. Drizzle the salad with the vinaigrette and gently toss. Serve!
- Note:** Honeycrisp or Granny Smith apples are great options, but any apple variety will work.
