Drivers Need to Wake Up and Sleep Better

The Automobile Club has a few words for area drivers about sleep: You're not getting enough.

That recommendation follows the AAA's startling discovery that as many as 10 percent of injury crashes are being caused by drowsy drivers who can't stay awake. A Southern California official with the group says no matter what tricks they try, drivers can't fool their bodies into feeling rested. Drowsiness is as bad as the other D-words -- like drinking alcohol and distraction -- that are associated with injury crashes involving drivers and passengers.

Jake Nelson, the director of Traffic Safety Advocacy and Research for AAA said that "missing just two to three hours of sleep can more than quadruple your risk for a crash, which is the equivalent of driving drunk."

Traffic safety researchers with the AAA looked at dashboard-mounted video of 700 injury crashes and they detected obvious signs of driver fatigue and sleepiness right before impact. Their observations led the AAA to conclude that drowsiness is hugely underreported as a cause of injury crashes on streets and highways.

"There is not a test that clearly shows when someone is too sleepy," says the UCLA Sleep Disorders Center on its website. In the aftermath of a sleep-associated wreck, the driver who caused it can appear wide awake.

That's because their body is pulsing with adrenaline, the sleep experts at UCLA say. The logical, but often mistaken conclusion is that the driver also was alert before the crash.

Seven hours of sleep per night goes a long way in keeping drivers from nodding off at the wheel. The body can't be fooled into feeling refreshed with caffeine, which only masks the fatigue and slower reaction times, according to a Southern California-based club official.

Melissa Vega, manager of the Automobile Club of Southern California's Driving School, warned against trusting caffeine, opening the windows or singing to keep from nodding off in traffic. "Your body's need for sleep will eventually override your brain's attempts to stay awake," she said.

The AAA had dash cam video to analyze. Law enforcement officers investigating traffic collisions on scene must rely on the drivers involved to explain what led up to a crash. With the video evidence, the AAA's new research estimates that operating a motor vehicle without enough sleep is eight times higher than traffic safety experts believed.

The U.S. Centers for Disease Control and Prevention reports that 35 percent of U.S. drivers sleep less than the recommended minimum of seven hours daily. Shockingly, 29 percent of drivers admitted in a separate survey by AAA they had trouble staying awake while driving within the past 30 days. Yet,

96 percent of the respondents believed that drowsy driving is an unacceptable behavior and a serious threat to public safety.

A driver who is falling asleep will exhibit symptoms including trouble keeping their eyes open, drifting from their traffic lane, and an inability to remember the past few miles driven, according to traffic safety experts. To avoid any of these dangerous behaviors behind the wheel of a moving vehicle, the AAA recommends that drivers plan trips during times of day when they are typically awake and alert. Also, avoid driving after eating a big meal and taking medication that makes them drowsy.

And don't underestimate the good that a 20-minute power nap can do for alertness and the body's energy level, club officials say. Drinking cold water also can kick-start the body, especially for midday fatigue.

According to the National Sleep Foundation's Sleep in America poll, 60 percent of Americans have driven while feeling sleepy and 37 percent admit to actually having fallen asleep while in traffic.

Uber this week announced a new policy for drivers for their safety and their passengers. The ride-sharing company will require its drivers to take a six-hour break from driving following a 12-hour shift. To guard against drivers cheating on their time, Uber said a driver's app will be taken offline once the 12-hour limit is reached. •

Wiseburn School Board Narrows Search for Superintendent, Contemplates Bond

Last Thursday evening's 90-minute open meeting of the Wiseburn School Board revolved around the only special presentation on the truncated agenda - discussion of a possible bond measure that could face voters on the June 5 ballot. The presentation came courtesy of representatives of the research firm EMC Research, based in Oakland; and East Shore Consulting, also based in Oakland, which specializes in polling, focus groups and public opinion research consulting.

Prior to the bond presentation, the assembled board members met in closed session to winnow down the number of applicants to take over the Wiseburn Unified School District superintendent reins from Tom Johnstone, who announced his plans to retire at the end of the school year.

Over 40 candidates expressed interest in the position, with 28 applications received. Although the board members Thursday evening did not divulge how many of the applicants made the final cut, the winners will take part in face-to face interviews on the Feb. 23-24 weekend.

EMC Vice President Jessica Polsky and East Shore's Michael Riemenschneider made the 45-minute presentation (and answer session) on the results of a survey they recently completed of likely voters in the district and the feasibility of getting a \$39 million school bond passed when the voters go to the polls on June 5.

The telephone/Web hybrid survey conducted Jan. 18-30 included 220 interviews. Among the key findings, respondents have positive opinions of Wiseburn Unified and Da Vinci schools and give the District high ratings. A majority of the respondents trust the District to properly manage tax dollars. Initial support for a bond measure is at 59 percent, which is four points above the 55 percent threshold for passage. High priorities include maintaining STEM classrooms/labs and updating technology, keeping property values strong, and continuing citizen oversight of bond spending.

The survey showed Wiseburn's ratings as very positive, especially regarding the quality of buildings and grounds as well as the quality of education. Seventy-six percent of those polled feel that overall the District is doing an "excellent or good" job.

Riemenschneider, noting the positive responses, posited that now is the time to take advantage of public relations opportunities in spreading the word to voters. Nearly two-thirds of the respondents trust the District to properly manage tax dollars and are willing to tax themselves to maintain top-notch schools, but there is a substantial anti-tax sentiment. Fifty-three percent of those polled strongly or somewhat agree that they are generally opposed to property tax increases, regardless of the reason for the increase.

The proposed measure to provide innovative K-12 classrooms; 21st century technology,

upgraded facilities to prepare students for college/careers; new athletic facilities; solar panels to reduce costs; and the ability to continue improving school facilities is on the table. Despite the early 59 percent approval rate for the potential bond, it also has the caveat of lower-propensity voters included in the polling. This means that those respondents answered the poll questions, but might not actually vote.

While younger voters are "highly supportive," less than half of those who are Republicans and voters between 50 and 64 would vote yes on the measure. More than seven in 10 renters said they would support the bond, while parents polled a 71 percent approval rate.

Among the bond components included in the outreach to June 5 voters were to maintain K-12 STEAM classrooms and labs, and to keep schools well-maintained. Those items were deemed top priorities. Providing new athletic fields and solar panels, not so much.

Support for four previous bond measures in Wiseburn was higher than the numbers shown in the current polling. The consultants concluded that while passage of another bond measure appears feasible, it may be more difficult than it has been in the past given the concern that there are already too many taxes. They noted that turnout in a June election may have a significant impact since lower-propensity voters are substantially more supportive of the possible bond measure. An independently funded campaign is recommended to ensure voters understand the benefits of strengthening local schools.

Not much occurred with the rest of the meeting agenda, though the new timeline for Phase 2 of the Wiseburn construction project has been moved down the road to Sept. 12, according to Johnstone. Director of Facilities Planning Vince Madsen emailed, "We are starting to get good traction on the work at the aquatics center now that we have resolved most of the soil challenges on site, which is our Phase 2 project. With all of the challenges we have had in both phases of the project, we are still working within the original budget funds and are working very hard with the design and construction teams to keep us on budget. Even though we have had change orders going to the board monthly, we have not gone over budget yet. The approvals the board have taken action on recently are simply reallocating our already approved contingency funds to our individual trade contractors as needed. I am very proud at where we are with this very unique and challenging high school project and how we have managed the problems as a collaborative team and managed the originally allocated funds. We are not out of the woods on budget yet, but I am still very hopeful that at the end of the day we can keep the overall \$160 million cost for this state-of-the-art high school under control and have less than a 1 percent budget increase when we are completed." •

Lakers Muster Magic at Trade Deadline

Just when it looked as if the NBA would have another somewhat quiet day at the trade deadline, an overflow of news poured out across the wire last Thursday. That morning, the Los Angeles Lakers and the Cleveland Cavaliers wasted no time in making improvements to their respective rosters. At approximately 9 a.m., the basketball world was bludgeoned with a series of trades -- one of which involved L.A. A blockbuster deal sent reverberating ripples across the league when Isaiah Thomas was traded to the Lakers and Jordan Clarkson along with Larry Nance, Jr. were both whisked away to the Cavs. With that trade alone, Magic Johnson and Los Angeles hit a grand slam home run and accomplished exactly what they needed to get done in order to begin to piece the Lakers back together once again.

Perhaps the biggest thing to understand about the trade that the Lakers made with the Cavaliers last week is that for L.A., it has absolutely nothing to do with this season. Both Thomas and Channing Frye -- whom the Lakers also received in the trade -- will come off of the books next year. Since Los Angeles is heavily rumored to be in the LeBron James sweepstakes, you can almost certainly bank on the fact that Thomas won't be back in the purple and gold next season after quickly failing to synchronize with James before he

was swiftly shown the door.

For Magic and the Lakers, the key heading into next year's offseason and free agency period was to cling to the team's young talent all while avoiding financial hardship in the pursuit of LeBron and other top-ranked free agents like Paul George, for instance. While Clarkson and Nance could be classified as young talent, the core group of Brandon Ingram, Julius Randle, Kyle Kuzma and Josh Hart were all kept in place. Clarkson may have provided instant offense for the team, but his contract (two years, \$26.9 million) was one of the biggest on the roster, aside from the atrocity that is Luol Deng's multi-year deal. Magic and General Manager Rob Pelinka didn't just move Clarkson and his contract, but they also surprisingly received a first round pick from Cleveland as well -- which was huge for a Lakers team that was devoid of a pick in this year's first round because of a previously made trade for Steve Nash.

Now the Lakers won't only be out from under the Clarkson contract, but they will clear as much as \$70 million in cap space once the contracts of Thomas, Frye, Brook Lopez and Kentavious Cladwell-Pope expire at year's end. That's enough money to make Magic smile and also enough for two max contracts. "I wouldn't have made the move if I wasn't confident," Magic explained at

the team's press conference following the trade. "We have got to take the next step. I like our core. I want to have us be in the playoffs, and the only path to that is to add to the roster that we already have."

Acquiring either James and/or George isn't necessarily a lock. The Lakers have shown the tendency to strike out in free agency in recent years and could indeed do so again. LeBron James isn't necessarily what's important about having all of that cap space, either. As Pelinka puts it, the flexibility that \$70 million brings the team is what really matters the most. "There's so many different ways you can use that [cap space]," Pelinka explained. "And then, of course, the obvious way is we now have in July of 2018 and July of 2019, we now have real 100 percent space to do two max players if that's what we decide to do, or one in 2018 and then following it up with another one in 2019. So the flexibility is really amazing."

While Isaiah Thomas may be a big name in the league today, he was perhaps the least important piece that the Lakers acquired in their trade with the Cavaliers. What's more important for Thomas, at least, is that he now has less than 30 games to prove that he is still a difference-maker in this league before free agency rolls around for him once again next year. That may be easier

said than done after his debilitating hip injury and swift departure from Cleveland. Unfortunately for Thomas, the Lakers already have a point guard in Lonzo Ball and don't necessarily need a ball-dominant style of player to go alongside him who will also undoubtedly require a huge payday on the free agent market. Thomas may bring a bit of excitement to the Staples Center floor down the stretch run of this season, but all that he really represents to the Lakers and their front office is opportunity in the future.

"Let's face it: in this league, you can't have an elite team if you don't have elite players," Pelinka went on to accurately explain. "So that has to be the strategy if you want to be elite." As Pelinka knows, the NBA is a superstar-driven league -- and although last week's trade didn't necessarily bring the Lakers any real, tangible superstars, it brought the team the flexibility to go out and get those players. While the Lakers' young core continues to excel, they and their fans everywhere can rest easily knowing that help will be on the way sooner, rather than later. Once again under Earvin Johnson, the Lakers pulled off their own little piece of magic at the trade deadline and are now well on their way towards rebuilding a team that has been stuck in the mud for years now. -- Aserrao6@yahoo.com | @UpandAdam6 •

Women In Agriculture Are Challenging Stereotypes



(BPT) - About a third of the nation's farmers are women, according to the U.S. Department of Agriculture. And most of these women are working family farms, since 99 percent of all American farms are family-owned and operated. Just under 1 million women farmers contribute \$12.9 billion to the nation's economy and are responsible for farming more than 301 million acres.

More women are seeking careers in agriculture, and they're breaking stereotypes about what their roles can be. Many women in the agriculture industry are farmers who grow crops and raise animals, while others are helping advance agriculture by fulfilling non-traditional roles:

Megan Moll grew up working on her family's farm in central Michigan. Today, as a sales representative for Syngenta, she supports a network of independent seed advisers who sell the company's corn hybrids and soybean varieties. She started with the company as an intern. "If you want to go after it, go after it," Moll advises women who may be considering a career in agriculture. "Don't let anything stop you."

In 1999, Brenda Wolgamott and her husband, Duane, entered the wine-growing business; and in 2002, they created their own label - Marin's Vineyard - named for their daughter, Marin Wolgamott. At age 14, Marin

began delving into the science of winemaking, learning how to test grapes for sugar and pH levels in a lab, so she could provide the service to neighbors who would otherwise have to send their grapes to far-off labs for testing. Today, she is the winemaker for the vineyard. Marin's experience and career path demonstrate "there are different avenues to get in," she says. "Whether you want to do chemistry or love to get your hands dirty in the cellar, everyone's job in the winery is always appreciated."

Born and raised in rural Iowa, Marj Guylar-Alaniz graduated from Grand View University with a bachelor's degree in graphic design, photography and journalism, and immediately went to work in agriculture for a crop insurance company. Inspired to draw attention to the roles of women in agriculture, she founded FarmHer, an online social community for women farmers. She now hosts the award-winning television show "FarmHer on RFD-TV." "I think showing women who are successfully farming or ranching plants a seed in the younger generation," Guylar-Alaniz says. "Younger girls who are interested in getting into agriculture or carrying on a family tradition can see for themselves that they can do it."

At a time when few women went to college, let alone pursued a higher degree in a scientific field, Mary-Dell Chilton, Ph.D., had the curiosity and drive to bring about major change. When one of her students turned in a paper suggesting bacteria that caused a common plant disease could actually transfer a portion of its DNA to the afflicted plant, Chilton thought his theory was wrong. In the spirit of the scientific method, she tested it and instead found her student's theory to be true. Her research laid the groundwork for transforming how scientists conduct plant genetic research. Her work in plant biotechnology has significantly affected the global agriculture industry. "I give young people today the same advice I've given throughout my career," Chilton says. "Pursue what you love and what fascinates you, and the rest will follow."
