Inglewood City Approves In-Kind Support for Cultural Arts, Inc. Afro-Latin and Dance Festival

Members of the Inglewood City Council approved the authorization of in-kind sponsorship of the Inglewood Cultural Arts Inc., Afro-Latin Music and Dance Festival by allowing festival organizers to use the amphitheater located inside Edward Vincent Park.

Inglewood Cultural Arts, Inc. will be hosting the day-long, free music and dance festival on Saturday, Sept. 12 from Noon to 6 p.m. and organizers Mona Lisa Whitaker, Michael Massenburg and Beta Gonzalez have dedicated part of their efforts to obtaining sponsorship from the city. In return for the in-kind subsidy, the City of Inglewood will be included as an event sponsor.

“the ICA Afro-Latin and Music and Dance Festival will foster a mutually educational and cultural experience for community participants and artist alike,”

The day’s activities will include the performance and presence of traditional Cuban, Puerto Rican, Brazilian, Mexican, African American and African traditional artists.

“Through bringing together artists representing the music and dance of the aforementioned cultures and highlighting a share heritage, the ICA Afro-Latin and Music and Dance Festival will foster a mutually educational and cultural experience for community participants and artist alike,” indicates the staff report.

This isn’t the first year that the city has

agreed to approve sponsorship, as it did for the 2014 festival. ICA is a nonprofit organization in the city, but independent of the city, and is dedicated to “enhancing the quality of life through diverse and educational art programs, exhibitions, and public art projects” states the staff report.

CONTRACT AWARDED FOR VINCENT PARK SWIMMING POOL PUMP REPLACEMENT PROJECT

Members of the Inglewood City Council adopted a resolution to authorize the transferring of \$100,000 from the city’s non-department/miscellaneous-contingency reserve account [general fund] over to the city’s sports/physical activities-contract service account [also general fund] in order to address much-needed repairs for the Vincent Park Swimming Pool.

In addition, the council approved the contract from the lowest bidder, Carolino Construction Corporation for the Vincent Park Swimming Pool Pump Replacement Project.

Edward Vincent Jr. Park, a 55-acre park, is located at 700 Warren Lane and is made up of numerous amenities such as baseball fields, soccer fields, tennis and basketball courts, as well as a swimming pool complex. The staff report indicated that at the moment the swimming pool, located on the southeast section of the park, is out of order due to inoperative pumps, controllers, tanks and other mechanical issues.

City staff consulted with an electrical contractor in order to better determine what items were defective and to what extent these pumps were defective.

“A project study was completed and a project plan and specifications were

prepared to replace the defective parts in the mechanical system with the goal of and having the swimming pool operational during the summer time,” indicates the staff report. “After the bids were evaluated and references were verified by staff, it was determined that Carolino Construction was the lowest responsible bidder.”

Bids were also received from ABC Builders, Inc., MMC Inc., North Phase Electric, Inc., Torres Construction, Inc., Ybanga Construction Corporation and Torres Construction. Carolino Construction Corp. was the lowest of the six bidders, while Torres Construction was the most expensive at a price tag of \$206,000.

For Carolino Construction Corp., this isn’t the first time working in the City of Inglewood as the company recently completed the Vincent Park and Darby Park Lighting Upgrade Projects in December 2014. At an \$82,000 bid, the city approved a contingency fund of \$15,000 in order to complete the replacement of five pumps and motors, as well as tanks, controllers, automatic sliding door, and other mechanical fittings.

Students Selected as Grades of Green Finalist

Will Rogers Middle School in Lawndale was one of three local middle schools recently selected as finalist schools in Grades of Green's Trash Free Lunch Challenge (TFLC). Oak Street Elementary in Inglewood was also one of three elementary schools selected as a finalist. The 25 competing schools spent the school year educating students about waste reduction and diverting as much lunchtime waste as possible -- and it's paying off! In total, this year's participating schools achieved a 77 percent average lunchtime waste diversion rate, which means about 320 tons of waste will be diverted from Southern California landfills thanks to the work of these dedicated students.

Hawthorne Continues to Dominate Leuzinger With Sweep

Hawthorne High's baseball team enters the Ocean League with good confidence after rolling over cross town rival Leuzinger in two non-league games last week. At Hawthorne on April 7, the Cougars routed the Olympians 11-1. At Leuzinger last Thursday, Hawthorne recorded a 12-0 shutout.

In the first game, Carlos Jacobo sparked the Cougars, who improved to 7-5-1, by going three-for-four with three runs batted in. Brandon Brown was three-for-four with two doubles, one RBI and three runs scored. He also stole four bases.

Andy Monarrez was the winning pitcher going five innings. The game stopped there due to a coaches' agreement. He allowed one run and three hits. David Oliver drove in the Olympians' only run with a double. Tony Ruiz scored on the hit.

Last Thursday, starting pitcher Charles Phelps and winning reliever Jesse Garcia combined for a two-hitter. Monarrez drove in a run with a double and Max Riley had a two-run double. Leuzinger was plagued with eight errors.

"Everybody played hard," Hawthorne assistant coach (to head mentor Jeff Hines) Chris Robles said. "They (the Cougars) did what they had to do."

Oliver had a double in the bottom of the sixth inning. "We just fell behind and couldn't catch up," Leuzinger head coach George Pech said. The Cougars began the Ocean League at Santa Monica last Tuesday. Hawthorne hosts the Vikings, one of the league favorites, today at 3:15 p.m. The Cougars host Beverly Hills in Ocean play next Tuesday at the same time.

Over the past few seasons, Hawthorne made the CIF-Southern Section Division IV playoffs from the Ocean but with the addition of traditional power El Segundo, things will be a lot more competitive. Many observers tab the Eagles, Santa Monica and Culver City as top contenders for this year's league title.

After struggling in the always highly regarded Bay League over the past several seasons, Leuzinger, which has not won a league game in six years, will not have it that much easier in the always tough Torrance-school studded Pioneer. The Olympians opened league against West Torrance, which is among the favorites in the Pioneer and currently ranked third in the CIF-Southern Section Division IV, at home Wednesday. Leuzinger visits the Warriors Friday at

3:15 p.m. West is 13-5 overall and won the always tough El Segundo Tournament earlier this season.

The Olympians continue Pioneer action at defending Southern Section Division IV champion Torrance next Wednesday at the same time. The Tartars are rebuilding and struggling after their first CIF title but always have very good talent. Leuzinger enters league with a 2-10 record with wins against Compton Dominguez 14-0 on March 19 and Inglewood Animo Leadership 5-4 on March 31. Both victories were at Leuzinger.

LAWDALE LANDS TWO ON ALL-CIF

Lawndale High's boys' basketball team had two players make the all-CIF Southern Section Division IIAA team, named recently. On the squad included seniors Chimzie Metu and Broderick Jones. The six-foot-10 center Metu sparked the Cardinals by averaging 16 points and 12 rebounds per game.

Metu was also the Ocean League's co-Most Valuable Player with Chance Commanche of league champion Beverly Hills. Metu will play his college basketball at University of Southern California in the fall.

Jones, a guard, averaged 15 points and made numerous three-point baskets for Lawndale. Sources are that Jones will be playing at Division I university Cal State Northridge next season.

Over this past season, Lawndale tied for second place with Santa Monica in the Ocean League. Leslie, regarded as one of the top female basketball players ever, helped the Lady Monarchs win back-to-back California State Division I championships in the 1988-89 and 1989-90 seasons. Among her biggest highlights in her prep career was scoring 101 points in the first half of Morningside's Ocean League game against South Torrance as the Monarchs surged to a 102-24 halftime lead during her senior year. The Spartans refused to come out in the second half ending the contest there.

Leslie continued to play at University of Southern California before playing in the Women's Basketball Association with the Los Angeles Sparks from 1997 until her retirement in 2010. She keyed the Sparks to back-to-back WNBA championships in the 2001 and 2002 seasons. Leslie was the league's Most Valuable Player three times.

The six-foot-five center-forward also was a big factor in the United States women's basketball team's four gold medals in 1996 (Atlanta), 2000 (Sydney, Australia), 2004 (Athens, Greece) and 2008 (Beijing, China). Leslie will be inducted at the Basketball Hall of Fame in Springfield, Mass. from Sept. 10-12.. •
