# Top Golf Is Fun, Food, and Fore You

"Golf is very dull, sorry. Don't tell me you enjoy watching it on TV. That can't be possible! Who's talking about watching? I'm talking about getting our own table and chairs, ordering food and drinks, and hitting golf balls programmed to play a cool game!" You live in the South Bay and don't know about Topgolf in El Segundo? Some folks have couches they can relax on before golfing. You yell 'Fore' just to get a laugh!

The history of Topgolf itself is pretty interesting: Steve and Dave Jolliffe, twin British brothers, had sold their mystery shopping business and were considering a new venture. It was 1997; both were golfers but unhappy about the time it took to play and the dearth of good driving ranges. They placed a microchip into a golf ball and, from there, developed Topgolf. The first location was in Watford, just outside of London, which was back in 2000.

Like the flight of a golf ball itself -- sometimes a good hit, sometimes right down the middle, sometimes out of bounds, sometimes hooked to the right or to the left (which, by the way, gave rise to the expression "military golf") - the inimitable Topgolf made its way to the U.S. in 2005.

Skipping like a ball across a water hazard, we come to 2017, during which Topgolf created a television series entitled Who Will Rock You, where eight unsigned bands competed for a prize of \$50,000 and a Topgolf tour. The roll of the ball continues until October 2020 when Callaway, the well-known, successful golf merchandise company, acquires Topgolf for a mere \$2 billion. (Yes, that's a

billion, with a "b"). OK, go ahead, if you really have to: "Fore!"

Today, there are at least 70 Topgolf locations, which include the United States, United Kingdom, Australia, Germany, Mexico, and the United Arab Emirates. There are multiple Topgolf game variations, one in which players aim for eleven giant dartboard-like targets. The microchipped balls score themselves and provide players with instant feedback on the accuracy and distance of each shot. So, come on.... it does sound like fun, doesn't it?

Remember, you have your own area to play, sit, relax, eat, drink, and be merry. The food and spirits you can purchase are plentiful.

Topgolf is meant for groups, and when I last visited, there were a number of families.

Doesn't quite sound like your typical trip to the golf course or golf range. Sounds more like very enhanced miniature golf or bowling, except you have your own lanes, the restaurant loves waiting on you, and you are in a comfort zone. Oh, and the ball lets you know how you did!

Now, for the record: Let's not forget there was quite a bit of controversy about Topgolf taking over the then-Lakes, El Segundo golf course, which, at the time, included nine holes, a driving range, putting green, and bar/


#### Best of 2023 Picture Books





# <u>Film Review</u>

#### The Iron Claw: The Hereditary Curse of Family Legacy

For a film so deeply rooted in machismo culture and the bonds of brotherhood, there is a soft side to The Iron Claw that is so unexpectedly moving it brought a grown woman (me) to tears. Director Sean Durkin's biopic of the world's most infamous wrestling family tells a haunting story of legacy, expectation, and the costly price of success. Complicated family dynamics between an

oppressive father and his four compliant sons create such palpable tension and discomfort that it can be hard to watch at times without intense feelings of parasocial guilt. Despite this, I'm hard-pressed to recommend anything else. Durkin and his incredible ensemble cast bring to the screen one of the most visceral films of the year, one full of tenacity and grit, and easily among my favorites of 2023. Now playing in theaters.

Set in the early 1980s, The Iron Claw tells the true story of the Von Erich family and their tragic, unfinished legacy within the competitive world of professional wrestling. Born and raised in Texas, the bond between the Von Erich brothers – Kevin (Zac Efron), Kerry (Jeremy Allen White), David (Harris Dickinson), and Mike (Stanley Simons) - is truly something special. Not only do they share a love of wrestling, but they all endured growing up in the shadow of their domineering father and coach, Fritz Von Erich (Holt McCallany). Determined to have his

sons pick up where he left off and push the family name toward victory, Fritz creates an environment where winning a medal equates to winning his respect.

The tough love, despite its borderline abusive tendencies, seems to work. Kevin's (Efron) commitment to the sport proves unwavering as he climbs the ranks and starts becoming a notable figure. He seems like the obvious choice to lead the Von Erich dynasty to victory but obstacles make his road to stardom difficult. His brother Kerry (White), whose Olympic discus dreams were dashed after President Carter denied Americans from competing due to political reasons, realigns his athletic ambitions and sets his sights on the wrestling ring as well. David (Dickinson), known for his outgoing personality, follows suit and quickly becomes Fritz's favorite son – a title Fritz doesn't shy away from publicly declaring. His attempts to subtly pit the boys against each other to stir up aggression and animosity have an adverse effect; the Von Erich boys instead band together to become a source of refuge and understanding.

This story could have resulted in many different outcomes, but the deaths of three of the four brothers never crossed my mind. For those unfamiliar with the story, unfathomable misfortune and loss pollute the Von Erich family's legacy. All silently suffering from childhood trauma at the hands of their father, which they express in different ways. It's a heartbreaking realization that Fritz is clearly more concerned about his family's legacy than his individual children's well-being and future.

As the credits rolled, I was left gobsmacked. The ensemble cast is phenomenal, nothing See Film Review, page 3

short of astounding. For his role as the sole survivor, Zac Efron undergoes a full-body transformation that is worthy of every award. Jeremy Allen White and Harris Dickinson tap into their raging animalistic side and give some of their best performances to date. It's guttural, emotive, and tender all at once. Breakout star Stanley Simons, who plays the youngest brother Mike, is breathtaking. His presence among the film's A-list stars feels authentic and grounded, a tall order for any actor but one that he fills with ease. Holt McCallany as Fritz and Maura Tierney as the boys' emotionally detached and stoic mother, Doris, are both pitch perfect. The film is incredibly physical, and all who

participate in the logistical aspects of the performance, both in the ring and outside of it, are exceptional. The amount of work that went into preparing for these roles and the amount of muscle that had to be built to achieve the Von Erichs' signature stature is an astounding feat.

In a career-defining role for Efron, as well as for director Sean Durkin, *The Iron Claw* lands squarely within the narrow qualifications for perfection. It is both a ghost story about lost potential as well as a testament to the antithesis of fame. It's complicated, emotionally taxing, and devastatingly abrupt. *The Iron Claw* should go down in history as one of the best sports biopics of all time. •



#### City of Hawthorne Summary of Ordinance No. 2247 amending section 17.29.040 (development standards) of Chapter 17.29 (CM - Mixed Commercial classification) of Title 17 (zoning)

Pursuant to Government Code section 36933(c), the following constitutes a summary of Ordinance No. 2247 which will be considered for adoption by the City Council at its regular meeting on January 9, 2024 at 6:00 p.m. Pursuant to California Government Code section 36933(c)(1), the City Council has previously directed the preparation and publication of a summary of Ordinance No. 2247 which implements specific commitments the City made in the Sixth Cycle, 2021-2029, Housing Element certification process. The Housing Element is one of several parts of the General Plan. Additionally, this ordinance brings development standards into compliance with the Downtown Hawthome Specific Plan. Ordinance No. 2247 makes the following changes to Section 17.29.040 of the HMC: Minimum lot area - The minimum lot area for

mixed-use development of 2 acres is replaced with no minimum formixed-use. Anew minimum lot area for residential-only developments of 1

Density and intensity - Three significant changes are in this section. First is returning the permitted density to 30 units per acre. A lower density excludes the zone from being countable toward the Regional Housing Needs Allocation (RHNA). The second change is resetting the minimum ground floor commercial component of mixed-use development to 5%. Currently it is 40%, which is unrealistically high. The third change is removing the requirement that the building footprint not exceed 90% of the lot area. This does not remove or reduce the open space required for residential uses Setbacks - Additional setbacks are currently required for structures abutting residential uses that increase as buildings become taller and apply to the entire building plane facing residential. This is replaced with a setback that grows modestly as the building height increases, but only applies to the third story and up. The bottom two stories will keep the setback already required for the first floor.

Height - In this section, the only change is removing the formula for mandating reduced massing on the frontage of Hawthorne Boulevard for 10 acre sites. Dwelling unit area - Specifics of this section

are being removed as it was identified by the state as a constraint for the development of housing. Making this change does not permit more units per acre, so there is no impact on density, it merely allows smaller units which reduce overall massing and provide opportunities for additional open space.


