Shade Hotel Owner, Residents Await Noise Study Results

A new noise study is hoped to resolve the long-standing impasse between a group of local residents and the operator of Shade Hotel. The Metlox Plaza-based luxury boutique inn and tapas lounge sparked outcry upon owner Michael Zislis’s June request for a conditional use permit (CUP) change in order to extend closing hours from 11 p.m. nightly to 1 a.m. on Friday and Saturday and midnight Sunday through Thursday. Nearly 100 residents signed a protest statement in response, citing concerns about adverse noise impacts from different areas of the hotel property. Though Zislis later trimmed down his initial request, asking for a midnight close on Fridays and Saturdays and an 11:30 p.m. close on Thursdays, the residents have held firm.

The matter came up at two recent Manhattan Beach Planning Commission meetings, spurring a spate of public commentary. At the first meeting in June, over 20 residents spoke against Shade, most of them homeowners who live within a couple of blocks of the bustling downtown venue. A month later, the overwhelming majority of speakers, residents and business leaders among them, praised Zislis’s contributions to community schools and the local economy. In addition to operating Shade, which generates over \$750,000 in rent and sales and transient occupancy tax revenues to the City, Zislis also owns popular downtown restaurants Rock’n Fish and Mucho Ultima Mexicana.

The Planning Commission members ultimately tabled the item in order to compile more comprehensive information about the noise impacts and to emerge with a concrete solution. As a result, Behrens & Associates, a Manhattan Beach-based acoustical engineering firm, began conducting 3-D sound evaluations last weekend, measuring noise sources in and around the hotel during both peak and quiet periods. Though Zislis is paying for the work at an estimated cost of \$10,000, the City of Manhattan Beach is managing the contract. “They’re looking at noise sources to identify potential mitigation measures,” said City Planning Manager

Laurie Jester, who commissioned the study. “Behrens got a list of special events and is taking noise levels during those as well as during the week for ambient readings, which is your everyday normal background noise that includes things like motorcycles on the street, your neighbor having a barbecue, or even wind chimes.” Jester expects to receive a draft report by September 25. City staff will then pore through the data before the item returns to the Planning Commission in mid-October for further review. If not appealed, the Planning Commission’s eventual decision will then go to the City Council as a consent agenda calendar item. Council members can review the decision at that time, and if no one pulls the item, it will be automatically approved.

The sound study is the latest out-of-pocket mitigation expense for Zislis, who has faced resident wrath almost from day one. He estimated he has spent over \$100,000 to address various sound complaints since opening Shade in late 2005. “The residents have valid concerns, but I’m not going to spend \$250,000 to mitigate the problem,” Zislis said. “I have a seven-year lease and I’ll make the necessary changes... I’m a very reasonable man...But there are a few people who will never be happy.”

Among other fixes, Zislis moved valet parking from its original location on 12th and Valley to a quieter spot along Morningside, installed glass barrier walls around the Zinc Lounge terrace and glass around the sky deck, and put in limiters to control decibel readings on the sound system. “We went across the street and turned up the music to the municipal code level of 55 decibels to make sure I don’t pass that threshold,” Zislis said, adding that main thoroughfares such as Valley Drive, Highland Avenue and Manhattan Beach Boulevard regularly exceed local noise ordinances.

Zislis readily admits that noise issues got out of hand on a few occasions. “Once we had an auction where the guy was yelling
