



State Budget Woes - Now They're Ours



(NOT TO MENTION THE ECONOMY)

I've written recently on this topic, but it is once again timely, so here is an update. Bear with me if I repeat myself.

I'm surprised it has taken this long, but the state of the economy and the state of the State's budget are finally taking their toll on El Segundo's City budget. Don't panic--we are in much better shape than most cities and we will ride this out without the drastic cuts in programs and people that other cities and counties need to implement now.

But the economic downturn and Sacramento's inability to structurally reform the way California gets revenues and spends money are hitting our city in significant fashion. We are lucky that in large part we are insulated from the State's fiscal follies.

For one thing, we are what is known as a "no-low" property tax city. That means that when Proposition 13 froze property tax rates in 1978, El Segundo's modest seven percent city portion of those revenues became permanent, so the City budget relies far less heavily on that source of revenue than many other municipalities. (The school district, like all school districts in California, is in a far different place, relying much more heavily on property tax revenues.)

Other sources of State-based revenues to cities, like the vehicle license fee, are allocated based upon residential population. With our residents numbering only about 17,000, we don't rely heavily on this source either.

But the economic downturn has had a substantial effect on El Segundo. We've made expenditure cuts in this fiscal year already and will probably need to make more before the fiscal year ends. (Unlike most California cities, our fiscal year ends September 30, not June 30.) These cuts should not hurt programs and won't result in layoffs.

The fiscal year beginning October 1 is going to be tough, though. The City Council has already given preliminary approval to cutting nearly \$6 million from general fund expenditures, including about \$400,000 in Fire Department overtime, to cite just one example. That's about 10 percent of the entire general fund budget, to put things in perspective. These cuts overall are by far the toughest in my 11 years in office.

But that's not going to be enough. The State Legislature and the Governor have once again picked the pockets of cities and counties across California. Proposition 1A, passed just a few years ago by voters across the state, says that the State can only take this money if it is paid back in three years with substantial interest. Where the state with the lowest credit rating in the nation is going to get the money to pay back this "borrowing" is an unanswered question.

For months Sacramento had told cities and counties that their money was safe. It wasn't. Big surprise, huh?

So what's the impact on our city? About \$865,000 less revenue for the fiscal year starting October 1. That means more painful cuts that the City Council needs to make and the City staff needs to find.

And where are we going to find these spending reductions? Every department will probably share in the bleeding, with the most heavily-funded departments, police and fire, bearing the brunt.

Will we be okay? Yes. El Segundo's substantial reserves remain untouched so far.

Is it over? Not in my estimation, it isn't. The State's recent history indicates a chronic inability to accurately forecast the economy and its impacts on revenues and expenses. To paraphrase a famous actor turned politician, "They will be back." Stay tuned.
