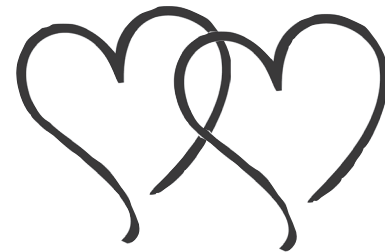

**HAPPY 50<sup>TH</sup> WEDDING ANNIVERSARY**

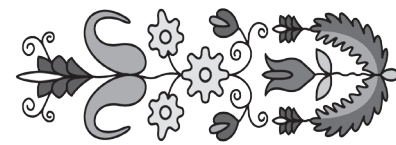
