# Mustangs in the Driver's Seat Against Chaminade

The top-seeded Mira Costa Mustangs have been on a roll all year long and they continued their drive against Chaminade in a CIF Southern Section Western Division playoff quarterfinal match-up. With another stellar game from the defense and an offense that keeps churning out the points on long drives, the Mustangs (10-2) advanced to their second consecutive CIF semifinals appearance with a dominating 41-19 win.

Chaminade (7-4) moved the ball during its first series and got inside the Mustangs' 10 yard line. The Eagles did all they could do to open the game but the Mustang defense responded by making a key stop on fourth-and-goal from the one yard line. Mustang quarterback Kyle Demarco didn't waver despite starting near his own goal line and directed the offense down the field with precision. Senior fullback Kellen Lockwood got the call at the Eagles' four yard line and bulldozed his way into the end zone for his third rushing touchdown of the year.

Chaminade responded early in the second quarter with a scoring drive of its own. Eagle quarterback Jake Basmagian found his favorite receiver, Jamal McClerkin, for a 28-yard touchdown pass. Chaminade head coach Ed Croson must have thought that points would come at a premium in this game. He decided to go for a two-point conversion attempt, but the try was unsuccessful and the Mustangs clung to a 7-6 lead.

If anyone on the Chaminade side thought that the Mustangs' narrow lead would last, they were in for a rude awakening. Mira Costa dominated most of the second quarter by scoring three touchdowns, and Demarco had a hand in all three scores.

The senior quarterback ran for touchdowns of one and 11 yards and he connected with one of the South Bay's best receivers, Kyle Nunn, on a 43-yard touchdown pass to increase the lead to 27-6. The catch in the end zone was tipped up into the air and grabbed by Nunn as he fell to the ground. Chaminade wouldn't go away though, and scored on a two-yard run by Brando Tessar shortly before the second quarter ended to make it 27-13.

With a two-touchdown lead on a team that had averaged 34 points in its previous four games, Mustang coach Don Morrow wasn't about to play conservatively. On their first series to open the second half, the Mustangs went to the air. A 51-yard pass play from Demarco to Nunn set up the quarterback's third touchdown run of the night and stretch Mira Costa's lead to 34-13.

In the fourth quarter, the Mustangs used a nine-play drive to chew up the clock and score one final time. After J.R. Oshima intercepted Basmagian, Demarco directed the 52-yard series that was capped by Rico Wright's seven-yard touchdown run. On the drive, Wright carried most of the load by rushing four times for 30 yards, including the TD run.

Wright has been the workhorse for the Mustangs lately since leading rusher Morgan

Reece tweaked his ankle and has been slow to recover. Does it bother Wright that he's pulling extra duty as the team's featured running back and the safety on defense? "I welcome the challenge, but I am a bit exhausted..but I'll do anything for our team," he said.

Mira Costa turned the ball over three times on fumbles including one on a punt return, but the Mustangs were able to withstand Chaminade's offense each time. The Eagles did score one last time with 4:21 left in the game on a nine-yard run by Tessar. But even that score was contested when the ball popped lose near the goal line and recovered in the end zone by McClerkin.

The offense certainly was hitting on all cylinders with Demarco completing 8 of 10 passes for 243 yards and rushing for 94 yards and three touchdowns. Rico Wright had his best day by rushing for 183 yards and Kyle Nunn was once again the big recipient of Demarco's passing by catching five passes for 153 yards.

The Mustangs will advance to the semifinals having won nine straight games after opening the season 1-2. Mira Costa will host Palmdale (10-2), the Golden League champions, tonight (Friday, December 4) at 7:30 p.m. The Falcons needed an overtime 49-42 win over St. Francis to advance.

Mira Costa will face the fourth-seeded Falcons and a team that has pretty much mirrored the Mustangs year. Palmdale comes into the game riding an eight-game win streak and is a team capable of running the ball. Corey Washington, Joshua Shaw and Joey Garba have combined to rush for over 2,000 yards and 25 touchdowns. Shaw runs the quarterback option much like Mira Costa's Demarco does and he has thrown 12 TD passes while rushing for another nine.

The Mustangs more than match up for the Falcons, and getting a home game should give the Bay League champs the edge. Mira Costa is just one of three South Bay teams still playing with Serra (12-0) and Chadwick (11-1), the other two teams vying for a CIF finals berth.

Should Mira Costa win, it will take on the winner of the Alemany versus Dominguez game next Friday night at 7:30 p.m. A coin flip to determine the home team has already been established at the CIF office and the Mustangs will be on the road no matter who wins the other semifinal game.

#### **Mustang News and Notes**

The girls' cross country team competed at the Division II state meet and was hoping to battle and upset Saugus, the top-ranked team in the nation. Savannah Pio ran a team-best 18:02. Aleyna La Croix (18:08), Aryn Foland (18:14), Shannon Hagedorn (18:33), Kelly Sugimoto (18:44), Vivian Cherette (19:27) and Kristie Fields helped lead the Mustangs to a second place overall finish behind Saugus.

The basketball season is upon us and both the boys and girls' teams started their seasons this week. The boys hosted the Pacific Shores Tournament while the girls played in the Inglewood Holiday Classic. •

## Crime Reports

#### HOUSE PARTY FRIDAY, NOVEMBER 6
