


# Student's forum

Tsuneyoshi said. "We're so far ahead of everybody else it's not funny."

Manhattan Beach City Councilmember Mitch Ward, who is running for Lieu's Assembly seat when the latter terms out next year, said boating is important to the area's economy. "Boating is a really important aspect of the economic revitalization that we need to undertake here and so if we get more people boating, that's more money spent in the area," Ward said. "So it's about trying to support the economy, plus helping the environment."

Lieu is hopeful Governor Schwarzenegger will sign the bill and said the Governor vetoed the bill last year despite it being passed in both houses and on a bipartisan basis. "If you remember, he vetoed hundreds of bills last year because he got mad at the legislature," Lieu said. "I think his office now understands the importance of this bill because it does help the State save money."

### Constituent Concerns

Most attendees seemed to approve of Lieu's bill, although there were other concerns, such as other legislation not supported by Lieu that could affect the industry. One deals with high slip fees. Los Angeles County Beaches and Harbors Director Santos Kreimann said the County conducts an annual survey of market prices in a 60-mile radius and found slip fees in Marina del Rey to be market rate, in accordance with County policy. However, he agreed with the abandoned vessel legislation. "It's certainly something that's pro environment and voluntary, so I don't see a downside to that."

As a state assemblyman, Lieu feels would he could play the role of a facilitator between the County and his constituents." Sometimes if [people] can't get through to these agencies, we can help them and I think its one of the best things I can do," Lieu said. "A lot of these more local issues, the State has

very little role in it ...but we can certainly facilitate better communications between the affected parties and the County."

Yacht broker Bob Koepple said nearly a dozen yacht brokers have been driven out of business during the economic downturn. He asked Lieu to replace the State's yacht tax loophole with a three or four percent tax on luxury items, saying it would spur yacht sales. Currently the tax code lets boat owners avoid sales and use taxes if they keep their vessel out of state for a year, with most people keeping their boats just south of the Mexican border. "It's not working... people think the people who own boats are millionaires and they're not," Koepple said. "The average people buy fifty, seventy-five, hundred-thousand-dollar boats." Koepple explained that slip fees, interest rates and the sales tax make it hard for people to afford boats, let alone store them offshore. "What are you going to do, drive to Mexico every weekend?" Koepple said.

Sean Guthrie, owner and operator of the King Harbor Marina, came to air his concerns over several pieces of pending legislation regarding water discharge requirements for marinas and possible fishing restrictions near Palos Verdes. He said such legislation could harm an already fragile industry with new regulations and added costs. "Those things that are going on right now, we'll see a huge impact on recreational boating," Guthrie said. "This is absolutely the worst time in the world to be doing things like this when we have a serious recession and the State is losing revenues as it is."

Guthrie hoped the town hall meeting made Lieu and other attending officials aware of the issues and concerns boat and business owners like him are facing. "Hopefully that will raise his involvement in those processes and help out...California is in dire straits," Guthrie said.
