America was rushing pell-mell into the Auto Age and nowhere faster or more recklessly than in Manhattan Beach. On May 9, 1924, a car leaped 30 feet into the air, landing on the beach. Fortunately only minor injuries resulted. Almost every week, there was some kind of traffic encounter. In August of that year, one penniless and reckless driver has to paint parking spaces for three days during what was pronounced as the "Week of the Speeders."

Another example was J. Harper, described as a person "from the large and congested city," who was speeding down Center Street (Manhattan Beach Boulevard) in his Studebaker Special when he was caught. The *Manhattan Beach News* stated, "Judge Price must have been in a terrible state of mind because he

charged the fellow \$500 in gold." Following sentencing, the hapless Harper was reported "to be convalescing from shock."

There were more then half a million cars in Los Angeles at the time and people went without necessities to have a prestigious car. At the time a driver did not have to take any tests. The only requirement to getting a license was to be able to fill out name, hair and eye color. The Automobile Association of Southern California found that incompetent drivers were the main cause of accidents.

One of the unhappiest events was the destruction of the Neptunian Memorial Fountain. In 1915, Mrs. John C. Stockwell, chairman of the committee to erect a memorial fountain to Mrs. Jessie Smith, founder of the Neptunian Club, announced the club had \$200. The club ladies had held bake sales and sponsored weekly card parties to raise
