Council Approves Plans for Renovation Along Hawthorne Boulevard

Downtown Hawthorne may be getting a revitalized look soon. Plans for a ground level office and retail spaces, second level restaurants and a theater and an upper level residential area was proposed and approved by the City Council, Tuesday night.

“All the successful malls, you see the activity of people walking in to the shops. The Hawthorne Mall previously was just a solid wall, you couldn’t see what was going on inside,” mayor Alex Vargas said, hoping to get a better idea of what the foot traffic impact would look like.

The preliminary plans were drawn up by the architecture firm, MIG, which took nearly two and a half years to draw up the vision for the downtown area in Hawthorne.

“We’re trying to take the old Hawthorne Mall model and perforate it so that people can look in and see what is going on to it,” Benjamin Anderson, the project architect and R&A Design co-founder said. “[It] includes a pedestrian park on two sides along with potential sidewalk cafes.”

Vargas was also concerned if the plans were conducive to the nightlife in Hawthorne as well as if the office space was designed for a large company or for smaller ones.

“We are actively looking to see what the market is looking for. There is nothing like this in Los Angeles right now,” Anderson said, who added that this is a real advantage to companies that might consider moving their employs into the same residential area.

The plans are still in a very preliminary stage, nut the development is ready to go and eager to being the process.

Mayor Pro Tem Angie Reyes English was curious to know about the feedback from the existing stores along Hawthorne Boulevard and if the Council would be working with the new businesses that would come in.

“On one hand, the plan is a vision for the future, but there is also a call for the Economic Development coordinator who proactively works

with the business owners to implement different parts of the plan,” Anderson said.

Interim City Manager Arnie Shadbehr added that all development would be funded by private money from businesses interested in inhabiting the office spaces.

“A lot of these businesses are holding on by a thread and a lot of them closed down because they didn’t get the information or help regarding funding opportunities,” English said in hoping that the city would be able to add input in the development process of adding new businesses along Hawthorne Boulevard.

Planners said they heard a lot of positive feedback adding that this isn’t a plan to change the entire boulevard but rather an incremental change.

“The plan addresses both sides of it in attracting large businesses but also helping small businesses grow by letting them know what kind of information and assistance is out there for them,” John Oshima, a representative from GRC Associates who oversaw the environmental impact report (EIR), said.

English also addressed concerns regarding where the start and end points were in the project. Councilwoman Olivia Valentine also expressed the same concerns.

After the EIR and subsequent analysis is turned in, the city’s relationship with the architects would end. The project would then pass over to an economic coordinator, someone who is dedicated to the development of the project.

“Yes it would be ideal to have a dedicated person, but in the absence of that, you have a dedicated department that is already working on the project,” Planning Director Gregg McClain said. “The thrust of this project is to get some jobs going – construction and getting retail areas to be development. There is potential for the Civic Center or the mall to lead the way.”

English also addressed the concerns over the fact that the railroad runs through the city, citing the pollution and traffic impacts.

“We did provide the EIR to the state which was also provided to the Public Commission, but we did not receive any comment from them,” Oshima said who added that removing the railroad was not a part of the analysis.

On the topic of trains, English also addressed the potential of the Metro Rail running from Inglewood, through Hawthorne and ending in Torrance.

The rail plans were not included in the initial plans before the Los Angeles Rams agreed to move in to a new stadium in Inglewood on Prairie Avenue.

“In regards to the Inglewood projects, as a neighboring community, you will have an opportunity to review their analysis and EIR and provide the city’s comments,” Oshima said.

Vargas asked the developers about the potential parking issues that might occur. The parking spaces presented to the city were drawn up according to code and that, “there is no need for people to park outside of the site.”

Vargas brought the onus back on to the Council that it is ultimately up to them to reach out to businesses and get them to want to open business in the city.

“One of the things to make this whole thing successful is to tap in the economic development part of the general plan which makes our city business friendly like training and so on,” Vargas said. “Everything is lining up for us and I’m really excited for us.”

While the meeting began on a somber note with Vargas informing the audience of the death of Councilman Haidar Awad’s cousin, Hashim Ali Awad, who died in a car accident last week, it concluded with City Clerk Norb Huber providing an update on the city’s plans for their upcoming centennial celebration which include a potential air show in 2018.

“There have been people who have come up to me who have asked to be a part of the committee and something positive that is funded outside of the city’s budget,” Huber said. •

Film Review

Knight of Cups, and How to Escape in a World Full of Escape

Christian Bale goes from playing one Dark Knight to another, a dark knight of a man weighed down by his own brooding and self-imposed burdens as he meanders and moseys through what one would surmise to be a personal journey of self-discovery, in Terrence Malick's new film, *Knight of Cups*, opening limited in theaters today.

Knight of Cups is truly arthouse cinema. This is not a commercial movie, which means there's a different sort of story unfurling here not typically seen or expected in mainstream movie-going – which, full disclosure, is also to say that there's barely a whiff of a story here at all, and is rather

a montage of aesthetically beautiful visuals and sequences. It's certainly an example of fine film-making and craftsmanship, though perhaps to most audiences, it will be that, and nothing more.

The journey and story here, in this beautifully shot film (photographed by Academy Award-winning cinematographer Emmanuel Lubezki, hot off of his historic third consecutive win for *The Revenant*) is one of existential crisis in this most modern of ages. What does it mean to live in a world of such available opulence and opportunity, and what does it mean when all of those things mean nothing in the face of un-satisfaction? How does one escape, when one's entire world is the offering of pleasures and escape?

Written (with no official script) and directed by Terrence Malick, *Knight of Cups* is able to pose these philosophic questions and stir these high-minded thoughts, as his more recent films (*The Tree of Life*) feel more like abstract compositions that allow audiences to project and infer meaning themselves. The film tells the story of a Hollywood screenwriter, Rick, (Christian Bale) who, sullen and silent, wanders and moseys and hangs his head through the streets of Los Angeles, all the while evoking something between despair and acceptance with breathy voice-over hovering above every moment. Despair and acceptance of what?, you may ask? We see that Rick's father (Brian Dennehy) may have neglected, or failed to give something

to his sons, the other son being a more manic LA type (Wes Bentley).

Rick floats through endless Hollywood Hills parties and nightclub raves like the Ghosts of Christmas Past, Present, and Future combined, in a sort of fever dream reality. All this, in chaptered storytelling, gives some semblance of structure to the thing. The tarot card motifs and solar and lunar imagery abound here all serve to show that this knight is fated to seek this treasure, this answer, in a world full of distraction and vapidty. The mystique of the goddesses further serve his noble quest, and the film has incredible talent to play these roles. Cate Blanchett, Teresa Palmer, and Natalie Portman all pop up

in chapters of Rick's life, each revealing a part of his spiritual lacking in different ways. It's a film constructed through the male gaze and understanding of life as he knows it, which will likely further split audience reactions.

Knight of Cups must be regarded for exactly what it is: a work of art. A work of art, in that it holds no commercial value and is rather the work of a singular artist commenting a singular vision and making a grand statement about the universe at large, even if it's just his own statement (and even if this statement feels as empty and hollow as the world it's commenting on). Fans of Malick's previous films will know this – others must be warned beforehand, lest they expect something resembling a comfortable narrative to watch.

It's a tough thing to make aimless wandering exciting to watch, or even empathic, and *Knight of Cups* will deter people from enjoying it for that reason. It burns ever-slowly, as we the audience are merely along for the ride, moment-to-moment, in which everything exists in the ultra-present of modern day living. Ultimately, it all feels like this longing dream is too abstract to take any substantial meaning from. This knight will most likely continue to wander for the rest of his days, which makes *Knight of Cups* feel more like a ceaseless spinning of plates.

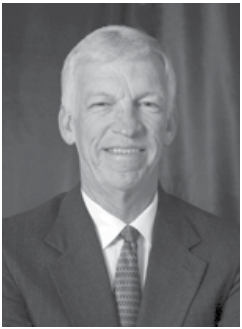
News for the ‘City of Good Neighbors’

DOWNTOWN HAWTHORNE PLAN APPROVED

Finally, after almost two decades of inactivity, the Hawthorne City Council approved the specific plan for the entire Hawthorne downtown area. This development plan includes the old Hawthorne Plaza Mall site and the civic center redevelopment. The strategic plan was over two years in the making. It was presented to the council and to the public through a series of presentations. After an hour of discussion the council voted unanimously to approve it. At the mall site, the mixed use proposal that still will have to go through planning approval, will include approximately 500 high-end housing units, innovative office space, commercial outlets open to Hawthorne Blvd., and outdoor dining sites. This council vote could be the turning point for the city. We are talking about millions of dollars being investing into turning out blighted north end into a desirable destination for residents and outsiders. There are still some steps that have to be taken to make it real, but we have taken a giant step by having the environmental impact study approved that allows for housing at the site. It is topped with either grilled chicken breast or filet mignon tips. The dressing we selected was a nice mild Caesar dressing that was the perfect blend for the palate and the perfect compliment for this salad.

If you like sandwiches the one that was brought to our table was the Roasted Turkey sandwich that is a free range turkey breast that is sliced to your wishes. This sandwich is piled high between slices of toasted 5 grain bread and includes avocado, jack cheese, tomato, butter lettuce, red onion, and a dab of chipotle sauce for flavor. Ask to add the basil mayo if you really want to make a perfect sandwich better. The sandwich was not dry and the turkey was moist.

An alternative to the Turkey sandwich is

the Southwest Turkey Roll Up. It combines turkey breast, avocado, jack cheese, shredded carrots, butter lettuce, cucumber and hint of salsa and chipotle sauce all rolled into a fresh spinach tortilla. Each of these comes with your choice of fresh fruit, organic green salad or Caesar salad.

What would a health club be without a place to get a smoothie. Café Vida has an array of all natural super food smoothies. We tried the BC Smoothie that combined strawberries, banana, fresh squeezed orange juice and vanilla protein. It was a refreshing boost having us wanting more and thinking we just drank a cup of sunshine.

The other we tried was the Almond Butter Cup. The taste of this smoothie lends a combination of all natural almond butter, banana, Isopure chocolate whey protein and almond milk. Though its loaded with an almond base the trace of the chocolate whey overcomes that nutty flavor for a truly delectable drink; almost like having a guiltless glass of dessert.

Overall Café Vida's secret to success has been leaked and certainly a destination for a healthy alternative. •
