# Wiseburn Looks at Mandarin Immersion; Facilities Master Plan

Last Thursday evening's Wiseburn School Board meeting started with a presentation from two parents about the launch of the Mandarin Language After School Program slated to begin during the 2019/20 school year. The presenters were Jenna Boller and Zalina Visentin, and they laid out a program that would culminate with a launch of the paid afterschool program at Anza Elementary this fall for TK, kindergartners and first graders.

The program will be run by a third-party group, Ni Hao Chinese, and will be open to all Wiseburn students, with those at Anza receiving priority if they sign up in March. The second of two informational parent sessions took place on Tuesday at Anza.

Superintendent Dr. Blake Silvers, Assistant Superintendent, Educational Services, Dr. Aileen Harbeck, and member Dr. Neil Goldman all praised Boller and Visentin for their tireless work in getting the Mandarin program off the ground.

The program hopes to attract an initial minimum of 15 students, with a tentative cap of 20, although Goldman quipped, "What happens when we get 400 students?" He also congratulated the organizers on their perseverance and tenacity as they "take the big-picture view."

Parents can sign their children up and leave an initial deposit (\$200, which will be applied to the first month tuition) at the Anza front office. The presenters detailed their communication plan to bring the program to fruition, including Silvers sending an email blast to community members to build aware-

ness. Principal Alberto Paredes will also email Anza families, while social media outlets like Facebook and Instagram will additionally promote the upcoming program.

Boller and Visentin also detailed next steps after the launch of the program, including summer camps, field trips, cultural experiences, and a possible fifth grade trip to China. They also showed the Board members a sample Ni Hao Anza class schedule that could be implemented this fall.

The second presentation came from Rick Musto, Associate Managing Director of the design firm LPA, which is working with the Wiseburn Unified School District in the nascent stages of the Long-Range Facilities Master Plan (LRFMP). Now that the heavy lifting has been accomplished with the opening of Wiseburn High, the District's focus turns to next best steps and future priorities. Silvers said the District had enacted a thorough vetting process to secure a LRFMP partner, and that LPA was selected as the "the best firm out there" to partner with Wiseburn

Musto provided details about the firm, which has been in business for more than a half century and boasts more than 400 employees, with more than a quarter of their personnel dedicated to education. He touted the firm's master-planning experience, noting collaboration with school districts in Hawthorne and Compton, among others. He spoke of establishing a "visionary" process, based on how students will learn in the future; discovering the impact of program to facilities and technology needs; and developing a long-term phased implementation approach. He then shared components of the

development of the LRFMP, including educational visions and goals; a demographics review; facilities condition assessments; and financial analysis -- all under the umbrella of necessary collaboration with all stakeholders in the final recommendations that will be brought to the Board.

Next Musto detailed planned stakeholder outreach, including the development of District focus groups; school site input; possible online staff surveys; and town hall forums and voter opinion surveys. He also spoke of the formation of a LRFMP Committee that would include from 25-40 members and meet monthly to provide their various inputs. All this process, according to the current timeline, would culminate in the LRFMP going to the Board for approval in late spring or early summer 2020.

Musto touted the work his company does with school districts, saying, "We do it well." He spoke of four tenets to "delivering education" and was hopeful that the first committee meeting would take place in September. At the conclusion of the presentation, Silvers added how comfortable he was working with the very strong team of personnel that LPA has assembled.

Board member reports then followed, with Goldman extolling the virtues of the recent District engineering-based Hackathon. Clerk Roger Banuelos termed the evebt a "wonderful program," noting it helps open the doors for District students to explore the opportunities to consider studies to pursue an engineering option. Goldman added that he was in awe of the diversity of learners Wiseburn was



# Meow! My Groovy Life with Tiger Beat's Teen Idols by Ann Moses with Ann Wicker

How many of you remember teen idols? Is that even a thing anymore? Frank Sinatra made his Bobbysoxers swoon, Elvis made teenage girls' hearts beat faster and the British Invasion brought the hysteria of fans screaming for the Beatles, the Rolling Stones and other UK bands of the era.

Ann Moses writes about her days working at Tiger Beat, the biggest teen fan magazine of the 1960s and 1970s. Her memories include going on tour with Paul Revere and the Raiders, watching the Monkees film their TV show, eating lunch with Bobby Sherman

and cooking dinner for the Osmonds in her home. When she visited England, she was picked up at the airport by Maurice Gibb of the BeeGees in a borrowed Rolls Royce belonging to John Lennon.

While reading Meow (Ann had a column in Tiger Beat by that name), I was swept away by my own memories of fandom: I remember being glued to the TV screen by The Monkees, American Bandstand and Where the Action Is. I bought every issue of Tiger Beat and their large family of other printed products. I had posters of Donny Osmond, David Cassidy and the Hudson Brothers on the walls of my room and I

collected every kind of memorabilia you can think of from the popular culture of those times. Ann's book is like a conversation instead of a tell-all as she reminisces about her friendships with the stars, but always acknowledges that the fans were the most important part of her job. She says that she tried to put herself in every teenage girl's fantasy when she interviewed her dreamy subjects and she was careful to be respectful of whom she was talking with, too. There were no scandalous tales or mean gossip -- just innocent photos of actors and singers with their families and pets.

Even though I was one of those girls who wished I was in Ann's place, I discovered in her book things I never knew before. Ann tells how she got her start by interning at Tiger Beat while she was studying journalism at a junior college in Fullerton. She wrote for a weekly music newspaper called Rhythm 'n' News and covered stars like James Brown, Wilson Pickett and Sam Cooke. She met Derek Taylor, the former press officer for the Beatles, when he headed his own public relations firm representing the Beach Boys, The Byrds and other acts. Derek wrote a column in Tiger Beat, so Ann boldly asked him to arrange an introduction to the magazine's publisher. The rest is history.

Meow is full of fun facts and recollections that are funny and also full of heartache. Ann Moses was once the envy of just about every teenage girl once upon a time. Join her in the retelling of her own story.

# <u>Film Review</u>

# **Ash Is Purest White Review:** No Good Deed Goes Unpunished

A poetic romance that transcends time, Ash Is Purest White tells a love story that doesn't play by the rules. Written and directed by Jia Zhang-Ke, the film is a tribute to the lengths one will go in order to reclaim a past relationship despite the intangible longing of a love that has been lost.

Qiao (Tao Zhao) is in love with the local "jianghu" (mafia) boss Bin (Fan Liao), even though he is hesitant to put a label on their relationship. One night, a mysterious murder in the group's inner circle puts everyone on edge, as the town's rival gang appears to be sending threats. That threat becomes personal

of strangers to the Village People's YMCA, gives off strong Pulp Fiction vibes. Ballroom dancers at a funeral and a UFO sighting are other nuanced touches that director Zhang-Ke also incorporates. Visually, Ash Is Purest White is drenched in the naturalistic beauty of the northwestern Chinese region where it looks as if every frame is a painting. The greenery of the hills juxtaposed with the neon vibrancy of city aesthetic breathes life into the tepid relationship we see on screen. The film also does a wonderful job of indicating that time is passing without relying on title cards or other obvious methods. We see our characters age through their wardrobe,

when a group of boys catch Bin off-guard and begin beating him in the middle of a busy street. Qiao, whose initial reaction of shock quickly turns into controlled rage, pulls out a gun -- the gun that Bin gave her days prior -- and shoots it up into the air as a warning. The rival group scatters, but unfortunately for our heroine, Qiao, she gets arrested for owning and discharging an illegal firearm.

Fast-forward five years, Qiao is finally released from prison and begins her search for Bin in the hopes to pick things up where they left off. The fact that Bin never came to visit her in prison and now is not answering his phone makes her nervous. When Qiao finally tracks Bin down, his selfishness dumbfounds her. Not only does he have a new girlfriend, despite Qiao's sacrifice to save his life, but his feelings for her have also clearly changed. He doesn't love her anymore, and for Qiao, that reality is the equivalent of a slap in the face. She now realizes that her whole adult life, she had been a prisoner in both the literal sense and also figuratively as a pawn in a non-committed relationship that had no future.

Almost Lynchian at times, Ash Is Purest White incorporates surrealist moments that serve to shake up the film's otherwise natural sensibilities. The dance club scene early on, in which Qiao and Bin dance with a group

hairstyles and the continuous upgrades in the technology of the times.

Ash Is Purest White is a film about life, love and freedom where coming into one's own can be an ambiguous and anxiety-ridden journey. Qiao learns this the long and hard way as she discovers that she must live her life for no one other than herself. It's a lesson about self-discovery that's not only important, but clearly timeless.

# Who Belongs in College?

Next month I'll board a redeye with 50 high school juniors from South Los Angeles, beginning a nine-day trip to 10 East Coast colleges. There, these new recruits to our non-profit, College Match, will try to picture themselves among the incoming freshmen. They are all highachieving, low-income, first-generation kids of color. The hyphenates, as one student put it. Superheroes, I say.

The recent admissions bribery scandal won't be on their minds, I suspect. Their worry is something different -- impostor syndrome: that even if accepted by one of the elite institutions we visit, they will eventually be outed as frauds by their more affluent and predominantly white classmates. Despite their being every bit as smart and arguably more resilient, it's a fear that nags at nearly every student in our program. By the time these juniors begin college in the fall of 2020, I worry that time will have erased any memory of Hollywood celebrities buying spots in the freshman class. It will once again be minority students at whom fingers are pointed for being undeserving. Business as usual.

Four years ago, as an admissions officer at Harvard College, I was tasked with reading applications from schools all over Los Angeles, public and private. I read essays from the children of affluent west-siders and the children of East LA housekeepers and gardeners, kids very much like the ones I now counsel. Given the ever-increasing number of applications, the odds of admission were abysmally low and remain so. However, a few amazing candidates, from the east side and west, were offered spots. And each year a few were students from College Match. I vowed to myself to keep an eye on the admitted first-gen kids (I'd been one myself 40 years before), meeting them for coffee or a walk on the Cambridge Common. The transition can be difficult and they appreciated our conversations. Maybe as much as I did. But without exception, they struggled with a persistent fear that they were looked upon as impostors. With time, and some real effort from the university, they grew in confidence. They would succeed and graduate. But the fear never left them.

In 2015, my wife and I returned to Santa Monica and I joined College Match. I loved working in college admissions, but find the closer connection with students more to my liking. Playing some small part in their success is a bit like witnessing the miracle of flight.

I joined a dozen dedicated counselors, each assigned to one or more of 31 schools in South LA. There we guide students through the admissions process and provide SAT prep they would otherwise find unaffordable. From early on, we encourage them as writers to express themselves honestly and clearly, to permit themselves to dream extravagantly. Then we push them hard.

It's a testament to the durability of dreams that they dream at all. Their schools are located in some of Los Angeles' bleakest neighborhoods. Their stories reveal that they have already lived through more hardship and abuse than most people will endure in a lifetime. And yet dream they do.

If only we can get them to feel like they deserve it. It can take a long time. Our organization is led by Erica Rosales. Born in East LA, she attended Wellesley before the use of hyphens became the norm. The combination of her pluck and pure luck put her in contact with a Wellesley rep and, just months later, she flew on an airplane for the first time. She made the journey, and the transition to college, completely on her own. Her parents saw the campus exactly once, at her graduation. When she speaks to parents and students, she tells her story without embellishment because it needs none. She returned to East LA, becoming the community organizer she set out to be years before. She started a school. And today she's executive director of the program founded in 2003 by Harley Frankel, who after leading the head start program, saw an uneven playing field for minority students and started leveling it. But she admits she was not immune from the same self-doubt that besets our current students.

When we can provide deserving kids with the opportunities enjoyed by more affluent students, they can achieve whatever they set out to do. Our College Match alumni have proven it. They are now full-time professionals: doctors, lawyers, community organizers and teachers. And each year as we graduate another class of Wonder Women and X Men, they come back to the banquet room at Luminarias in Monterey Park to deliver a message: You belong. You deserve it. Believe it.

Chief Business Official David Wilson dove into the weeds on District finances, including the wrap-up of much of the construction at Wiseburn High, answering questions from Board members about the all-important financial purse strings. Members were also looking forward to the upcoming Rock-Around-The-Block program, which will take place April 6.

Action items passed included an agreement with Studio Roja for brand development and marketing materials; an agreement with USC for the placement of student teachers at Wiseburn; a visitor management proposal agreement with Raptor Technologies that will run the gamut at all District schools; and a positive financial certification as positive as Wiseburn makes its mandated Education Code filing for the remainder of this school year, and the next two.

In other District news, Peter Burnett Elementary Principal Kim Jones emailed about the strides being made at her school as staff has been busy focusing on different campus initiatives, particularly in the areas of math and science. She wrote of recent training that Burnett teachers have received to garner certifications in the Project Lead the Way program; and professional development days relating to the further implementation of Next Generation Science Standards.

On the math side, Jones spoke about the continued focus at Burnett on Cognitively Guided Instruction practices, and the bolstered from front page

support of the math instruction team. She also noted that this spring, Wiseburn will partner with El Segundo Unified School District instructors to "foster a sense of community around math." Jones said the partnership was possible because of an Innovation Grant the school received from the Wiseburn Education Foundation.
