# Longtime Resident Robert Smith Honored as Veteran of the Quarter

As a special prelude to its regular biweekly meeting, the Hawthorne City Council heard updates from the Veteran Affairs Commission that included the presentation of the latest Veteran of the Quarter. Chairperson Kyle Orlemann presented Robert Smith with the Veteran of the Quarter recognition for his service in the United States Air Force from 1955 until his discharge as a tech sergeant in 1969.

“During his 14-year career, he served in a variety of position and duty stations including assignments in Texas, Oklahoma, Japan and Korea, retiring from Edwards Air Force Base in California,” Orlemann read from the official proclamation.

Smith was a jet air craft mechanic and then a crew chief on the renowned T-33 pilot training aircraft before moving to a planning and scheduling maintenance position. He was recognized for his service and bestowed with the Air Force Longevity Award, Good Conduct Medal and National Defense Service Medal.

Smith has also been a resident of Hawthorne for more than 80 years and was a member of the Hawthorne High School’s first graduating class is 1954. After his 1969 discharge, he began his business career in the savings and loan industry and after 22 years began his own company as a provider of management and business services that is celebrating its 29th anniversary.

“His leadership roles include the Westchester Chamber of Commerce, Rotary Club...and for the past 17 years, he has served as a planning commissioner for the City of Hawthorne and is currently the Planning Commission Chair,” Orlemann said.

Mayor Pro Tem Olivia Valentine, who stated

she has collaborated with Smith and the Planning Commission in the past, offered some congratulatory remarks for Smith. “Thank you for all your service to the City of Hawthorne and your service in the U.S. Air Force. It was always a pleasure working with you. I found you to be fair, thorough, always dedicated to what you were doing and even-tempered and just a great planning commissioner,” Valentine said. “You are very deserving of this award and we are very proud of you as a Hawthorne citizen.”

Councilman Alex Monteiro added that he would love for Smith to pass along his knowledge of Hawthorne given his 80-plus years as a resident. “We should be getting a lot of lessons from you,” Monteiro said. “I hope that you could have a book or a memoir about Hawthorne, because I think you have a lot of things to tell us.”

Councilman Mike Talleda, who served with Smith on the Planning Commission as the chairperson, added his thoughts as well. “It was one of the most enjoyable times I spent here in the city and I’m glad to see that you took over my job,” he said.

Councilman Hadir Awad offered his congratulations and joked, “It’s wonderful to see you still here strong and leading our Planning Commission and you’ll lead it well after Mike left and do a better job.” Awad added “I’ve seen you work on the Planning Commission. I’ve seen how you interact with the other commissioners -- especially with Mike -- and you guys always had a wonderful relationship, so I would love to see that continue and thank you for your service.”

Mayor Alex Vargas rounded out the congratulatory remarks for Smith, whom he had

known since joining the City Council. “I think I was on the Civil Service Commission when we bumped into each other. When we finished meetings, we would swap and you guys would come on board,” Vargas said. “You’ve lived in the same area, the same apartment complex for a long time and you are very committed to the City of Hawthorne -- so much so that you frequent our local businesses.”

Vargas added, “You live in Hawthorne, you buy in Hawthorne, you eat in Hawthorne and it looks like you’re going to stay in Hawthorne. Congratulations on your service.”

After the Veteran of the Quarter honors were addressed, Orlemann presented an update on the state of the Veterans’ Commission. Orlemann has led the commission as its chairperson for the past year. “It has been quite a ride,” he said. “Filling Colonel Gaffney’s shoes has been quite a large order, but I have a terrific commission working with me.”

In addition to the ongoing Veteran of the Quarter presentation, Orlemann highlighted the commission’s trip up to Sacramento to visit the Vietnam War Memorial that includes the names of 19 Hawthorne residents who were killed in action during the conflict.

“This past October, there was a 30th anniversary celebration of that memorial and we were able to go up there and represent the City at that dedication,” Orlemann said. “Since the City’s colors are yellow and blue, we came as close to that as we could. We took a basket of yellow flowers in a blue bag and we added 19 red roses, one for each of our veterans.”

## Check It Out

### The Clockmaker's Daughter by Kate Morton

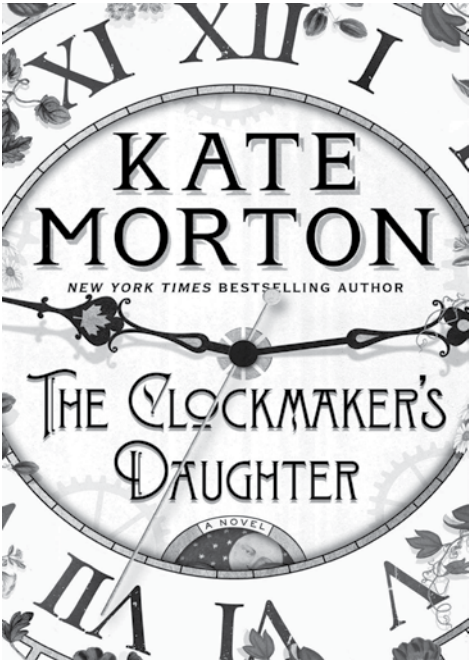
Part ghost story, part mystery, Kate Morton's latest historical fiction book, *The Clockmaker's Daughter*, weaves multiple storylines through time while touching on music, art, war and the supernatural. At first glance, the various characters and their tales don't appear connected... but by the end of the story, they have converged in interesting and sometimes unexpected ways.

Similar to other Morton works, *Clockmaker* features a house, Birchwood Manor, located in a small English village. Throughout the 150-plus years, the house is the setting for joy, grief, love

and even death, but, despite tragedy, endures as a symbol of refuge for characters in need.

Morton excels at crafting tragic outcomes where small decisions in series of events can have far-reaching implications. While readers wish the characters made different choices that might have resulted in happier results, they understand the complex human emotions and complicating circumstances that can lead to the imperfect human decisions. Morton's writing is beautiful, elegantly crafting rich characters that draw you into lush descriptions of their hopes, dreams, disappointments and fears.

## Film Review

### Us Review: A New, Essential American Nightmare

Last year's *Get Out* ended up being more than just one of the scariest and most wildly original movies of recent times. Jordan Peele's horror flick, about a group of African Americans who become enslaved through mind control after getting hypnotized by a family of wealthy Whites, became a pop cultural lightning rod for people to discuss the Black experience of living in America – speaking to both its earliest historical roots of enslavement through the modern anxiety of Trump-era politics.

For such a stunning achievement of a debut, it's no wonder that audiences have been looking forward to whatever Peele's follow-up film would be with feverish excitement. And now, Peele is back with another

enough, being each of their actual selves.

A family of four staring back at their exact opposites, they see these attackers all clad in red jumpsuits, brandishing scissors as weapons and noticeably all mute – except for Adelaide's doppelgänger, Red (also played by Nyong'o). From there, it's a story of the family trying to outlive their attackers, who aim to do away with them and take their place in this world.

Peele, a previous funnyman whose background on the two iconic sketch shows *Mad TV* and *Key and Peele* helped shape him into the brilliant premise inventor that he is, proves more amazingly here that it's his deep understanding of film history that makes him such a gifted talent (the Hitchcock comparisons have been flying his way as of late). While this review could spend even more time unpacking the visual references that are everywhere in the film and their significance (while still not touching on everything), quite simply put, *Us* is everything any audience could want in a movie. And one of the best parts is Peele marries his uncompromising vision with the mindset of being big-screen popcorn entertainment, giving *Us* the opportunity to be seen and discussed by people of all types. And this is what films – the best, paradigm-shifting films – are supposed to do. We should not only escape into something for 100 minutes and return to modern life unchanged, but come back from the experience more learned, or at the very least willing to confront real-world discomforts. So beyond being one of the most unsettling films of this or any other recent year, *Us* achieves an importance that will be recognized, re-watched and discussed for years to come.

suspense thriller – *Us* – which is equally ambitious in its masterfully layered allegory (this review is spoiler-free).

It's this duality that makes *Us* work on two operatic levels: a familiar yet pulse-pounding set-up of a family trying to survive a home invasion, as well as a wildly conceptual existential dread-fest that ties in such gigantic conversations as race in America. When an African American family (a detail that isn't relevant to the story until you think about it symbolically afterwards) vacations at their beach house, haunting memories can't help but pop up for Adelaide (Lupita Nyong'o), who remembers an experience she had when she, as a little girl back in 1986, wandered away from her family one night at the boardwalk only to find herself face to face with another girl – her exact self. It's enough to make for a traumatic childhood that makes her feel not quite herself and sets the stage for years later when her family becomes the targets of home invaders – frighteningly and inconceivably

## Some Things Are Too Toxic to Trash! Free Countywide Household Hazardous and E-Waste Roundup in Hawthorne on March 30

**WHAT:** County of Los Angeles residents will have the opportunity to safely dispose of household hazardous waste such as anti-freeze, unused pharmaceuticals, car batteries, used motor oil, paint, pesticides, home-generated sharps waste such as hypodermic needles, pen needles, syringes, lancets, and intravenous needles, universal waste including household batteries, fluorescent light bulbs, and electronic waste (e-waste) such as TVs and monitors, computers, VCRs, stereos, and cell phones at the next free Countywide Household Hazardous Waste Roundup.

**WHO:** The free Countywide Household Hazardous and E-Waste Roundup Program is brought to residents by the County of Los Angeles and presented by the Department of Public Works and the Sanitation Districts of Los Angeles County in cooperation with the City of Hawthorne and the neighboring cities of Carson, Compton, Culver City, El Segundo, Gardena, Hermosa Beach, Inglewood, Lawndale, Los Angeles, Manhattan Beach, Redondo Beach, and Torrance.

**WHERE:** Betty Ainsworth Sports Center 3851 W. El Segundo Boulevard (El Segundo Boulevard and Doty Avenue) Hawthorne **WHEN:** Saturday, March 30, 2019 9 a.m. - 3 p.m.

**WHY:** The County of Los Angeles Department of Public Works and the Sanitation Districts of Los Angeles County conduct more than 50 free Household Hazardous Waste and E-Waste Roundups annually throughout the County to provide residents with a convenient way to rid their homes of unwanted hazardous materials. Because hazardous waste can pollute the environment, it is illegal to discard these items in trashcans, sinks and storm drains. The Roundups are part of a campaign to promote public awareness of proper disposal practices of household hazardous and e-waste and to provide a convenient, free disposal option. BE IT ENACTED BY THE COMMISSION OF THE CALIFORNIA STATEWIDE COMMUNITIES DEVELOPMENT AUTHORITY: SECTION 1. Pursuant to California Government Code Sections 53316 and 53340, and in accordance with the Rate and Method of Apportionment (the "RMA"), as set forth in Exhibit E of Resolution No. 19SCIP-1 (the "Resolution of Intention") adopted January 24, 2019, as incorporated into Resolution No. 19SCIP-35 (the "Resolution of Formation") adopted March 7, 2019, with respect to the California Statewide Communities Development Authority Community Facilities District No. 2019-01 (333 North Prairie), City of Inglewood, County of Los Angeles, State of California (the "Community Facilities District"), a special tax is hereby levied on all taxable parcels within the Community Facilities District for the 2019-2020 fiscal year and for all subsequent fiscal years in the amount determined by the Community Facilities District in accordance with the RMA, until collection of the Special Tax by the Commission ceases and a Notice of Cessation of Special Tax is recorded in accordance with Section 53330.5 of the Act, provided that this amount may in any fiscal year be levied at a lesser amount by resolution of the Commission. SECTION 2. The Authority's special tax consultant, currently David Taussig & Associates, Inc., 100 West San Fernando Street, Suite 430, San Jose, CA 95113, telephone (800) 969-4382, is authorized and directed, with the aid of the appropriate officers and agents of the Authority, to determine each year, without further action of the Commission, the appropriate amount of the Special Tax (pursuant to, and as that term is defined in, the Resolution of Formation) to be levied for the Community Facilities District, to prepare the annual Special Tax roll in accordance with the RMA, and to present the roll to the Commission for consideration. SECTION 3. Upon approval by the Commission, whether as submitted or as modified by the Commission, the special tax consultant is authorized and directed, without further action of the Commission, to provide all necessary and appropriate information to the Los Angeles County Auditor in proper form, and in proper time, necessary to effect the correct and timely billing and collection of the Special Tax on the secured property tax roll of the County; provided, that as stated in the Resolution of Formation and in Section 53340 of the California Government

SECTION 4. The appropriate officers and agents of the Authority are authorized to make adjustments to the Special Tax roll prior to the final posting of the Special Tax to the Los Angeles County tax roll each fiscal year, as may be necessary to achieve a correct match of the Special Tax levy with the assessor's parcel numbers finally utilized by the Los Angeles County Auditor in sending out property tax bills. SECTION 5. The Authority agrees that, in the event the Special Tax is collected on the secured tax roll of Los Angeles County, the County may charge its reasonable and agreed charges for collecting the Special Tax as allowed by law, prior to remitting the Special Tax collections to the Authority. SECTION 6. Taxpayers claiming that the amount of the Special Tax on their property is not correct are referred to Section F of the RMA for the proper claims procedure. SECTION 7. If for any cause any portion of this Ordinance is found to be invalid, or if the Special Tax is found inapplicable to any particular parcel by a court of competent jurisdiction, the balance of this Ordinance, and the application of the Special Tax to all other parcels, shall not be affected. SECTION 8. This Ordinance shall take effect and be in force thirty (30) days after its final passage; and before the expiration of fifteen (15) days after its passage a summary of the same shall be published, with the names of the members voting for and against the same, at least once in a newspaper of general circulation published and circulated in the area of the Community Facilities District.
