Mayor Vargas Touts City, Business Development Successes in Address

Hawthorne Mayor Alex Vargas covered a number of topics during his State of the City speech earlier this month. In addition to spending half of his speech touting the success of Hawthorne schools over the past year, the mayor also touched on the police department, city projects, and major business developments in town.

Vargas first spoke about the Hawthorne Police Department, which underwent change in leadership recently with former Chief Robert Fager retiring and current Chief Mike Ishii being confirmed to his new role. "The Hawthorne Police Department continues to keep our community safe and making a high impact in the community," Vargas said. "Chief Ishii brings a wealth of experience, knowledge and community partnerships that will help the department to continue to grow and provide the best public safety services to the residents of Hawthorne."

A few Hawthorne Police Department projects were highlighted as well. "Our police department is addressing [the homeless] by creating the Community Improvement Task Force, which focuses on providing services to those who unfortunately are out on the streets and are unable to have shelter and find the resources to make it through life," Vargas said. The task force handled "over 900 homeless outreach incidents," last year.

"The chief has also pledged a renewed commitment in partnering with our local schools in order to provide the best possible safety and security for the staff and the students," Vargas said. "There's a strong focus on active shooter training, medical aide training, and traffic safety."

The police department's Safe Parks Initiative has also seen positive results, according to Vargas. "In 2018, the police department conducted over 3,200 park checks across the city," Vargas said. "With the installation of security cameras at all the major parks, the police department now has the ability to monitor and respond to incidents with increased safety to our police officers."

In 2018, the Hawthorne Police Department hired 10 new officers to fill in vacancies that exist and continue to hire this year due to the vacancies from retirements. "Our Coffee with a Cop continues to be highlighted around the world and adopted," Vargas said.

Vargas said that recently a police department in Australia adopted the program and there has been some interest from Mexico.

Public Works was the next topic that Vargas highlighted. "The City of Hawthorne's Public Works Department has been continuing its tremendous efforts to improve our city," he said.

Vargas broke down the projects into three categories – the completed projects, the projects that are in progress, and the maintenance of the projects. Among the completed projects were \$310,000 in storm drain inlet improvements, \$320,000 in alley improvements, \$2 million of intersection widening and traffic signal improvements at Inglewood Avenue and El Segundo Boulevard., plus traffic improvement at Crenshaw Boulevard and Rocket Road, and at Crenshaw Boulevard and Northrop Avenue. Of the Crenshaw and Northrop project, Vargas noted that "it is right

there at SpaceX making sure that employees are safe when crossing the street."

Among the projects currently in progress, Vargas highlighted the \$5.2 million Hawthorne Boulevard Improvement project, \$6.4 million El Segundo Boulevard Improvement project, \$280,000 for Hawthorne Municipal Airport Master Plan updates, and an aerial survey to "measure things through pictures over the city of Hawthorne." Additionally, there is a \$500,000 project to address Hawthorne Municipal Airport noise exposure map updates.

Among the maintenance updates, Vargas mentioned that 27,000 square feet of allies and sidewalks were reconstructed, 20 local streets have been repaired, 1,400 square feet of sidewalks have been grinded down, 780 catch basins were serviced, 104 square feet of graffiti have been removed, and 120 miles of sewer pipe have been serviced.

The City has also distributed 70,000 quarterly environmental newsletters to the community and businesses and implemented the Green Business Certification Program with 15 businesses already certified. "Whenever there's something that goes on during the week – an accident, and we need to block off the streets or clean up, these are the people we call. We have people on call that just get up in the middle of the night because of their dedication," Vargas said.

The final topic for the evening was about the development in Hawthorne. "Development in our city has been moving forward and with great speed," Vargas said. "We have a Room Garden Inn hotel that staff has been

Film Review

Mary Magdalene: A Timely, Quietly Captivating Biblical Drama

Just in time for Easter Sunday comes Mary Magdalene, another emotional drama from director Garth Davis (Lion) that brings the story of the apostle (or mythical apostle, depending on whom you ask) Mary Magdalene to light for the first time. Aside from the film's visual beauty, it's important to note that Mary Magdalene is the last film score by the incredibly gifted composer Jóhann Jóhannsson.

The film opens on a shot of a woman drowning -- her wavering, sinking body looking more like an underwater ballet than a death. This imagery is strong, but should not be taken literally. It is her the perfect Mary. She reteams with Garth Davis and delivers a simmering performance. From Jesus to the Joker in a matter of months, Joaquin Phoenix flexes his range as an actor as the proverbial Son of God. This film proves that he really can do it all.

Throughout the film, Davis is respectful to the religion and the beliefs of Christians, handling the crucifixion and miracles with sensitivity. He even goes so far as to dispel the popular "rumor" that Mary Magdalene was a prostitute. In one of the title cards at the end of the film, a statement reads this was a "misconception" started by Pope Gregory in 591 AD.

made to resemble Mary's (Rooney Mara) suffocation at the hands of her father, her arranged marriage and her lack of a sense of purpose. Mary is beautiful and headstrong -- two qualities that aren't compatible with her time -- and so all she can do is pray for change. When news spreads that a mysterious man named Jesus (Joaquin Phoenix) has come into town, claiming he knows the path to God's kingdom, Mary finally sees a way out. Without hesitation, Mary follows her faith and blindly follows Jesus and his disciples, including Peter (Chiwetel Ejiofor), on his journey to preach the word of God.

Mary falls under the spell of the bearded messiah after witnessing him heal the blind and bring people back from the dead, but it is their intimate, abstract discussions that bond the two. There is no romance between Jesus and Mary. It is purely platonic (off-screen, however, Phoenix and Mara found love on the set). Mary is there with Jesus until the very end as he hung lifeless on the cross. She was there when he was buried in the tomb made of rocks. And she was the first person to witness his resurrection.

Rooney Mara's ethereal beauty and wideeyed innocence are natural features that make Morgan Ro

Believer or not, there is a quiet captivation in Mary Magdalene that audiences will find themselves lost in, be it the picturesque surroundings, Mara and Phoenix's chemistry, or the gift of hearing Jóhann Jóhannsson's final musical score one last time.

Mary Magdalene is rated R. 120 minutes. Now playing at Laemmle theaters and on VOD and digital platforms.




Check It Out

Wiseburn Looks at Small Reading Group Instruction at Cabrillo

Last Thursday evening, the Wiseburn School Board members viewed a presentation form Cabrillo Elementary Principal Lisa Baggio and her colleagues regarding the implementation of the school's "Small Reading Group" instructional program. Baggio and her presenting team opened with the tenet that their mission statement is to "nurture the whole child to love learning," adding the tagline that "we learn and grow together." The next slide of the presentation portrayed school 2019 goals, including the implementation of the small reading group program and development of an inclusive, multi-tiered system of interventions to support the program.

Baggio talked about what she termed the PEDR cycle as one the school's 2019 goals, which means "plan, execute, debrief, reflect." The presenters spoke of building foundational literacy skills as a cornerstone to enriching learning opportunities for Cabrillo students. Cabrillo students also were present and spoke to the Board about the value that they have gleaned from the small reading group program.

The presentation stressed the need to build on foundational skills to help students achieve at their highest levels, and delved briefly into the available research that shows the benefits of offering an environment "for teachers and students to provide extensive opportunities to express what they know, and receive feedback from other students, and the teacher." IT also noted that studies show "instructional conversations are easier to support with a small group of students."

The next slide presented posed the question to instructors: "How am I meeting the needs of my students?," and noted how the best avenue was to propose one specific strategy or skill to a group of students who are at a similar reading level and utilizing the same book, as well as targeted mini-lessons and development of strategy groups that target skill rather than a specific rote reading level. These tactics intend to help English Language learners succeed by strengthening their grasp of vocabulary and phonics, as well as implementing decoding and comprehension strategies, developing vocabulary fluency, helping in the analysis of text, and opening avenues to participation in book clubs.

The presenters next played a quick video, which portrayed students' thoughts on participating in the small reading groups, and why the elementary school students felt it valuable. Six benefits of small reading group instruction were highlighted, including the benefits of individualized learning; the confidence gained by participants; the opportunity to glean effective feedback; the collaboration that takes place; the increase in students reading ability; and tracking individual strengths and needs.

The next steps highlighted were the continued use of data for the 2019/20 school year to bolster small reading groups, the continuing teacher-to-teacher observations about the program, and professional development opportunities for teachers that will be ongoing.

Post-presentation, Wiseburn Unified School District (WUSD) Superintendent Dr. Blake Silvers emailed, "Cabrillo is a dynamic school. Every time that I am at the school and see the Cabrillo staff, a smile comes to my face. The teachers and the entire Cabrillo community are exceptional and such an integral part of what makes our district tick. One word that would describe Cabrillo is...amazing!"

In Board member reports, which followed the Cabrillo presentation, Dr. Neil Goldman opined how he believed that "individualization is the key to success, if somebody knows that you care about them," and how he was happy to attend the recent Anza Elementary open house, commenting that he saw "joy" and that "if learning is fun, that is half the battle."

President JoAnne Kaneda gave her blessing to the Cabrillo presentation, saying it was "so fun, and so professional. When you can combine that professionalism with fun, there is a lot of learning going on."

In his comments, Silvers echoed the earlier remarks made by the Board regarding the recent Rock Around the Block (RAB) festivities, and drew attention to the Community Advisory Committee and the awards bestowed on District employees who have enriched the lives of children with disabilities. He mentioned honorees Lisa Downer, Madison Scar, Stacey Henry, Melissa Mathias, Dana Stern, Mathew Gomez, Pleshette Mojonnier, Kim Jones, Cathy Ginter and Marie Hornback.

"I am proud to be a part of such a caring group of educators who ensure all students receive a great education," Silvers emailed. "But most noteworthy is the commitment and love that our teachers exhibit each day they work with the students."

In other District news, the Wiseburn Education Foundation (WEF) Interim Executive Rebecca Hamburg reported on the RAB activities that took place on April 6. Hamburg emailed that more than 1,000 members of the Wiseburn community participated in the 16th annual festival that brings students, parents and community members together to support top-notch educational programs. Hamburg wrote that through programs like RAB, the WEF can further music and art instruction and continue to support STEAM education and the "Growing Great" nutrition program.

Hamburg emailed that more than \$70,000 was raised at RAB festivities, with food, games, community booths and a silent auction taking place. She noted the participation of Wiseburn High School's rock band, as well as bands from the middle and elementary schools. She also touted the work of WUSD art students under the tutelage of Tiffany Graham, who staged a live painting event during the festivities that added to the proceeds.

Silvers was effusive in his praise if the people who planned and executed the RAB carnival. "I am extremely grateful to the WEF team," he said, lauding the work of President Debbie Felt, as well as Hamburg. He also mentioned a new event that occurred at RAB: a fitness challenge led by Dana Middle School physical education teachers. "We continue to pride ourselves on providing diverse learning opportunities for our students that focus on the whole child," Silvers said. "The expertise of our arts team was on full display, and it was evident that various forms of art bring our community together."

Anza teacher Suzanne Guidi emailed information about her campus second annual Eagle Expo, which showcased learning in the area of the design thinking process, through 3D design and the additive process. She wrote that 68 students presented at the April 3 expo, which featured approximately 150-200 community members in attendance, including District administrators and employees. Guidi wrote that the expo highlighted a program that has helped young learners increase their proficiency in developing their design skills, acceptance of failures and motivation to quickly revise their design pathway.

Wiseburn's spring break commenced on Monday, April 15. Upcoming WUSD events include the next regularly-scheduled Board meeting, on April 25, and Anza Elementary Math Night on May 2. •



reviewing and facilitating approval of this brand new 131-room hotel. It was approved in December 2018 and is to be located near Imperial Highway and Hawthorne Boulevard."

Vargas also briefly spoke of The Boring Company's underground tunnel running below 120th Street from Crenshaw Boulevard to Prairie Avenue saying, "This is Elon Musk's project, which hopes to create a flawless underground transportation system to alleviate any of our traffic problems."

Vargas also touched on the Marriott hotels that opened up recently across from City Hall. "These two hotels contain 354 total rooms, a gourmet bistro, and two more dining experiences to come," he said.

Vargas added that Planning Department staff has commissioned a site at 14550 Aviation Boulevard to repurpose and facilitate an almost 80,000-square foot office campus to meet the growing needs of the area. The campus will include a bank, corporate offices and restaurants.

Vargas also thanked representatives from Ring, the security camera company owned by Amazon, for choosing Hawthorne for its new headquarters. The company was previously located in Santa Monica.

Urth Caffé has called Hawthorne its corporate home since 2016 and recently closed out all the permits for its Hawthorne restaurant, which Vargas said would be opening very soon. "There's a lot of momentum happening. A lot of people wanting to come in and open up shop, so I'm really excited about that and I know the residents, businesses and the community leaders are [as well]," Vargas said, adding that the Planning and Building Department processed 604 plan checks that represent nearly \$43 million of investments in the city - a 15 percent increase over the previous year. •
