TWBI Students Make Final Preparations for End-Of-Year Performance

Students and staff at Ramona Elementary School are fine-tuning the final details for the annual End of the Year Dance Performance for the Two-Way Bilingual Immersion Academy to take place at Hawthorne Memorial Center on Tuesday, May 12 beginning at 5:30 p.m.

The evening’s event is a celebratory culmination of the TWBI program’s year-round effort to help students develop into bilingual Spanish- and English-speakers, while learning to read and write in both languages as well.

“We have Catherine Wahl, who comes in once a week on Tuesdays [to teach kids to dance] and at this point there are three to four teachers that do their own choreography with students,” English Learner Specialist with the Hawthorne School District Miguelina Lopez said. “One of our former TWBI teachers, Norma LeRoy, continues to make skirts for the [girls]. She donates her time and makes them herself; she is fabulous. She [LeRoy] always checks in at the beginning of the year and makes the tuxes for the boys so that they match the skirts for the girls.”

The teachers and instructors work with kids enrolled in TWBI in each grade level, Kindergarten through fifth grade, to prepare for the end-of-year dance beginning in October. In addition, TWBI introduces students to other elements of culture aside from dance and language.

“Each grade level will have a different focus such as Mexico in one grade, Central America in another group and South America with the third group,” Lopez said. “At the performance on Tuesday, there will be booths and tables set up with the culminating projects that the kids at each grade level worked on as part of the TWBI program and what they have learned.”

The kindergarten and first grade students will present their projects entirely in Spanish;

by third grade the projects begin to include more English and by fifth grade there is an equal presence of English and Spanish.

TWBI, an opt-in program available to Ramona Elementary students, emphasizes Spanish instruction in the early grades that allows English-speaking students ample exposure to the target language-Spanish. English reading is introduced by the third grade. The program also allows Spanish-speakers the opportunity to expand their vocabulary and build a strong base in their first language, while helping achieve more success as they begin to acquire English oral skills, as well as down the line when they transfer into reading and writing in English.

“They slowly get immersed into the English through the years so by fourth and fifth grade it is fifty-fifty,” Hawthorne School Board Superintendent Dr. Helen E. Morgan said. “They truly are bilingual/biliterate by fourth and fifth grade.”

The test numbers used are from two years ago, since that is the last time state testing took place, demonstrated a steady trend of proficiency among students in the TWBI program. It was noted by Dr. Morgan that second and third grade kids have lower test scores; however, it is only because the kids are required to take an English test when they haven’t had any real instruction in English, since the first years of TWBI dictate instruction in Spanish.

Due to the differences in in the immersion program to that of non-TWBI students, the parents are made aware of the structure of the program and the expected student growth.

Still, parents have demonstrated strong interest enrolling their children in TWBI, causing the program to grow at a steady rate since its inception 18 years ago.

“We have so many people trying to opt in right now that there is a possibility that we are going to have to open a third kindergarten class next year,” Dr. Morgan said.

TWBI is also very parent-involved and has several resources available for them, including a homework hotline, for English and Spanish speakers, through where they can connect with other parents.

“We support the parents via TWBI parent meetings, where they are invited to come in and the teachers give an update on the program and what is happening,” Lopez said. “There are activities where the parents learn what the teachers want parents to focus on, in order to give parents the tools to help the children at home.”

Tuesday’s performance is a culmination of another successful year for TWBI students, who now have the opportunity to continue the TWBI academy during sixth, seventh and eighth grade.

“Usually kids are very shy and bashful when they aren’t comfortable with what they are doing,” Dr. Morgan said. “But these kids are confident in going up there. Sure, you will see one or two kids who get shy, but they do a good job. It is heartwarming and one of my favorite events of the year.”

The Hawthorne Memorial Center is located at 3901 W. El Segundo Blvd. in Hawthorne. The performance is free and begins at 5:30 p.m. •

Financial Management Tips for Adult Learners Going Back to College

(BPT) - The ever-rising price tag of college education has been in the news for years, with the average cost hovering just less than \$20,000 a year, according to the National Center for Education Statistics. That number, however, speaks to first-timers enrolled full-time in a four-year or two-year college. If you’re considering returning to school as an adult learner, it’s essential to find effective ways to control education costs and manage your overall finances. Here are five steps that can help you control costs while earning a degree:

1. Comparison shop for the best tuition and costs.

While more than one institution may offer the degree program you want, costs will vary



from school to school. Many adult learners find that online degree programs offer the best value in terms of cost and quality of education. Not only is tuition typically less, online programs offer adult learners greater schedule flexibility - so they can continue earning a living wage and arrange their schedules to minimize costs like childcare and transportation.

2. Prior learning assessment credits may lower costs.

First-time students have a lot to learn, and the costs of a full-time education at a four-year college reflect that. Adult learners, however, already have professional and

life experience under their belts, and many institutions have created programs that take this into account. Credit you earned at other colleges or universities may transfer to the institution where you’ve chosen to continue your education. You may hold professional certifications, licenses or corporate training that could also qualify as college-level credit toward a degree. 3. Find ways to lower textbook costs.

After tuition, textbooks are a significant

expense - for both adult learners and first-time students enrolled in a full-time degree program. Many schools sell used textbooks at a lower cost than new. You may also be able to buy or rent textbooks through a variety of independent online websites. Many online degree programs also include digital copies of text book and course materials with no extra charge.

4. Explore financing options.

Paying for college is a complex endeavor, regardless of whether you’re an adult-learner or a first-time student. It’s important to explore all financing options - from loans and grants to other forms of financial aid. Many employers offer tuition reimbursement programs, while other students may qualify for additional assistance for their service in the military. To determine if you are eligible for federal financial aid, visit studentaid.ed.gov.

5. Practice basic financial planning.

Smart money management habits are always valuable - especially when you’re paying for a college degree. If you haven’t already done so, create a personal budget or a household budget that will allow you to closely track monthly expenses and income. Curtail discretionary spending, but don’t eliminate important long-term financial goals such as saving toward retirement or to buy a home.

“Improved earning potential is one of the many benefits of returning to school,” Lorenz notes. “With research and planning, adult learners can protect their financial wellbeing while earning their degree.” •

Animo Has Unbeaten League Record

Brian Rocha went four-for-four with two RBI's and five runs. Animo (13-3 overall) will take on Environmental Charter from Lawndale at Kendall Field in Torrance tonight at 6:30 p.m. in another league game. The Aztec-Eagles, then, host Newport Beach Sage Hill at the Urban Youth Baseball Academy in Compton next Wednesday at 3 p.m.

Environmental, meanwhile, is struggling with a 1-9 overall record and is 1-3 in Harbor action after a 7-3 loss at Shalhevet on April 27. Shalhevet scored three runs in the bottom of the first inning and four runs in the second before the White Tigers scored three in the top of the third. The rest of the game was scoreless.

At Hawthorne on April 28, the Eagles rolled over the Cougars 16-4. At Stevenson Field on the ground of El Segundo Recreation Park last Thursday, the Eagles overwhelmed Hawthorne

23-0. Both games ended after five innings due to a mercy rule coaches' agreement. At Hawthorne, the Eagles rolled to a 16-0 lead before the Cougars scored all four of their runs in the bottom of the fifth inning. Senior Chris Phelps, one of the two Phelps brothers (the other being sophomore Charles) who transferred to Hawthorne from El Segundo prior to last season, had two hits and drove in a run. Caregiving Expert Gives Advice on Advanced Estate Planning

“I’m a caregiving expert, with more than 30 years of experience in the field of aging, so you’d think I’d be fully prepared for a loved one’s death, especially when that person is older or has been battling illness. Yet even for me, death caught me by surprise.”

There are many things caregiving expert Amy Goyer wished she would have asked before her mom and sister passed away. She says that it’s harder for her to feel that she totally lived up to her responsibilities as executor of their estates.

Her recent AARP article, titled “5 Questions I Wish I Had Asked Before They Died,” explains that she is going to ask her other sisters and other loved ones about this type of information now—long before she hopes she’ll ever need it. She has in place the proper advance directives, estate and financial planning, but she says that she’ll also be more thorough with the finer details. To that end, the author

recommends asking these questions:

Where is important paperwork located? The author of the original article thought she had the most recent valid copies of her sister’s legal documents; however, that wasn’t the case. She had to search through mountains of paper! Your loved ones may know where their financial and legal documents are located—but that’s no help after they’re gone.

What are the details of what you want for your memorial service? Obviously with the stress of losing a loved one, any decisions about the service that can be made in advance are most helpful when relatives are deep in shock and grief. Discuss details with them like music, the service location, speakers, flowers, and food.

Who should get your personal items? The article urges you to catalog your collectibles, jewelry, and special mementos. Most people fail to list these items in their wills.

Who is in that picture? Many folks have stacks of family photographs of people who look familiar, but they’re not sure who they really are. To avoid this, label each photo when discussing it with your loved ones and hang on to that family history.

Finally, the original article stresses that you don’t let your hesitancy to talk about death keep you from bringing up these subjects with your family. Start the conversation early and have them often; it will help reduce the awkwardness.

Remember, as much as we hate to face it, death is inevitable for all of us. The better prepared we all are—in addition to the basic legal documents—the easier it will be when the time comes. •

Tech Talk

My Internet Connection is Slow. Should I change providers?

There are several reasons your internet connection may seem slow. Before you jump to the conclusion the problem is with your Internet Provider you need to do some investigation.

First, run a speed check of your Internet Provider. This is actually quite easy to do. A speed test program will test the speed of your computer connecting to the Internet – called the “upload” speed. It will also test the speed of copying data from the website onto your computer - called the “download” speed. There are many speed test programs available. You can search by typing “internet speed test” into your search engine. One I found on Google is <http://www.speakeasy.net/speedtest/>.

After you run the speed check and have both the upload and download speeds, compare them to the contracted speed of your Internet provider. Most of the time you’ll find the Internet Provider is not the problem. If yours is not, continue the investigation.


The most common cause of a slowing computer is a virus or malware. Check your virus protection or malware program status. You may find your computer is infected and needs attention. Follow the steps to clean or quarantine the problem.

Another possibility can be a problem with a specific program. If one program seems slow, log in to a completely different program to determine if the problem is widespread or limited. I use Quickbooks to manage my accounting so I’d log in to Quickbooks to see if I still notice a similar response time problem. If the slowness only occurs in one program, you have probably found the culprit. If the slowness affects multiple programs, your computer may be to blame.

After investigating all of these without finding any issues, your computer itself may be the source of the problem. You will most likely need help from a local computer expert who can evaluate further. If you live near Torrance, I’d recommend PC Parlor run by Tony Musorafite. Ask for his bench rate, which is very reasonable.

Hopefully, these tips will help you find the problem and get your computer back up-to-speed!

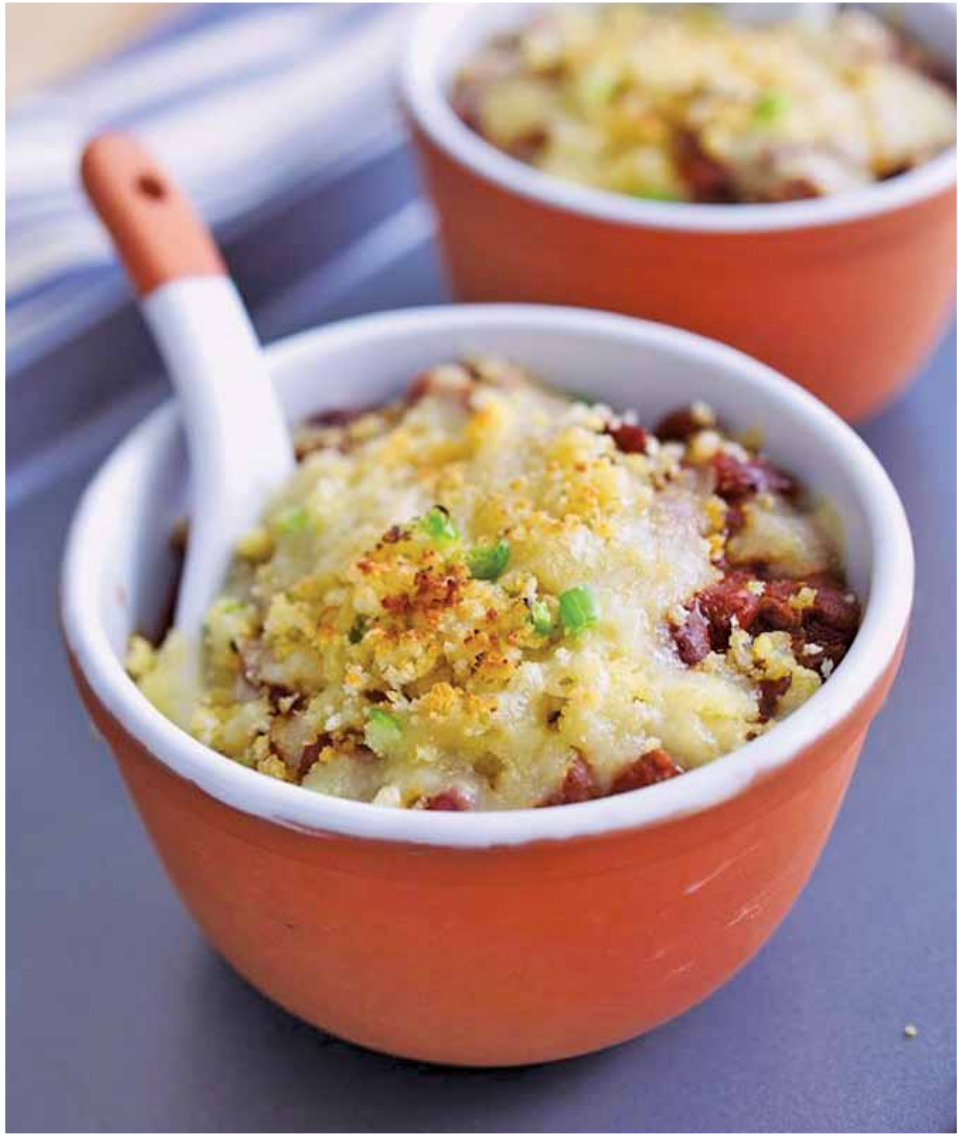
