




# Check It Out

The Seven Husbands of Evelyn Hugo is a scandalous novel written by Taylor Jenkins Reid about a young, inexperienced journalist who gets the opportunity of a lifetime to interview Hollywood's glamorous and oh-so-outrageous Evelyn Hugo. As with

# **Burning:** This South Korean Thriller Will Fire You Up

Burning (available to stream now on Netflix) tells the story of a directionless Jong-su (played by acclaimed Korean film star Yoo Ah-in), who falls into a love triangle with a girl from his hometown who herself has the affection from a wealthy playboy.

The drama begins with a chance meeting when Jong-su runs into his mysterious childhood neighbor Hae-mi (played with wide-eyed calls Ben a Korean Gatsby, ranting, "How does he live like this at his age? Traveling abroad, driving a Porsche, listening to music while cooking pasta." He seems to believe that Ben is everything insincere, while his own connection with Hae-mi is real. Jong-su claims he's an observer of life's mysteries rather than a judge, but we watch as his -- and our -- judgmental, pattern-seeking impulses flare at Ben's behavior. It's not long until Jong-su gets the

intensity by Jong-Seo Jeon) after she has been rendered unrecognizable by plastic surgery. She's a free-spirited presence who sweeps Jong-su into a relationship. She loves to reinvent herself, dancing and speaking with a vulnerable rawness that Jong-su lacks. The plot thickens when Haemi travels to Africa alone to seek out a group that teaches people to release the small hunger of life to seek the "Big Hunger" of spiritual meaning. When Hae-mi returns, she is joined by the fit and wealthy Ben, played by Steven Yeun (Walking Dead, Sorry to Bother You) in his first Korean language role. Once this main trio is in place, the film bursts with ambiguous rivalries.

Jong-su and Ben are constantly contrasted. Where Jong-so is slouching, Ben is suave. While Jong-su is burdened by his family's financial troubles, Ben commands vast wealth. Jong-su idea that Ben's interest in Hae-mi is sinister.

Accomplished director Lee Chang-Dong knows just when to mete out information to keep an audience yearning, adding more mysteries and ominous moments to the film's Jenga-like structure. Much unease stems from the unsatisfied, troubled characters, who all have reasons to tease, manipulate or harm one another to fulfill their own desires.

I won't spoil the conclusion. I'll only say that the more we watch these characters, the less sure we become of them. Are their relationships sincere or transactional? Are their memories honest or unreliable? If creeping dread and haunting mysteries fire you up, you'll get endless fuel from Burning.

#### Down Year for Baseball Attendance? Not With Supportive Dodgers Fans

The Los Angeles Dodgers keep winning on the bases and at the turnstiles. The Blue Crew are the best-drawing team in Major League Baseball and playing before bigger crowds this season at home and on the road. That's exactly what baseball needs right now.

Attendance is shrinking at Major League games, though poor weather and underperforming teams with losing records explain some of the drop-off at National and American League ballparks. Eighteen of the league's 30 teams reported smaller crowds in April and through mid-May. The Dodgers, who are trying to win the club's first World Series title in 30 years, have responded so far to the challenge. The team's Southern California fan base has responded by turning out for home games in bigger numbers.

Los Angeles leads the league in home attendance through the first 25 games, according to ESPN baseball figures. Average attendance at home was a league-leading 47,119 fans per game. L.A. surpassed the 1 million home attendance mark by mid-May despite losing Yasiel Puig and Chase Utley, two of the team's most popular players.

The Dodgers traded Puig to the Cincinnati Reds during the offseason, and Utley retired. Utley's fans in Philadelphia, where he played before coming the Dodgers, have embraced the Phillies and their new free agent outfielder Bryce Harper. The Phils are one of only three teams, including L.A., to draw over 1 million fans at home this season. The New York Yankees are the other. All three teams currently sit in first place in their divisions.

Twelve teams are bucking the league-wide trend of smaller crowds, though. Philadelphia and MLB superstar Harper have increased home attendance by 302,219 fans through the first 28 games. The San Diego Padres, with former Dodger Manny Machado now playing for them, have boosted home crowds by 80,000 through the first 26 games. Another California team, the Oakland Athletics, have seen brisk business at the stadium turnstiles too, adding 60,000 fans

through the first seven weeks of this season.

Down south in Anaheim, the Angels soon will hit the 1 million attendance mark, but it's taking longer than last season. The Angels' home crowds are down by 53,000 so far. The team's home attendance stood at 857,694 after last weekend's three-game homestand.

The Dodgers have remained the number one team for attendance in the Major Leagues for the past six seasons. They leapfrogged the Phillies in 2013 for the highest attendance in Major League Baseball. The Yankees outdrew both L.A. and Philadelphia back in 2010.

The San Francisco Giants are losing paying fans faster than any major league team this season, ESPN's figures show. The Giants -- who ranked fourth last season and drew more than 3 million spectators at home -- are in a freefall. The team ranks 10th in attendance and is last in the National League West. San Francisco and Los Angeles were the first major league teams to relocate from New York to the West Coast between 1958 and 1959.

The Dodgers made the list too. They've added 866 paid admission per game over last season. Milwaukee's Brewers, another playoff team from last season, gained about the same number as L.A: 896. The Brewers play in a climate-controlled domed stadium, where fans watch games without braving the wind and cold that the league says has contributed to smaller crowds, including at Yankee Stadium. Attendance in the Bronx is down 2,763 per game, and players in early-April games wore

# **Council United in Opposition of State Housing, Cannabis Bills**

The Hawthorne City Council continued its opposition to potential state-mandated laws that would erode local control over issues such as low-income housing and cannabis during the group's most recent meeting.

The Council voted unanimously to oppose State Assembly Bill 1356, introduced by Assemblymember Phil Ting of the 19th District, which encompasses western San Francisco and northern San Mateo County. The bill states that if a local jurisdiction received more than 50 percent of the vote in favor of legalizing cannabis in last November's election, that city would be required to issue a minimum number of local licenses authorizing specified cannabis retailers. Hawthorne had a 58 percent vote in favor of legalizing marijuana.

"Our city prohibited the sale of cannabis and since that time, there has been a real push by Sacramento to pressure the cities into accepting marijuana in some form," Mayor Pro Tem Olivia Valentine said. "This latest bill requires cities to issue cannabis licenses based solely on the percentage of city residents who voted in favor of cannabis sales. What they're saying is if this bill passes, those cities would be forced to allow a certain number – and they've got a formula for the number of facilities that must be established."

The bill calculates the minimum requirement by dividing the number of currently active alcohol sales licenses in the city by 1/6, or one license for every 15,000 residents in the city, whichever of those two is greater.

"This is another example of local control," Valentine added. "Our city did vote to ban the sale within our city and there have been several bills and regulation was passed that subverted cities that had banned sales that said deliveries could be made to any legal address anywhere in the state." Valentine requested that the Council send its opposition of the bill to Assemblymember Autumn Burke, State Senator Steven Bradford and Governor Gavin Newsom.

#### Eleven Lennox Students Awarded Full Scholarships for LACMA Summer Art Programs

The Los Angeles County Museum of Art (LACMA) awarded full scholarships valued at \$1,685 for summer art programs to 11 Lennox Middle School students on Wednesday, May 15. The LACMA awards scholarships to promising students who do not have the financial means to attend an art class. These scholarships are available for students ages 6–17.

The LACMA offers a five-week Kids Art Class for students ages 10-13 to explore printmaking, typography and patterns with innovative techniques using conventional and unconventional materials. Six students from Lennox Middle School will be able to attend the courses at no cost and learn from Gloria Westcott, an artist, educator, curator and producer who has been based in Los Angeles for over twenty years.

The second course, Sketching for Teens, will provide students the opportunity to develop their drawing skills. They will receive

a sketchbook and portable media such as graphite pencils, colored pencils, charcoal, and oil pastels. Five Lennox Middle School Students will work with Jenny Ziomek, a painter, illustrator and writer, to develop their personal styles.

Lennox Middle School and LACMA representatives presented the scholarship awards to students in front of family and friends. The Kids Art Class program will begin June 2 and the Sketching for Teens class will begin July 20.

"We are extremely thankful for this opportunity," said Rafael Ramos, teacher at Lennox Middle School. "It was a great surprise to all of us when we heard 11 of our students are going to be part of this amazing experience. They definitely deserve this opportunity and much more! They are talented kids. I can't wait to see what they create and learn as a result of the program."

"It sounds like these guys are up there smoking this stuff themselves," Mayor Alex Vargas joked, adding that, "I would like to know how our representative - our assemblymember, our state senator – where they stand on this issue."

Valentine theorized that the reason the state was pushing cannabis sales on local jurisdictions was because of a disappointing start to the economic side of legalization. "They promised cities that they were going to make millions and millions of dollars if they allowed cannabis in the cities and it didn't work out that way because a lot of times, the illegal distributors would outnumber the ones that were legal," she said. "The cities and legal distributors were not making the money they thought they were going to make and the illegal distributors were making out like fat rats. I think the state is trying to find a way to force the cities to accept dispensaries in their cities to help the cannabis manufacturers."

The Council also stood united in opposition to AB 1763, which is being referred to as the Density Bonus Law. Assemblymember David Chiu, who represents the 17th District that encompasses the eastern half of San Francisco, introduced the bill.

The bill requires a city or county to provide a developer that proposes a housing development

with a density bonus or other incentives or concessions for the production of lower-income housing units. The bill additionally requires a density bonus to be provided to a developer who agrees to construct a housing development in which 100 percent of the total units are for lower-income households. Basically, the higher the density, the more concessions and favors the state will be willing to make with the developer.

The local government erosion comes from the bill not allowing cities to review or approve a developer's application. The bill also plays rather loosely with the term "low-income housing," which ranges from senior citizen housing developments to low-income student housing as well as a minimum of five percent of development for very low-income housing.

"They think they know what is best for communities like ours," Vargas said. "They live in their nice cozy ranch-style homes or gated communities where they're never impacted by the decisions they make."

The bill also pays incentives on a scale with 10 percent low-income units reaping a 20 percent density bonus or 32.5 percent bonus for 10 percent very low-income units.

"There are unscrupulous developers that come into cities and they say they're going to

help out the community and give low-income housing and then they ask for concessions," Vargas continued. "Since they're doing that, the state looks at them and says they're doing such a great thing... so we're going to let them have less parking, smaller-sized units and a couple of other things where they can pack more units into one place."

As much as cities fight back against the erosion of local control, Valentine pointed out that there are more than 200 housing-related bills currently circulating in Sacramento. Councilman Alex Monteiro added that as much as cities continue to hold their ground, some of those bills will pass and the governor is going to sign them.

Monteiro adds that Governor Newsom has come up with a proposal to build two million new housing units in the state by 2023. In March, Newsom announced a \$1.75 billion funding package with \$750 million going to support incentives to help jurisdictions plan and zone for high-density housing.

"It can't fall on us," Vargas said, adding that Hawthorne has done its fair share of meeting low-income housing requirements. •

#### Baseball Attendance

insulated headgear under their ball caps.

Teams in the NL West other than San Francisco are doing better than most, ESPN's data shows. The Colorado Rockies who play in a high-altitude outdoor stadium, are down 1,331 fans per game through the first 20 home meetings, while the Arizona Diamondbacks in their desert ballpark with retractable roof have only lost an average of 316 fans per game in 2019.

#### The Biggest Losers

Besides the Dodgers' rival, the Giants, teams with the biggest drop in attendance have been: Toronto Blue Jays, 130.948 (5,952 per game); the Kansas City Royals, 104,821 (4,193 per game); and unexpectedly, the Houston Astros who've lost 83,197 in paid attendance at home despite being in first place and being one of the baseball's best teams this year. Another team you wouldn't expect to be going in reverse is the Chicago Cubs, whose home crowds have dipped by 12,000 over the first 22 games. Per

game, that is 549 empty seats.

League attendance at all 30 major league ballparks declined last season by 4 percent, which the league blamed on poor April weather that forced 54 games to be cancelled. •

Bobbs and Officer Stuart Sato responded to the scene. As Officer Bobbs and Officer Sato were walking toward the apartment, they could see that the female subject was climbing out of the second story window and appeared to be preparing to jump. The officers broadcast this information over the radio.

Officer Amendola and Officer Booth forced the bedroom door open and saw the female subject attempting to jump from the second story window. The upper half of her body was outside the window and her feet were dangling in the air inside the bedroom. The female subject had grabbed the exterior of the window frame and was pulling herself out. Officer Amendola and Officer Booth rushed towards the window and each grabbed onto the legs of the female subject to pull her back into the room. The female subject repeatedly screamed that she wanted to jump and die. Officer Bobbs and Officer Sato then ran into the bedroom and assisted Officer Amendola and Officer Booth with pulling the female back inside the bedroom. The female subject was detained and placed on a 5150 hold.

The grandmother was visibly shaken by the actions of her granddaughter, but was extremely thankful for the actions of the officers. The quick and decisive actions of Officer Amendola, Officer Bobbs, Officer Booth, and Officer Sato prevented the female subject from jumping out of the second story window and sustaining serious bodily injury and/or death.

#### **Life Saving Award Winner: Hawthorne Police Department** Date of Action: July 11, 2018 **Award Recipients: Officer Pedro Nambo** and Officer Jonathan Skovold

On July 11, 2018 at approximately 18:14 hours, officers of the Hawthorne Police Department, including Officers Nambo and Skovold, responded to a report of an automobile collision with injuries near the intersection of Doty Avenue and El Segundo Boulevard. Dispatch further advised that one of the reporting parties stated the driver of one of the vehicles was not breathing.

Upon their arrival at the scene of the collision, a passerby had broken out the driver side window of the vehicle but could not get the driver out. Due to the driver's side door being blocked, Officers Nambo and Skovold moved to the passenger side of the vehicle and removed the driver out that side. Once outside on the ground, they confirmed that the driver was pulseless and not breathing.

Officer Nambo immediately began chest compressions while Officer Skovold set up a BVM from the patrol car STAT bag. Officer Skovold then began administering rescue breathing in conjunction with the chest compressions. The officers continued their two-person CPR for at least four rounds before noting some labored breathing and a faint pulse had returned. At that point, they moved the driver to the recovery position and continued to monitor his condition. Shortly thereafter they noted the driver had again lost his pulse and stopped breathing, at which point they resumed CPR. Upon the arrival of LA County Fire personnel, the two officers were eventually relieved of their duties and began processing the crash scene. The patient was transported to the hospital where he continued his treatment and recovery.

It was later determined that the 61-year-old driver (whose birthday happens to be July 12) had suffered a heart attack while driving, which resulted in him losing control of the vehicle and crashing. LA County Paramedics contacted members of the Hawthorne Police Department later on in the evening to pass on that information, as well as their appreciation for the officers' efforts. According to those paramedics, Officer Nambo and Officer Skovold were directly responsible for that driver's survival. According to those experts, the driver would have most certainly died without their prompt intervention.

Without a doubt, Officer Skovold and Officer Nambo's quick response, decisive action and prompt application of CPR were directly responsible for the saving of a life. Their lifesaving interventions and actions are in keeping with the finest traditions of service to the community and reflect great credit upon themselves and the Hawthorne Police Department.

(Government Code 53075.5(k)(5)); and

WHEREAS, at the present time, there are no taxi companies that are "substantially located" in the City; and

"Substantially located" is limited to the following locations for each company or driver (i) the company or driver's "primary business address" and (ii) the jurisdiction for which the "the total number of prearranged and non-prearranged trips that originate within that city's or county's jurisdiction account for the largest share of the taxicab company's total number of trips within each county where the taxi cab company operated over the previous calendar year, as determined annually.

'Taxicab" means any vehicle designed to carry not more than eight persons, excluding the driver, and which is used for the transportation of passengers for hire over and along public eets, not over a defined route, but as to route and destination in accordance with and under the directions of the person hiring such vehicle. "Taxicab service" means any public passenger transportation service utilizing taxicabs and available for hire on call or demand over the public streets of the city where the services is not provided over a defined route, but is between such points and over such routes as may be directed by the person(s) hiring the same, and irrespective of whether the operations extend beyond the area of the corporate limits of the city. The term "taxicab service" shall include the act of picking up any passenger in the city, but shall not include the sole act of delivering any passenger to a location within the city.

Taximeter" means a printing meter instrument or device attached to a taxicab which measures calculates and registers, by means of figures,

the fare, the distance traveled and/or the time elapsed upon which the fare is based, and which prints a receipt of the passenger. "Taxicab stand" or "stand" shall mean a public place alongside the curb of a street or elsewhere in the city, which has been designated by the chief of police as reserved exclusively for the use of taxicabs. (Ord. 1731 § 1, 2003.)

SECTION 3. Section §5.74.030 (Permit required

for automobile for hire and taxicab drivers) of Chapter 5.74 (Taxicabs) of Title 5 (Business Licenses & Regulations) of the Hawthome Municipal Code is hereby amended as follows: 5.74.030 Permit required for automobile for hire and taxicab drivers.

It is unlawful for any person to drive an automobile for hire or taxicab for hire in the city, whose company or driver is substantially located within the City (pursuant to Ca Government Code § 53075.5(k)(5)), without having a permit to do so pursuant to the provisions of the chapter. **SECTION 4.** Section §5.74.038 (Permit Fees) of Chapter 5.74 (Taxicabs) of Title 5 (Business Licenses & Regulations) of the Hawthome Municipal Code is hereby amended as follows:

5.74.038 Permit fees. A. Every person engaging in or carrying on the business of taxicab or auto for hire servi whose company or driver is substantially located within the City (pursuant to Ca Government Code § 53075.5(k)(5)), shall pay an annual permit fee as established by resolution of the city council. Required fees shall be paid at the time an application for a permit or renewal there-of is submitted under this chapter.

B. Every vehicle permit issued under this chapter shall terminate at the expiration of each calendar year unless revoked prior to said termination. Any renewal of a permit issued under this chapter shall be pursuant to the same requirements, procedures, provisions and regulations set forth in this chapter for an original permit, except as otherwise herein provided. A person holding a taxicab or auto for hire vehicle permit may not drive a taxicab or auto for hire without also possessing a current taxicab or auto for hire driver's permit and otherwise satisfying all requirements of this chapter pertaining to city approval of taxicab and auto for hire drivers. Every taxicab or auto for hire vehicle permittee shall provide written notification to the city manager upon the termination of any taxicab

or auto for hire driver possessing a city taxicab

or auto for hire driver's permit.

#### Summary of Adoption of Ordinance 2182 Amending Chapters 17.04.010, 17.20.030, 17.35.00, 17.35.030, and 17.35.130 of the Hawthome Municipal Cope ("HMC") Related to Structures and Signage in Residential Zones.

Pursuant to Government Code section 36933(c) the following constitutes a summary of Ordinance No. 2182 which will be considered for adoption by the City Council at its regular meeting on May 14, 2019 at 6:00 p.m. Pursuant to California Government Code section 36933(c)(1), the City Council has previously directed the preparation and publication of a summary of Ordinance Nos. 2182 which clarifies existing residential yard sign provisions, and provides new time, place and manner restrictions on the number and types of vard signs homeowners can place in their yards. The ordinance amendment is designed to protect free speech rights of Hawthorne residents while preserving the aesthetics and integrity of residential neighborhoods.

Ordinance No. 2182 recognizes that signs constitute a vital means of communication and can serve as an economic and aesthetic asset The intent of this ordinance is to promote and facilitate commerce by means of attractive signage and by addressing aesthetic concerns about visual clutter and visual blight. 2182 is intended to be consistent with land use pattems by adding rather than detracting the architecture of the buildings where they are located. A summary of the amendment

is as follows:
a) Section 17.04.010 – Introduces "holiday decorations" to the definition section of the HMC to distinguish from commercial advertising and free speech, and mandates a maximum 45-day duration period.
b) Section 17.20.030 – Clarifies accessory

structures that are permitted within residential zones and their heights.

c) Section 17.35.000 - Now contains language that addresses applicability, adds depth to the purpose and intent of Section 17.35.000 and delineates clear standards and introduces a new violation policy.

d) Section 17.35.030 - Distinguishes governmental signs, addresses security signs and discusses temporary non-commercial signs.
e) Section 17.35.130 – describes personal expression, and includes more information regarding sign face and number of signs.

The revised ordinances permit a resident to post up to five yard signs with a maximum three-foot sign face on his property, with a five-foot setback from the sidewalk. Structures over four feet are not permitted in residentia yards. However, portable sports equipment such as basketball hoops, soccer kickbacks, etc. are exempt from the structure limitations Lastly, the proposed new sign ordinances maintain the City's right to protect the interests of traffic safety, aesthetics and public welfare by the limitations placed on residential signs. A certified copy of the entirety of the text of Ordinance No. 2182 is available both on the City's website and also in the office of the City Clerk, 4455 West 126th Street, Hawthome California, and is open for public inspection Pursuant to Government Code section 36933(c), the summary Ordinance No. 2182 was published at least five (5) days before the ordinance was adopted on May 14, 2019.
