Public Works Continues Focus on Capital Improvement Projects

Arguably the most unsung of municipal departments with usually the least amount of fanfare or community recognition, Public Works has its hands in virtually every aspect of a city’s operations. Areas of focus include such integral items as streets, sewers, storm drains, water distribution, sidewalks, parkway trees, vehicle fleets and more.

The City of Hawthorne’s Public Works Department includes four divisions: Engineering, Airport, Equipment (the vehicle fleet), and Maintenance. Up until last year, Public Works also encompassed Recreation and Community Services, but the latter is now its own department. The Engineering Division handles administrative duties as well as plan checks, encroachment and construction permits, and field surveys. It develops design drawings and specifications, manages construction projects, and administers contracts for various public improvement projects. It also administers street lighting and energy conservation projects. Most notably and for the purposes of this article, Engineering oversees capital improvement projects critical to Hawthorne’s infrastructure.

“The City maintains an active Public Works capital improvement program that includes street projects, facilities upgrades, and infrastructure maintenance,” said Public Works Director/City Engineer Arnie Shadbehr, who has served in this capacity for the past decade. “In 2014/15, the City’s biggest project was the \$13.5 million Hawthorne Boulevard Mobility Improvement project. This project reconstructed Hawthorne Boulevard between El Segundo Boulevard and Rosecrans Avenue, including the addition of bike lanes, eight new traffic signals, storm water infiltration chambers, landscaping, new sidewalks and curbs, and a complete reconfiguration of center medians and parking areas.”

The plan to revamp Hawthorne Boulevard was long in the making, with only occasional upgrades made over the previous decade. Shadbehr noted that last year’s project was

a huge step forward in transforming the community’s most traveled thoroughfare into a more pedestrian-friendly environment that includes outdoor dining options.

Public Works also completed an upgrade of its air traffic control tower at the Hawthorne Municipal Airport, thanks to a \$1.2 million competitive grant from the Federal Aviation Administration (FAA). That project allowed local and airport officials to breathe a sigh of relief since Hawthorne’s tower was on an initial shortlist of facilities nationwide considered for FAA closures in 2013 in the wake of sequestration. The agency ultimately spared Hawthorne from the chopping block, but did shut down 11 other towers at small airports in California including those in Fullerton, Riverside and Palmdale.

As part of an annual maintenance quota, Public Works also completed \$230,000 in sidewalk repairs plus replacement of over 1,000 feet of sewer lines. “This month, we also embarked on a new \$1 million local street improvement project that includes reconstruction of the Memorial Center parking lot as well as seven aging residential streets,” Shadbehr said.

Additionally, Public Works staff are currently in various phases of preliminary engineering activities for major highway improvement projects. These include an Inglewood Avenue traffic signal upgrade funded through a competitive Highway Safety Improvement Program (HSIP) grant, an Aviation/Marine widening project to be paid for with Measure R monies, and El Segundo Boulevard and Prairie Avenue improvement projects subsidized by a Metropolitan Transportation Authority (MTA) competitive grant. “These projects are all funded in part by grants from the MTA and other State and Federal funding sources totaled at \$20 million,” Shadbehr said. “These grant applications were won through a competitive application process and were developed and submitted by the Public Works Engineering staff.”

Portions of Inglewood Avenue previously underwent reconstruction with ADA (Americans with Disabilities Act) ramps and landscaped center median islands, restriped traffic lanes, and improved traffic signals on the stretch between Rosecrans Avenue and Imperial Highway. Crews wrapped up Phase I of the Aviation/Marine project last year by relocating federal property facilities on Marine east of Aviation. “This phase of the project was carried out after completing nine months of negotiation with the Federal Department of General Services and obtaining 13,500 square feet of Federal land for the roadway widening purposes,” Shadbehr said. “Relocation of 11 high-voltage transmission poles is currently underway and we are in the process of executing cooperative agreements with the cities of Manhattan Beach and Redondo Beach public works departments to include their portions of intersection widening at Aviation and Marine into one comprehensive project with the City of Hawthorne as the lead agency.”

Upcoming capital projects include a retrofit of 500 of the City’s catch basin inlets at an estimated cost of \$1 million; street tree-trimming (continuation of an ongoing, three-year schedule); and traffic signal upgrades and spot widenings on Inglewood Avenue and Crenshaw Boulevard. Shadbehr explained that the catch basin inlet retrofit was mandatory due to a new statewide NPDES (National Pollutant Discharge Elimination System) permit that went into effect in late 2012 in an effort to reduce coastal pollution and endangerment of marine life.

Despite so much activity in Engineering, Shadbehr also singled out the Maintenance Division’s role in another vital, ongoing infrastructure project. “Last but not least, Public Works’ Maintenance Division is responsible for year-round maintenance activities for our 90 miles of sewer pipelines and asphalt patch works as well as graffiti removal and maintenance of the City’s traffic regulatory signs,” he said. •

Film Review

Mad Max: Fury Road is a Towering Feat in Blockbuster Filmmaking.

Early into the film, Nux (Nicholas Hoult) screams the film's tagline with cultish insanity: "What a Lovely Day!" Indeed, there isn't a better way to summarize the visceral, unconventional, deranged journey that unfolds over the course of two jam-packed hours in Mad Max: Fury Road. An important note for potential viewers of this film is that despite the fact that it is a reboot of an existing character and world, Mad Max: Fury Road requires no preface or introduction. This

to get progressively bigger without losing its genuine feeling. From time to time the film cuts to black to break up the sequences, and I found myself catching my breath each time. When it comes to big-budget blockbusters, this is what we should be asking for. With the amount of money that gets poured into these movies, seeing Mad Max is a reminder of the insanely good results that can be produced. It's just as relevant to mention how well utilized the principal cast is. This isn't a movie





is a film meant to be seen by new audiences, in direct contrast to so many of the reboots which are more a ploy of nostalgia for fanboys prior to 1990. The visionary George Miller, who has directed every film in the series, is back to tell more Max stories for an entirely new audience. And he doesn't hold back. Without a second to waste, we enter the world of Max Rockatansky (Tom Hardy) and it's a nasty, fully realized post-apocalypse. Dystopias are all the rage in the wake of The Hunger Games, but none of them have nearly the level of detail and sophisticated madness that Fury Road displays. A major point of praise is that so much of the story is displayed through the visuals. The same goes for characters, plot points, you name it; this is an exercise in using dialogue to a bare minimum in favor of visual spectacle. The level of detail sets the bar extremely high for any future film trying to capture a futuristic world. Nothing is easy to digest about Fury Road: it is a wild ride of non-stop mayhem. In other words, it is an absolute blast. One of the most exciting elements of the film is the stunt work. According to the director, 80% of what is onscreen is practical effects. Seeing some of the ludicrous stunts that are pulled off so magnificently is an incredible treat. The pacing of the film, while still remaining a nonstop thrill ride, builds nicely as it continues

grounded in flashy performances, but every character manages to say so much with so little. Tom Hardy may be my favorite working actor today, choosing such a wide range of daring projects and bringing so much poise to each one. There is an interesting parallel between this film and Locke, Hardy's film from last year in which he is the only actor on screen, and the entire runtime he is driving in a car talking on the phone. This time around, Hardy is once again driving a majority of the time, and dealing with similar themes of chaos and control. But this isn't just his movie. Charlize Theron is just as much the lead this time around as Imperator Furiosa, and true to form, she is the toughest female lead you could possibly conjure. Pinning the two together creates a dynamic that is top tier. The film goes at you very fast, and because the story is so richly detailed, it's hard to capture everything the first time around. I found myself wanting to watch the film again. Incredible CGI-minimal action sequences, top-notch production design, convention-defying structure and story— if you haven't already gathered, this is not just another film, it is a towering feat in blockbuster filmmaking and a reminder of what movies aim to be. Mad Max: Fury Road is now playing at ArcLight Cinemas. •

NASA's Europa Mission Begins With Selection of Science Instruments

NASA has selected nine science instruments for a mission to Jupiter's moon Europa, to investigate whether the mysterious icy moon could harbor conditions suitable for life. NASA's Galileo mission yielded strong evidence that Europa, about the size of Earth's moon, has an ocean beneath a frozen crust of unknown thickness. If proven to exist, this global ocean could have more than twice as much water as all of Earth's oceans. With abundant salt water, a rocky sea floor, and the energy and chemistry provided by tidal heating, Europa could be the best place in the solar system to look for present-day life beyond our home planet. "Europa has tantalized us with its enigmatic icy surface and evidence of a vast ocean, following the amazing data from 11 flybys of the Galileo spacecraft over a decade ago and recent Hubble observations suggesting plumes of water shooting out from the moon," said John Grunsfeld, associate administrator for NASA's Science Mission Directorate in Washington. "We're excited about the potential of this new mission and these instruments to unravel the mysteries of Europa in our quest to find evidence of life beyond Earth." NASA's fiscal year 2016 budget request includes \$30 million to formulate a mission to Europa. The mission would send a solar-powered spacecraft into a long, looping orbit around the gas giant Jupiter to perform repeated close flybys of Europa over a three-year period. In total, the mission would perform 45 flybys at altitudes ranging from 16 miles to 1,700 miles.

The payload of selected science instruments includes cameras and spectrometers to produce high-resolution images of Europa's surface and determine its composition. An ice penetrating radar will determine the thickness of the moon's icy shell and search for subsurface lakes similar to those beneath Antarctica. The mission also will carry a magnetometer to measure strength and direction of the moon's magnetic field, which will allow scientists to determine the depth and salinity of its ocean. A thermal instrument will scour Europa's frozen surface in search of recent eruptions of warmer water, while additional instruments will search for evidence of water and tiny particles in the moon's thin atmosphere. NASA's Hubble Space Telescope observed water vapor above the south polar region of Europa in 2012, providing the first strong evidence of water plumes. If the plumes' existence is confirmed—and they're linked to a subsurface ocean—it will help scientists investigate the chemical makeup of Europa's potentially habitable environment while minimizing the need to drill through layers of ice. Last year, NASA invited researchers to submit proposals for instruments to study Europa. Thirty-three were reviewed and, of those, nine were selected for a mission that will launch in the 2020s. "This is a giant step in our search for oases that could support life in our own celestial backyard," said Curt Niebur, Europa program scientist at NASA Headquarters in Washington. "We're confident that this versatile set of science instruments will produce exciting discoveries on a much-anticipated mission." •



Clark Leaves Samo for Lawndale

Over the decades, Travis Clark enjoyed success as a football player and coach at Santa Monica High. After some successful seasons with the Vikings, it was time for Travis Clark to move on, as he is now the head coach at Lawndale High. Currently, Clark is preparing his players for the upcoming season with a series of spring practices, passing leagues and tournament games and other football fundamental competitions.

Clark was named the Cardinals' head mentor in early March, replacing Rick Mathieson, who was dismissed by the Lawndale administration shortly after guiding the Cardinals to a second place finish, behind champion El Segundo, in the Ocean League. For the first time since the Lawndale High Part I era of the 1970s (the high school was closed from 1981-98, with Lawndale Part II not fielding varsity sports until the start of the 2002-03 school year), the Cardinals advanced to the CIF-Southern Section playoffs being eliminated in the first round of the Western Division by eventual champion Palos Verdes in a hard-fought 35-28 loss in mid November at Mira Costa High. The Sea Kings went on to top host Ventura 32-24 for the championship in early December.

Clark, who graduated from Santa Monica High in 1986, spent the past six seasons (2009-14) head coaching at his alma mater. He guided the Vikings to Ocean League titles in the 2011 and 2012 seasons with Santa Monica advancing to the Western Division semifinals in the first of those two league championship seasons. The Vikings finished 11-2 overall in 2011.

Prior to head coaching at Santa Monica, Clark was defensive coordinator at Inglewood High in the 2003 and 2004 seasons, and was defensive coordinator with the Vikings from 2005-08. While playing at Santa Monica, Clark was an all-CIF Southern Section free safety.

He went on to play at Utah State University, where he was an all-Big West free safety. He graduated from Utah State in 1991 with

a degree in interdisciplinary studies and he plans to use that as head coach with the Cardinals.

"I like unity and discipline," Clark said. "I want the players to respect me. They also want me to discipline them. I'm excited about them. It's motivating."

Clark brought two of his Santa Monica assistants with him in secondary coach and co-defensive coordinator Sean Weston and running back coach Andre Gaines. Last season, the Cardinals, under Mathieson, defeated the Clark-coached Vikings 20-19, Lawndale's first ever victory over a long time powerhouse high school that opened in 1891, and Clark is optimistic about returning to his former playing and coaching grounds at Santa Monica City College to face his former team on Oct. 16. Santa Monica ended up finishing third behind the champion Eagles and the runner-up Cardinals last fall.

Lawndale will be definite contender for a possible league and maybe even a Southern Section Western title. If the Cardinals can win CIF, they also have potential at a spot in the California State Bowl Series with the return of two premiere players in quarterback Chris Murray (the 2014 Ocean Offensive Player of the Year and all-Western Division) and wide receiver-defensive back Jaelin Walker. Both are highly regarded Major NCAA Division I college prospects. Also back is all-around athlete Bryant Perkinson, a first-team all-leaguer who was recently a CIF-Southern Section Division II triple jump finalist in track and field. He also has 10.84 100-meter speed.

Lawndale begins its season on Sept. 4 at home against South Torrance, a school that the Cardinals were in the Pioneer League with the previous several years before moving into the Ocean League at the start of this school year.

BELLES ADVANCE THREE TO STATE

St. Mary's Academy's girls' track and field team from Inglewood advanced two athletes and its 4x100-meter relay teams to the California State Championships after

high enough finishes in last Friday's CIF-Southern Section Masters Championships at Cerritos College. The Belles' 400 relay team of Anaiah Brown, Aliyah Hale, Briana Shufford and Keshawna Myles finished fourth at 46.93 seconds.

Hale, who won the CIF-Southern Section Division IV title in the 300 hurdles on May 23, advanced to state after a sixth place finish clocking 43.72. Kyra Anderson also made the state meet in the 100 hurdles after placing sixth in 14.3.

The state championships kick off with the prelims beginning at 1:30 p.m. on Friday and the finals start at 4 p.m. with the field events and 6 p.m. with the running events Saturday at Buchanan High's Memorial Stadium in Clovis.

ANIMO FALLS ON CATALINA ISLAND

Animo Leadership High's baseball team from Inglewood traveled to Catalina Island to take on Avalon but came home with its season over with a 7-6 CIF-Southern Section Division VII quarterfinal loss last Friday. The Aztec-Eagles, who won the San Joaquin League, ended their season at 16-6.

In the second round on May 26 at the Urban Youth Baseball Academy in Compton, Animo defeated Immanuel Christian from Riverside 7-3. Keying the Aztec-Eagles was Elliano Gutierrez who had two hits and drove in a run. Cesar Rocha had two doubles and Erick Lopez tripled and scored a run. •

organization created by Congress in the Patient Protection and Affordable Care Act of 2010.

Offering 21st Century-style convenience and mobility, Arthritis Power data will be collected using a smart phone, laptop, desktop or tablet where there is an internet connection. As patients track their symptoms over time - a convenient way of self-monitoring changes in fatigue, pain and physical activity - they are also securely donating their data. This information will be used by universities, research facilities, physicians and others to better understand how patients measure treatment success and satisfaction, to compare treatments, identify new treatments and, perhaps, find elusive cures.

Usually patients with RA or other musculoskeletal conditions learn about opportunities to participate in research, such as clinical trials, from their doctor. Arthritis Power will proactively offer a variety of

clinical trial opportunities and patients can decide when and how to participate.

“Patient-centered clinical research means that the research questions being asked are important to patients to help them make informed healthcare decisions,” says Louis Tharp, Executive Director of CreakyJoints and its parent organization, Global Healthy Living Foundation. “Though it’s called Arthritis Power, we’re also seeking people living with arthritis and other related bone, muscle, skin or joint conditions, such as fibromyalgia, lupus, psoriasis and many others. The more people who join and share their data, the more powerful the registry will be!”

It is the idea of learning from real patient experiences that most excites Rachelle about the future of arthritis treatment. “Patient-led research, like Arthritis Power, is important because patients can express how research will directly impact their lives. But in addition to advancing arthritis research, what I particularly like about the application is that I can access my personal data and send progress reports to my physician, which means we can discuss my ups and downs during check-ups. I anticipate this will make for very productive conversations.”


