

# Local Lawmaker's E-Scooter Bill Offers Path Forward for Cruisers

Legislation to regulate electric scooter rentals offers them a chance to operate again in South Bay cities, some which have banned the motorized boards over liability and safety concerns. Supporters think that Assemblyman Al Muratsuchi has struck the proper balance between protecting cities from lawsuits and being opened-minded about a new technology.

Scooters and bikes for rent are popular with office employees and tourists for short trips. The bill requires rideshare companies, including Bird, Lime and L.A-based Wheels, to work with cities before launching operations. The Consumer Attorneys of California supports the attempt to regulate e-scooters and bikes and the "Wild West" nature of the business.

The attorneys don't consider the state protections a huge burden, calling them minimal. One of those protections is to set a limit on how much insurance the scooter companies must carry before they approach local governments to enter their zones. "E-scooters and bikes have appeared in major California cities often overnight," and left cities and counties "in the dust as they attempt to catch up and create regulations," the consumer attorneys group said. The chaotic rollout of e-scooters led to a "patchwork of conflicting laws and regulations" that needs continuity, according to the group the filed its remarks in support of AB 1286. The State Assembly approved the bill on May 3.

The State Senate must approve the bill yet, and the governor sign it for the e-scooter regulations to become law. The scooter and bike operators themselves are divided on the idea of being regulated in California. Three operators of mobility devices oppose restrictions while three are neutral, according to Muratsuchi's office.

Short trips under 10 miles account for a majority of the travel by car done by local residents and commuters, according to the South Bay Cities Council of Governments that studies transportation trends. The council is drawing up a map of low-speed corridors in the South Bay, which would be safe routes for e-scooters and bikes to travel. The goal of regional transportation planners is to ease traffic congestion and gridlock by promoting access to bus and Metro lines in the hopes that more drivers will use public transportation.

The scooter and bike companies would be required to carry liability insurance in case of accident, injury and damage under the proposed legislation. The general liability policy must cover at least \$1 million per event. A company must be insured for \$5 million or more against multiple crashes and mishaps, and must cover injuries and damage claims made by the person riding the e-scooter or bike when the crashed occurred, according to the bill.

A city or county that authorizes a provider to operate within its jurisdiction on or after

January 1 next year must adopt rules regarding the use of e-scooters and bikes before a provider can offer them for rent. Local rules must cover the operation, parking, maintenance and safety of the devices within the city or county limits, under the law.

E-scooters are a "last mile" transportation option and they give access to bus and Metro lines to people living in traditionally underserved communities, Muratsuchi noted. The regulations in his bill reflect the approach taken successfully by Santa Monica, he believes, and create guiding principles and financial obligations for the free-wheeling industry.

"California has been in the forefront of consumer protection with emerging technologies such as our first-in-the-nation insurance requirements for transportation network companies such as Uber and Lyft," the assemblyman said. Companies that offer shared mobility devices are already complying with minimum insurance requirements in cities like San Francisco and Santa Monica. "This bill would codify these regulations to create a uniform statewide standard, require basic safety standards, and prohibit waivers of rights to protect riders," Muratsuchi added.

As noted, three of the rideshare operators in the state oppose the restrictions on how and where e-scooters are permitted to go. A group called the Civil Justice Association of California opposes this bill over a concern it will lead to more lawsuits against

# Wiseburn Board Honors District Employees, Remembers Scott

Superintendent Dr. Blake Silvers, completing his first year on the job, described last Thursday's Wiseburn School Board session as one of his favorite meetings of the year because it highlights the exploits of long-time employees. "This is the fun meeting," he said. "We get to look at all of our superstars in the [Wiseburn Unified School] District. It is nice to recognize and be thankful for the hard work that they do. They make a big difference in our community." The well-attended gathering, mostly celebratory and raucous, also included a somber moment as the audience recognized the sudden recent passing of Wiseburn Watch's Siobhan Scott.

School Board President JoAnne Kaneda noted the death of Scott, who volunteered for multiple Wiseburn community activities. She conscientiously attended the group's meetings and held Board members accountable for their decisions, always championing students and Wiseburn's best interests.

Among the District employees recognized Thursday evening were Anza Elementary School teachers Karen Aria (35 years of service), Maureen Martineau (30 years), Rebecca Robelotto (30 years), Liza Downer (25 years) and secretary Anita Collins (25 years).

Also recognized were Dana Middle School (DMS) teacher Candace Gray (35 years), campus aide Theresa Rehbein (25 years), Peter Burnett Elementary's Dorothy Sweeney (30 years), Cabrillo Elementary's Debra Davis (25 years), and the District Director of Human Resources Ana Montes (30 years).

School site administrators spoke about each of the honorees. Anza Principal Alberto Paredes talked glowingly of his school's honorees, saying that all had several things in common. "They are hard-working, dedicated and compassionate," he said. "But, most importantly,

they put students first." Paredes mentioned the impending retirement of Collins, saying that "she is the queen of the office. No matter how busy she is, she will always stop what she is doing to help someone in need."

Assistant Principal Lisa Wilberg represented DMS and touted the work of Rehbein, saying that "she is always there to support our school in times of need." Of sixth grade teacher Gray, Wilberg said that she is "beloved by students for her kindness, quick wit, delicious baking and homemade quilts."

Sweeney, according to Peter Burnett Principal Kim Jones, exemplified all the traits that personify Wiseburn's teachers, and went on to note several laudatory comments from fellow teachers. Cabrillo Elementary Principal Lisa Baggio noted how Davis was "an amazing teacher, staff member, mother and friend" who goes "over and beyond for our students and staff."

Silvers effusively praised the work Montes has done, calling her "incredibly knowledgeable and detail-oriented" and pointing out the "resource that she is for our phenomenal district." Montes emailed prior to the meeting, "I feel fortunate to be part of an organization that is constantly evolving and striving for the betterment of children, and where our collective contributions are valued. And it is interesting work!"

Silvers called Montes a "pivotal piece of the District office," saying she "brings a unique source of historical knowledge" and commenting that she made his transition to the superintendent's position much easier. "I am really lucky to work with her," he said. "She has ascended the ranks. We are blessed to have professionals that are dedicated to the District and stay in the District."

Silvers, prior to the meeting, had lauded



Chris was murdered in 2013 and his widow Taya has been in the process of reclaiming her life through public speaking and in service to others, heading a foundation and inspiring other charitable groups with her words and deeds.



American Spirit: Profiles in Resilience, Courage and Faith by Taya Kyle with Jim DeFelice

American Spirit is a celebration of what is good in our country: the people who still believe that helping those less fortunate and/or in trouble is an instinctual response. Taya tells the stories of more than 30 individuals who pay it forward and establish means to address those struggling with disease, homelessness, hunger and the varied ills we all face in our society. Many of these "working class heroes" saw a need and filled it, no matter the hardships they faced themselves in establishing methods of serving those who are desperate for help. She also includes a few of the rich and famous who have donated time and money to causes and people that touch their hearts.

Santa Monica-based Angel Flight West is a network of more than 1,400 volunteer pilots who transport non-emergency medical patients and their families across the country for treatment in faraway hospitals and medical centers.

Even victims of domestic violence are assisted in their quest for a new life in another city. The pilots fly their own planes and pay for all costs out of their own pockets, so that those whose lives are in turmoil can more easily cope.

Helping veterans who have sacrificed so much for our country and its people is very close to Taya's heart. She shines a light on Operation Safe Haven, a tiny house community for homeless veterans in New Jersey. Donnie Davis served in the Air Force and as a police officer before becoming a pastor for the Amazing Grace Community Church. He led an initiative for the church to purchase an abandoned 277-acre campground with a 65acre lake. Tiny houses are built by volunteers in order to give shelter to veterans who are battling mental trauma and homelessness.

There are other feel-good stories such as the couple who started a program that helps kids who are aging out (at the age of 18) of the foster care system. When she was just four years old, Alex Scott held her first childhood cancer fundraiser in her front yard and raised over \$2,000. By the time of her death in 2004, Alex raised \$1 million and inspired a legacy of hope and cures for childhood cancer – Alex's Lemonade Stand. And there's the blind veteran whose work with disabled bike riders inspired a volunteer organization that takes blind bikers on rides through New York City. These and other accounts will make you smile through your tears. We can all make a difference in someone else's life.

This book is available as a book on CD and is read by the author. There are many other books in the library on the topic of helping those less fortunate: ask our library staff for help in locating these items and do a good deed! •

# The Last Black Man in San Francisco: A Stirring, Winning Love Letter to Home

This balance between character-driven drama and grand meditations makes The Last Black Man in San Francisco an absolute dream of a film. And while autobiographical content doesn't always make for a great film, the odyssey of Jimmie Fails (whose name the actor shares) and his quest to come home feels so mythic and resonant when summarized that it's hard to imagine a film that stems from that not being worthwhile. And of course, the

time, and The Last Black Man in San Francisco suggests that the financial dissolution that led to selling the house was a precursor to a more general dissolution as Jimmie's family dispersed and their bonds weakened. So, Jimmie skateboards over with his friend Montgomery (Jonathan Majors) anytime he can - often getting found out by the white couple as he weeds their garden or spruces up their trim. It's a brisk, even funny introduction to a story with interests that naturally encom-

filmmakers aren't married to autobiographical reality. They use their lives and observations as a leaping-off point for their narrative creation.

Fails likes to show up unannounced at his childhood home. Usually, he has a can of paint in tow, but this could easily be changed out for gardening equipment or cleaning supplies. Whatever he carries, it's all in the service of realizing the image in his head. In his mind's eye, there exists a glowing picture of the craftsmanship and colors of this house, which, legend has it, his grandfather designed and built as one of the first black men to prosper in San Francisco. And Jimmie won't let that history be chipped or faded. So even though his family sold the house decades ago, he keeps coming back to faithfully recreate it as it was, new owners wishes be damned.

The white couple that currently owns the swanky Victorian house would describe Jimmie's visits as incessant. But Jimmie considers them a passion, a service and a way to stay close to the house he hopes to someday buy back. You see, Jimmy was happy there, for a pass gentrification, environmental racism, the physical and psychological constrictions that come with being a black man, and the crisis of values and, ultimately identity, in which San Francisco is currently embroiled.

At Sundance, many echoed the sentiment that The Last Black Man in San Francisco is hard to fully appreciate on first viewing because it combines so many ideas and genres. It's a buddy comedy, character study, tragedy, social commentary and tone poem whose visuals are so splendid and real-world relevance so immediate that it demands the deeper engagement that comes with re-watching, discussion and contemplation. The tapestry of city life and black masculinity weaved onscreen here is certainly dense, but that dense and branching narrative only makes me more excited to watch the film over and over again -- and more importantly, for the world to watch along. Because like the film itself, the discussion of it should be a stirring symphony of voices.

scooter manufacturers. The association says e-scooters and bikes are being singled out by a provision in the proposed law that prevents companies from requiring users to sign standard liability waivers. Participants sign waivers before taking a spin class, the group has claimed.

"Providers of recreational activities that involve some amount of risk (in some cases the risk is part of what makes the recreational activity fun) require participants to sign liability waivers before engaging in the activity," the association said in submitted remarks before the Assembly voted on the bill.

The Civil Justice Association of California says its mission is to "work in the State Legislature and the courts to reduce the kind of unwarranted and excessive litiga-

tion that increases business and government expenses, discourages innovation and drives up the cost of goods and services for all Californians."

Another group called TechNet opposes this bill, saying it would deprive 40 million Californians of access to transportation options from e-scooters and bikes. It also believes the regulation will hinder cities from creating mobility networks -- the kind of low-speed travel routes that the South Bay's regional transportation engineers envision in the next decade.

the District's continuing partnership with the Wiseburn Education Foundation (WEF), calling it "an amazing organization" and lauding its commitment to STEAM, which, he said, is a "positive add to our district. We have a solid momentum going forward with a similar vision."

The other presentation on the agenda was to bestow an \$18,000-plus check to the District from DMS, which the school was able to raise while participating in the fundraiser Pennies for Patients that benefits blood cancer research for the Leukemia and Lymphoma Society (LLS). The funds raised were the most by any school in Southern California, and a representative of LLS was on hand to thank DMS and the District for their efforts. Wilberg spearheaded the quick presentation, saying "We are really

proud of our students." Silvers added, "The amount they raised this year was phenomenal." He called the experience "one of those times that we can teach kids to give back. We are proud of the kids, the teachers and the community in general."

Board member and administration reports followed after WEF representative Rebecca Hamburg gave a quick report about the fundraising success of the recent Rock Around the Block event, as well as newly endowed scholarships.

Member Nelson Martinez called Thursday's meeting a "wonderful evening" for recognizing the District employees. Vice President/ Clerk Roger Banuelos added his thanks for the "amazing and wonderful things happening

in the district. Sometimes we don't take the time to recognize them." He also gave kudos to teachers, noting the strong showing that the students had in the recent science/technologybased Herndon competition, and congratulating those who coordinated the Washington, D.C student trip. He also mourned the loss of Scott. "We lost a great person in the community,"

Kaneda spoke about the "splendid, rewarding times" spent attending recent school site open houses. "This is they payback that we get," she said. She also lauded the support given to programs by the WEF.

Silvers lauded the scholarly accomplishments of the students who participated in the Herndon competition and the success of the Washington, D.C. excursion. He too mentioned the passing of Scott, saying that he had already received emails from community members who wanted to have a plaque placed in her honor at one of the sporting venues where she had volunteered. He also thanked the teachers for their above-and-beyond work during what he termed the "open house season."

Silvers added that for the first time ever, the DMS graduation will take place in the new Wiseburn High gymnasium. Quipped Kaneda, "That is the first time it won't be taking place in the hot sun" at a sunbaked outside school site venue.

The next regularly scheduled Wiseburn School Board meeting has been bumped up a day, to Wednesday, June 12, to avoid conflict with District promotion/graduation ceremonies. •
