# Lawndale City Council Continues Appointments to Commissions

After the elections in April for mayor and two Council members and the appointment of the fifth member to complete the City Council on May 19, appointments continue to all city commissions and committees by the newly seated City Council. At recent meetings, four Planning Commissioners were named. The Beautification Committee and the Parks, Recreation, and Social Services Committee members were all appointed on June 2.

Monday night the City Council appointed five members to the Cable Commission from the candidate’s pool of eight applicants. Lenore Bemis, Andrew Gardiner, Bob Givens, Jeremy Lara, and Joseph Madrigal will serve for two years. The appointments of 10 members to the Senior Citizens Advisory Committee (SCAC) were chosen from the field of 12 applicants. Appointees are: Betty Jean Bailey, Oscar Bernal, Penny Bolton, Ruthi Davis, Margie Heinemann, Harlika O’Balles, Sally Riddle, Emelda Santos, Maureen Williams-Grimes, and Theresa Garcia. With only two candidates not appointed, Council member Daniel Reid suggested the Council explore changing the policy and consider appointing 12 members to the SCAC so that applicants who all meet the requirements could serve, since they showed a desire to volunteer.

Resolutions for the appointments to the Cable Commission and the SCAC will be amended to include the names of the appointees before they become part of the public record.

The California Emergency Services Act requires that each municipality appoint standby officers in the case of an emergency and the elected officers are not available to make decisions contained in the city’s Emergency Operations Plan (EOP). Mayor Robert Pullen-Miles appointed Johnny Castro and Wanza Tolliver to serve as first and second standby officers respectively.

Mayor Pro-Tem Jim Osborne retained Chris Beamer and Frank Flores as his first and

second standby officers. Council members Larry Rudolph and Pat Kearney both retained their previous standby officers—Anthony Molino and John Clark and Tabitha Gomez and Jason Nall, respectively. Council member Daniel Reid appointed Rhonda Gorman and Ken Baum as first and second standby officers for his two-year term.

Wanza Tolliver, a business owner and resident in Lawndale, was reappointed as the Lawndale representative to the South Bay Workforce Investment Board for a four-year term beginning on July 1, 2014. These appointments were all made after each appointee was informed of the expectation of the duties should the need arise to call on any or all of them if an emergency situation occurs and the EOP goes into effect.

In other business, the City Council approved the ordinance requiring that all construction and demolition debris be diverted from any landfills and not be disposed of in any way that does not include complete recycling of the concrete, roofing materials, wood, metal, and any other recyclable matter that can be reused in some way by the city or any agency that accepts recyclables.

The Council approved the three-year contract with MV Transportation, Inc., to continue the fixed route transportation services for the Lawndale Beat Bus Service for the total amount of \$1,225,110 over the entire contract. The Sheriff’s Department offered the Public Safety Report, which included apprehension of a suspect who was found with burglary tools used in stealing vehicles. The suspect matched the description given to the deputies as the victim witnessed what was occurring. The suspect was arrested and booked.

The Sheriff’s Department will join with the city and the Los Angeles County Fire Department, which serves Lawndale, in enforcing the possession or use of illegal fireworks before, during, and after the July 4th holiday. Citations will be issued. Persons could be arrested, jailed, and subject to fines up

to \$1,000, plus all court fees. It was reported that 25 tons of illegal fireworks were recently confiscated and an additional 1100 pounds of illegal fireworks were confiscated in Gardena. The Fire Department is on the lookout for any and all illegal fireworks and citizens are urged to call the local fire station and report any illegal fireworks that are discovered in neighborhoods. Illegal fireworks can cause devastating fires, injuries including loss of limbs, and even death, according to the Los Angeles County Fire Department. Citizens are encouraged to not purchase fireworks but instead to attend professional fireworks shows that are held throughout the county for the Independence Day festivities.

A new Sheriff’s Department captain will soon be appointed to the Lawndale Service Center and replace Captain Eli Vera, who will be reassigned on June 23 to a new location within the Sheriff’s Department.

The County Library in Lawndale will host a Summer Reading Program for youth, teens, and adults with special programs scheduled every Wednesday at the library at the Civic Center at 3 p.m. Special guests, entertainment, activities, and prizes for reading levels will be available to all.

The annual Health, Safety, and Pet Fair will be held at the Civic Center on Burin Avenue on Saturday, June 21 from 10 a.m. to 2 p.m. Pet licensing and immunizations will be available for all pets who are leashed and with their respective owner(s). Special programs will be available for all participants with information booths from many vendors in health and safety, and local veterinarians, SPCA, pet adoption services, etc. The Los Angeles County Fire Department will have the earthquake simulator on hand for all to experience. First Alert will be donating free smoke alarms for low-income families to obtain. The next meeting of the Lawndale City Council will be on Monday, July 7, at 6:30 p.m. •

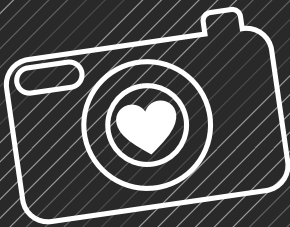

The Tri Park Senior Little League Bandits and the Lennox Dodgers fought to the bitter end in a double final of the Carl Magee, Jr. District 37 Tournament of Champions last Saturday at Jim Thorpe Park in Hawthorne. The Bandits entered Saturday unbeaten, having already defeated the Dodgers earlier in the tournament. In the first game, though, the Dodgers, behind a fifth inning grand slam home run by Donovan Garza, rallied from a 6-2 deficit to defeat Tri Park 13-9 that sent the tournament into the double final. That grand finale proved to be a see-saw battle before the Bandits stole it away when Issac Galan blasted a solo homer over the high left field fence in the bottom of the eighth inning for a thrilling 9-8 victory. The crown gave Tri Park its third straight Carl Magee, Jr. title. “Lennox is the best team we’ve gone against,” Bandit manager Alex Campos said. “It was 21 innings of hell, win or lose. I’m satisfied. The boys had a lot of heart.”

Both games were slug fests as the two squads combined for 39 runs in those two contests. There were a total of 10 home runs in the twin bill, five in each game on the small field. Galon’s round tripper, one of three by Tri Park in the second game, came on the first pitch of the bottom of the eighth that finally ended the contest that lasted almost three hours. In fact, both games took about the same amount of time.

As Galon rounded the bases, teammates crowded around him with high fives in celebration of his championship walk-off homer. With both teams tied at one after the first inning, Lennox’s Carlos Jacobo started the nightcap slugfest with a three-run homer that gave the Dodgers a 4-1 lead. The Bandits, though, came up with single runs each in the bottom of the second, third and fourth with the latter being a homer by Miguel Osorio to tie the game at four. Lennox, though, came back with a 7-4 advantage when Jacobo hit his second homer of the contest and his third of the day. That went for three runs. Tri Park quickly responded in the bottom of the inning. With the bases loaded and two out, Marqueece George blasted a grand slam that gave the Bandits their first lead at 8-7. Lennox tied the game at eight as Donovan Garza scored on a fielder’s choice by Johnny Pacheco in the top of the seventh. Dodger relief pitcher Eddie Romero, in relief of starter was able to set Tri Park in order in the bottom of the seventh and Bandit reliever Orsario, who walked the first two batters, got a key double

play, then Angel De La Torre popped out to end the threat. That set up the heroic of Galan in the bottom of the eighth.

In the first game, Lennox hit four home runs that included a go-ahead grand slam from Garza that gave the Dodgers the lead for good at 8-6 in the top of the fifth. Lennox added two-run homers from De La Torre and Romero. Jacobo also homered earlier in the game. Galon had a home run for the Bandits. With the Magee Baseball and Softball Tournaments that ended on Sunday, all-star tournaments will begin on Saturday.

### COUGARS PLAY IN ALL-STARS

Two Hawthorne High baseball senior standouts, Andrew Banuelos and Javier Martinez, played on opposite sides at last Friday’s 45th Annual South Bay All-Star Baseball Classic at El Segundo Recreation Park’s Stevenson Field. Martinez played on the Red squad, which rolled over the Blue team 12-3. He had a bad hop single and scored one of the Reds’ four runs in the top of the third inning. Martinez scored on a bases-loaded walk to Manhattan Beach Mira Costa’s Cooper Griffin. Martinez was also one of six Red pitchers who threw one scoreless inning. Others included Wilmington Banning standout Gino Brockway, Rolling Hills Estates Chadwick Cole Freeman, South Torrance standout Matt Mogollon, Harbor City Narbonne’s Adrian Padilla and Taylor Rashi from West Torrance.

Martinez was a first-team all-Ocean League player and will be playing for West Los Angeles College next season. Banuelos, also a first-team all-Ocean Leaguer, went 0-for-one with the bat. He pitched in the sixth inning, allowing three runs, including a run-scoring double by Griffin and a two-run home run from El Segundo’s Conner Underwood. Underwood also had a run-scoring sacrifice fly in the top of the third.

Kyle Smith, who keyed Torrance High’s baseball team to the CIF-Southern Section Division IV crown with an 11-0 shutout of Pioneer League cross town rival South Torrance on June 7 at UC Riverside, ended up the winning pitcher despite giving up two first inning runs that gave the Blues a short lived 2-0 lead. Cassius Hamm, who keyed Redondo to the CIF-Southern Section Division III semifinals where it lost to eventual champion Bishop Amat 3-1 on June 3 in La Puente, led the Blue stars by going two-for-two that included an RBI (run batted in) double in the bottom of the sixth. He was also the Blues’ starting pitcher, giving up one run. •



# Continental Gourmet Market

## Family Business in Empanada Heaven

By Brian Simon

In most instances, a successful longstanding business will also offer an interesting backstory—especially if the road to starting out was completely unexpected. Such was the case of Roberto Mortara, who has owned the Continental Gourmet Market in Hawthorne since 1980. A native Italian whose family moved to Argentina when he was a child to escape the ravages of World War II, Roberto eventually moved to the United States to make a better life for himself—first in New York in the early ‘60s before ultimately settling in Los Angeles because he didn’t like The Big Apple. He chose engineering as his career path and his resume included a stint working on the Concorde SST, the supersonic jet of which only 20 were made. Another gig involved designing a wheelchair and Roberto ended up having an argument about how the rotation should go. “After that, he decided he was never going to work for anyone again,” said Sergio Mortara, Roberto’s son.

So did Roberto go on to start his own engineering firm? Not quite. Instead, he bought a pizzeria in Los Angeles on Hobart and 3rd because “the price seemed right.” Realizing he had zero experience in the restaurant business and no crew to boot, he flew back to Argentina and spent a month soaking up every bit of information and advice he could muster from six successful pizzeria owners. The trip proved fruitful. Flash forward five years and Roberto had launched another seven locations. He then opened La Traviata in Hermosa Beach and during this period heard about an opportunity to purchase a rundown little grocery store on Prairie in nearby Hawthorne. Thirty-four years later, Continental Gourmet Market is a community

landmark and a destination for shoppers looking for hard-to-find products from Latin American countries such as Argentina, Peru and Guatemala.

Now in his eighties, Roberto only works at the store part-time—though he is still very involved with the business. The day-to-day operations of the place now fall under the steady hand of Sergio, who has run Continental Gourmet Market with his wife Sandy since 2004 and taken it to the next level. An eight-year community resident married with two young children, Sergio Mortara was elected to the Hawthorne School Board in 2013. “My son [now three years old and he also has a nine-month-old daughter] will be going to school across the street from us, so I wanted to get a head start,” Sergio explained of his desire to serve. “PTA

is wonderful and has some voice, but it’s not the same as being a decision-maker.”

At the market, Sergio still runs every decision by his dad—and can usually expect to encounter a roadblock. “He is my worst critic and even after multiple attempts at tweaking a recipe, he still says it needs to be better,” Sergio said. “But that’s actually a good thing.”

Though it wasn’t that way in the early years, Roberto eventually transformed Continental Gourmet Market into a destination for specialty and nostalgic products from Central and South America. The deli counter features hard-to-find, labor-intensive delicacies such as Matambre (an Argentinean meatloaf). The butcher section has just about every specialty cut from Argentina you can imagine—from vacio (flap meat) to tiras de asado (three-bone short ribs),

as well as the popular chorizo and morcilla (blood sausage). “We’re very selective with our meats and only carry choice or prime,” Sergio noted. Pricing is also unusually reasonable considering the quality. For instance, a recent display showed some tempting T-bone steak at just \$6.29 a pound.

The market also carries an interesting selection of Argentinean and Chilean wines, cheeses, fresh-baked breads, cookies and pastries, plus Peruvian ice cream, among other selections. Of course, one can also shop for “regular” household sundries and groceries as well as fresh produce. As small as the place is, it’s surprisingly well-stocked.

But the item that has truly put the market on the map is its signature empanada. A stuffed pastry that is a staple in Argentina, empanadas are made by folding dough around a filling that usually consists of some type of meat, cheese or vegetable. Baked daily on the premises, Continental’s empanadas have earned acclaim across the region with customers as far away as New Jersey—not to mention the Marine son of a Herald Publications sales representative who takes home a box to his Camp Pendleton buddies every Monday. The empanadas even drew the attention of Food Network star Alton Brown, who stopped by in late 2012 to sample the goods for his show. “The empanadas took off in 2010/11 after we decided to focus on them,” Sergio said. “A lot of items we have you can find at other Latin specialty markets, but not empanadas.”

While staying mostly true to his dad’s original recipes, Sergio does like to make tweaks to the specific blend of flour and spices and

he can’t share particulars when it comes to the ingredients or, as they say, he “might just have to kill you.” For the spicy beef empanada (the other varieties at the Hawthorne market are beef, chicken and spinach and each is “stamped” with an ID), he is especially driven to perfectionism. “I want it to be when you bite into it, you say, ‘Ah, okay,” and you don’t realize it’s spicy, but then it kicks in.” A few bites of the spicy beef proved his point—it did kick in, prompting several swigs from the water bottle. But it was worth it. This and the other varieties are outstanding empanadas and as good as you’ll find, with perfectly baked crusts and all-natural fillings bursting with complex flavors. At just \$1.49 each and \$14.99 for a dozen, they are also a bargain.

You can find other empanada options (including ham and cheese and pomodoro) plus a full menu of sandwiches, pizzas, pastas, salads and more at Continental Gourmet Market’s second location opened in Lomita two years ago that provides a sit-down restaurant experience. You may also notice some subtle differences in the empanadas between the two locations. While the Hawthorne market uses a four-burner oven for its baking, Lomita utilizes a pizza oven. Sergio was pleased to report that the Lomita spot has succeeded nicely despite initial reservations from Roberto. “He didn’t think I could pull it off—the place is hidden, but I wanted to see if our product could become a destination and it has,” Sergio said.


Empanadas are not the only items that consume Sergio. “I tried 12 different flours to bake the perfect cookie,” he said. He may have succeeded, though he will never rest on his laurels. “We use only natural ingredients—butter, sugar, salt and flour.” Cookies such as pepas (which also feature a quince filling) crumble delicately and melt in your month. The Peruvian alfajores with dulce de leche and coconut provide an understated elegance in every bite. These are some serious cookies, folks.

Now that he serves on the School Board, Sergio has noticed more teachers coming into the market as well as neighbors who didn’t even realize the place existed before. “It has helped,” he said of his position. “But when I look at my dad and all the hard work he put into it, more than 30 years later all of it paid off. People may see me around town and say, ‘That’s the empanada guy,’ but it’s not me—it’s him [Roberto]...”
