Mayor Blocks Move to Convert Zone to High-Density Residential

Following a healthy debate amongst his colleagues, Mayor Alex Vargas was able to continue his long-running stance against high-density residential projects in town at Tuesday's Hawthorne City Council meeting. The issue this time centered on a vacant, 13,253-square foot commercial-zoned parcel located at 11415 York Ave. that was to be converted to an R-3 high-density residential area pending approval. An R-3 zoned property allows for more than two units to be built on the site.

Planning Director Brian James noted that the area had been a long-running law enforcement and maintenance issue for the City of Hawthorne and stated that building the residences would help ease the necessity for such services. "Not only is it a vacant lot, but it's also a constant enforcement issue," James said. "Weed abatement, trespassing, dumping, illegal parking... so having this put into productive use would be a big relief for staff."

The parcel has been vacant for 25 years since the 105 Freeway had been built, with initial intentions of putting in a billboard. When those plans fell through early on, the parcel stayed empty and remained zoned as a commercial area. "It's not a viable commercial site and the only access is through a residential neighborhood to a cul-de-sac," James said.

The proposed project called for a four-unit residential structure to be built on the parcel with ample parking for residents. Two units would be attached while another two would be detached, with sizes ranging from 1,600 to 1,700 square feet. Each would have had its own private open space and meet all current parking requirements.

"Because it's also adjacent to the freeway, that's also a concern," Councilmember Angie Reyes English said. "I know we've had numerous reports to us in terms of large homeless encampments, cleanups and actual costs that accrue to the City that we have to pay out of our pocket. I think residents would be upset if it was a commercial use [because if] it were a commercial use, it could be operational in a number of forms."

Vargas, however, didn't waver in his decision, holding steadfast to his opposition to high-density residential projects in the city. "My concern is the high density," he said. "I've always mentioned it and even though we've written that extra step for people to come to the Planning Commission to apply as part of the process, the fact that we're labeling it R-3 allows for the opportunity to occur there in an area that's already impacted. Parking situations, crime, shootings, and to aggravate the problem with another example of high density is not conducive to what we're trying to achieve to try to give residents a high quality of life."

Vargas asked why the area couldn't be changed to an R-1 or R-2 zone and stated that there was an almost automatic propensity for the city to have to debate high-density residential proposals without considering alternative options.

An R-1 and R-2 zoning would restrict the land to either a single family home or, in the case of an R-2, a maximum of two units. "High-density housing in Hawthorne in the situation that we're in now is not appropriate," Vargas said.

Vargas went to the extent of hypothesizing that a developer could come in and buy

up all the homes on the block and build a massive apartment building. In such a case, City Manager Arnie Shadbahr noted that any change from what was being proposed would have to filter its way through the Planning Commission again before getting a final vote from the City Council.

"It's my hope that we are looking at people to better the city," English said. "If this is a property that has been vacant for some many years, I don't see why we would not allow an opportunity to better it." English added that the City Council needed to have a little more faith when it came to development projects, especially any potential mixed-use proposals that could be brought to them. "We need to give opportunities to individuals. Not everybody is a bad apple. It's really sad that has been pretty much said up here. I don't know this [developer]. I hope this person wants to better the community and develop it and pay lots of development fees and ultimately do whatever it takes to get this to what it needs to be. If not, here we are again with, 'No, no, no, no.' Hawthorne's going to continue to grow. We're either going to help in that or we're not."

Both English and Councilmember Olivia Valentine, while expressing some concern for the zoning conversion, ultimately voted in favor while Vargas was the lone vote against. With only three members on the dais, a unanimous vote would have been needed to approve the project.

Mayor Pro Tem Hadir Awad excused himself from the vote and discussion due to potential conflict of interest and living near the proposed project. Councilman Nilo Michelin was absent from the meeting. •

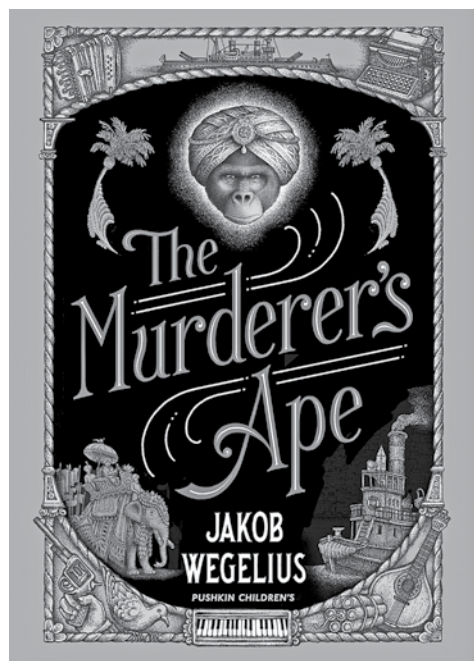

Check It Out

The Murderer's Ape Ratchets the Imagination Most Rigorously

The summer sweats might have you wading in drowsy delirium, but the library has some refreshing respite on the shelves just for you. A blast of Arctic erudite ambiance that'll have you pulling on a parka. Jakob Wegelius' mystery-thriller *The Murderer's Ape* is a humdinger of a yarn. The book'll breeze right by in a blink. Paragraph one pitches you right into a tale of intrigue boasting memorable characters and a plot that

takes us all over the world and back again. It ticks every box in terms of young adult literary fare.

It's an epistolary story written from the vantage of our charismatic and thoroughly charming protagonist, Sally Jones. She meets a colorful cast of characters and her journeys take her by plane, train and tugboat all over the map. She's also a gorilla handy with a wrench and wields a welcoming demeanor -- a skill and minor species-related detail that plays a huge role throughout her misadventures. Equal measures *Indiana Jones*, *Forrest Gump* and *Curious George*, Sally Jones is our unflinching and intrepid hero as she unravels this who-dunnit murder mystery in which she finds herself embroiled. Sally Jones really carries the narrative single-handedly. Her observations and deductions imbue her with a unique perspective on the proceedings. She's something akin to a more eloquent and thoughtful Chewbacca.

The content is emotionally rich and the story is hauled along swiftly, with the characters presented as satisfactorily complex and sympathetic to the reader. It also neatly fulfills genre

expectations. It's a swashbuckling adventure tale that manages to cobble together just the right amount of the harrowing and the heartfelt. Many a mile is wrung out of these compelling and convincing characters. I glean spin-off potential and a franchise property that will run at least three more books. That's just testament to how likeable the characters are and that there is still untapped potential in this strong series. One can't help but to look forward to the further katzenjammers and brouhahas Sally Jones and company will lumber into next.

The narrative velocity is laudable through and through and certainly worth a re-mention. The writer displays much literary dexterity as he manages to implant a chorus of voices and tonal shifts through a variety of distinct and eccentric characters. He weaves a palpable charisma between our ensemble of characters and it's all but too convincing as we delve deeper and deeper into this tangled plot.

The pacing is exemplary. Narrative momentum is the necessary mainstay of the young adult novel. It is a fine balance of breakneck speeds of exposition and apropos pauses in turbulence to give the reader a chance to catch their breath and digest the whirlwind of plot twists and revelations during the first and early stages of the second act. It is a second act with plenty of ups and downs and feigns and forward-lunges galore.

All in all, Wegelius' *The Murderer's Ape* is a fine manner in which to while away a few summer hours. Exuding surplus imagination, it'll instantly globetrot you to the fado-laced alehouses of Lisbon, ornate maharajah palaces of India, and the familiar hearth of home that can only be found when you've been fervently circumnavigating the world and acquiring hard-earned life lessons.

This is a fine feast for young and eager minds looking to tack on a few more miles to the ol' mental odometer. Anchors away, wayward wanderers! •

Film Review

Sorry to Bother You is a Crazy Comedy by Newcomer Boots Riley

Sorry to Bother You may sound apologetic... but as a directorial debut, it's every bit as brash, ballsy and bonkers as any movie I've seen. First-time filmmaker Boots Riley's satirical and zany comedy, which is set in an alternate present-day Oakland, portrays a young man of color who takes a telemarketing job and -- in an effort to increase his sales -- literally adopts a "white dialect" to speak to his customers. This could have been the extent of where the movie settles, to explore this concept more thoroughly, but Riley's unbridled creativity continues to seep in and we find that this storyline is just the beginning.

Lakeith Stanfield plays Cassius "Cash" Green, a young man whose objective is to

telemarketing agency's best employees and into the inner circle of the company's CEO Steve Lift (Armie Hammer). This is when a dark secret that the company is harboring comes to light. The film ends with one of the most head-spinning twists that would be less fun to spoil here, even though it could use a little more editing in its final act before it makes you do a double take.

Sorry to Bother You is commanding. It is either making you laugh or making you think. Riley does a very good job pulling in all elements, specifically the production design by Jason Kisvarday in which everything is so detailed that it creates a visually rich movie. The ensemble cast does well. Stanfield carries the movie on his back, Thompson delivers another fierce and unwavering performance,

line his pockets with a little extra money. After starting the new job as an entry-level telemarketer, he takes the advice from senior co-worker Langston (Danny Glover) to adopt a "white voice" (voiced by David Cross) in order to connect with his customers during cold calls. In hilarious fashion, when Stanfield opens his mouth, Cross' voice is overdubbed and the movie has fun inserting a "square dialect" into Stanfield's soulfully visual performance. It's this sort of playful comedy that makes *Sorry to Bother You* a fun time, and its comparison to a Spike Jonze and Spike Lee lovechild are accurate.

Boots Riley is equally interested in fostering a message of activism in addition to the investment of strong comedic elements. Cash realizes that his newfound success comes at a price when his growing status puts him at odds with his lesser established co-workers. It gets to a point where Cash must decide to cross a picket line made up of his bohemian girlfriend Detroit (Tessa Thompson) and best friend Squeeze (Steven Yeun). The decision of who chooses to assist him in getting to work each day creates an emotional hardship that he weighs against his large paycheck.

All of this is put on the highest stage when Cash rises in the ranks to become one of the

Armie Hammer has fun as the crazy CEO, and David Cross and Patton Oswalt's "white voices" are a huge part of the laughs. *Sorry to Bother You* will find success with audiences willing to have a good time and entertain new visual thoughts. The film was picked up by Annapurna Pictures after making its world premiere at Sundance this year for a reported seven figures.

Looking Up

“City of Astronomy” to Host Gathering of International Space Experts

Based on a Press Release from Caltech, Provided by Bob Eklund

From July 14 to 22, the world’s leading experts in space science will gather in Pasadena, informally known as the City of Astronomy [http://www.cityofastronomy.org], for the 42nd assembly of the Committee on Space Research, or COSPAR. Caltech is hosting the meeting, with the support of the Jet Propulsion Laboratory, which is managed by Caltech for NASA.

“We call Pasadena the City of Astronomy because it’s home to many astronomy institutions, such as Caltech and JPL, the Carnegie Observatories and Mount Wilson and more,” says Thomas (Tom) Prince [http://pma.caltech.edu/content/thomas-tom-prince], the Ira S. Bowen Professor of Physics at Caltech and chair of the scientific organizing committee for the COSPAR 2018 meeting. “It made sense that Pasadena would host the entire international community involved in space science and exploration.”

Up to 2,500 participants are expected at the meeting, taking place at the Pasadena Convention Center and the Hilton Pasadena. Media interested in attending with complimentary registration should contact Laura Gordon by emailing cospar2018@icsevents.com.

The meeting will feature talks, roundtable discussions, and exhibits on a wide range of space science subjects, including icy worlds in our solar system, such as Jupiter’s moon Europa; the search for life beyond

Earth; upcoming space telescopes; Earth climate science; exoplanets; and more. Prince says that the European Space Agency’s Gaia mission, which recently released a three-dimensional map containing more than one billion stars in our Milky Way galaxy, will be a hot topic.

“Even though the topic is space science, the atmosphere is very much down to Earth,” says Prince. “It’s a place for people to get together and collaborate.”

“COSPAR was created by the United Nations Committee on Peaceful Uses of

Outer Space, at the dawn of the space age and height of the Cold War, specifically to facilitate exchanges between scientists in the U.S. and former USSR,” says Gregg Vane, a senior strategist for solar system exploration at JPL and chair of the local organizing committee for COSPAR 2018.

A public lecture [http://cospar2018.org/scientific-program/public-lecture]—scheduled for Wednesday, July 18 at 8 p.m. at the Pasadena Civic Auditorium—will feature Sara Seager, a planetary scientist and astrophysicist at MIT. A panel discussion about

searching for life in the solar system will follow, moderated by Bill Nye “The Science Guy” and including Bethany Ehlmann, a professor of planetary science at Caltech and a JPL research scientist, and Kevin Hand, a planetary scientist and astrobiologist at JPL.

At the same time as the COSPAR meeting, Pasadena will host AstroFest 2018—a week-long series of space-themed events and activities for the public. AstroFest 2018 kicks off July 14 at the Pasadena Convention Center with exhibits, planetarium shows, and evening stargazing. Activities later in the week include Astronomy on Tap [https://magazine.caltech.edu/post/pulsars-and-pretzels], an informal evening at a local pub, where astronomers and the public discuss everything from black holes to bratwurst.
