Residents Fired Up About Illegal Fireworks

Residents of Hawthorne came to the first City Council meeting of July fired up to address illegal fireworks that were set off in the city leading up to the Fourth of July weekend. The complaints were highlighted by an impassioned speech by Hawthorne resident Kaya Lorlaman who spoke about combat veterans and the website militarywithptsd.org.

“This is an organization that works with military of all generations who are dealing with PTSD issues. An individual veteran did something that hadn’t been done before,” Lorlaman said. “He was so frustrated with the fireworks situation in his community that he had a sign made up that said, ‘Combat Veteran Lives Here. Please Be Courteous With Fireworks,’ and the military members with PTSD saw that sign and it went viral on the internet.”

She continued, “This year, they devoted a lot of their funds to having those signs made up for any veteran that requested them free of charge.”

Lorlaman and her husband, a disabled veteran, were fortunate to get one of the signs and spent the holiday at home as they were concerned about past events that might paint them as a target by drunk neighbors.

“Two years ago we had neighbors right down the street who we normally get along with really well set off illegal fireworks under our car which led said neighbors to physically assault and batter my disabled veteran husband,” she said. “We thought to stay at home this year in case anyone decided to put a target on our address. We were fortunate that the neighbors at the end of the block were respectful and several of the neighbors that are usually problems did not do illegal fireworks. Other neighbors, unfortunately, did.”

Other residents also expressed their frustrations with the illegal fireworks that went off

weeks before the holiday.

“If it happens on the Fourth of July or New Years, I’m expecting that. I can leave town, I can go someplace and put my dogs in a kennel that is nowhere near a place that has fireworks. But I can’t do that for two weeks leading up to each events,” Hawthorne resident Hans Phifer said.

One resident called for the council to ban fireworks in the city by the end of the year.

“Leave the fireworks to the professionals,” Alan Richards, a Ramona Track resident said. “Our veterans are trying to recover from serving in war zones and our pets are cowering for someplace to hide and are running off because they cannot handle the explosions.”

Holly Park resident Darlene Love worked in a fireworks stand leading up to the holiday and said that she was asked numerous times by customers where they could find illegal fireworks. She joked that she started directing people to the Hawthorne Police Department saying, “they have plenty in storage.”

She says that one woman had an aunt that went down to Mexico and came back to fill up her garage to sell illegal fireworks for the Fourth of July weekend.

“It’s a shame that it is happening, but I don’t know how you’re going to be able to control it because these people get it long before the holiday,” Love said. “Even if you stop those illegal stands, it looks as though it’s going to go on.”

The fine for setting off illegal fireworks in Hawthorne is \$1,000 and Phifer says that, “I would guarantee you that 50 or 60 people on my block alone shot off illegal fireworks. Not one of them got a fine.”

He continued, “That’s \$50,000 that the city did not collect through fines. That’s just my block and I represent a very small block. I do not want to endure another Fourth of July or New Years Eve of something that has been

illegal for a very long time and that is not being enforced enough to make it stop.”

Lorlaman ended her statement to the council with the story about two brothers, one a veteran suffering from PTSD, who had a tragic holiday.

“A lot of people have the attitude that veterans should just suck it up for that day,” Lorlaman said. “There were two brothers who spent the holiday playing pool. The fireworks started and the veteran brother got triggered. The non-veteran brother went to start playing some music to distract his veteran brother from the PTSD problem. As he was starting up the music to play, the veteran brother walked in and said to his brother, ‘I love you,’ and then blew his head off.”

Councilmember Alex Vargas did not have any comment on the fireworks issue, but rather proceeded to move on to discuss at length a matter of removing a three-hour parking restriction on Hawthorne Boulevard.

Toward the end of the meeting, Councilmember Angie Reyes English briefly addressed the matter calling for a study to look at call-ins to the police department and to see what changes can be made to better enforce the laws.

“We need to look at and quantify the complaints from the constituents,” English said in what amounted to a passing acknowledgement to the matter.

Mayor Pro Tem Olivia Valentine also addressed the issue saying that the council and the city manager should coordinate with the police commissioner to assess the matter.

“I think there have been enough complaints that we should have a serious discussion about it,” Valentine said, stating that there have been many complaints from citizens.

“There were fewer fireworks set off on July Fourth than the two weeks leading up to it,” Valentine said.

Mayor Chris Brown and Councilmember Nilo Michelin were absent from the meeting. •

helps us build a promising future.”

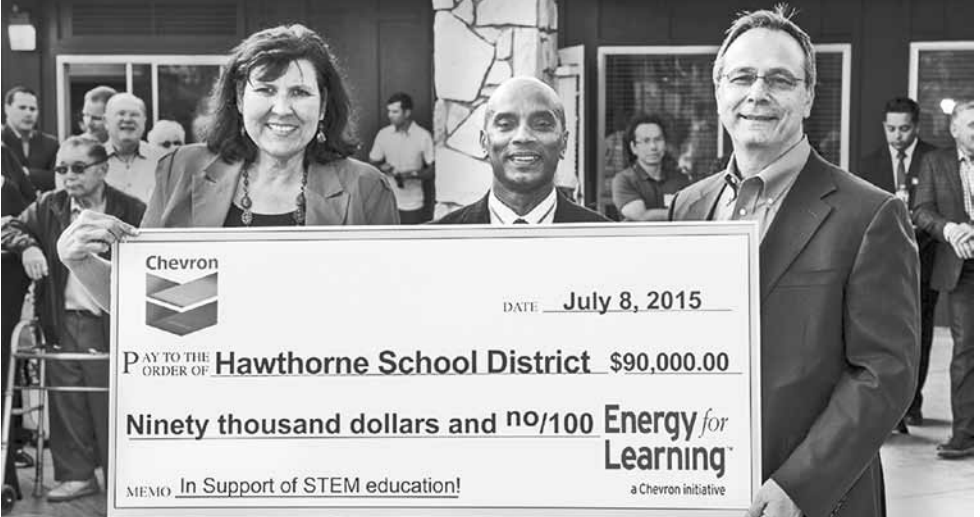

Walsh-Shea Corridor Constructors (WSCC) will be installing framing for a new bridge over Century Bl between Aviation Bl and Bellanca Av. Corporate Privacy Becoming A Top Business Concern In 2015

(BPT) - As many as 43 percent of companies experienced a data breach in the past year - a 10 percent increase from last year, according to an annual study conducted by the Ponemon Institute. As companies scramble to keep their names out of the headlines by bolstering up security practices and protocols, it's important to take a deeper look into the little things you can do to better manage privacy and security within your own company.

Here are a few things to keep in mind as you think about how to keep your company secure this year:

• **Host a policy refresher.** Employees can be your company's greatest asset, as well as the weakest link when it comes to upholding standard security protocols. While it may seem obvious that an informed workforce is a more secure workforce, many employees aren't always aware of the latest corporate procedures established to protect the organization. As the calendar turns, consider hosting a policy refresher course for all employees, regardless of level, to start the new year off strong. It will give you an opportunity to address any policy changes that may have been made in the past 12 months, speak to any industry-wide security



changes and update the staff on the privacy and security tools at their disposal.

• **Protect against visual hacking.** While a lot of resources are spent protecting data from high-tech cyber criminals, many overlook other potential threats like visual hacking, a low-tech method that may be used to capture sensitive, confidential and private information for unauthorized use. If an employee is working on sensitive company or customer information outside of the office or in full-view of an office with employees who don't have the same

access, information is at risk of falling into the wrong hands.

In fact, the 3M Visual Hacking Experiment, conducted by Ponemon Institute on behalf of the 3M company, a leading manufacturer of privacy filters, found that in nearly nine out of 10 attempts, sensitive corporate information, such as employee access and login credentials, was able to be visually hacked. In addition to providing employees with the right tools, like privacy filters, it's important to educate them on the potential risks of a visual breach and incorporate the need to protect visual privacy in corporate security policies.

• **Rethink the open floor plan.** As a means to increase productivity, many organizations are creating open workspaces, allowing employees to work within a more free-flowing setting. While it may work for some, an open floor plan comes with its own set of privacy and security drawbacks. By taking employees outside of the confines of their office walls, it becomes all too easy for vendors, third-party workers or even malicious, opportunistic employees to see confidential information from a device screen or hard-copy file. This office configuration can needlessly put your employees and data at risk.

If you have, or are moving to, an open floor plan, it is critical to assess how the set up will affect your company's security procedures and make sure that privacy protocols are updated to reflect what information can be worked on where and when to better secure corporate information.

• **Prevent social engineering.** Employees may succumb to a social engineering attack because they were simply trying to be helpful and nice. However, that same employee can be the "in" a hacker needs to launch a more widespread attack on the company's system.

Before this happens within your organization, take the necessary steps to teach employees about the impact of social engineering and how they can be part of the solution to prevent it. Show them examples of what a typical phishing email looks like, make participating in social engineering trainings mandatory so that someone doesn't accidentally give away corporate information over the phone, and incorporate best practices for how to deal with a social engineering attempt in official corporate policies. The more your employees know about potential risks, the better equipped they will be to protect themselves - and the company. •

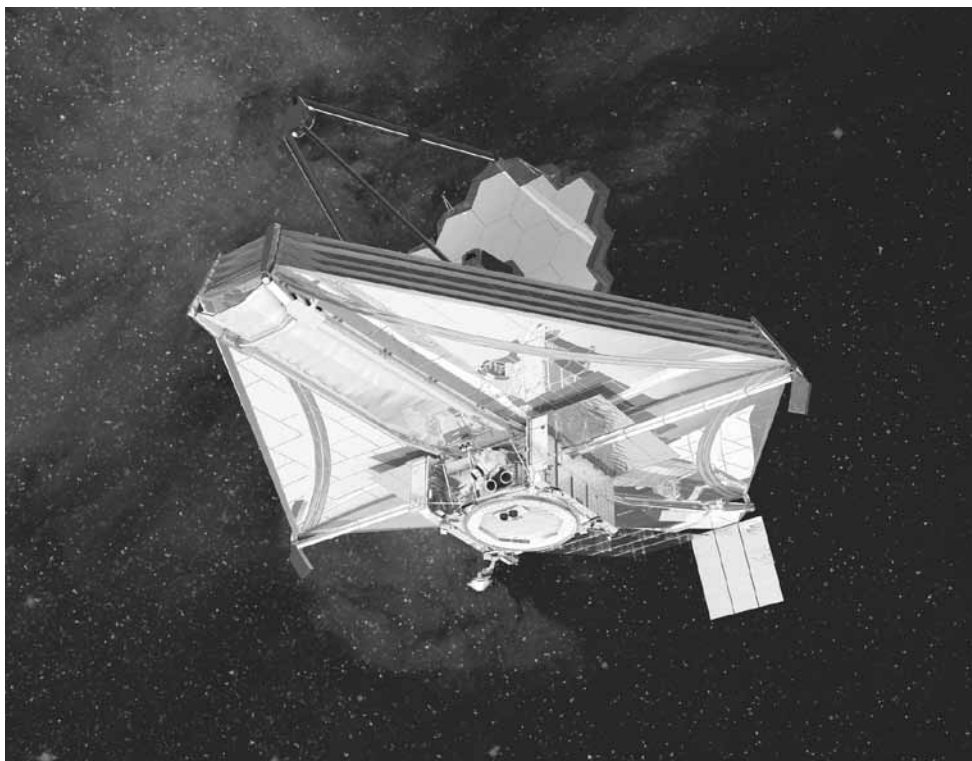
Eyeing Up Earth-Like Planets With The James Webb Space Telescope

Almost 2,000 exoplanets have been discovered to date, ranging from rocky Earth-like planets to hot Jupiters, and orbiting every type of star. But how many of these distant worlds are habitable? Today's technology means that we currently have very little information about what exoplanets are like beyond their presence, size and distance from star. With the launch of the James Webb Space Telescope (JWST, <http://www.jwst.nasa.gov>), we may have our first glimpses into atmospheres of Earth-like exoplanets, according to the results of a study by Dr. Joanna Barstow, presented at the British National Astronomy Meeting in Llandudno, Wales, UK, on Wednesday, July 8.

"A planet's atmosphere provides a good guide to likely conditions on the surface," said Barstow, of the University of Oxford. "The Earth's atmosphere contains significant amounts of nitrogen, oxygen, ozone and water. By contrast, its inhospitable 'evil twin,' Venus, has an atmosphere made mostly of carbon dioxide, which drives its surface temperature to a blistering 450 degrees Celsius."

A successor to the Hubble Space Telescope, JWST is due for launch in 2018 and will study the universe in infrared wavelengths. Barstow's study shows that JWST may be able to differentiate between a planet with a clement, Earth-like atmosphere, and one with

more hostile conditions such as are found on our neighboring planet Venus. JWST will have the capability to detect key markers that could indicate the presence of a climate like our own when looking at Earth-size planets around stars that are smaller and redder than our Sun.

Different gases have already been identified successfully in the atmospheres of several

large, hot, Jupiter-size planets by studying tiny variations in the starlight that passes through their atmospheres when they cross in front of their parent stars. However, these variations are minuscule: the light filtered through the exoplanet's atmosphere is one ten-thousandth of the total starlight detected. Studying planets the size of the Earth is an even greater challenge. Although JWST

would struggle with analyzing a solar system exactly like our own, it would be capable of studying Earth-like planets around cooler stars—if such a system were to be found.

"If we took the Earth and Venus, and placed them in orbit around a cool, red star that's not too far away, our study shows that JWST could tell them apart. Earth's ozone layer, 10 kilometers above the surface, is produced when light from the Sun interacts with molecules of oxygen in our atmosphere, and it produces an unmistakable signal that could be detected by JWST. Venus, without a substantial ozone layer, would look very different," said Barstow. "That's assuming that planets starting out like Earth and Venus would evolve in the same way around a cool star!"

However, JWST will be used for a wide range of astronomical applications, not just detecting exoplanets, and securing time on the telescope will be highly competitive. To make these detections, astronomers would need to observe the exoplanets at least 30 times, taking valuable telescope time.

"Future telescopes that are dedicated to observing the atmospheres of many rocky planets around different stars will be required to fully resolve the question of habitability on exoplanets. In the meantime, JWST will observe many other weird and wonderful planets in unprecedented detail," said Barstow.

Grape-a-licious Fro-Yo Mini Pies



Makes 12 mini-pies

Ingredients

- 1/2 cup grape juice concentrate (divided use)
- 1 tablespoon lemon juice
- 1 1/2 cups California grapes
- 1 tablespoon corn starch
- 2 tablespoons unsalted butter, melted
- 1 cup graham cracker crumbs (about 9 squares)
- 3 1/2 ounces vanilla frozen yogurt (softened)
- Frozen grape clusters for garnish
- Lemon slices (optional garnish)

Preparation

1. Preheat the oven to 350 F. Line 12 muffin tins with foil cup liners and set aside.
2. In a small bowl, mix the graham cracker crumbs with the butter. Place 1 tablespoon of the graham cracker mixture into each muffin cup and gently press to form a crust in the baking cups. Bake for seven minutes; set aside.
3. Combine 1/4 cup of the grape juice concentrate, lemon juice, and grapes in a small sauce pan over medium heat. Meanwhile combine the remaining grape juice with corn starch and mix well, then add to the sauce pan. Bring the mixture to a boil for one to two minutes until thick. Allow to cool. Once this mixture cools, pour into a blender and blend until smooth. Add the softened yogurt and blend for a few pulses until just combined.
4. Place about 4 tablespoons of the grape-yogurt mixture into each muffin tin. Place in the freezer for four hours or more. Serve with small clusters of frozen grapes and enjoy. •
