Wiseburn School Board Grapples with Little League

After months of contentious debate and no resolve, the Wiseburn School Board agreed last week to effectively suspended Little League activities within the district. After hearing from disgruntled parents and other community members affiliated with the league, Board President Israel Mora said the Board would suspend the district’s facilities-use agreement with Little League until further notice.

This is the third meeting in as many months where the board fielded grievances about Little League during public comments. Complaints run the gamut from nepotism to elections and financial misconduct.

Board member Nelson Martinez reminded the audience that in previous discussions, the board has asked for an audit of financial documents from the teams representing Hollyglen, Wiseburn and Del Aire. Because the school district’s baseball fields are used by these teams, the board’s decision essentially shuts down the league’s try-outs, practices and games until a resolution is achieved.

Superintendent Tom Johnstone remained optimistic about an affable outcome, saying Little League is currently on summer/fall hiatus anyway. “Our fields shut down in August, for maintenance,” he said. “There is time to resolve this.”

Little League typically takes sign-ups in the fall, with scheduled try-outs and training happening in January through early spring.

Proposed solutions to the current impasse included suspending the program and barring or limiting the number of managers, coaches and parents on governing boards.

Getting rid of Little League all together was also proposed. Other leagues have lost their charters, it was pointed out, and have been replaced by Babe Ruth and Pony programs. This extreme measure would destroy 13 leagues,

said Jerry Flory, administrator over District 37.

“The charter is a federal charter,” said Flory, explaining that rules and by-laws of the leagues are set at that level and are not easy to circumvent. Still, he added, “Little League is a community affair. These other programs expand the boundaries. It becomes no longer community-based. We need to keep this league alive.”

Flory said he had overturned a recent election, and was waiting for results of the new election. He said he has authority to suspend league operations and he can address nepotism on the governing boards.

“I’ll give 30-day notice and I can take care of family members on the board,” Flory said.

“We want this to happen right,” said Mora, referring to the various suggestions offered to get Little League back on track. “Otherwise, let them know they won’t get on our fields,” Mora said firmly.

In other business, Deputy Superintendent Chris Jones introduced Quan Tran, a new staffer who will oversee the district’s computer network. The hire brings Tran into the fold, after consulting for three years through a contract arrangement with ICC. Tran will spearhead “future-ready” initiatives and technology purchases.

Johnstone said, in a later interview, that the district often loses people even after a long stint, due to the nature of contract positions. “Tran is in charge of the nuts and bolts of out entire network system, including servers and software,” Johnstone said. In addition, he will handle all troubleshooting and ordering. The district maintains an extensive Qualbooks inventory, with every student from third through eighth grade having a Chromebook, linked to the internet.

“He really is the brains and general of our operation,” Johnstone said. Tran will be assisted by a staff of one full-time and one half-time

equivalent personnel.

Doug Johnson, president of National Demographics Corporation (NDC), gave a presentation on the California Voting Rights Act (CVRA), specifically looking at voting practices and procedures in board elections. Johnson’s company assesses potential for liability, and helps boards to evaluate their current elections’ procedures for violations of the CVRA.

With recent litigation having netted millions in settlements from city councils and school boards throughout the state, many governing boards are moving away from electing board members through an “at-large system.”

A nearby example: Palmdale City Council went to trial on the issue and lost. They were found in violation of the voting rights act. Four years later, and at a cost of more than 4.5 million in tax-payer dollars, Palmdale ultimately changed their elections to the by-district system.

The CVRA was written to encourage “by-district” elections. Johnson said his company represents 250 schools, over 100 which have already made the switch. Superintendent Johnstone clarified that the move is designed to “make sure minority groups that may not be represented on the board are getting their fair shake.”

Johnson acknowledged that Wiseburn is actually not at risk currently, as the board is reflective of the community it represents. Nevertheless, Wiseburn School District will be moving toward adopting the “by-trustee-area” model in upcoming elections.

Johnstone announced that the Wiseburn Teacher of the Year will be feted at the annual celebration, to be held, Friday, Sept. 16.

Summer school ends July 22; the first day of school for the 2016-17 academic year will be Monday, August 29. The next regular board meeting will be held Thursday, August 18 at 6 p.m. •

Obituaries

AUDREY B. ROGERS

September 20, 1926 - July 13, 2016



Mrs. Audrey Madge (Brown) Rogers passed away at home in Inglewood, California on July 13, 2016, after a long battle with Parkinsons Disease and a recent stroke during hospitalization for pneumonia. She would have been 90 years of age on her next birthday in September. She had been an Inglewood resident since the 1950’s. Her body will be flown from Inglewood Mortuary to be buried alongside her husband at Coop Prairie Cemetery in Mansfield, Arkansas. The ashes of her sister and four beloved pets will be buried with her. She was born in Barber township in Logan County, Arkansas in 1926 to parents Arthur Brown and Lula (Davis) Brown; and she was raised in Huntington, Arkansas (south of Ft. Smith). Her mother was one-half Native American Indian. Audrey survived cancer twice in her lifetime, and a major stroke in 2006. The death of her husband, John David Rogers, preceded hers by 23 years, and she also outlived her

siblings -- two brothers, Ray and Roy, and her sister, Edra. She is survived by several loving nieces and nephews, their children, their childrens’ children, and recently her first great-great-grandniece, Scarlett; as well as loving friends, in-laws, and caregivers. Most of her closest relatives live in Oklahoma, with some in-laws and one niece in California. Audrey was a waitress all her working life, and loved it, finding jobs in Arkansas and Oklahoma first; then moving to Southern California in her twenties where she worked at various restaurants, including a few years at Jola Bowl (long since closed) on La Brea in Inglewood; then many years at Ollie Hammond’s Steakhouse on restaurant row in Beverly Hills, until it closed; and also many years at Ships Coffee Shop at La Cienega and Olympic, until it closed as well. Her last job was at Denny’s on Manchester in Inglewood. Her waitress friends say she was the best, both as a friend and waitress. She worked into her seventies before Parkinsons forced her to give it up, and she always wished she could go back to work. She was a gentle person -- notable for her kindness to animals and concern for children, her generosity in helping loved ones in need (you didn’t even have to ask), her good-natured attitude/repartee with everyone she met, and her tendency to find humor in even the worst of times. She was a rock of dependability, and surprisingly strong-willed when it came to doing what she thought was right. She carried herself like a lady, had long, beautiful nails, and loved wearing fingernail polish (preferably fire-engine red) and costume jewelry. She was a “people person” -- fun to be around, always uplifting and supportive, and will be sorely missed by those fortunate enough to have known and loved her. •

Film Review

“Tony Robbins: I Am Not Your Guru” Captures Grandeur of Mega Self-Help Event

“Tony Robbins: I Am Not Your Guru,” a new documentary about the larger-than-life motivational speaker and communicator, will be watched by three different types of people: the first, of course, will be Robbins’ ever-devout fans and followers, who most likely will praise the movie for its very existence. The second type of person will be the cynical, critical person, arguably having a pre-loaded bias or thought of Robbins as more huckster than savior. The third type of person, someone who might find themselves more comfortably in the middle, will no doubt get the most out of what this movie has to offer. From Academy Award-winning director Joe Berlinger, the man behind such seminal non-fiction documentaries as the “Paradise Lost” trilogy and “Metallica: Some Kind of Monster” (the latter film, which Robbins approved of in getting this documentary made), trades in his darker, more investigative documentary exposé for something unapologetically hopeful, choosing to show the more uplifting side of Robbins’ work rather than a take-down approach. On that note, those looking for a deeper, more personal, profile of Robbins may be left unsatisfied. Those who are looking for a peek behind the curtains of one of the most famous self-help

At one hour and 55 minutes, “I Am Not Your Guru” shows the entire gamut of the seminar. Condensed down from 12 hours a day to a highlight reel of select participants sharing their stories of hardship and traumatic pasts (try not to think anything of the fact that the people who make the cut are mostly attractive women), it is the raw emotion and vulnerability of the crowd that offers real moments of honesty. Horrific scenes of childhood sex slavery, suicidal thoughts, and the general feeling of being unloved are just some of the issues brought up here, most of which Robbins relates to with his own abused past. Now, back to the overarching uneasiness that a self-help documentary might inspire: people will take whatever they wish out of a movie like this, depending on what they are looking for. Objectively, documentaries are thought to be real when they are without personal bias, rather than amplifying a certain side of a story. In this regard, Berlinger is unapologetic about how he portrays his subject, intending to highlight the good a film like this can bring. In an industry of ever-growing takedown documentaries that seek out the bad in the world, Berlinger attempts to be among the minorities of good-hearted and inspiring films. What is entirely undeniable, however, is that Robbins helps people in need of help,

events, however, will have more than enough footage to take in here. Covering the six-days of Robbins’ famous “Date With Destiny” at a convention center in Boca Raton, Florida (a hop-skip-and-jump away from his ocean side mansion), more than 2,500 people from 71 different countries excitedly await their own personal life-changing transformations. At about \$5,000 a ticket for the weeklong event, Anthony “Tony” Robbins, (though he would prefer “life-strategist”) has built his empire on loyalty, charisma, and results. Standing at an immense 6’7” with a gravely voice and fixed gaze (while dropping profanity-laden language to snap people into the present moment), Robbins’ work is the epitome of tough love by calling people out on the things they are choosing not to confront. seemingly telling them the things that they already know but in his trademark will-power framed mindset. Perhaps Robbins is as divisive as he is because what he’s selling might be smoke and mirrors: is the idea of happiness an illusion? Is willing yourself to be happy delusional? Does it last beyond the six-day event? And if it works, does it really matter? As Christian Bale’s Batman says at the end of 2008’s “The Dark Knight” in response to a series of crimes that have been pinned on the caped crusader, “Sometimes, the truth isn’t good enough. Sometimes people deserve more. Sometimes, people deserve to have their faith rewarded.” “Tony Robbins: I Am Not Your Guru” is unrated, but features strong language. 115 minutes. Now streaming on Netflix. •

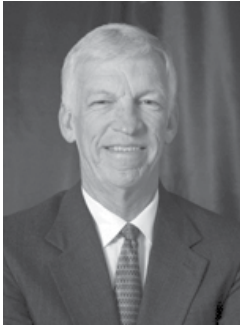
Hawthorne Happenings

South Bay Companies Take the Green Building Challenge

South Bay companies and commercial tenants are reaping the rewards of a sustainable-business challenge that asked them to think hard about how their day-to-day operations affect their communities and the environment.

Participants in the Green Building Challenge say they've gained a new appreciation for sustainable practices for their employees, customers and communities. The yearlong pilot program was created by the South Bay Cities Council of Governments, and is scheduled to end Aug. 31. A reception for the participants will be held Sept. 28 at the Automobile Driving Museum, which accepted the challenge to do more with fewer nonrenewable resources.

"This opportunity was perfect for what I was hoping to accomplish," said special events director Kobi Albert with the El Segundo auto museum. "Having done extensive research on venues such as Staples Center, The Verizon Center and Olympic venues, I knew there was a huge opportunity here to reduce the operational costs by changing the energy usage and to become a more sustainable and efficient venue."

The Green Building Challenge supports area businesses and points them to rebates and discounted-rate programs through Southern California Edison and the Gas Company. The challenge is less of a competition, and more of a network of 150 participating companies, organizations and cities that want to know more - and maybe do more - good for the planet and their communities.

"It's almost like we needed to join the challenge to energize that spark to make the necessary changes," said Albert. The museum's current exhibit through July 31 is about the electric car, and the venue is now using recycled plastic cups, and re-introduced a recycling bin for glass and plastic bottles. The changes aren't only happening inside either, according to Albert.

"We want to change the green spaces in front of the museum to be more sustainable by bringing in drought tolerant plants," she said. Speaking of water, the number of half-empty water bottles is way down since the venue added a drinking fountain and gave staff and docents reuseable water bottles. "I was surprised by how much we have accomplished in six months as a team."

The South Bay Cities Council is a joint

powers authority of 16 South Bay cities dedicated to preserving and improving the quality of life and productivity in the region. Staff members promoted the Green Building Challenge and hit the pavement to inform business owners about the first-year program underwritten by Southern California Edison, the Gas Co., the Energy Network, and the West Basin Municipal Water District and the Golden State Water Co.

Program co-coordinator Renee Daigneault said that businesses are generally unaware that assistance programs exist to lower their consumption of energy and water, and that utilities will pay for some or all of the modifications made to a worksite. That includes new equipment.

"That's what we're there to do, to connect them with the right resources," she said. "They're running a business and focused on their core competency. They're not thinking about the expense of operating their boiler down in the basement."

The challenge is comprised of 70 different actions a business can take with energy, water, waste and transportation. Businesses can log in to view the activities available to them.

"We want them to look at all of the things they need to do to be more sustainable," she said.

Raytheon Space and Airborne Systems decided to get involved and the El Segundo plant redoubled its already considerable energy-conservation and waste-reduction efforts. Raytheon had replaced 25,000 light fixtures at the facility by the time the challenge got underway last September. Still, the company saw that more building-energy management could be done.

"Green Building Challenge inspired Raytheon to broaden our sustainability programs at our El Segundo site," spokeswoman Trudy Sullivan told the Herald. The vice president for Communications and Community Affairs said that Raytheon employees, customers and suppliers share a responsibility for sustainability. It did all right before the challenge began.

Raytheon is ranked 33rd on the U.S. Environmental Protection Agency's Green Power Partnership Fortune 500 Partners list, is a 2016 Energy Star Partner of the Year and a recipient of 2014 Governor's Environmental and Economic Leadership Award.

The El Segundo employees turn down nonessential lighting, computers, and equip-

ment during statewide flex alerts. Raytheon reduced water consumption by 58 percent from 2008 to 2015, and sent 80 percent less waste to the landfill through a "Zero Office Waste" program started in 2013, according to the company.

Lindsay Palomera at Stream Realty in Torrance said her office used the challenge to make a dozen changes, from switching to eco-friendly cleaning products to tinting exterior windows that keep out the heat. Stream Realty manages the eight-story Pacific Center at 21250 Hawthorne Blvd. with 300,000 square feet of offices and suites.

Tenants in the building are offered an opportunity to recycle cardboard, light bulbs and electronics. LED lighting and controls are required for all tenant improvements, and fan motors for heating and cooling the building use a smart technology for lightening the energy load, plus the wear and tear on the HVAC system.

"It is important to Stream Realty to uphold our own environmental responsibility and to do our part to allow each tenant in Pacific Center to uphold their environmental responsibility as well," Palomera said.

Green Hapas Recycling owner Erik Minamihata says he realized from entering the challenge that things around the office and in the business needed attention, "such as making sure all of our computers and electronics are off before we leave the office. Another thing we do is that we don't run our AC (air conditioning) unless it's

absolutely necessary."

The family-owned supplier of printer inks and toners for businesses sells original equipment manufacturer toners, from companies like HP and Brother, and compatible toners made by third parties. His own office uses manufactured toners because they're cheaper and made from reusable products, Minamihata said.

"We provide them so that was an easy one for us," he said, "and we make sure they're recycled properly after we're done with them." Green Hapas reduces printing and paper usage by creating and storing online documents, and the staff work from home as much as they can.

"We also make sure to reach out and help educate local businesses on what to do with their empty toners when they're done with them," the Torrance business owner said.

He credits the Green Business Challenge and the Leadership Torrance group for connecting him with a new customer, Walser's art supplies and digital printing in that city, and the owner Jack Walser. "I had a great experience being in the challenge," Minamihata told me.

The challenge will end next month, but the momentum to eliminate wasteful practices will continue. "Absolutely, it's time to take action," Daigneault said.

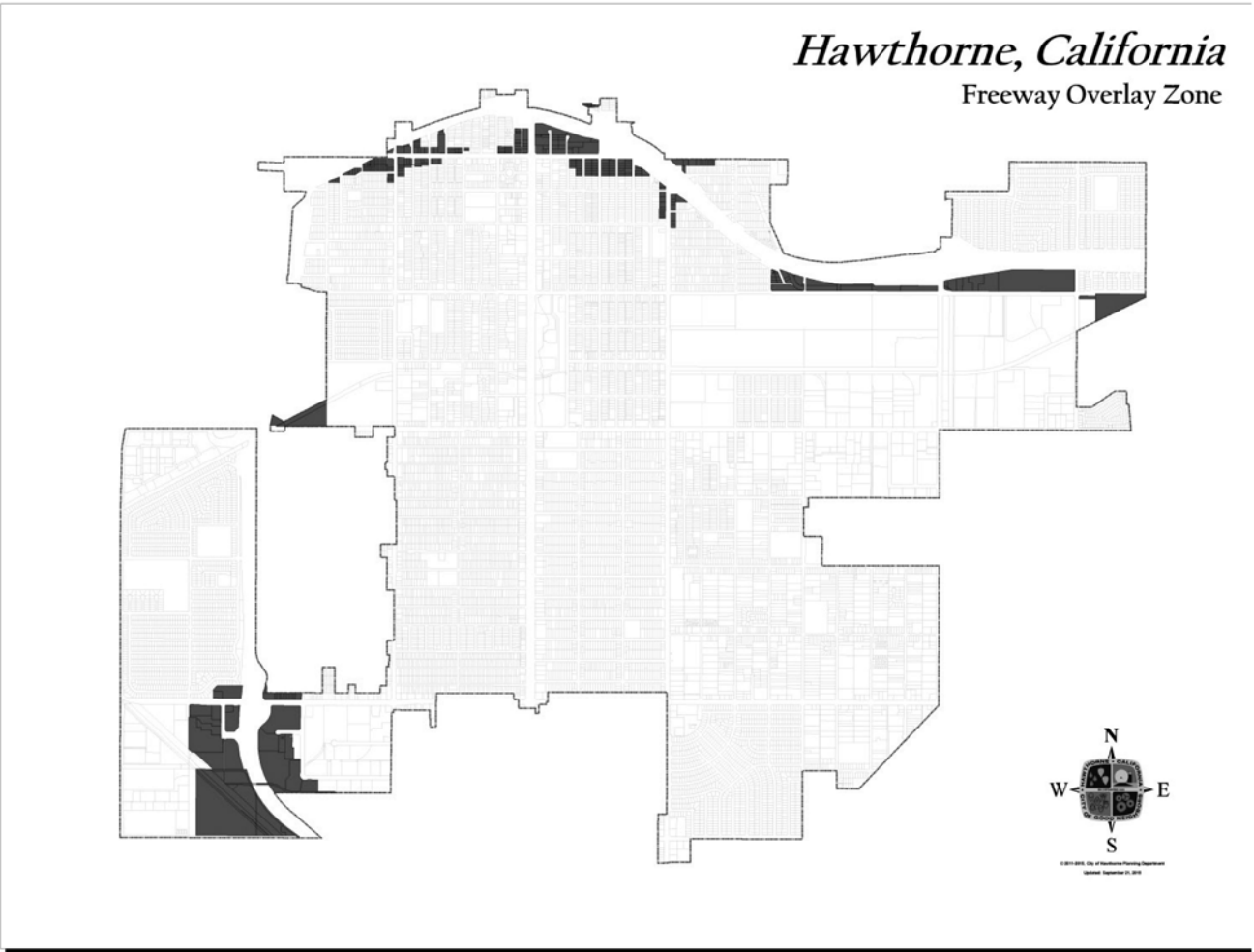

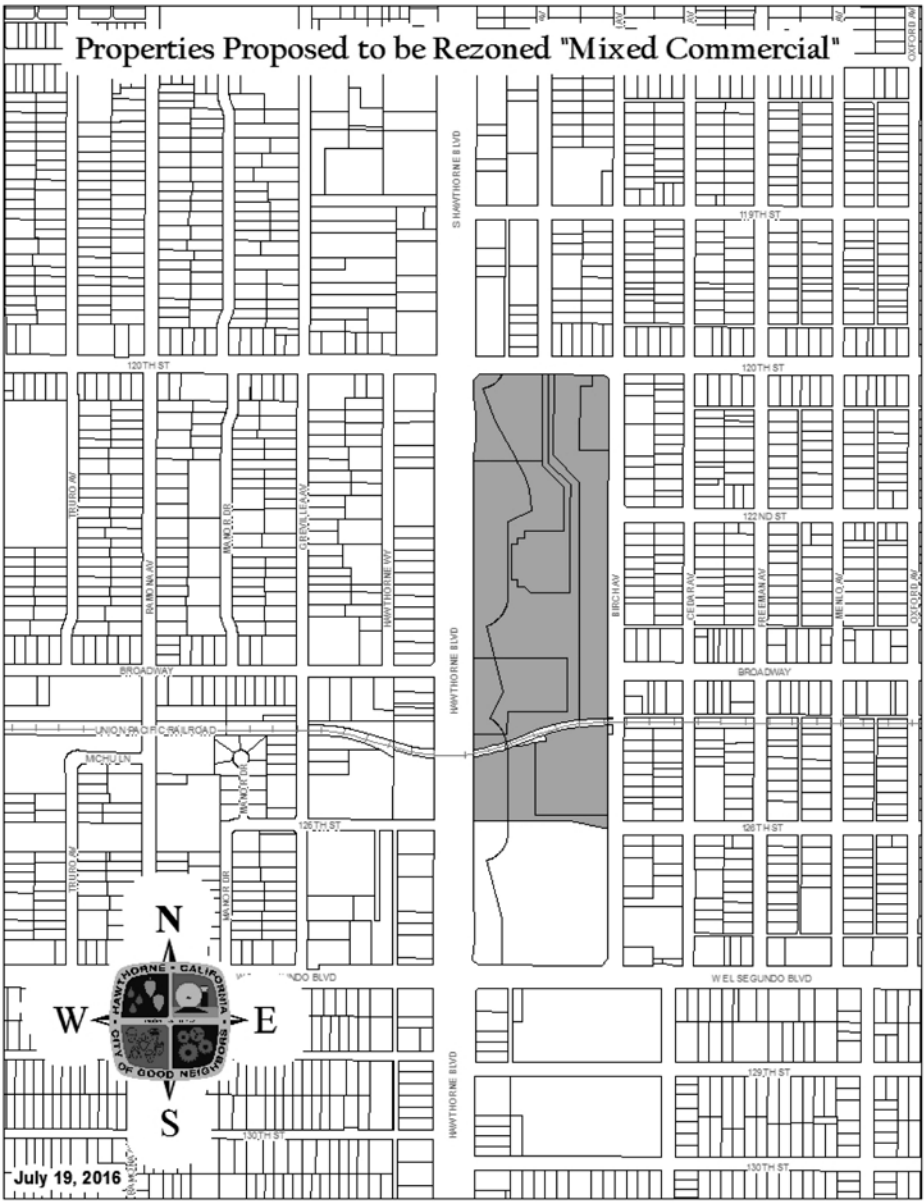

Ex-NBA, College Assistant is new Lawndale Basketball Coach

Former National Basketball Association and Division I College assistant coach David Miller was recently hired as Lawndale High's head boys' basketball coach. Miller will begin coaching the Cardinals this fall, replacing interim mentor Patrick Marks and previous head coach Chris Brownlee, according to Lawndale High principal Paula Rodas.

Several sports fans may have heard Miller as a studio sports analyst on Time Warner Cable's Sportsnet. Sportsnet does the Los Angeles Lakers, Women's National Basketball Association's L.A. Sparks and the Major League Soccer's L.A. Galaxy. Last year, Miller won the Emmy and Telly Awards for his outstanding roles for the Lakers and Sparks.

Miller has 17 years of coaching experience that ranges from amateur to being an assistant with University of Southern California (The Trojans currently have ex-Lawndale High star Chimeze Metu.) and the NBA's New Orleans Hornets. Miller has been ranked as one of college basketball's top recruiters.

Miller hopes to continue the success left by Brownlee. Brownlee guided the Cardinals for four seasons that saw Lawndale win 20 or more games in each of those years. His best came in the 2014-15 season that saw the Cardinals advance to the CIF-Southern Section Division IIA championship at the Honda Center in Anaheim. In that contest, Lawndale appeared to have its first ever Southern Section title wrapped up, leading by as many as 28 points late in the third quarter against Canyon High from Anaheim. In the fourth period, the Comanches rallied to

tie the game, then pulled out a wild 103-98 double-overtime victory over the Cardinals. Lawndale advanced to the Southern California Regional Division II finals where it fell to eventual California State Division II champion La Mirada 49-40 at the Cal State Long Beach Pyramid.

Lawndale was also hoping to get its first Southern Section title for any sport since its football team won the crown against Victor Valley in 1966. The Cardinals had back-to-back Pioneer League crowns in 2012-13 and 2013-14 but settled only for a second place finish behind eventual CIF-Southern Section Division IIIA champion Beverly Hills in Ocean League play in 2014-15. Last season, Brownlee was dismissed for undisclosed reasons right before Ocean League play began and was replaced by interim Marks. Marks went on to guide a lesser experienced Lawndale squad to a third place finish, behind champion and eventual Southern Section Division IA champion Santa Monica and runner-up Beverly Hills, in league play and advanced to the Southern Section Division IIAA quarterfinals before falling to Santa Barbara.

Marshall led throughout most of the game. After leading 6-2 at halftime and 16-14 after three quarters, Marshall led by as many as six points to put
