Heavy Foot Traffic Convinces DMV to Open on Saturday

Welcome to the Department of Motor Vehicles. Watch for slowing ahead.

The department notorious for its long lines and agonizing wait times is now open on Saturdays in Hawthorne and Culver City. The DMV began its extended hours in early August, a move necessitated by a surge in applications for the new federally approved driver's license and ID card.

Not all DMV offices are open on Saturdays, and weekend services do not include driving tests. Still, South Bay residents who can't resolve their vehicle or licensing transactions online can visit these DMV offices from 8 a.m. to 5 p.m. any Saturday. The extended hours started on Aug. 6.

DMV Director Jean Shimoto echoed the sentiments of many drivers and vehicle owners who've spent hours waiting for their numbers to be called at the motor vehicle licensing office. "Today's wait times are unacceptable and we are continuing to take action to improve service for all Californians," Shimoto said in announcing Saturday hours at 60 DMV offices around the state.

Behind-the-wheel driving tests won't be offered as part of the Saturday effort to deliver motor vehicle services at a faster clip, the department announced last week. The Legislature released \$16.6 million in late July to hire 500 more DMV employees. They've been assigned to the busiest field offices, a department spokesperson said. It's unknown how many of the new hires are in the South Bay.

The DMV said it's using employees from its headquarters to staff the busiest district offices. The department also relaxed the rules against food and drink inside DMV buildings. To head off problems caused by missing documentation and paperwork, DMV employees

will be stationed outside to assist customers and answer questions before they reach the check-in counter.

No longer will DMV customers need to stick around inside the building and risk losing their place in line if they step outside. The DMV announced a text message service that alerts customers before their number is called. Another technology being added at local DMV offices are handheld devices for people to fill out a license application if they don't have a smartphone.

What's driving this innovation and attention to customer service at one of the state's busiest departments? It's the REAL ID driver's license and identification card that can be used at airports and federal buildings to pass through checkpoints more quickly. California initially resisted issuing the REAL ID licenses and cards, as did several states that wanted more time to comply.

Under the REAL ID Act, the California DMV must meet requirements set by the U.S. Department of Homeland Security for its driver's licenses and identification cards to be accepted for federal purposes. California began issuing the Real IDs on Jan. 22. Current driving licenses and identification cards will be accepted at TSA airport checkpoints until Oct. 1, 2020, according to the DMV.

TSA agents will allow passengers to board domestic flights if the travelers produce photo identification other than a driver's license, the DMV explained ahead of the Jan. 22 implementation of REAL ID. California had postponed implementing the federal REAL ID after Congress passed a 2005 law requiring all states to comply with post-9/11 security requirements for driver's licenses and ID cards. California was one of 21 states that received an extension from the Department of Homeland

Security. The extension expired a year ago.

The consequence for not meeting the federal deadline of Jan. 1, 2018 was that passengers from California would have been required immediately to show an alternative form of acceptable identification at TSA checkpoints, according the Department of Homeland Security's website. Other acceptable forms of federal identification for anyone without a REAL ID include a valid U.S. or foreign government-issued passport or U.S. passport card, or a military ID, according to authorities. A permanent resident or border-crossing card, and a Department of Homeland Security Trusted Traveler card also are valid.

Children under 18 aren't required to get the new identification cards. TSA does not require minors to provide identification when traveling with a companion within the United States. Drivers can wait for their renewal notices to arrive before applying for the federally compliant licenses. Applications for REAL ID must be made in person and cannot be processed by mail. Applicants are advised to save time by scheduling an appointment.

Residents do not need a REAL ID to drive -- just to fly or enter a secure federal building or military base. U.S. citizens and all legal residents are eligible to apply for one. The cost of a federally compliant license vs. a traditional California one is the same: \$35. A DMV-issued identification card is \$30 for either type.

The DMV reminds customers that many transactions can be completed without visiting a field office, including vehicle registration and driver's license renewals. People can save time by booking an appointment and filling out the driver's license application online before they visit a field office. Library Helps Former Teenage Father to Make a Better Life

Inglewood Public Library and Career Online High School gave a 38-year-old student a second chance at success.



At 38 years old, Ramon Llamas is well on his way to earning his high school diploma from Inglewood Public Library and Career Online High School. Read his story below.

When Ramon Llamas was in high school, he received some surprising news from his then-girlfriend: he was going to become a father. Ramon wanted to do the right thing and provide for his young family. He dropped out of high school and began working manual jobs knowing that once he left the classroom, it was unlikely that he'd find another path back to it.

Flash-forward almost two decades and Ramon's now-wife had more exciting news for him. She too has enrolled in the accredited high school completion program through the public library called Career Online High School (COHS). The program is free to adult learners aged 19 years and older who qualify. It allowed Ramon to work on the lessons on his own schedule because it's all online. He was also given an academic coach who helped him stay on track and remain motivated. If he needed help with a lesson, the coach put Ramon in touch with a certified instructor

who further assisted with the material.

The Inglewood Public Library started offering the program as a way to "lift the neighborhood to new heights of achievement and success," according to Associate Librarian Tommy Vinh.Bui. "We recognized a need within the community and were enthused to receive such a positive response once we began this educational initiative," he shared.

Just hearing about the possibility of finishing something he started long ago was enough to spur Ramon to action. He reached out to the library, completed all the necessary steps to qualify and was granted a scholarship by the library. Since then, he has been responsive and kept in regular contact with his academic coach as he progresses throughout the program. Each student is given up to 18 months to complete the program, but it can be finished sooner by transferring in high school credits previously earned. Although he's not quite finished, Ramon already has plans to continue his education at a local college, and he's started working a part-time job with hopes to secure a regular full-time position with the County of Los Angeles. He loves the COHS program and believes it has contributed to his drive for a better future.

Ramon is one of nine students currently taking advantage of this educational service provided to Inglewood residents through their local library. That's an all-time high for the library, and interest in the program is robust. Along with earning an accredited high school diploma, graduates receive a career certificate in one of 10 employment fields, making them career-ready as well.

"We're proud of students like Ramon who are working towards their educational goals, and we are excited to continue to enrich the lives of our community members," added Bui. "Our students are engaged and committed and the feedback has been positive from the academic coaches. We are thrilled that our first graduation will be imminent."

Film Review

Watch Ed Sheeran Create His Most Personal Work in *Songwriter*

Ed Sheeran fans rejoice: the English singer-songwriter is getting candid by inviting viewers to take an intimate look into his artistic process in the documentary, *Songwriter*. Directed by his cousin, Murray Cummings, the documentary follows Sheeran throughout the creation of his chart-topping album

"÷" (divide) which, after just one week on sale, became the biggest-selling album of 2017. From early jam sessions in his tour van to brainstorming lyrics and chords with friends in Malibu, *Songwriter* is the ultimate film for Sheeran groupies, music fans and anyone pursuing a creative passion.

Ed Sheeran is more than just a talented singer – that we know. His songs have found their way on to multiple "Best Of" lists and his last record, "x" (multiply), earned him his first number one spot on the Billboard 200. But what sets him apart from others in the industry -- besides his shaggy red hair and colorful tattoos -- is the authenticity in his music and his poetic way with words. Sheeran is involved in writing all of his own songs. It's a process that is taxing yet ultimately rewarding and fascinating to see play out on the big screen.

The phrase "it takes a village" is at the core of Sheeran's success, and the film does a fantastic job of showing how much he values and depends on collaboration and input from his creative team, which includes musician Foy Vance, producer Benny Blanco and his brother Matthew, among other singer-songwriters. Seeing (and hearing) their ideas bouncing around the room gives off a vibe of infectious happiness and an "anything is possible" attitude. Much like the Showtime documentary, *Lost Songs: The Basement Tapes Continued*, *Songwriter* is an equally powerful look into the writing and recording process that is neither as glamorous nor as easy as one may think.

Director Murray Cummings incorporates archival footage from Ed's younger days that shows just how far back his passion for music goes. We see him learning how

to play multiple instruments, get a glimpse into his family home life, and revisit his high school days. Seeing Sheeran's determination and grit to get to where he is today will only gain him more respect as an artist.

Songwriter plays also like a private acoustic concert for an hour and a half. Sheeran's talent is undeniable -- even when dressed in a green t-shirt, blue plaid pajama pants and

fuzzy moccasins. His soothing and uplifting voice is always on point, a juxtaposition that makes for some (perhaps unintentionally) funny moments.

I personally will never tire of music documentaries, and *Songwriter* is a beautifully composed and inspiring addition to this genre. Fun fact: at one point Sheeran admits that this is the first time he has ever written a song on camera -- an act that typically leaves him feeling self-conscious. *Songwriter* made its North American premiere in the Documentary Spotlight category at the Tribeca Film Festival, and just before the screening, was acquired by Apple in a seven-figure deal for worldwide distribution. Above all else, Sheeran shows that his story is just getting started, which should excite fans everywhere.

Songwriter is not rated. 84 minutes. Opening this Friday at ArcLight Hollywood and streaming exclusively on Apple Music on August 28. •

Looking Up

Journey to Touch the Sun Launch Begins

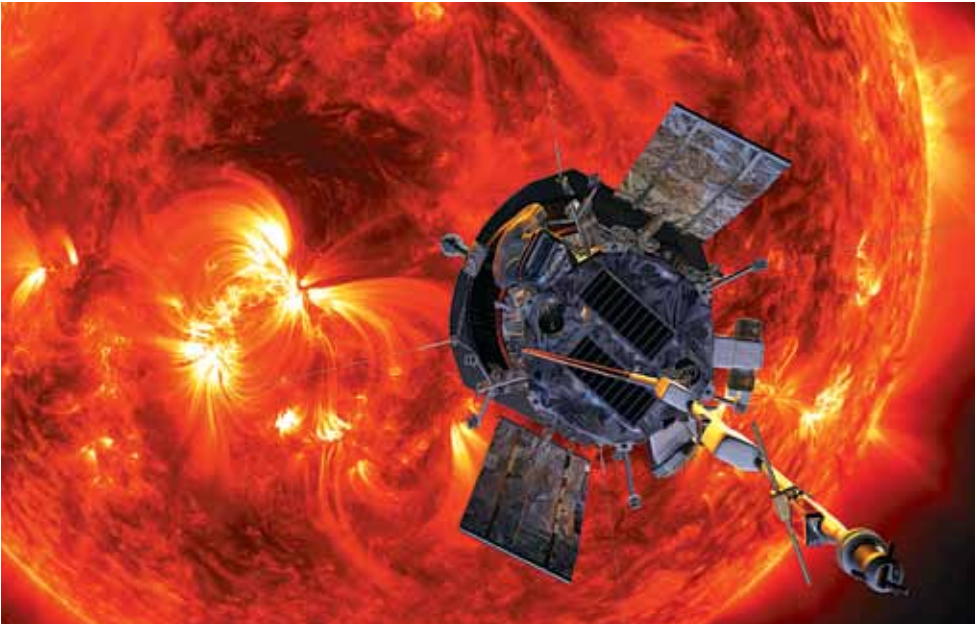
When NASA’s Parker Solar Probe launched into space from the Kennedy Space Center August 11, it began its journey to the Sun, our nearest star. The Parker Solar Probe will travel almost 90 million miles and eventually enter through the Sun’s outer atmosphere to encounter a dangerous environment of intense heat and solar radiation. During this harrowing journey, it will fly closer to the Sun than any other human-made object.

To revolutionize our understanding of our most important and life-sustaining star, scientists and engineers have built a suite of instruments aboard the Parker Solar Probe to conduct different experiments. Some of these instruments will be protected by a thick carbon-composite heat shield. However, others will be more exposed.

The Solar Wind Electrons Alphas and Protons (SWEAP) investigation is the set of instruments that will directly measure the hot ionized gas in the solar atmosphere during the solar encounters. A key instrument on SWEAP called the Solar Probe Cup (SPC) was built at the Smithsonian Astrophysical Observatory (SAO) in Cambridge, Mass.

The SPC is a small metal device that will peer around the protective heat shield of the spacecraft directly at the Sun. It will face some of the most extreme conditions ever encountered by a scientific instrument, and allow a sample of the Sun’s atmosphere to be swept up for the first time.

The SPC uses high voltages to determine what type of particles can enter, which is a way of measuring the energy of the particle.

This is crucial information for probing the wind of hot ionized gas that is constantly produced by the Sun. As the spacecraft flies towards the Sun for an encounter, the wind is directed straight into the cup.

This unique probe of the solar wind is important for scientists to better understand space weather, which is responsible for effects that range from endangering astronauts on space walks to impacting the electronics in communications satellites.

The solar probe will travel faster than any spacecraft in history, at its peak reaching 430,000 miles per hour, and will be only four-and-a-half solar diameters, or 3.8 million miles, above the solar surface at its closest approach to the Sun around 2024. The probe is equipped with a heat shield to protect its sensors from the Sun’s heat, which could reach 2,500 degrees Fahrenheit, nearly hot enough to melt steel.

At this distance, the solar probe will be within a region where electrons and ionized atoms—mostly hydrogen ions, or protons, and helium ions, called alpha particles—are accelerated and shot out toward the planets at high speed.

When these ions, called the solar wind, hit Earth, they interact with Earth’s magnetic fields and generate the northern and southern lights as well as storms in the outermost atmosphere that interfere with radio communications and satellite operations. Accelerated to higher speeds, so-called “solar energetic” particles can pose a hazard to astronauts.

The namesake of the mission is a Caltech alumnus, 91-year-old Eugene Parker (PhD ‘51), who predicted, in 1958, the existence of a supersonic solar wind—a flow of charged particles that stream off the Sun, accelerating at speeds faster than that of sound. •

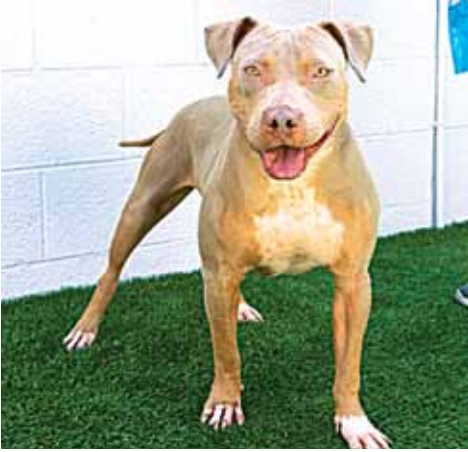
