# Hawthorne City Council Takes Steps to Address Airport Noise

After months of hearing complaints from residents, the Hawthorne City Council took its first steps toward addressing noise from aircraft that uses the Hawthorne Municipal Airport. The Council unanimously passed Resolution 8030, which adopts a new voluntary pilot guide and noise abatement procedures; and Resolution 8031, which will encourage the voluntary use of noise reduction technology and procedures and also mandate restrictions on hours of engine run-up testing for maintenance.

“Basically the changes that we had to make include revamping the entire document by making it easier to read for pilots,” Interim City Manager Arnie Shadbehrr said of the updates that were made to the original noise abatement ordinances that the City of Hawthorne already had on the books.

Runway 25 is the one heading west and has 95 percent of the take-offs. Runway 7 is the one heading east and sees 1 to 5 percent of take-offs annually, according to Shadbehrr. “When they take off in the upwind direction, and then they go crosswind and stay on top of Hawthorne Boulevard and then in the downwind direction, they go up El Segundo Boulevard and back to base,” he said. “It is recommended that they stay on top of the golf course in order to reduce the noise and they should maintain 1,100 feet of altitude.”

In addition to private helicopter companies, Shadbehrr said that the U.S. Coast Guard also uses the airport. “They don’t even have to give us courtesy call -- they are allowed to come at any time they want and utilize our airport,” he said. “They have been doing this,

it started 10 years ago. They are extremely noisy and they come to use our airport for practice.”

Shadbehrr pointed out that flight schools also use the airport as a base and circle around it in the air during training sessions. He went on to note that the new resolutions were passed along to “airport users” on Wednesday. “Hopefully we can get them started with some training processes with pilots in upcoming meetings,” Shadbehrr said.

Councilwoman Olivia Valentine sought clarification on why the new resolutions were a voluntary process. “It’s voluntary [because] once the airplane is up in the air, they don’t listen to us -- they are governed by the FAA rules and regulations,” Shadbehrr explained. “Unfortunately we cannot go and cite the pilots, but we have had cases in the past because we can go to flight tracking, we can get the tail number and we can find the pilot. We have had, in the past, communication with these pilots that the residents are complaining, so hopefully we can get their attention more actively from now on.”

Shadbehrr added that the private companies that use the airport are aware of the measures that the Council took with the new resolutions. “We’re working with them and we have to get their cooperation in establishing an airport community network to meet regularly and go over these issues,” he said. “These two resolutions are not going to solve all of the problems. This is just the beginning of it.”

Councilmember Angie Reyes English said, “[The City has] come a long way in trying to address the issues at hand in general. I think for the most part we have done probably the most than any of the other agencies and I say that because oftentimes when you’re dealing with federal governments, assembly districts, senate districts, etcetera, that is where the complaints should go in a sense. Because at the end of the day, we know that Hawthorne Airport resides in Hawthorne and it only makes sense to complain to Hawthorne.”

English added, “I hope that residents realize the work that we’re doing. I know that complaints are complaints, but they also have to understand how we’re doing due diligence and addressing their concerns as well. I think it’s important that a report gets to Congresswoman [Maxine] Waters’ office, gets to State Senator [Steve] Bradford’s office, gets to Assemblymember [Autmn] Burke’s office, gets to Supervisor Mark Ridley-Thomas’ office – I say that because most of the residents live in that area.”

English said that she appreciated the patience from residents and the work that has been put in by the City Manager’s office, noting that it has been a long process in addressing the issue. “We are going to pursue [these resolutions] rigorously with them,” Shadbehrr said of the private companies that operate out of Hawthorne Airport. “We want them to train on a regular basis their pilots with these guidelines -- because at the end of the day, we want to be community-friendly and they want to continue their business but we should work together.”

Shadbehrr said that Resolution 8031 would “basically encourage pilots to equip their aircraft with some sort of muffler or hush kit that are available for different types of airplanes.” •

## Film Review

### A Star is Born Review: An Emotional Musical Supernova

Since making its debut at the Venice Film Festival a few short months ago, where it received an 8-minute-long standing ovation, the remake of the 1937 musical *A Star Is Born* has been feverishly anticipated by fans worldwide. Starring Lady Gaga like you’ve never seen her before, *A Star is Born* is a fantastically observant and delicate movie musical and a wonderful remake of the 1937 classic of a timeless love story but with a 2018 modern twist.

Jackson Maine (Cooper) is rock n roll’s bad boy -- a swoon-worthy crooner on stage, but a heavy drinking and lonely man when off of it. During a spontaneous visit to a late-night bar, he meets the alluring Ally (Lady Gaga) and upon hearing her rendition of “La Vie En Rose,” he immediately falls under her spell, seeing the potential in her music even though she doubts herself. As the supportive partner we all aspire to have in our lives, Jackson encourages Ally to live her dream and speak her truth -- not just as a singer, but also as a songwriter. Gaining notoriety very quickly from her undeniable talent, Ally skyrockets to fame but loses her authenticity as she bends to conventional pop star tropes while Jackson watches from the sidelines. Ally finds herself at the peak of her career at the very same moment Jackson is at rock bottom, and their personal circumstances

prove to have heartbreaking consequences. A star was born in 1986 and her name, or the name the entire world knows, is Lady Gaga. In a role made famous by Barbara Streisand, Lady Gaga – born Stefani Joanne Angelina Germanotta – is one of the only few artists who could successfully pull off the all-encompassing and demanding role of Ally by singing, dancing and acting so effortlessly that it makes one think this was the role she was born to play. This isn’t Gaga’s first foray into acting, as she won an Emmy in 2016 for her role in *American Horror Story*. But what surprised me most was how she completely transformed into Ally: Gaga gets lost in Ally’s insecurities and body shaming, and it’s hard to imagine her as a celebrity superstar at all. If *A Star is Born* proves anything, it’s that it is time we take Lady Gaga seriously as an actor. *A Star is Born*’s conventional story is alluring to every generation, it being a classic fairytale and our protagonist a singing Cinderella. But with Bradley Cooper, assured and showing his directorial skills, along with one of today’s biggest pop culture icons in the lead role, this emotionally charged, cinematic knockout proves that it can stand on its own and is sure to inspire the next generation of movie and music lovers. *A Star is Born* is rated R for language throughout, some sexuality/nudity and substance abuse. 135 minutes, Now playing in theaters everywhere. •



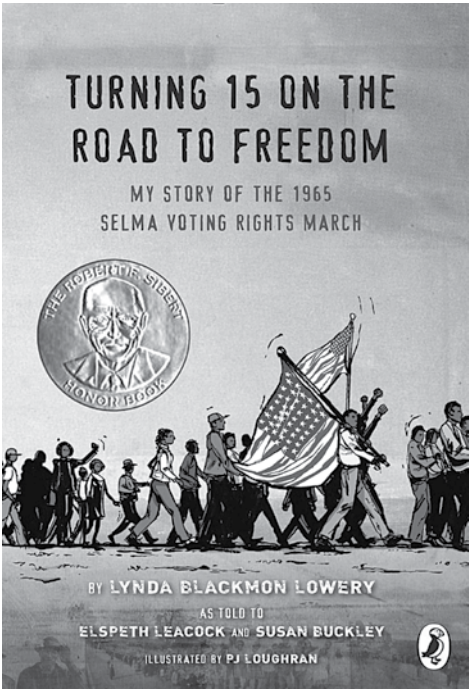

## Check It Out

### Turning 15 on the Road to Freedom Is Relevant and Rousing

“Give me the ballot” and “a voteless people are a hopeless people” are the impassioned pleas of an empowered people. And that’s the sentiment that this week’s book strives to impart. Standing up and demanding to be heard. *Turning 15 on the Road to Freedom: My Story of the 1965 Selma Voting Rights March* by Elspeth Leacock, Susan Buckley and Lynda Blackmon Lowery is a book that delves into your belly and stokes the embers of social justice within. It’s a book that’s all too relevant today.

This memoir recounts the harrowing chutzpah of the youngest activist present during the voting rights march from Selma to Montgomery, Alabama in 1965. Lynda Blackmon Lowery is steely proof that young adults can seize the day and be heroes. She marched side by side with the vanguard of the civil rights movement -- step by step and through rain, sleet and snow. Her personal struggle and resolve to be disenfranchised no longer was nothing short of herculean and page by page proves to be a call to action to young people everywhere. Via narrative nonfiction, young Lynda Blackmon Lowery tells of the travails and violence she experienced along the trail. The hardships and discrimination that met the marchers every mile are conveyed here in primary-sourced detail. Courage was in no short supply as she defied expectations and fought valiantly for the civil

rights of African-Americans. She stood tall at a pivotal crossroad in American history. In this narrative, she manages to convey the tumult and close-knit kinship of her fellow marchers during this fraught epoch of social change from a youthful perspective. Eras change and decades pass, but the enduring themes of harmony and peace withstand the turbulence of time. Illuminating and clear-eyed in its depictions of events, this is a story that should strike resonant ripples of hope at the tensions and conflicts that dominate the headlines of today. It is a timely reminder of the capacity of the young to enact great social change. Lowery is a singular firebrand that is testament to the power of youthful mobilization and moral strength to overcome seemingly unconquerable racial prejudices and obstacles to the advancement of an increasingly marginalized population. This book ignites a desire to be involved. And that’s a foremost mandate for the younger generation. The onus is on them to carry the torch further. The book will also hold particular appeal to young girls. Lowery beautifully flaunts the gender conventions of the era and is front and center standing up for equality and what’s right. It presents a picture of ostentatious egalitarian notions. She’s a shining example of heroism and heroine all hewn together into one inspirational figure. November will be here in a blink. Soon polling booths will be erected and the affray of elections will be upon us again. Let’s spare a thought and take a moment to pay due reverence to the sacrifices made that allow us to cast our ballots freely today and fulfill our democratic duty. This is a right that was hard-fought and long-sought. We’ve come a long way, but there are still miles to go before we can rest. Miles to go. So vote. It’s imperative. Vote, vote, vote. •

## Two El Segundo Residents Vie for West Basin Division IV Board

Though not part of a local municipal election, the race for the West Basin Municipal Water District's Division IV director position carries a great deal of interest in town. Not only does

the agency have its water recycling facility in El Segundo, but the two candidates vying for the spot on the board are also residents here. That said, Division IV encompasses a wide geographical area that also includes Culver

City, West Hollywood and Malibu as well as the unincorporated communities of Topanga, Marina del Rey, North Ladera Heights, Windsor, Lennox, Del Aire and Wiseburn.

Incumbent Scott Houston hopes to garner a

second term on Nov. 6, while challenger Joe Lococo looks to unseat his opponent. Both candidates spoke about their backgrounds, their views on key water issue and their priorities as they move towards Election Day. •

### ★ Candidate and Current Division IV Director Scott Houston ★

Born in Arizona, Scott Houston lived in several states across the country growing up with a father in the construction industry. A Chevron project brought the family to California in 1993 and he graduated from Torrance's West High School. Houston holds a Bachelor of Science degree in Business Administration from Michigan Technological University. He is an 18-year El Segundo resident.

Houston's professional experience includes public relations for technology companies as well as management in the manufacturing and printing industries. In addition to his service on the West Basin Board, he currently works in communications consulting.

Local community involvement included four years on the Capital Improvement Advisory Committee (CIPAC), a host/reporting role on El Segundo TV covering business and feature stores, and a 7-year stint on the Tree Musketeers board. Houston also volunteered for the Run for Education and The Friends of the El Segundo Public Library.

**Herald:** What led you into pursuing a director seat for West Basin? Why do you want to run?

**SH:** Serving on CIPAC introduced me to the infrastructure needs of a city -- the "non-glamorous" but vital services we rely on daily including streets, sewers, trees, parks and public facilities. This sparked my interest in water, particularly since West Basin's recycling plant is located in our community. I also had a strong interest in local government and public service having previously run for El Segundo City Council. When a Board seat opened after our former director's retirement, I jumped at the chance to run four years ago and am honored to represent West Basin's Division 4 that includes my adopted hometown of El Segundo.

**Herald:** What were your chief accomplishments during your term? Why should you be re-elected?

**SH:** I advocated for conservation and water use efficiency during the drought. I authorized expansion of our facility with a goal to nearly double production from 40 to 70 million gallons of recycled water daily. I distributed 1,500 free rain barrels to residents working with non-profits including the El Segundo Woman's Club. I've built working relationships with elected officials, business and environmental groups, homeowners, and other stakeholders to make informed decisions. I'm a proactive and energetic representative committed to results -- with a track record of good fiscal management and staff accountability to ensure safe, reliable and affordable water.

**Herald:** What decision/policy of the current board to you most agree with/disagree with?

**SH:** The issues facing the Board are complex and varied. I'm proud of several things including our robust capital improvement program, our conservation rebates and classes, and our improved community outreach efforts. But I do not want to say one is more important than another or this was more disappointing than that because each of the issues our board



addresses, and we deal with many, is important and has real life impacts on our community. So for me to clarify any one issue as more important or more disappointing would be a disservice to any of the other issues we address.

**Herald:** What are the two most important water issues the District faces and how would you address those?

**SH:** The volatility of imported water supplies and increasing costs.

These are supplies we rely on from aqueducts providing water from the Colorado River and Northern California. Both sources are greatly stressed due to climate change and susceptible to major earthquakes that could interrupt our supply of fresh water into Southern California. Besides the erratic nature of these two sources, costs of imported water continue to escalate while we can no longer count on consistent year-over-year water deliveries to meet our needs. I continue to prioritize reducing West Basin's dependence on imported water through robust conservation efforts, rebates and education programs, and increasing recycled water production and infrastructure.

**Herald:** What other priority item would you bring to the Board should you be elected to a second term -- and why?

**SH:** Over my first term, I have successfully increased our community outreach efforts, including the use of social media to provide information to the public as well as championing a new website that is user-friendly and provides our agendas and minutes in a timely manner. I will continue to push for more transparency at the Board. I am currently advocating to televise our meetings so the public can witness first-hand the important items that come before us and our decision-making process as your public servants.

**Herald:** What is your stance on a desalination plant in El Segundo (or elsewhere)?

**SH:** As a Board member, I must remain neutral on the proposed desalination project West Basin is studying because the draft Environmental Impact Report will come before the Board for a vote on its certification at a future date. My role is to ensure the District has a safe and reliable supply of water, and to make an informed decision on this potential project.

The Board has only authorized preparation of an EIR. No decision has been made to build a desalination facility. A number of future determinations must be made before this project can move forward. As a Board member, it's imperative for me to understand how a desalination plant will impact the environment of our Santa Monica Bay and its costs to ratepayers while also weighing future water supply security for the South Bay. I look forward to reviewing the details of the EIR and public comments in the months ahead.

**Herald:** What is your position on dealing with rising water rates?

**SH:** Affordable water is paramount to me as a Board member representing Division 4. While we are asking you to use less, our costs continue to rise that pay for infrastructure and staff so water flows uninterrupted to your tap.

### ★ Candidate Joe Lococo ★

Born in Hawthorne and raised in the South Bay, Joe Lococo "played, worked and raised a family" in the area and is a long-time El Segundo resident. He retired after a 32-year career in the airline industry, working most recently as a supervisor for one of the major carriers. Lococo's community involvement includes 23 years of volunteer work with the Westchester/Playa del Rey girls' softball program as a president, board member and coach.

**Herald:** What led you into pursuing a director seat for West Basin? Why do you want to run?

**JL:** As a resident of El Segundo, I have had the opportunity to tour West Basin's recycling plant. I am impressed with their commitment to developing local water supplies. What really motivated me to run was when I saw the March 15, 2018 Daily Breeze article by Megan Barnes regarding the decisions the Board made to hire the current general manager. He is being paid more than most city managers, superintendents and police chiefs. I feel the West Basin Board lacks leadership. There are opportunities for better management staffing, reduced costs and increased water recycling.

**Herald:** Why should voters elect you and what do you bring to the table that is unique?

**JL:** I am not a politician, or water expert -- however, a regular Joe.... If you read about what this board is doing in terms of hiring practices, use of public funds and past history, I strongly believe I can help right this ship. I believe in keeping water rate increases low and having transparency and accountability.

**Herald:** What decision/policy of the current board to you most agree with/disagree with?

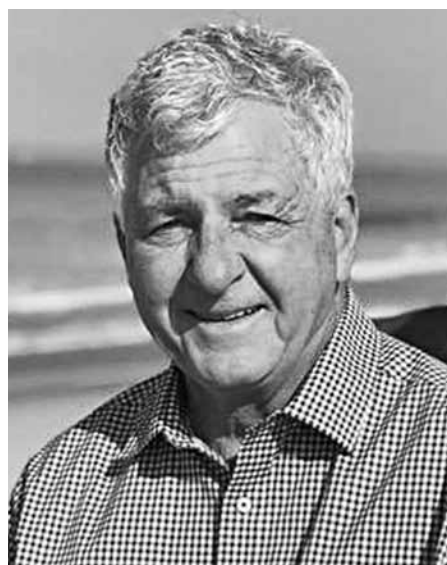
**JL:** Ocean desalination is important to be studied, but I would need to make that decision when the organization finalizes the environmental impacts. I disagree with the hiring practices and cronyism. I think the agency has shown tremendous potential, but can do more.

**Herald:** What are the two most important water issues the District faces and how would you address those?

**JL:** Maximizing water recycling and determining if ocean desalination is the right future for West Basin Municipal Water District.

**Herald:** What other priority item would you bring to the Board should you be elected -- and why?

**JL:** I would ask to look into the practices of the Board in regards to requesting RFPs (Request For Proposal) for contracts, outreach, travel and other expenditures. We have a responsibility to the public to be fiscally



responsible and I am convinced there is a lot of waste.

**Herald:** What is your stance on a desalination plant in El Segundo (or elsewhere)?

**JL:** This is a very important issue and highly debatable. I feel as a coastal agency, it is important to tabulate this as a future supply. I do believe that there could be environmental impacts to the marine environment, as well

as, high energy use. If these issues can be addressed, then it could be a viable source. We need the staff to conclude an analysis before a decision can be made. I believe it should be a science-based approach. I will not vote to move forward with the proposed facilities if the host city opposes. This is a local matter, and I would not overrule a two-thirds majority vote. I stand for and respect local control.

**Herald:** What is your position on dealing with rising water rates?

**JL:** Water rate increases are inevitable as is anything. It is the Board's job to make sure they rise appropriately and based on proper investment into the water systems. I am very against government waste and would ensure that doesn't happen should I get elected.

**Herald:** What is your position on dealing with water scarcity?

**JL:** I agree with the approach West Basin has taken. They have been a leader in conservation and water recycling for over two decades. They are literally creating new water supplies. I would like that to be maximized!

**Herald:** What are your thoughts on impacts specifically to El Segundo residents/businesses?

**JL:** El Segundo is fortunate to host the water recycling plant, as well as being right next to the Hyperion Water Reclamation Plant in Los Angeles. While we should be proud of hosting, we also have to ensure that our residents are not impacted significantly or carry the burden of construction or operation.

**Herald:** What water programs are most important and why?

**JL:** Conservation of water supplies and water recycling. We are fortunate that West Basin does both. I would push the staff to see how we can recycle more!

**Herald:** Is there anything else you can think of that we didn't ask that you feel is important?

**JL:** Yes... How would I respond to anyone who might think that I do not have experience? I would say that's not true. I possess integrity, ethics and morals that will far raise the bar of experience. •

# Grilled Flank Steak with Southwest Corn and Grape Salad

Recipe provided by Brandpoint  
Prep time: 25 minutes • Cook time: 15 minutes • Servings: 4



## Ingredients

- 1 1/4 pounds trimmed flank steak
- 1/2 teaspoon kosher salt (divided)
- 1/2 teaspoon ground cumin
- 1/2 teaspoon ground coriander
- Freshly ground pepper to taste
- 3/4 cup corn kernels, either freshly cut off the cob or thawed, frozen corn kernels
- 1/2 avocado, diced
- 3/4 cup red California grapes, halved
- 1/2 cup green California grapes, halved
- 1 tablespoon chopped shallot
- 2 teaspoons extra-virgin olive oil
- 2 tablespoons lime juice
- 1/2 teaspoon lime zest
- 2 tablespoons chopped cilantro (optional)

## Preparation

1. Pat the steak dry. In a small bowl, combine 1/4 teaspoon salt, the cumin, coriander and freshly ground pepper. Rub the mixture onto both sides of the steak; let stand for 15 minutes. Place the steak on a medium-high grill and cook it for 5 minutes on one side without moving it. Flip the steak and cook for another 4-5 minutes for medium-rare, or until desired doneness is achieved. Transfer the steak to a cutting board, cover loosely with aluminum foil and let rest for 5 minutes before slicing.
2. While the steak is resting, combine the corn, avocado, grapes, shallot, olive oil, lime juice, lime zest, the remaining 1/4 teaspoon salt, and pepper to taste; mix gently. Cut the steak diagonally across the grain into 1/4-inch thick slices. Arrange the steak slices on a serving platter or among four plates and top with corn and grape salad. Garnish with cilantro.

## Looking Up

### Origami Opens Up Smart Options for Architecture on the Moon and Mars

Based on a Press Release from the European Planetary Science Congress, Provided by Bob Eklund

Origami and high-performance textiles are transforming architecture plans for smart human habitats and research stations on the Moon and Mars. Initial field tests of the MoonMars project’s origami prototype have been presented at the European Planetary Science Congress (EPSC) 2018 in Berlin by Dr. Anna Sitnikova.

MoonMars is a collaboration between the International Lunar Exploration Working Group (ILEWG), ESA-ESTEC, research institutions and textile architect studio Samira Boon. The MoonMars team has incorporated origami structure into digital weaving processes to sculpt complex forms that are compact to transport and easy to deploy through inflatable, pop-up or robotic mechanisms in extraterrestrial environments.

“Origami structures made of textiles can be unfolded into a myriad of different shapes. They are lightweight. They can be easily deployed and re-used in different configurations and sizes for flexible spatial usage. Structures remain functional in changing circumstances, thereby extending their useable life-span,” said Sitnikova, who leads the MoonMars project on behalf of the ILEWG.

In the hostile environment of space, high-performance textiles and the flexible nature

of origami can provide unique architectural advantages. The angled facets of origami structures mean that incoming micrometeorites are less likely hit surfaces at 90 degrees, dissipating the energy of potential impacts and the risks of penetration, thus protecting astronauts inside habitats. Solar panels embedded in shape-shifting textiles can follow the Sun to gather more energy

through the day. Transparent and opaque facets can change direction to alter internal lighting and climate conditions.

Following initial tests of a prototype entrance tunnel during the EuroMoonMars simulation at the European Space Agency’s ESTEC facility in April 2018, the MoonMars team is now planning an ambitious series of trials for 2019. In June, the IGLUNA project, led

by the Swiss Space Center, will include tests of an origami habitat in the glacier above Zermatt in Switzerland. In September 2019, the team will travel to Iceland to participate in a campaign inside a lava-tube cave system.

“We’ve just returned from a scouting trip and have selected the cave systems of Stefanshellir and Surtshellir, which has large galleries and a very elaborate tunnel system. We are provisionally looking at setting up a small habitat, implementing knowledge from previous demonstrations of our origami tunnel and woven domes,” said Sitnikova.

The next design milestone will be a self-deployable origami habitat. Origami, from ori meaning “folding” and kami meaning “paper” (kami changes to gami) is the art of paper folding, which is often associated with Japanese culture. In modern usage, the word “origami” is used as an inclusive term for all folding practices, regardless of their culture of origin. The goal is to transform a flat square sheet of paper into a finished sculpture through folding and sculpting techniques.

“Origami for space architecture promotes cross-disciplinary approaches and applications, providing state-of-the-art production and design methods,” said Sitnikova. “Habitats enhanced by such structures are temporal and alive as they are able to transform and redefine themselves in resonance with human and environmental factors.” •

My first priority is to ensure reliable, affordable water and do everything in my power to minimize rate increases while providing safe, reliable water to our customers.

**Herald:** What is your position on dealing with water scarcity?

**SH:** Water security and water scarcity are the issues of our time. As we experience the effects of a drying climate, we’re seeing longer periods of hot, dry conditions with less precipitation than our state’s infrastructure was designed for. We now often receive rain instead of precious snowpack that has traditionally met our water needs. Our communities must adapt to this new normal by conserving water and using it more efficiently. There will be greater emphasis on developing new water supply sources such

as stormwater capture, recycled water and ocean water desalination to ensure we meet our region’s water supply needs.

**Herald:** What are your thoughts on impacts specifically to El Segundo residents/businesses?

**SH:** As a resident of El Segundo, I am very cognizant of the impacts of water scarcity to our community and appreciate that our residents and businesses have taken the drought seriously and stepped up to conserve. Our community is respected for its water efficiency that continues to improve and we are fortunate to have recycled water provided to many of our parks, businesses and retail centers because West Basin’s water recycling plant is located here. I will continue to advocate for more efficient use of water throughout

our city and adding recycled water lines wherever we can.

**Herald:** What water programs are most important and why?

**SH:** Our education and rebate programs are the most important tools we have to improve water use efficiency. These include providing free field trips for our school students to the water recycling plant, as well as our public classes and tours that teach residents about California’s water supplies and West Basin’s leadership producing recycled water that benefits our region. In addition, providing free rain barrels, turf removal rebates, grants for water bottle filling stations, and other water savings incentives combine to help us meet our conservation goals and reduce our District’s water use while setting an example

for others to follow.

**Herald:** Is there anything else you can think of that we didn’t ask that you feel is important?

**SH:** Our water supply challenges will only grow more difficult and require the experience, leadership and vision I bring to this position. I have a track record of success and I’m proud of my accomplishments during my first term. It’s truly an honor to represent the unique and diverse communities that make up Division 4 working on your behalf to ensure we have clean, safe and affordable water. El Segundo residents know my commitment to public service and have shared this journey with me. I look forward to continuing this critical work to ensure West Basin remains one of the leading water agencies in California. •

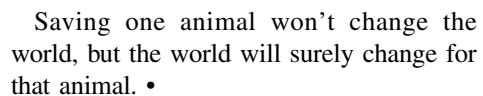
