Police Chief Robert Fager Retires

After 28 years of service to the City of Hawthorne, Chief of Police Robert Fager has announced his retirement, effective tomorrow, Friday, Oct. 26. Chief Fager was appointed as Hawthorne Police Department's Chief in December of 2010. Prior to that, he served as Interim Chief beginning in May of that year. Across the next eight years, he directed and oversaw significant departmental reorganizations that established a contemporary value-building philosophy towards Hawthorne's public safety mission.

Chief Fager's organizational reformations intrinsically began with the creation of the department's Community Affairs Unit in 2011. Always a strong advocate for community engagement, he asked this unit to markedly develop and fulfill a new mantra - one built on focused relationship-building with the Hawthorne community. Sitting at the forefront of the innovative programs designed sits "Coffee with a Cop." Endorsed by the U.S. Department of Justice, this nationally recognized program grows annually and is hosted by agencies in every U.S. state and in over 18 countries internationally. Another notable program/partnership established came alongside the Major League Soccer franchise LA Galaxy, and corporate partners Chevron and Herbalife. These involved the repurposing of sparsely-used tennis courts at two city parks. The recreation areas were redeveloped into futsal courts. Today, Hawthorne PD staff mentors groups of varying-age children weekly as they play competitive games and interact on life learning lessons. In similar fashion, a partnership with the National Hockey League players Association resulted in the creation of a boys and girls youth hockey team. The Hawthorne Force - a roster of children 14 years of age and under from the local community - come together to learn and play ice hockey (a sport often both unavailable and financially unattainable for families). Each of these sports-based endeavors allows platforms for Hawthorne Police staff to engage and build positive relationships with community youth and parents alike.

In a separate direction, another notable program developed and running under Chief Fager's mission plan is the Ride to Live motorcycle safety course. Taught by Department Traffic Bureau motor officers, RTL allows the agency to offer a fee-free program that increases rider awareness and skills, improving traffic safety and reducing potential accidents.

Under Chief Fager's direction, the department is currently implementing advanced technologies that increase effectiveness and efficiencies. Automated camera systems installed at main



tomorrow's demands.

Outside of Hawthorne's doors, Chief Fager has served in positions for the California Police Chiefs Association (CPCA) and the Los Angeles County Police Chiefs Association (LACPA). He currently sits as Chair for the Los Angeles Interagency Metropolitan Police Apprehension Crime Task (LA IMPACT) and the Interoperability Network of the South Bay (NSB). Further, he has served in advisory roles with Fight Crime: Invest in Kids Council, the National Safe Internet Surfing Foundation, and the South Bay Workforce Investment Board's Youth Development Council.

Originally hired by Hawthorne PD in 1990, Chief Fager has served in a multitude of positions during his career. A long-time member of the department's SWAT team, he has worked in various capacities and ranks within enforcement, field training, investigations, and administration. He is a 1996 recipient of the South Bay Medal of Valor award. Chief Fager relates, "I couldn't be prouder of the genuine talent and passion brought to work by the men and women of the department daily. In these most challenging and evolving times, our staff retains the true nobility of the law enforcement profession while working to better the quality of life within our community. That says something beyond special about our officers and their focuses. Our community is blessed. I have been blessed." In his succession, Captain Michael Ishii, a 28-year veteran of the department, will be appointed as Interim Police Chief upon Chief Fager's retirement. Captain Ishii, the seniortenured Captain both in the department and the South Bay region at-large, has worked hand-inhand alongside Chief Fager since 2010. Having overseen all Administrative and Operations division facets, Captain Ishii will seamlessly continue the department's proud tradition of police services and advance the value-focused community programs and relationships.

Wildlife: A Stunning and Powerful Debut from Director Paul Dano

The last time Paul Dano was celebrated at the Sundance Film Festival, he was riding waves atop Daniel Radcliffe's corpse like a jet ski in 2016's *Swiss Army Man*. The last time Zoe Kazan was at Sundance, she was starring opposite Kumail Nanjiani in the beloved romantic comedy, *The Big Sick*. The creative duo and real-life couple returned to Sundance earlier this year with a movie of their own -- an adaptation of the 1990 Richard Ford novel, *Wildlife*, which marks Dano's directorial debut.

Wildlife tells the story of a small-town nuclear family in 1960s Montana. Jerry (Jake Gyllenhaal) and Jeanette (Carey Mulligan) live a simple life: he works on a golf course and she's a homemaker. Their 14-year-old son Joe (Ed Oxenbould) attends public school and struggles to meet friends, a byproduct of the family's consistent moving around the country due to Jerry's flighty nature and always-changing career paths. After an unexpected layoff not only hurts his financial stability but also his pride, Jerry makes a spur-of-themoment decision to uproot his life and join a nearby firefighting brigade that is battling an uncontrollable forest fire close by, leaving his small family behind for an unknown period of time.

As the movie shows through the limited but observant perspective of Joe, his mother edges ever closer towards the brink of unforgivable resentment and finds herself coping in ways

a married woman shouldn't. From getting a part-time job to exploring an extramarital affair with a client (Bill Camp), Jeanette slowly discovers her own independence. As she begins to figure out what she really wants out of life, it leaves Joe, who is still waiting for his father's return, as the emotional support system for the family. Witnessing his parents' marriage fall apart right before his eyes is devastating, and even more so because of how much his parents each depend on him to be their anchor.

It's obvious that every detail of *Wildlife* has been carefully crafted from the eyes of a passionate artist. From the 1960s costumes to every detail of the production design, the ambiance of the film screams warmth and heart, even if its central characters struggle with those same virtues. Here, Dano proves that he has not been idle as an actor on his previous movie sets, showcasing a strong visual style all his own. Every frame of *Wildlife* looks like it was lifted from a Norman Rockwell painting. The sweeping cool, blue hues give a layer of sophisticated authenticity to this quiet yet powerful indie drama.

It will be interesting to see Dano and Kazan's filmmaking path post-*Wildlife*, which is a confident debut in and of itself. Dano certainly proves that he can command a tough yet tender film both technically and creatively and I, for one, can't wait to see what he does next.




Looking Up MASCOT Lands Safely on Asteroid Ryugu

Based on a Press Release from DLR, the German Aerospace Center, Provided by Bob Eklund

The near-Earth asteroid Ryugu, located approximately 120 million miles from Earth, has a new inhabitant: On 3 October 2018, the Mobile Asteroid Surface Scout (MASCOT) landed on the asteroid and began to work. The lander successfully separated from the Japanese Hayabusa2 space probe at 03:58 CEST. The 16 hours in which the lander will conduct measurements on the asteroid's surface have begun for the international team of engineers and scientists. The day before, the Japanese Space Agency's Hayabusa2 began its descent towards Ryugu. MASCOT was ejected at an altitude of 51 meters and descended in free fall-slower than an earthly pedestrian-to its destination, the asteroid.

The relief about the successful separation and subsequent confirmation of the landing was clearly noticeable In the MASCOT Control Centre at the German Aerospace Center (Deutsches Zentrum für Luft- und Raumfahrt; DLR) as well as in the adjoining room: "It could not have gone better," explained MASCOT project manager Tra-Mi Ho from the DLR Institute of Space Systems. "From the lander's telemetry, we were able to see that it separated from the mothercraft, and made contact with the asteroid surface approximately 20 minutes later." The team is now in contact with the lander. The moment of separation was one of the risks of the mission: If MASCOT had not successfully separated from Hayabusa2 as planned and often tested, the lander's team would hardly have had the opportunity to solve this problem. But everything went smoothly: Already during the descent on the asteroid, the camera switched MASCAM on and took 20 pictures, which are now stored on board the Japanese space probe. "The camera worked perfectly," says Ralf Jaumann,

DLR planetary scientist and scientific director of the camera instrument. "The team's first images of the camera are therefore safe." The magnetometer team was also able to recognize in the data sent by MASCOT that the MASMAG instrument had switched on and performed measurements prior to the separation. "The measurements show the relatively weak field of the solar wind and the very strong magnetic disturbances caused by the spacecraft," explains Karl-Heinz

Glaßmeier from the Technical University of Braunschweig. "At the moment of the separation, we expected a clear decrease of the interference field—and we were able to recognize this clearly."

MASCOT came to rest on the surface approximately 20 minutes after the separation. Now, the team is analyzing the data that MASCOT is sending to Earth to understand the events occurring on the asteroid Ryugu. The lander should now be on the asteroid's surface, in the correct position thanks to its swing arm, and have started to conduct measurements independently. There are four instruments on board: a DLR camera and radiometer, an infrared spectrometer from the Institut d'Astrophysique Spatiale and a magnetometer from the TU Braunschweig. Once MASCOT has performed all planned measurements, it is expected to hop to another measuring location. This is the first time that scientists will receive data from different locations on an asteroid. "With MASCOT, we have the unique opportunity to study the Solar System's most primordial material directly on an asteroid," emphasises DLR planetary researcher Ralf Jaumann.

With the data acquired by MASCOT and the samples that Hayabusa2 brings to Earth from Ryugu in 2020, scientists will not only learn more about asteroids, but more about the formation of the solar system. "Asteroids are very primordial celestial bodies." •




