School Board Approves Memorandum of **Understanding Between District, CYS**

Last week members of the Hawthorne School Board approved a Memorandum of Understanding (MOU) between Centinela Youth Services (CYS) and the Hawthorne School District (HSD) that will allow CYS to collaborate with Kornblum, Ramona and Washington elementary schools, as well as Hawthorne Middle School. The MOU will remain in effect from Oct. 26, 2016-June 30, 2017 and will work toward incorporating the Students Able to Resolve Situations (STARS) program, tailored to create positive school climate activities.

CYS has been providing youth counseling services, physical and mental health, as well as academic and developmental intervention since 1975 to youths and families in need. In addition, the nonprofit administers juvenile crime prevention services. Since the mid-'90s, CYS has achieved strong outcomes with the youth it serves and has since expanded its services into many communities in need throughout Los Angeles County.

The relationship between the Hawthorne School District and CYS has been ongoing since the early 1990s; at the time the Moneta Gardens area in Hawthorne struggled with high rates of gang violence. In response, the HSD decided to provide avenues for students to engage in activities that would keep them distant from interacting with criminal influences in the area, while teaching kids ways to peacefully resolve conflicts.

"Peggy [Doherty, former Assistant Principal at Bud Carson Middle School] was instrumental in the creation of Moneta Gardens Improvement Incorporated," said Hawthorne School District Director of Pupil Personnel Services Dr. Sonya Smith. "She knew the children were in danger and that we had to do something. We had some Bud Carson students go to Leuzinger [High School] and get killed, outside of the school. So she was instrumental in bringing

them [CYS] into the district."

CYS has been successful in several of the District's schools in the past, and presents no financial burden. The program will use staff members, or college interns, in training peer mediators to work with students in order for them to resolve peer conflicts and other situations. "So when there is an issue that involves some type of aggression or a dispute, it's about asking the student if they would be willing to sit down and resolve it verbally, with the assistance of a trained mediator, as an alternative to a different type of discipline which back in the day would be suspension," said Dr. Smith. "We look at alternatives to suspension because back then it would become zero-tolerance issues as a result of the violence."

Prior to working with CYS, student suspension was the standard disciplinary action. However, in an effort to avoid having the student potentially roam the streets and lose learning time, the District began looking for ways to keep the child at school and learning. Furthermore, the intent of the partnership with CYS was to teach students the skills necessary to become assertive, while expressing to people that they felt hurt in an effort to renegotiate a settlement.

"We make assumptions that the children come to us with the skills to be successful in the classroom and in life, but we can't control what happens outside of the school door--so for us to make that assumption is naive on our part," Dr. Smith said. "We have to give them the skills needed to survive out there as citizens."

Through the application of Restorative Justice and Trauma-Informed Care principles, CYS is committed to empowering young people, their families, and victims of crime to become accountable in order to heal. The non-profit's targeted demographic is youth between the ages of 7-21, with the goal to teach the young kids life skills such as peaceful conflict resolution to help them become successful and productive students and adults.

In 1973, several Inglewood Police Department officers recognized that response calls included a growing number of youths who were simply being arrested instead of receiving any type of counseling or support. To remedy the problem, the officers began to connect offending youths with the better-suited services to address behavioral needs. However as street violence grew and perpetrators became younger, it became clear that there was a need for an organization dedicated to helping youth and families in high-need communities. By 1975, CYS was established.

The organization was initially administered by the City of Inglewood, but CYS services would soon expand to offer support for youth and families in the neighboring cities of Lawndale, Hawthorne, Gardena and Lennox. By 1995, CYS began receiving youth referrals from juvenile court jurisdictions throughout Los Angeles County.

The relationship between CYS and the HSD has been going strong for more than two decades, but there is still a need to enter into the MOU to ensure that the District is aware of who is authorized to be on the participating campuses, and what services they are providing. Furthermore, through the MOU there are certain requirements that each site must meet, such as making the space available and referring a certain amount of students per month. Dr. Smith explained, "Just think about it in terms of academics: If a child were struggling to read, what would you do? You would give the extra assistance, you would refer them to intervention or afterschool tutoring. You have this whole range of services available for students when they are struggling academically. Behavioral issues are no different. They are acting out because they have a need that is not being met and it's our responsibility to look at that child as an individual and try to find out what he or she needs and then help them meet that need." •

Shared Experiences And Support Can Help People Manage Type 2 Diabetes

(BPT) - Nearly 30 million Americans have diabetes, and most (90-95 percent) have type 2 diabetes. Diabetes management isn't always easy - some people may have difficulty visiting their doctor regularly, eating healthy foods and reaching their A1C goal. That's why America's Diabetes Challenge, a program from Merck and the American Diabetes Association, is encouraging people to share their stories about the challenges and successes they've faced managing type 2 diabetes or supporting a loved one with the disease.

The program also encourages people with type 2 diabetes to work with their doctor to set and reach their A1C goal (average blood glucose level over the past 2 to 3 months), as well as learn if they're at risk for low blood glucose, known as hypoglycemia, and how to help reduce that risk.

In 2015, artist Tim McGraw, actress S. Epatha Merkerson and chef Leticia Moreinos Schwartz each shared their personal connection to type 2 diabetes, and now they're calling on people around the country to share their stories too. "Even if you don't have type 2 diabetes, chances are you know someone who does," McGraw says. "People can help each other by talking about the steps they're taking to get to their A1C goal, including challenges or successes they experience."

Hoping to inspire others with type 2 diabetes, Merkerson has shared her own personal struggles and accomplishments after living with the disease for nearly 14 years. "After my diagnosis, I got serious about my health

and worked with my doctor to develop a personalized diabetes management plan." Merkerson says. "I'm sharing my story as part of America's Diabetes Challenge and challenge you to do the same. We need to stick together, so share your story with us today and help us to inspire others to make healthy choices."

America's Diabetes Challenge plans to identify the most common challenges patients submit and will offer tips to help address them.

As people work with their doctor to create an individualized treatment plan that's right for them. there are some important tips to keep in mind:

· Both blood glucose self-tests and A1C tests are needed to help a patient and their doctor understand how well blood glucose is being controlled, because these tests measure blood glucose in different ways. The American Diabetes Association recommends that people with diabetes have an individualized A1C goal; the A1C goal for many adults with diabetes is less than 7 percent. A higher or lower goal may be appropriate for some people.

• Many people with diabetes are aware of the importance of controlling high blood glucose by diet, exercise and taking medicine (if prescribed), but they may not know that blood glucose can also go too low. People should learn to recognize the signs and symptoms of both high and low blood glucose, and talk to their doctor if they're experiencing problems. Some people may be aware that low blood glucose can be caused by skipping meals or exercising excessively, but what they may not know is that certain diabetes medicines could also cause it to go too low.

• Diet and exercise are an important part of any diabetes management program. Tips for making healthier food choices include choosing lean proteins, opting for whole grains and reducing sodium intake.

A Windy City Wish Come True

When the Cleveland Indians took a 3-1 series lead in the World Series over the Chicago Cubs, most people thought, "Ah, that's just the Cubs, squandering another chance at a title." What happened after that, however, was a series of events for the record books. When all was said and done, the Cubs that everyone loved to give up on came back in the series, rattled off three straight wins and took a championship back home from Cleveland to Chicago. Most people thought that they would never see the day when the Cubs won the World Series. But 108 years later, it was written in the Major League Baseball history books.

No Billy Goat, Bartman, or black cat could stop the history that this year's Chicago Cubs were destined to write after a season in which the team won 103 regular season games--good enough for best in all of the MLB. The next best team in the entire league won eight less games than the Cubs, so you might even say that Chicago deserved its recently acquired championship ring. After 39,466 days of waiting, who wouldn't deserve it? Of course, when you beat the likes of the San Francisco Giants and Madison Bumgarner, the Los Angeles Dodgers and Clayton Kershaw, and the Cleveland Indians and Corey Kluber, there is certainly something to be said for a team that can now comfortably call itself the best in the world.

"Nothing's been easy, nothing's been given to us," Cubs ace Jon Lester explained of his team's heroics in this year's postseason. "Every series has been a battle and been a grind for us. We played three really good opponents to get here, and here we stand. It's an unbelievable feeling to be a part of this. You wouldn't expect it any other way." One might expect Lester to be the team's playoff MVP. The Cubs constantly leaned on him, even out of the bullpen, to pick them up on defense and get the team pointed back in the right direction. On offense, it happened to be a rather unlikely hero in Ben Zobrist.

Zobrist hit the go-ahead double in the 10th inning of Game 7 to break the tie and ultimately give his team the 8-7 victory over Cleveland in the deciding game. "I know he threw a pretty hard cutter," explained the player who was later named World Series MVP. "I just barely hung in there, and fortunately he put one just close enough to the plate where I could slap it down the line."

With that slap down the line, the curse of the Cubs was officially broken. Even though the team tried to add a bit more drama by giving a run back to the Indians in the bottom of the $10^{\rm th}$, it was too little too late for Cleveland. The superior team battled back time and time again, and beyond simply the offense--or even simply the defense--it was the Cubs' team as a whole

that won the World Series. For that reason, Chicago President of Baseball Operations Theo Epstein should be viewed as the real catalyst and most valuable person in the entire organization.

Epstein arrived in Chicago in 2011 after a 71-win season. He had just assisted in replenishing the Boston Red Sox's 86-year World Series drought. The Red Sox hadn't won the championship since 1918. With the help of Epstein, the team won in 2004 and 2007. Theo then brought his magical mind to Chicago to try to erase the league's longest-standing curse. After trading for Anthony Rizzo from the San Diego Padres and acquiring Kyle Hendricks from the Texas Rangers in 2012, Epstein traded with the Baltimore Orioles for Jake Arrieta and drafted Kris Bryant in 2013. He then acquired Addison Russell from the Oakland A's, hired Joe Madden as the manager and signed Jon Lester all in 2014, before acquiring Dexter Fowler and signing John Lackey, Zobrist and Jason Heyward in 2015. Finally, closer Aroldis Chapman was acquired from the New York Yankees in 2016. The result? A 2016 MLB championship.

With their victory, the Cubs became the first team to come back from a 3-1 deficit in the World Series to win Games 6 and 7 on the road since the 1979 Pirates. For once, there will be no more talk of the 1945 team that lost the World Series to the Tigers. There won't be any more talk of the '84 team that lost in the NLCS to the Padres, or even the 2003 team that tragically lost it all in the NLCS to the Florida Marlins because of the infamous "Bartman game" (okay, people may still talk about that one). Now, the Cubs and their fans can talk about what they did do. "There's no curses - there never was a curse," said Cubs General Manager Jed Hoyer. "It's about having the best team and playing well over seven games in a World Series, and we did that. Enjoy it. The Cubs are no different than any other team. When we're the best team, we can win, and we were the best team."

There certainly is something to be said about a team that had gone over a century without a championship. Almost everyone you know who enjoys and loves the game of baseball has a story about someone or maybe even knows someone who has been waiting their entire lifetime for a Cubs championship victory. Maybe that someone is even you. The team has been mocked, displayed in television shows and movies...and despite not winning, the Chicago Cubs have been one of the most popular and recognizable teams in the nation. Well, they are not the loveable losers any longer. The Chicago Cubs are the 2016 champions of Major League Baseball and with such a young group of core players, don't expect them to go anywhere any time soon. •


