Council Adopts Cleaning, Airport Commercial Project Ordinances

In one of the briefest meetings of the year, the Hawthorne City Council spent its post-Thanksgiving get-together approving a pair of ordinances that will affect businesses in the community. The first came from the approval of the previously mentioned Ordinance 2152, which would require commercial centers in the city to maintain a cleaning schedule.

“This ordinance adds teeth to the Hawthorne Municipal Code requiring that shopping centers have a cleaning schedule for high-pressure cleaning, graffiti removal, building façade cleaning, landscaping and litter removal,” Councilmember Olivia Valentine said. Valentine spearheaded the ordinance after receiving numerous complaints from residents about shopping centers in the city allowing trash and debris to accumulate on their properties.

“The cleaning schedule would require that the name and phone number of the person responsible for the cleaning be made available as well as a schedule be posted and provided by all tenants,” Valentine added. “I am hoping this is going to be the beginning of a great period in which the shopping center owners who are negligent in keeping their shopping centers clean will have more motivation to do so.”

The ordinance will be revisited in six months to assess its effectiveness and further necessity. “Ideally, I would like to have this reviewed in six months and that we make a decision on whether or not to keep it,” Valentine said in response to Mayor Alex Vargas’ question on the long-term plans for the ordinance.

The second ordinance approved (with Councilmember Nilo Michelin dissenting and Councilmember Angie Reyes English absent),

concerned the area around the Hawthorne Municipal Airport. Ordinance 2151 establishes a protection from any future commercial developments in the Runway Overlay Zone for the airport.

“What we had was that it was zoned for commercial development and now it is not going to be, so adopting this ordinance--now there’s no commercial development, especially building any structure in the zone,” City Manager Arnie Shadbehr said. “Finally we have a protection in place for [the zone] that nobody can submit a development.”

The ordinance cleans up one of the forgotten issues from previous administrations. “We are cleaning up our codes with this ordinance and therefore we will be in full compliance with the FAA design guidelines and grant insurances,” Shadbehr said.

The Council had previously heard a proposal for the development of a restaurant in the Runway Overlay Zone, which would have put the City in conflict with the FAA on a number of safety and development standards. “All these years, we were not aware of it,” Shadbehr noted about updating and approving the ordinance. “[The] previous City Planner had zoned it a commercial area and I don’t know what the reason was for it.”

City Attorney Russell Miyahara added that when the restaurant development plan was first proposed, there was an environmental impact report included that prohibited any buildings in the Runway Protection Zone--but at that point around 2012, the development agreement for the project expired. Then, according to Miyahara, “it fell through the cracks in terms of enacting a new ordinance to prevent further structures in the Runway Protection Zone.”

The Council also introduced Ordinance 2156, which would approve the joint powers agreement for the Los Angeles Community Choice Energy Authority and authorize the implementation of a community choice aggregation program. The ordinance would provide greater flexibility and choice in power supply for residents by allowing more renewable energy options and reducing energy costs for consumers.

The Council also officially canceled its final meeting of the year on December 26, which also coincides with City Hall being closed on that date. “I bring this up because it’s been tradition every year. We just have to go through the formal ratification of being able to say, ‘Wait until January for the next meeting,’ because a lot of the residents aren’t even here to begin with,” Vargas explained.

The Mayor concluded the meeting along with his colleagues in thanking volunteers and organizations in town for sponsoring and facilitating numerous events throughout the holiday last week. “Thank you to all the different organizations that had the Thanksgiving events and holiday giving of turkeys and food,” Vargas said in his closing statement. “We have a great spirit of volunteerism here in the city of Hawthorne and there’s definitely a lot of different events coming up, so we hope that the residents of Hawthorne will participate, give, volunteer and enjoy themselves.”

Vargas added, “I ask that you support all of my Councilmembers’ different charities that they participate in, events that they are promoting. Everybody has a series of things that we need your support and participation in.”

The final Hawthorne City Council meeting of 2017 will take place on December 12. •



# Film Review

## Rapturous *Call Me By Your Name* Is a Sunshine-Soaked Love Story

“Is it better to speak, or to die?” These are the words Mrs. Pearlman reads aloud to her son, Elio (Timothée Chalamet) and her husband from the love story about a prince who doesn’t know whether or not to express his love to the princess—the love of his life—or not. Lounging about in the living room of their 17th Century vacation villa in Northern Italy, the Pearlman family takes in the endless summer afternoon of 1983. The prince’s quandary is the same one felt by young Elio when exchange student Oliver (Armie Hammer) comes to stay with the family in Luca Guadagnino’s latest film, *Call Me By Your Name*—a beautiful film of discovery and pure love, and one of the best films of the year.

The summer will be a transformational one for the intelligent, but still boyish 17-year-old Elio, who spends his afternoons studying classical piano sheet music and reading novels. His academic parents may have been able to culture him on the finer things in life regarding art and history. However, Elio finds himself inexperienced when it comes to understanding his feelings and own sexuality. It is only when his father’s 24-year-old American intern, Oliver, arrives at their family’s home to study for the summer that Elio is awakened to the feelings of pure love and desire for the very first time.

*Call Me By Your Name* (much like our previously reviewed film, *Thelma*) explores the theme of finding one’s voice and navigating through the messiness of being in love against the backdrop of coming to understand one’s sexual desires. It plays like a beautifully orchestrated dance. The patient, measured pace allows the audience to experience all

of the visceral and sensual moments the film has to offer: the bite into a plump apricot, the sound of trickling water, the warmth of the Italian sun, and an alarmingly welcomed first touch on a shoulder all convey the feelings of sensuality that first love can awaken us to in life.

These are the things that director Luca Guadagnino evokes so vividly in creating an endless summer with an amazing visual language (much as he did in his previous film, 2015’s *A Bigger Splash*). In a technical sense, Guadagnino understands how to transition between these moments to allow the film to breathe effortlessly into the next as scenes are woven together with cross-dissolves and fades rather than harsh cuts. Adding to the film’s overall tone is the original music from singer-songwriter Sufjan Stevens, whose whispered, confessional lyrics against the quiet staccato of melodic piano keys perfectly capture and heighten the optimism of discovery in the film.

Based on the 2007 novel from André Aciman of the same name, *Call Me By Your Name* was quickly regarded as a modern classic on first love. Although mainly celebrated in the LGBTQ community for its subject matter, it has since been embraced universally for its portrayal of the joy and heartache that comes from first love that transcends gender or sexuality. The film has also been nominated for six Independent Spirit Awards, including Best Feature, Best Actor and Best Supporting Actor—and if that is any indication, there will likely be many awards tied to this film in the months to come. *Call Me By Your Name* is rated R for sexual content, nudity and some language. 132 minutes. Now playing at ArcLight Hollywood and The Landmark. •

## Know Thrombosis: Tips to Prevent Deadly Blood Clots



(BPT) - When you think of potentially deadly health issues, do you think of a blood clot? According to a recent U.S. survey, only 7 percent of people say they are concerned about blood clots, known by the medical term thrombosis. However, what they might not know is one in four people worldwide die from conditions caused by thrombosis, making it a leading cause of global death and disability.

So, what is thrombosis?

- Thrombosis is the formation of potentially deadly blood clots in the artery (arterial thrombosis) or vein (venous thrombosis).
- When a blood clot forms in the deep veins of the leg, it is known as deep vein thrombosis (DVT).

- If a blood clot travels in the circulation and lodges in the lungs, it is known as a pulmonary embolism (PE).

- Together, DVT and PE are known as venous thromboembolism (VTE), a dangerous and potentially deadly medical condition. DVT + PE = VTE.

“Thrombosis is a significant public health issue about which many people are unfortunately unaware,” says Dr. Gary Raskob, Ph.D., dean of the College of Public Health at the University of Oklahoma Health Sciences Center and chairman of the World Thrombosis Day Steering Committee. “Understanding the risk factors for thrombosis and if you are at risk, as well as the signs and symptoms, is knowledge that could save your life.”

Some signs and symptoms of DVT include pain or tenderness in the calf and/or thigh;

swelling of the leg, foot and/or ankle; redness and/or noticeable discoloration; and warmth.

People with PE often experience shortness of breath, rapid breathing, chest pain (which may be worse during deep breath), rapid heart rate, lightheadedness and/or fainting. Risk factors for VTE include hospitalization, surgery, cancer, prolonged immobility, family history, estrogen-containing medications and pregnancy or recent birth. Given that up to 60 percent of VTE cases occur during or after hospitalization, it’s important to ask your doctor for a risk assessment anytime you are admitted to the hospital.

“Knowing the facts about thrombosis can save your life,” says Mike Albanese, a comedian living with AFib, a common type of irregular heartbeat, or arrhythmia, which can lead to the formation of a deadly blood clot. “As a comedian, I try to use my shows as a platform to educate others about thrombosis, which can be preventable when you know what to look for.”

VTE-related events cause more deaths each year in the U.S. and Europe than breast cancer, AIDS and motor vehicle crashes combined. That’s why the International Society on Thrombosis and Haemostasis (ISTH) created a global movement called World Thrombosis Day on Oct. 13 to increase awareness of this often-overlooked condition.

When it comes to thrombosis, knowing the signs, symptoms and risk factors can help you keep life flowing.

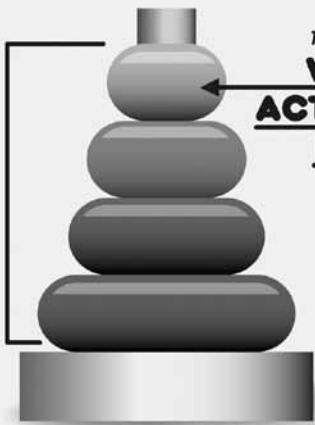

## Lakers, Rookie Ball Experiencing Early Season Highs and Lows

Oftentimes, an NBA fan base can be overly excited when a player is taken high in the draft. Expectations become understandably high as a new hope is enlivened for an organization. Between drafting Julius Randle, D’Angelo Russell, Brandon Ingram, and even now, Lonzo Ball, Los Angeles Laker fans know all about that feeling. A complete rebuild certainly takes time in a post-Kobe Bryant era. Lakers fans have also learned that the hard way. There is no doubting that L.A. is surely inexperienced up to this point in the regular season and their unpredictable play does its own part in portraying that. Not every prospect that puts on the purple and gold is going to be the next Kobe--not even Lonzo. Despite various inconsistencies to start the year, however, an extremely young Lakers team may just be on the right track towards success.

The new star of Los Angeles, at least as far as the Lakers are concerned, is Lonzo Ball. Ball has been the starting point guard of the Lakers ever since the first day of the regular season. Despite Ball’s inconsistent play, head coach Luke Walton and the rest of the coaching staff have handled the situation perfectly by keeping the point guard in the starting lineup, despite his off days and subpar shooting from the field. “The benefit is he gets the game experience,” Walton explained of the sometimes shaky

play of Lonzo. “Whether it’s close games, it’s blowouts, it’s playing against top elite point guards that do different things. He gets all that in-game experience on the go and gets to learn from it all.”

Grading Ball on approximately 20 games of NBA play after he spent just one season in college at the age of 20 years old certainly sounds like an unfair thing to do. When you play in Los Angeles and you’re the number two overall pick in the draft, though, it sort of comes with the territory. Despite what critics may say of Lonzo, he is certainly young and inexperienced and at times looks overwhelmed on the grand stage of the NBA while taking on superstar veterans like John Wall, Russell Westbrook and more. Even Kobe had a horrible first year in the NBA, though, so this isn’t necessarily the time to pull out the report card on the first-year guard.

Despite the inexperience and inconsistencies, however, Ball and the rest of the Lakers team have shown flashes of brilliance—which is certainly something that you want to see from a group of young players. As unlikely as it may seem, most of that brilliance has come on the defensive side of the ball. After ranking dead last in defensive efficiency in each of the last two seasons, the Lakers--behind Ball, Ingram and surprising rookie sensation Kyle Kuzma--were ranking in the league’s top five in

defensive efficiency as of last weekend. While it is always glaringly obvious when Lonzo struggles on the offensive side of the court, Walton enjoys giving the rookie credit for the team’s newly invigorated defensive efficiency. “He’s got great anticipation and great hands as a player already, so he’s able to get a lot of loose balls for us,” Walton explained. “Or he comes down and strips offensive rebounds that guys don’t really see him hanging around, which gets us extra possessions obviously.”


Those extra possessions have turned into victories for the Lakers too. Less than two weeks ago, Ball recorded his second triple-double of the season to join Magic Johnson as the only other rookie in Lakers history with multiple triple-doubles in their rookie seasons. Ball recorded 11 points, 16 rebounds and 11 assists in a 127-109 victory over the Denver Nuggets, showing that when he’s on his game, Los Angeles can put points up on the scoreboard. “You should always play better in front of your fans,” Ball said after that game. “I’m just trying to put on a good show for them and win at the same time.” The Lakers were 5-5 at Staples Center dating back to last weekend.

So far in the young season, as Lonzo Ball goes, so do the Lakers. That’s not to say that Randle, Ingram and Kuzma, among other Lakers, have not come through with


monster games at various times during the year. Ball, however, is the engine that runs the Lakers offense as the point guard. For all of his good also certainly comes the bad. Lonzo’s shooting percentage --which was hovering around 31 percent prior to the game against the Clippers this past Monday, ranked worst among rookies who have averaged at least 10 minutes per game. His three-point percentage--at 25 percent--also ranked last among rookies who have attempted more than one three-pointer per game. That poor shooting, from a player who constantly has the ball in his hands, has done its part to not only lead to deficits in games, but also losses this season.

Just like Lonzo, the 2017-18 Lakers team has been full of good play and bad play so far this season. That being said, what more can you expect from a team that is full of youth and inexperience? The takeaway from the first quarter of this regular season is that the Lakers are good enough to at least keep their heads above the water against elite talent, which should certainly garner attention from some big-name free agents come the trade deadline and the offseason. Once a legitimate, big-name superstar is added to this core of young talent, the sky will once again be the limit for the Lakers and all of their fans. •

# Solar System’s First Interstellar Visitor Dazzles Astronomers

Astronomers recently scrambled to observe an intriguing asteroid that is passing through our solar system on a steep trajectory from interstellar space—the first confirmed object from another star.

Now, new data reveal the interstellar interloper to be a rocky, cigar-shaped object with a somewhat reddish hue. The asteroid, named ‘Oumuamua by its Hawaiian discoverers, is up to one-quarter mile long and highly-elongated—perhaps 10 times as long as it is wide. That aspect ratio is greater than that of any asteroid or comet observed in our solar system to date. While its elongated shape is quite surprising, and unlike asteroids seen in our solar system, it may provide new clues into how other solar systems formed.

The observations and analyses were funded in part by NASA and appear in the November 20 issue of the journal Nature. They suggest this unusual object had been wandering through the Milky Way, unattached to any star system, for hundreds of millions of years before its chance encounter with our star system.

Immediately after its discovery, telescopes around the world, including ESO’s Very Large Telescope in Chile, were called into action to measure the object’s orbit, brightness and color. Urgency for viewing from ground-based telescopes was vital to get the best data.

Combining the images from the ESO telescope with those of other large telescopes, a team of astronomers led by Karen Meech of the Institute for Astronomy in Hawaii found that ‘Oumuamua varies in brightness by a factor of 10 as it spins on its axis every 7.3

hours. No known asteroid or comet from our solar system varies so widely in brightness, with such a large ratio between length and width. The most elongated objects we have seen to date are no more than three times longer than they are wide.

“This unusually big variation in brightness means that the object is highly elongated: about ten times as long as it is wide, with a complex, convoluted shape,” said Meech. “We also found that it had a reddish color, similar to objects in the outer solar system,

and confirmed that it is completely inert, without the faintest hint of dust around it.”

These properties suggest that ‘Oumuamua is dense, composed of rock and possibly metals, has no water or ice, and that its surface was reddened due to the effects of irradiation from cosmic rays over hundreds of millions of years.

This remarkable object was discovered October 19 by the University of Hawaii’s Pan-STARRS1 telescope, funded by NASA’s Near-Earth Object Observations (NEOO) Program, which finds and tracks asteroids and comets in Earth’s neighborhood that could pose a danger to Earth.

Preliminary orbital calculations suggest that the object came from the approximate direction of the bright star Vega, in the northern constellation of Lyra.

The object’s official name is interstellar asteroid 1I/2017 U1. In addition to the technical name, the Pan-STARRS team in Hawaii dubbed it ‘Oumuamua (pronounced oh MOO-uh MOO-uh), which is Hawaiian for “a messenger from afar arriving first.”

‘Oumuamua is travelling about 85,700 miles per hour relative to the Sun. Its curent location is approximately 124 million miles from Earth—the distance between Mars and Jupiter—though its outbound path is about 20 degrees above the plane of planets that orbit the Sun. The object passed Mars’s orbit around November 1 and will pass Jupiter’s orbit in May of 2018. It will travel beyond Saturn’s orbit in January 2019. As it leaves our solar system, ‘Oumuamua will head for the constellation Pegasus. •
