# City Council Votes to Join BizFed to Spur Growth, Help Businesses

In the final meeting of 2017 on Tuesday, the Hawthorne City Council took another step toward continuing to build up commerce in the coming years. With a unanimous vote of 4-0 (Councilmember Nilo Michelin was not in attendance), the group agreed to join the Los Angeles County Business Federation for a one-year trial.

The Los Angeles County Business Federation, also known as BizFed, is an alliance between 160 business associations that include more than 80 chambers of commerce representing 325,000 businesses in all 88 cities of Los Angeles County. Their core focus is public advocacy with a goal, in Hawthorne's case, to help reach its revitalization goals.

"We have leadership relationships on all levels of government--local, regional, state and federal," BizFed Senior Director of Business Relations Kevin Harbour told the Council. "What that means [for Hawthorne] is that we can educate you on not only Senate and Assembly bills as they come down and impact business, but also help the City mobilize to support them to the benefit of the City of Hawthorne."

BizFed has been in existence for 10 years and is currently working with other cities including Cudahy, Maywood, Inglewood, Lawndale, Whittier and El Monte. "As the City sets it sights on growing technology, infrastructure and bring in restaurants and logo-type businesses that will improve the quality of life for the residents, we are the connective tissue between the City's goals and actualizing them into reality and bringing those goals to fruition," Harbour said.

The Federation operates on various levels of membership ranging from \$5,000 to \$15,000 a year for entry-level participation. The lowest level of membership and the level that the City Council voted for allows for a seat on the Board of Directors, five advocacy seats, and business intelligence that includes alerts on any Assembly or Senate bills moving through Sacramento. The cost is \$5,000 a year for membership.

"You have five advocacy seats so Council

members can choose amongst themselves which advocacy community they'd like to belong to whether that be transportation, land use, housing...and then the City Manager a lot of times or the Mayor can kind of carry things forward," Harbour said.

The \$10,000 level includes all the low-level perks as well as a link on the BizFed website and a priority to meet and present to some of the working groups and communities that are pertinent to Hawthorne's revitalization plan. The highest level includes all of the above as well as social media advocacy spread among multiple platforms including Facebook, Twitter, Instagram and LinkedIn.

"We're able to make people aware of what you're doing and draw in the kind of audience that [Hawthorne] wants to target," Harbour said. "We put together an annual plan for the length of your membership and we want to understand what your plan is--and if you don't have a plan, we give you some thought leadership on how to develop a plan and then we mobilize companies and people within our organization that will compliment and help move that plan forward more effectively."

Councilmember Angie Reyes English, who held a lengthy and much-needed interrogation of the proposal, ultimately said, "It's important that existing businesses are being championed just as much. I know the City is growing. However it's important to know that organizations such as [BizFed] have the opportunity should we need your assistance to outreach to you in regards to an existing business that might have some concerns about expansion and development."

English added, "I know that we have a Planning Department, I know that we have our land use, I know we have no permitting and all this other stuff. I'm aware of that. I know we used to have monies that we would be able to give to existing businesses to fix their façade. We no longer have that."

English also addressed the long-held wish to implement public Wi-Fi in the city. "It's been something I've been discussing for numerous

years, in regards to the Hawthorne Specific Plan and other stuff that we have," she said. "I would hope that [BizFed] look to Hawthorne, look to its history, look to what it has been doing versus just becoming a member. My wish list is that we can ultimately benefit this community through Wi-Fi."

While still voting in favor of trying BizFed out, Mayor Alex Vargas mentioned that he was curious to see how that would impact the Hawthorne Chamber of Commerce and what its goals and accomplishments have been to date. "Since we're looking at an outside company to help do some of this development, I think we really need to ask our Chamber of Commerce President to come and give us a report on all the benefits her group is doing," Vargas said. "Why are we finding a need to be a member of another group?"

Vargas issued a request to City Manager Arnie Shadbehr to have Chamber of Commerce President Patricia Donaldson provide a report with regards to a budget and what the organization is doing-and then the Council can be the judge on whether or not it is sufficient. "Later on they're going to ask us for money... and if they're doing something [for the City], then okay, good," Vargas said. "If they're not and they're [supposed to be] representing the City of Hawthorne as our Chamber of Commerce, I think they really need to be delivering something to our business owners instead of forcing Councilmembers to ask [BizFed] how they can help our businesses when our Chamber of Commerce should be the first line of attack on that."

Councilmember Olivia Valentine, who introduced the discussion item, voiced her adamant support for membership. "We've been looking for something to bring in more retail, more restaurants into the city and I think this is a way to do it," Valentine said. "I think this is also a way to assist the businesses that are already here that need help. I think this is a big step for us to be able to network on a regular basis with the business community. •

# Film Review

# Let Yourself Be Swept Away in the Romance of *The Shape of Water*

Imagine the timeless love story Beauty and the Beast set in 1960s Cold War America, and the beast is an amphibian-man desired by the U.S. and Russia for weapon-utilizing purposes. Here you have director Guillermo Del Toro's latest film, The Shape of Water, or the basic outline, at least. The special ingredient in this affectingly heart-filled film is its achingly dutiful ode to classic romantic movies of the past. The Shape of Water feels like the ever-magisterial Del Toro was swept up in the same intoxicating aroma as spellbound director Damien Chazelle with the Hollywood backlot homage, La La Land. This holiday season, let the feel-good, achingly beautiful *The* Shape of Water color your heart anew--even if that color is a seafoam green like our fincovered friend.

Audiences should know (and not mind) that in the classical tradition, this period piece does away with an intricate storyline for a more classic, familiar one. And why should it be anything but a simple tale of two starcrossed lovers? Anything more would weigh down this otherwise beautifully buoyant film, whose best quality is a lightness that keeps the fireplace warm. This tone and spirit stem directly from the performance of Sally Hawkins, who plays Elisa--a mute janitor who works at an underground facility in 1960s Baltimore. Meek in demeanor, she works alongside her co-worker, Zelda (Octavia Spencer)--with whom she has clearly gotten comfortable.

Elisa's routine and unassuming lifestyle, which includes waking up in her one-bedroom apartment, enjoying herself in the tub and clocking in for work suddenly becomes upended when she actually meets "the asset"--the Amphibian Man resembling the creature from

the Black Lagoon. A timid courting begins between both silent creatures. She teaches him to sign simple phrases to communicate while the Amphibian is chained in his iron-cast tank. The two also enjoy late-night indulgences of hard-boiled eggs and jazz records.

But as we all know, the kindred-spirits-finding-companionship story needs its villain, which Michael Shannon deliciously delivers as Strickland--a hell-bent overseer of the facility and self-appointed torturer of the asset. The film plays to its expected path: Elisa sets in motion a plan to break the creature free with help from her similarly sheepish illustrator neighbor (played by a wonderful Richard Jenkins--seriously, this whole cast rocks!). Conventional and comforting, but also adventurous and erotic (sensual scenes between Elisa and the Amphibian Man are not shied away from), *The Shape of Water* is everything we wish the film would be.

Del Toro has shown with his previous work that he can create some of the best fantasy-creature movies ever made, like the modern=day masterpiece Pan's Labyrinth, which portrayed his dark extraction of children's fantasy, as well as comic book shoot-'em-ups like Hellboy. But where those films were considerably more action-filled, The Shape of Water is decidedly affection-filled and sure to imprint a soft smile on doting audience's faces. For a film about two creatures who won't let anything--politics, danger, or the fact that they're two different species--stand in their way, that's something that audiences should let themselves snuggle up to this season.

# Don't Let the Flu Bug You this Year



(BPT) - Flu season is upon us, and many healthcare facilities are urging you to start preparing now with vaccines. Ironically, one of the places where you need to be careful is at the doctor's office or healthcare clinic.

The number of people in and out of clinics this time of year increases the chance that someone will leave behind a harmful pathogen. Being in close proximity with people who may already have the flu can put you and your family at risk. You can reduce this risk by following some simple instructions from healthcare cleaning experts.

"Healthcare-acquired infections can be a threat to everyone, especially the elderly and young children," said Steve Zimmerman, director of healthcare services for ServiceMaster Clean, one of the nation's leading cleaning and janitorial service providers. "Most facilities do a good job of sanitizing their waiting areas, but sick people can spread their illnesses through the touch of a door, magazine or pen - leaving you vulnerable to pick up germs you can't see."

The Centers for Disease Control estimate that 9 million to 35 million people will get the flu each year, 140,000 to 710,000 will be hospitalized because of it, and 12,000 to 56,000 will die from the illness. The CDC recommends a vaccination each year for those six months of age and older.

While the vaccine may help protect you from the flu, cleaning experts urge everyone to avoid high-touch areas as much as possible.

What are high-touch areas? In a healthcare

setting, Zimmerman defines high-touch surfaces as anything that multiple people will likely touch during their visit. Some high-touch surfaces are hard to avoid, such as door handles and chair armrests. That's why it's wise to wash hands often and use hand sanitizer when necessary. But there are other high-touch areas you can avoid, such as:

- Magazines. These are nearly impossible to disinfect once they have been contaminated. Don't pick them up while you're waiting.
- Toys. Bring your own toys to help prevent your child from picking up an illness from another child.
- Restrooms. They can harbor lots of pathogens unless cleaned often. If you must go, limit touching surfaces in the restroom, wash your hands thoroughly and use hand sanitizer if it's available.
- Ink pens. Think about how many hands touch the ink pens in facilities whether signing in or filling out paperwork, bring your own and eliminate the possibility of sharing germs.
- Coffee urns. For many Americans, coffee is a must. If you pick up a coffee pot or stop in your favorite coffee shop, take hand sanitizer with you and use immediately after you pour a cup.

Zimmerman also points out that if you schedule visits for the early morning, you are less likely to contract the germs that typically accumulate, since cleaning crews often perform a deep clean at the end of each day.



# Dodgers Preparing for Another Successful Season After Near Title

It may be difficult for fans of the Los Angeles Dodgers to even think about baseball once again after the team's heartbreaking defeat in last season's World Series. After making it to the very last game that they possibly could have played, the Dodgers once again came up short of their goal of attaining the team's first championship since 1988. Despite their shortcomings, Dodgers president of baseball operations Andrew Friedman and general manager Farhan Zaidi have already begun to discuss moves for the 2018 season and remain optimistic about their team's chances. In fact, the Baseball Winter Meetings took place this week and by the time this article comes out, the Dodgers may very well have made a deal or two. Though it may indeed be difficult to think forward to next October, what the Dodgers do in this offseason may just be what gets the team over their horrific postseason nightmares from seasons past.

"We're excited and encouraged that a lot of this group is going to be back and we're going to look for every way to make it better," Zaidi explained while addressing his team's chances next season. "It was exhilarating to get to the World Series, to see our fans respond to it. In the last few years we've taken steps each year to get to the ultimate goal. And our goal is a year from now, we'll be able to say that was another step for us."

But what can the Dodgers do to take that next step? The team already finished with the

best record in the entire league and made history at various points throughout the regular season for their prolific play. Yet, still, no World Series. The biggest stars on the team like Clayton Kershaw and Kenley Jansen--who had been counted on all season long to get the best players in all of baseball out--simply failed to do so. So how do you make a team that was already considered to be the best in baseball, yet failed under the pressure of the postseason, even better?

Well, despite being in the running for twoway Japanese star Shohei Ohtani since August, the team recently lost out on that bidding war to the Los Angeles Angels. Giancarlo Stanton remained a longshot trade option for the Dodgers before he also signed elsewhere with the New York Yankees. That left L.A. with the offseason task of filling needs in the bullpen, possibly at second base, certainly at starting pitching and definitely in the starting lineup, all while having already missed out on this offseason's two hottest commodities. So, where else could the team look to get better?

Brandon Morrow was a gem for the Dodgers last year, specifically in the playoffs. Unfortunately for Los Angeles, Morrow played so well that he earned a role as a closer and a contract that matches. Sure enough, he signed with the Cubs last weekend. Logan Forsythe didn't necessarily set the world on fire in his first year in Dodger blue and can be seen as one weakness in an otherwise healthy Dodgers lineup. Bringing back Chase Utley

to platoon at second could be an option, but his intangibles certainly outweigh his playing abilities at this point in his career. Kershaw, Rich Hill and Alex Wood will be back at the top of the rotation for L.A., but a clear number two starter who may or may not be named Yu Darvish could be in the team's sights. Andrew Toles could join Alex Verdugo as possible offensive additions to the lineup, but fans would have likely much rather seen a big-name bat like Stanton step to the plate in between Justin Turner and Cody Bellinger.

As far as other free agent targets go for the Dodgers who are not named Ohtani, Stanton or Darvish, look for the team to possibly make a strong push for Lorenzo Cain. Cain would provide the club with a great right-handed hitting bat who could hit pitchers who throw either right or left. He also won a World Series with the Kansas City Royals and is almost as reliable as they come in the outfield. As far as pitching goes, don't be surprised to see Los Angeles in on the Jake Arrieta hype. Dodger fans have almost certainly grown at least an acute dissatisfaction with the Cubs and their former players, but the right-handed ex-Cy Young Award-winning Arrieta might just look good in the pitcher-friendly Dodger Stadium with Rick Honeycutt tweaking his delivery.

One thing to understand about the Dodgers and their front office executives is that they have the tendency to not rely on expensive free agent trades (like Stanton) or signings to come in and save the day for the team.

Friedman and Zaidi took over with the promise to create a sustainable model for success. So far, they've done so, all while relying on players like the previously unknown Chris Taylor and others from the farm system like Bellinger who don't tend to initially break the bank. The Dodgers will be near the top or at the top of the MLB in payroll in 2018. That figure is designed to drop drastically in subsequent years. All that said don't expect the guys who are calling the shots to pull the trigger on high-figured free agents. The front office has a plan in place. Unfortunately for the fans, it doesn't involve taking on any other large contracts that would force them into paying the luxury tax next season.

The 2018 season is still months away with 162 games to be played that seemingly take ages to complete beyond that. Once the season does start, though, the entire Dodger faithful can rely on the fact that the team will once again be among the league's elite. Even with a lineup closely resembling the one that took the field last season, Dodger fans will certainly still be able to look forward to competing for a sixth straight NL West title and a World Series appearance for what should become the second year in a row. •

# **Coconut Chocolate Chip Cookie Bars**

- 2. Add in the almond milk, vanilla extract, flour, salt, melted butter, brown sugar and eggs and beat until combined.
- 3. Pour batter into the prepared baking sheet and bake for 30-35 minutes or until the bars begin turning golden brown and a toothpick inserted in the center comes out clean. Allow to cool for 5 minutes.

### Glaze

- 1. In a medium mixing bowl, whisk together the confectioners' sugar, heavy cream and vanilla until smooth.
- 2. Gently spread over the cooling bars.
- 3. Top with toasted coconut and allow to cool completely before eating. Tip: Try cutting the bars up and placing them in the refrigerator, they taste even better cold!

# Puzzling Supermassive Black Hole Is Found in Infant Universe

# Based on a Press Release from JPL, Provided by Bob Eklund

Scientists have uncovered a rare relic from the early universe: the farthest known supermassive black hole. This matter-eating beast is 800 million times the mass of our Sun, which is astonishingly large for its young age.


"This black hole grew far larger than we expected in only 690 million years after the Big Bang, which challenges our theories about how black holes form," said study co-author Daniel Stern of JPL.

Astronomers combined data from NASA's Wide-field Infrared Survey Explorer (WISE) with ground-based surveys to identify potential distant objects to study, then followed up with Carnegie Observatories' Magellan telescopes in Chile. Carnegie astronomer Eduardo Bañados led the effort to identify candidates out of the hundreds of millions of objects WISE found that would be worthy of follow-up with Magellan.

For black holes to become so large in the early universe, astronomers speculate there must have been special conditions to allow rapid growth—but the underlying reason remains mysterious.

The newly found black hole is voraciously devouring material at the center of a galaxy—a phenomenon called a quasar. This quasar is especially interesting because it comes from a time when the universe was just beginning to emerge from its dark ages. The discovery will provide fundamental information about the universe when it was only five percent of its current age.

"Quasars are among the brightest and most distant known celestial objects and are

crucial to understanding the early universe," said co-author Bram Venemans of the Max Planck Institute for Astronomy in Germany.

The universe began in a hot soup of particles that rapidly spread apart in a period called inflation. About 400,000 years after the Big Bang, these particles cooled and coalesced

into neutral hydrogen gas. But the universe stayed dark, without any luminous sources, until gravity condensed matter into the first stars and galaxies. The energy released by these ancient galaxies caused the neutral hydrogen to get excited and ionize, or lose an electron. The gas has remained in that state since that

time. Once the universe became reionized, photons could travel freely throughout space. This is the point at which the universe became transparent to light.

Much of the hydrogen surrounding the newly discovered quasar is neutral. That means the quasar is not only the most distant—it is also the only example we have that can be seen before the universe became reionized.

"It was the universe's last major transition and one of the current frontiers of astrophysics," Bañados said.

The quasar's distance is determined by what's called its redshift, a measurement of how much the wavelength of its light is stretched by the expansion of the universe before reaching Earth. The higher the redshift, the greater the distance, and the farther back astronomers are looking in time when they observe the object. This newly discovered quasar has a redshift of 7.54, based on the detection of ionized carbon emissions from the galaxy that hosts the massive black hole. That means it took more than 13 billion years for the light from the quasar to reach us.

Scientists predict the sky contains between 20 and 100 quasars as bright and as distant as this quasar. Astronomers look forward to the European Space Agency's Euclid mission, which has significant NASA participation, and NASA's Wide-field Infrared Survey Telescope (WFIRST) mission, to find more such distant objects.

"With several next-generation, even-moresensitive facilities currently being built, we can expect many exciting discoveries in the very early universe in the coming years," Stern said. •

### ORDINANCE NO. 2156

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE APPROVING THE JOINT POWERS AGREEMENT FOR LOS ANGELES COMMUNITY CHOICE **ENERGYAUTHORITYAND AUTHORIZING** CHOICE AGGREGATION PROGRAM THE CITY COUNCIL OF THE CITY OF HAWTHORNE ORDAINS AS FOLLOWS:

WHEREAS, the City of Hawthome has been actively investigating options to provide electric services to constituents within its service area with the intent of achieving greater local involve-ment over the provisions of electric services and promoting competitive and renewable energy; WHEREAS, on September 24, 2002, the Governor signed into law Assembly Bill 117 (Stat. 2002. Ch. 838: see California Public Utilities Code section 366.2; hereinafter referred to as the "Act"), which authorizes any California city or county, whose governing body so elects, to combine the electricity load of its residents and businesses in a community-wide electricity aggregation program known as Community

Choice Aggregation; WHEREAS. the Act expressly authorizes participation in a Community Choice Aggregation (CCA) program through a joint powers agency, and to this end the County of Los Angeles (County) has been participating since 2015 in the evaluation of a CCA program for the County

and the cities and towns within it; WHEREAS, through Docket No. R.03-10-003. the California Public Utilities Commission has issued various decisions and rulings addressing the implementation of CCA programs, including

the recent issuance of a procedure by which the California Public Utilities Commission will review "Implementation Plans." which are required for submittal under the Act as the means of describing the CCA program and assuring compliance with various elements contained in the Act;

WHEREAS, representatives from the City along with representatives from the County and participating cities within the County, have developed the Los Angeles Community Choice Energy Authority Joint Powers Agreement ("Joint Powers Agreement") (attached hereto as Exhibit A) in order to accomplish the following: To form a Joint Powers Authority known as "Los Anaeles Community Choice Energy

To specify the terms and conditions by which participants may participate as a group in energy programs, including but not limited to the preliminary implementation of a CCA program: WHEREAS, representatives from the City along with the County and participating cities within the County have developed a Business Plan (attached hereto as Exhibit B) that describes the formation of Los Angeles Community Choice Energy (LACCE) Authority and the CCA program to be implemented by and through the LACCE Authority

WHEREAS, a final Implementation Plan will be submitted for review and adoption by the LACCE Authority's Board of Directors;

WHEREAS, as described in the Business Plan, Community Choice Aggregation by and through the LACCE Authority appears to provide a reasonable opportunity to accomplish all of the following:

To provide greater levels of local involvement in and collaboration on energy

To increase significantly the amount of renew able energy available to LACCE Authority energy customers,

To provide initial price stability, long-term electricity cost savings and other benefits for the community, and

To reduce greenhouse gases that are emitted by creating electricity for the community; WHEREAS, the Act requires CCA program participants to individually adopt an ordinance "CCA Ordinance") electing to implement a CCA program within its jurisdiction by and through its participation in the LACCE Authority WHEREAS, based on the feasibility studies and Business Plan, it is in the public's interest and welfare to establish a CCA program within

City of Hawthome; and WHEREAS, the Joint Powers Agreement expressly allows the City to withdraw its membership in the LACCE Authority (and its participation in the CCA program) by providing no less than 180 advance written notice to the LACCE Authority. NOW THEREFORE THE CITY COLLINGIL OF

THE CITY OF HAWTHORNE, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS: SECTION 1. That the recitals set forth above are true and correct and are incorporated as though fully set forth herein.

SECTION 2. Based upon the findings and declarations set forth in this ordinance, and in order to provide businesses and residents within the jurisdictional boundaries of the City with a choice of power providers and with

the benefits described in the recitals above. the City Council hereby elects to implement a CCA program within the City's jurisdiction boundaries. Upon approval of the LACCE Joint Powers Agreement, the City will implement the CCA program by and through the City's participation in the LACCE Authority), a joint powers authority established pursuant to California Government Code section 6500 et seq. and California Public Utilities Code section 366(c)(12).

SECTION 3. That the City Council hereby approve and direct that the City proceed with participation in the LACCÉ Joint Powers

SECTION 4. That the City Council declares that, should any provision, section, paragraph, sentence or word of this ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining ns, sections, paragraphs, sentence or words of this ordinance as hereby adopted shall remain in full force and effect

SECTION 5. That all the provisions of any of the City's ordinances as heretofore adopted by the City that are in conflict with the provisions of this ordinance are hereby repealed. SECTION 6. That this ordinance shall take

effect thirty (30) days after its adoption.

SECTION 7. That the City Attorney prepared and framed this ordinance pursuant to the Hawthome Municipal Code and finds that the City Council has the authority to adopt this ordinance, that the ordinance is constitutionally valid and that the ordinance is consistent with the general powers and purposes of the City as
