The Guilt-Free Secret About Gift Cards

I was thinking about gift cards for everybody on my list this year anyway because December 25 is four days away and I haven't started my Christmas shopping. But an email about a UCLA research project sealed the deal. There's no reason to feel embarrassed about grabbing a handful of gift cards off the cash register rack because you're short on time, according to Professor Cassie Mogilner Holmes. Those cards have an unexpected and beneficial effect on relationships.

Holmes, who's considered an authority on consumer happiness, reports that a palmsized gift card provides an experience that is more deeply felt than the traditional gifts that come wrapped with a shiny bow on top. "What we found was that the recipient feels more connected to you as the gift-giver after receiving an experiential gift rather than a material one," she said in a guilt-free UCLA press release. The announcement was perfectly timed as South Bay residents hit the stores for the final countdown to Christmas. The chances of finding the right size, color or style at South Bay stores get slimmer over the next 72 hours. Locally-owned businesses and boutiques offer a variety not found at larger national retailers, and the mom and pops are closer to home than the mall stores. Even giant e-retailers Amazon and Walmart who carry a wide selection of clothing, toys and electronics aren't miracle workers--though they promise to ship and deliver gift purchases up to Christmas Day.

While it's the thought that counts, Holmes says that consumers report more powerful feelings when a gift is an activity or an experience rather than a store-bought item. "And that sort of intensity of emotion translates into feeling more connected and a stronger relationship," she said, after observing similar results within families and between friends.

To study the effectiveness of gifts, Holmes and her team measured how closely a group of dads felt to their children before and after Father's Day. The researchers looked at what gifts the children gave, and concluded that fathers who received "experiential" gifts also

enjoyed a boost in their relationship with their kids.

Parents and grandparents can do better knowing that gift cards are what pre-teens, teens and young adults say they want the most nowadays. Cards generally come in \$10, \$25, \$50 and \$100 values, but most cards are loaded with between \$20 and \$50, according to the people at giftcardgranny.com. The number one reason people give gift cards is because those allow their loved ones, friends, co-workers and even the newspaper delivery guy freedom to choose what they want. More than 90 percent of Americans say they've given a gift card, and last Christmas season the average number given was two cards.

Retail stores and restaurants top the list of most popular gift cards, followed by coffeehouses and the movies, according togiftcardgranny.com. Prepaid cards that bear the Visa, MasterCard and American Express logos make the top five, shows research done by the online reseller of gift cards.

My own circle of friends confirmed what the UCLA professor and a gift-reseller website are saying about this gift-giving shift. Annual sales of gift cards will reach \$1.6 billion sometime next year, according to giftcardgranny.com. I asked my Facebook friends--all with South Bay connections--how they feel about gift cards and who gets one versus a present to go under the tree.

Cindy Ceravalo Stevens admits to feeling like she's "phoning it in" when she gives gift cards instead of a fancily-wrapped present. They might not see it that way since she's sending them to the spa, Starbucks or their favorite dining spot. Though she does add, "I do appreciate receiving a gift card." To entice shoppers this holiday season, businesses are offering a small gift of \$10 to anyone who spends \$50 on a gift card. "They're always fun," writes Paula Lake Purser. After-Christmas sales are a reason why my friend Sue Kemp Schultz says she gives them. She adds, "I really prefer gift cards, because they are easier and cheaper to mail. There are way less returns too. Plus, if given on Christmas Day, the recipient can

take advantage of 'after-Christmas' sales. And if the recipient wants to re-gift, who am I to judge?"Another friend, Stella Cordova, says she never likes handing over a gift card to anybody, though they are a win-win especially for kids and for the businesses in town. To dress up cards, she'll wrap them in a small or large gift box, or one that's odd-shaped. So they immediately know they're getting a gift card, plus we get the look of gifts under the Christmas tree, which is always nice," she told me. Gift cards have been growing in popularity for almost a decade, and no longer is there the embarrassment of showing up empty-handed to a Christmas party or a family get-together. The path to happiness, which is what Professor Holmes explores in her consumer research, apparently leads past the gift card kiosk. Time is an issue both for givers and recipients, Holmes found. People have a lot to do and only a limited number of hours to cram in all of their daily activities and obligations to family and friends. Maybe it's not that surprising that American adults value additional time over more money--which is what her research has discovered. When a person's attention is drawn subconsciously to time, they are more inclined to engage with other people, Holmes discovered. "And that will make you happier than if you were thinking about money," she said.

Luckily for parents and grandparents, today's gift cards have value beyond the \$25, \$50 or \$100 spending limits. They offer experience and freedom for kids and young adults. Spending data also shows that people over 65 plunked down more money on gift cards last year than other age groups. On average, they spent nearly \$190 on them in 2015. The slow, but steady march to the gift card kiosk makes the retailers happy too because most recipients overspend to get what they really want, according to giftcardgranny.com. The website says it sells traditional plastic cards, online gift cards and e-codes to more than 1,000 retailers and restaurants. •

Playwright Ong Receives Inglewood Grant to Stage Dream of the Red Chamber

The City of Inglewood has awarded an Inglewood Growing Artists Performed Project (IGAPP) grant to playwright Henry Ong to stage his six-hour adaptation of the famed Chinese classic Dream of the Red Chamber. The play will be presented in the Inglewood Amphitheater in Edward Vincent Park in 2017. The story, based on Tsao Hsueh-chin's romance novel, is a blend of realism and the supernatural that details the decline of the Chia family during the early Ching Dynasty (1644-1912). The novel's theme centers on the love story between protagonist Pao-yu and his cousin Black Jade.

Ong called it a "thrill to receive the grant. "It has been a dream of mine to do this epic in its entirety," he said. "I believe the Inglewood

Amphitheater is the perfect location to stage this universal fable—a story that transcends boundaries where everyone, regardless of ethnicity or age, can participate and enjoy."

Ong will assemble a core group of professional actors, with area residents also portraying some of the play's more than 70 roles drawn from the novel's 30 main and 400 minor characters. "We are excited to have a playwright of Mr. Ong's caliber share his talent and expertise in an art project that not only brings a revered Chinese classic to the City of Inglewood, but will also involve the diverse communities living in and around Inglewood and highlight our beautiful facilities," said City of Inglewood Public Art Program Manager Helen Lessick •



Lawndale Soccer Looks to Improve on Last Year

The Hawthorne Cougars head basketball coach mThe Lawndale Cardinals' soccer team has enjoyed much success lately under head coach Angel Mendez. One thing that has constantly eluded the team, however, is the CIF championship trophy. While Mendez's teams have certainly had enough talent on the roster over the past few years, they have simply gotten unlucky come playoff time. This year, Mendez and Lawndale are looking to turn that all around. A roster full of seniors, led by forward Anthony Martinez and mixed with explosive youngsters in sophomore Mario Perez and junior Alex Perez, may just give Mendez the winning recipe to get the team over the hump this season.

Lawndale soccer's most successful season in the recent past came in 2013-'14 when the team went 9-1 in league play and finished with an overall record of 20-8-1. That year, the team made it into the playoffs but ran up against a tough Hart team that narrowly knocked Lawndale out of the postseason in the second round with a 3-2 victory. Coach Mendez improved upon his team's playoff standing the very next season when the Cardinals advanced to the quarterfinals of the CIF Division 4A playoffs, but still the team came up short of advancing to a championship game.

This season, the Cardinals are back and started the year in an explosive way. A 3-2 victory over Environmental Charter in the opening scrimmage game got the team off to a great start before the real first test of the very young season would come. A matchup against Inglewood to begin the Westside Tournament yielded a 5-2 victory for Lawndale and saw senior star Anthony Martinez score three goals. Sophomore Mario Perez also added one in the win. It's production like that from his star players that Mendez will be looking for all season long. If players like Martinez and Perez can consistently come through for the team on a daily basis, there are no limits to where Lawndale can go within its own division and even in this year's CIF playoffs.

Despite the firepower on the Cardinals' roster, the team has been through some hard times of late. A 6-1 loss to Palos Verdes brought Lawndale down a notch and showed the players that they still have some work to do if they want to compete with the best. Even in the loss, Perez still showed up and had a great game. His goal from 40 yards out not only scored the first point of the game, but also impressed his head coach. "That's what Alex does is take shots like that." Mendez explained. "It's why I put him in that position. We know how good PV is. One thing we know we can use against them is Alex's leg." Mendez and Lawndale will have to use Alex's leg if they wish to compete with the likes of Hawthorne and Culver City in the Ocean League this year. While everyone is looking for Lawndale to finally break through the playoff barrier this season, it will have to do it against some very tough opponents--including league rival Santa Monica in the first Ocean League game of the season in early January.

HAWTHORNE HIGH

The Hawthorne Cougars are a soccer team consistently getting better year after year. Two years ago, Hawthorne finished in fifth place in the Ocean League standings. Last season, it was more of the same as far as the end of the year standings go, but instead of winning seven games all season, the team won 10. This year, head coach Yury Navarro is looking to take his team to the next level.

At the moment, the Cougars sit at 6-3-1 through their young season and are all but poised to break their win records from the previous two years. Sophomore Oskar Gomez has been a standout for Hawthorne so far and is really adding a spark to a team that produced almost no offense over the last couple of years. Gomez had a goal scored in each of the team's first two games and despite

not scoring in a 1-1 tie against St. Monica two weeks ago, he took six shots on goal in an attempt to bring his team to victory. Last Tuesday, the Cougars rallied after trailing for the entire first period of play. It was Gomez again, of course, who brought his team back and prevented the loss, scoring two goals in the second period to bring Hawthorne to a 3-3 tie against the North High Saxons. With Gomez playing lights out, there's no limit to what the Cougars can do this season.

INGLEWOOD HIGH

While Hawthorne has been tearing up the competition in the Ocean League in early action, the Inglewood boys' soccer team has been doing the opposite. Head coach Clemente Gonzalez has been looking for a way to get his team from out of the depths of the Bay League standings throughout the early season, but has not been able to find any answers. A 0-0 tie against Gardena is certainly better than a defeat, but losses to Lawndale, San Pedro, Hawthorne and Santa Monica have all put a bad taste in the collective mouths of the Sentinel faithful. Inglewood has only scored so far in the first first game of the season in a 5-2 loss to Lawndale. A 0-4-1 Inglewood team will look to right the ship before league play begins in mid-January.

AN INTERIM ORDINANCE OF THE CITY COUNCILOF THE CITY OF HAWTHORNE, CALIFORNIA, PROHIBITING THE ESTAB-LISHMENT OF Nonmedical marijuana related uses in the CITY OF HAWTHORNE DURING THE PENDENCY OF THE CITY'S REVIEWAND ADOPTION OF PERMANENT ZONING REGULATIONS, DECLARING THE URGENCY THEREOF AND THE IMMEDIATE EFFECTIVENESS OF THIS ORDINANCE PURSUANT TO GOVERN-MENT CODE SECTIONS 65858, 36934 AND 36937 AND APPROVING STAFF'S DETERMINATION OF EXEMPTION FROM CALIFORNIA ENVIRONMENTAL QUALITY REVIEW PURSUANT TO TITLE 14. SECTION 15061(b)(3) OF THE CALIFORNIA CODE OF REGULATIONS

THE CITY COUNCIL OF THE CITY OF HAW-THORNE DOES ORDAIN AS FOLLOWS:

Section 1. Legislative Findings.

A. Implicit in any plan or regulation is the City's interest in maintaining the quality of life and the character of the City's neighborhoods, as without stable, well-planned neighborhoods. sections of the City can quickly deteriorate with consequences to social, environmental and economic values.

B. The People of California voted to approve Proposition 64, the Adult Use of Marijuana Act ("AUMA"), in the statewide election occurring

on November 8, 2016.

C. The AUMA allows for local governments to regulate, control, and prohibit various nonmediand if local governments fail to enact local ordinances concerning such matters, the AUMA and associated state laws and regulations the cultivation and distribution of nonmedical marijuana commercially and the indoor and outdoor cultivation of nonmedical marijuana

the residences of private individuals.

D. Sections 17.14.030 17.16.030, 17.19.030, 17.34.025, 17.18.030, 17.87.050, 17.32.025, 17.28.025, 17.25.025, and 17.26.025 of the Municipal Code prohibit "Marijuana cultivation marijuana processing, marijuana delivery, and marijuana dispensaries, except where the city is a prohibition on any such activity." Notwithstand ing these provisions, the Municipal code does not expressly address the sale, distribution or cultivation of nonmedical marijuana, nor address the unique legal, land use, and public health, safety and welfare issues and impacts associated with nonmedical marijuana uses It is with an abundance of caution that this Interim Ordinance is proposed.

E. The City Council finds that the existing zoning regulations are not adequate to expressly regulate nonmedical marijuana uses that may The City Council further finds that there is a current and immediate threat to the public health, safety, and welfare presented by the issuance of permits or licenses related to nonmedical marijuana uses in the City. In the absence of this Interim Ordinance's immediate effectiveness, the provisions of the AUMA may may be able to establish per the AUMA prior to the City being able to consider and adopt appropriate regulations addressing nonmedica marijuana. This Interim Ordinance will allow with the public, police department, and City Attomey's office to craft an appropriate response Section 2. CEQA Finding. The City Council that there is no possibility the adoption of the the environment. The moratorium would impose limitations on the use of nonmedical marijuana, would allow time to formulate regulations ad-

dressing the use of nonmedical marijuana in the City, would not result in physical develop-ment or alterations, and would serve to reduce potentially significant impacts and threats to safety and public health. It is therefore exempt from California Environmental Quality Act review pursuant to Title 14, Section 15061(b)(3) of the California Code of Regulations.

Section 3. Moratorium Established. The City of Hawthorne hereby establishes an interim moratorium on the issuance of any entitlements, licenses and permits, including building permits nonmedical marijuana related uses in the City. Section 4. Moratorium Defined. Notwithstanding any other ordinance or provision of the Hawthome Municipal Code, no person shall establish a business that sells, distributes or cultivates marijuana or be issued a building permit or any other entitlement authorizing building or structure to be used for marijua related uses during the term of the moratorium established in Section 3 above

Section 5. Moratorium Exclusion. Notwith standing any other provision of this Interim Ordinance, the moratorium established under Section 3 and 4 shall not apply to any license for which a Federal or State law precludes the

Section 6. Term of Moratorium. This Interim Ordinance shall expire, and the moratorium established hereby, shall terminate, 45 days after the date of adoption unless extended by the City Council at a noticed public hear ing pursuant to California Government Code Section 65858.

Section 7. Penalty. Violation of any provision of this Interim Ordinance shall constitute a fine not to exceed one thousand dollars to exceed six (6) months, or by both such fine and imprisonment. Each and every day such a violation exists shall constitute a separate and distinct violation of this Ordinance. In addition to the foregoing, any violation of this Interim Ordinance shall constitute a public nuisance and be subject to abatement as provided by all applicable provisions of law.

Section 8. Effective Date; Findings of Urgency;

and Duration.

A. This Interim Ordinance is adopted as an urgency ordinance pursuant to the provisions of Government Code Sections 65858, 36934 and 36937, and shall take effect immediately upon its adoption. Based upon the findings set and determines that the adoption of this Interim Ordinance is an urgency ordinance authorized by Government Code Section 65858, and is necessary for the immediate preservation of the public peace, health and safety.

Pursuant to Government Code Section 65858(a), this Interim Ordinance shall be adopted by not less than a four-fifths vote of the City Council and shall be in effect for 45 days from its adoption. After notice pursuant to Government Code Section 65090 and a public hearing, the City Council may extend the Interim Ordinance for up to an additional 10 months and 15 days and subsequently for one year, if necessary. The Planning Director and the City Clerk's office shall undertake all actions legally necessary to extend this Interim Ordinance in the event the studies and reports desired by the City Council will not be concluded on or before the 45th day subsequent to the adoption of this Interim Ordinance.

Section 9. Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance, or any part thereof is for any reason held to be unlawful. such decision shall not affect the validity of the remaining portions of this Ordinance or any part it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any

one or more section, subsection, subdivision, paragraph, sentence, clause or phrase be declared unlawful.

Section 10. The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the summarized ordinance to be published once in a newspaper of general circulation, published and circulated in the City of Hawthome, or if there is none, he shall cause it to be posted in at least three public places in the City of Hawthome, California. ORDINANCE NO. U-2132

AN INTERIM ORDINANCE OF THE CITY COUNCILOF THE CITIY OF HAWTHORNE, CALIFORNIA, PROHIBITING THE ESTABLISHMENT OF NEW BUILDINGS OR STRUCTURES IN THE RUNWAY PROTECTION ZONES OF THE HAW-THORNE MUNICIPAL AIRPORT DURING THE PENDENCY OF THE CITY'S REVIEW AND ADDITION OF DEPMANENT ZONE AND ADOPTION OF PERMANENT ZON-ING REGULATIONS, DECLARING THE URGENCYTHEREOF AND THE IMMEDIATE EFFECTIVENESS OF THIS ORDINANCE PURSUANT TO GOVERNMENT CODE SECTIONS 65858, 36934 AND 36937 AND APPROVING STAFF'S DETERMINATION OF EXEMPTION FROM CALIFORNIA ENVIRON-MENTAL QUALITY REVIEW PURSUANT TO TITLE 14, SECTION 15061(b)(3) OF THE CALIFORNIA CODE OF REGULATIONS THE CITY COUNCIL OF THE CITY OF HAW-THORNE DOES ORDAIN AS FOLLOWS:

A. The Hawthome Municipal Airport ("Airport") is a City-owned general aviation reliever airport located 12101 S. Crenshaw Blvd. within the City of Hawthome ("City"). The Federal Aviation Administration has established design standards applicable to the Airport and surrounding properties. Airport design standards are intended, in part, to further the Federal Government's policy "that the safe operation of the airport and airway system is the highest aviation priority." [49 USC § 47101(a)(1)]. The FAA has developed design standards for the Airport runways known as the "Runway Protection Zone." The Runway Protection Zone is defined as "[a]n area at ground level prior to the threshold or beyond the runway end to enhance the safety and protection of people and property on the ground." [FAA Advisory Circular AC 150/5300-13A, pg. 9]. The FAA instructs Airport sponsors, such as the City, to "maintain the RPZ clear of all facilities supporting incompatible uses." [FAA Advisory Circular AC 150/5300-13A, pg. 71]. New buildings or structures are incompatible

Runway Protection Zone, Sept. 27, 2012]. In the interest of protecting people and property on the ground and airport operations, the FAA encourages airport sponsors to take "all possible measures to protect against or mitigate incompatible land uses." [FAA Memorandum, Interim Guidance on Land Uses Within a Runway Protection Zone, Sept. 27, 2012]. B. The Runway Protection Zone for the Airport's Runway 25 is zoned M-2 General Industrial and C-R Regional Commercial. The Runway Protection Zone for the Airport's Runway 7 is zoned C-3 General Commercial, R-3 High Density Residential, and R-1 Low Density Residential. The zones encompassing these Runway Protection Zones permit certain land uses that may be incompatible with the FAA's design standards and recommended land within the Runway Protection Zones Accordingly, the City Council finds that this Interim Ordinance is necessary to provide the City time to review and update the permitted uses and impose new development standards for the zoning designations within the Runway Protection Zones. The City intends to work with the FAA and Los Angeles Regional Planning Commission, which serves as the Airport Land Use Commission with jurisdiction over the Airport, to identify appropriate zoning designations for land within the Runway Protection Zones. The City Council intends for City Staff to review the FAA's design standards relating to development within the Runway Protection Zones and propose fair, balanced, and effective land use ntrols that protect the public on the ground and Airport operations. The City Council intends to establish an Airport Zoning Commission to review and make recommendations on zoning regulations related to the Airport. The City begin its review within a reasonable time

C. The City Council finds that the existing zoning

regulations governing the land encompassing

at this time to regulate development that may

threaten the public health, safety, and welfare

The City Council further finds that there is a

current and immediate threat to the public

health, safety, and welfare presented by the construction of new buildings or structures within the Runway Protection Zones. In the absence of this Interim Ordinance's immediate effectiveness, the City would be unable to consider and adopt appropriate zoning regulations for development within the Runway Protection Zones, as well as to protect the public health, safety, and welfare from the potential adverse

effects of new buildings or structures located within the Runway Protection Zones. Section 2. CEQA Finding. The City Council hereby finds that it can be seen with certainty that there is no possibility the adoption of the Ordinance may have a significant effect on the environment, because the moratorium will impose greater limitations on development in the City, and will thereby serve to reduce potentially significant adverse environmental impacts. It is therefore exempt from California Environmental Quality Act review pursuant to Title 14, Section 15061(b)(3) of the California Code of Regulations.

ction 3. Moratorium Established. City of Hawthome hereby establishes an interim moratorium on the construction of new buildings or structures any part of which would be located on property within the designated Runway Protection Zones for Runways 7 and 25 of the Hawthome Municipal Airport, as those Runway Protection Zones are identified in the current Airport Layout Plan, attached hereto as Exhibit "A" and incorporated herein by this reference

Section 4. Moratorium Defined. Notwith standing any other ordinance or provision of the Hawthorne Municipal Code, no person shall construct a new building or structure in the Runway Protection Zones, and no application for a building permit or any other entitlement authorizing construction of a new building or structure in the Runway Protection Zones shall be approved during the term of the moratorium established in Section 3 above Nothing contained in this Interim Ordinance shall preclude the improvement, renovation or demolition of an existing building or structure provided that such development otherwise conforms to applicable law.

<u>Section 5.</u> Moratorium Exclusion. Notwith-standing any other provision of this Interim Ordinance, the moratorium established under Section 3 and 4 shall not apply to any project for which an application for a building orgrading permit was submitted to and accepted by the City prior to December 13, 2016, unless the project is found exempt from the California Subdivision Map Act or the City's Subdivision Ordinance. If the project is not subject to the California Subdivision Map Act or the City's Subdivision Ordinance, or if the application for the building or grading permit was submitted after September 1, 2014, this exclusion shall not apply and the project shall be subject to the moratorium established under Sections 3 and 4. Section 6. Special Conditional Use Permit Notwithstanding the provisions of Sections 3 and 4 of this Interim Ordinance, the City of Hawthorne may accept, process and approve applications for special conditional use permits for development or use of property otherwise subject to Sections 3 and 4 of this Interim Ordinance, if the City Council finds, after receipt of a recommendation from the Planning Commission, that an owner of property subject the moratorium imposed by Ordinance will be deprived of all economically viable use of his or her land unless the property owner is allowed to develop or use the property, or that the law of California or of the United States otherwise requires the City to approve an application for a permit or an entitlement for the development or use. The special conditional use permit provided by this Section shall be an available entitlement process and permit for a property owner affect the moratorium whether or not a conditional use permit would otherwise be required by the Hawthome Municipal Code. A special conditional use permit submitted pursuant to this Section shall be processed in accordance with Chapter 17.40 of the Hawthorne Municipal Code, except that the City Council shall serve the additional findings required by this section prior to approving the conditional use permit. Section 7. Term of Moratorium. This Interim Ordinance shall expire, and the moratorium

established hereby, shall terminate, 45 days after the date of adoption, unless extended by the City Council at a noticed public hear-ing pursuant to California Government Code Section 65858.

Section 8. Penalty. Violation of any provision of this Ordinance shall constitute a misdemeanor and shall be punishable by a fine not to exceed one thousand dollars (\$1,000) or by imprisonment for a period not to exceed six (6) months. or by both such fine and imprisonment. Each and every day such a violation exists shall constitute a separate and distinct violation of this Ordinance. In addition to the foregoing, any violation of this Interim Ordinance shall constitute a public nuisance and be subject to abatement as provided by all applicable provisions of law

Section 9. Effective Date; Findings of Urgency; and Duration.

This Interim Ordinance is adopted as an urgency ordinance pursuant to the provisions of Government Code Sections 65858, 36934 and 36937, and shall take effect imme upon its adoption. Based upon the findings set forth in Section 1 above, the City Council finds and determines that the adoption of this Interim Ordinance is an urgency ordinance authorized by Government Code Section 65858. and is necessary for the immediate preservation of the public peace, health and safety

. Pursuant to Government Code Section 65858(a), this Interim Ordinance shall be adopted by not less than a four-fifths vote of the City Council and shall be in effect for 45 days from its adoption. After notice pursuant to Government Code Section 65090 and a public hearing, the City Council may extend the Interim Ordinance for up to an additional 10 months and 15 days and subsequently for one year, if necessary. The Planning Director and the City Clerk's office shall undertake all actions legally necessary to extend this Interim Ordinance in the event the studies and reports desired by the City Council will not be concluded on or before the 45th day subsequent to the adoption of this Interim Ordinance

Section 10. Severability. If any section, subsection, subdivision, paragraph, sentence,

clause or phrase of this Ordinance, or any part thereof, is for any reason held to be unlawful, such decision shall not affect the validity of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more section, subsection, subdivision, paragraph, sentence, clause or phrase be declared unlawful.

Section 11. The City Clerk shall certify to the

passage and adoption of this Ordinance and shall cause the summarized ordinance to be published once in a newspaper of general circulation, published and circulated in the City of Hawthome, or if there is none, he shall cause it to be posted in at least three public places in the City of Hawthome, California.
