City Council Puts a Halt on Prefential Parking Permits in Hawthorne Residential Areas

Preferential parking in residential areas has become such a frequently requested ordinance amendment that the Hawthorne City Council decided it was time to put the halt on any future requests.

The discussion Tuesday night was spurned by the latest request for preferential parking between 129th and 130th streets and Jefferson Avenue.

"Many individuals have multiple cars within a family that are parking in the streets," Mayor Alex Vargas said. "What we have here is a situation where not only are those people who live in the apartments having excess cars it's also the residents who are parking all of their cars on the street when they could utilize the parking within their driveways."

Vargas says part of the issue comes from a large number of people moving into the city. He says the preferential parking that has been approved will only be a short-term solution to the parking issue.

a temporary preferential designation in order to park on the street.

"I just want to make sure that we solicited as much as possible, so that we don't have folks that were not aware and possibly not interested in doing this," English said. "I know this was mentioned as temporary however I want the community to understand what preferential parking means."

Interim City Manager Arnie Shadbehr addressed the concerns stating that the ordinance request requires two thirds majority. Before petition paperwork is handed out, the ordinance also states that residents are limited to three vehicles and the permit is ten dollars for a lifetime designation.

"It is burdensome to city staff and to our parking enforcement," Shadbehr said. "I'm bringing one of these [preferential parking requests] almost every council meeting. Parking is a commodity in the city and it's really getting out of control. [Preferential parking] is a way to address the problem for people when they are coming home and they can't find a place to park." English expressed concern about the money and time that is required to monitor the preferential parking areas and the impact it has on the city. "There has to be a sense of reviewing exactly what we're trying to do here," English said, stating that the ten dollar fee seemed "lucrative" for the amount of time and work the city needs to put in to monitor the preferential parking areas. According to Shadbehr, the fee was established 20 years ago and "isn't really paying for anything, it's not even the paying for the permit that we print and publish." "I think it is important that we bring this back and have further discussion," English said who ultimately was the only councilmember to abstain for voting. "I have the same issue. I live here. I have to go through the same thing. If it wasn't for my little carport, I would be

screwed having to find parking elsewhere."

English requested that her council colleagues review the matter at a future meeting because the request for preferential parking is appearing on the meeting agenda "too frequently."

"If it's not a speed bump, speed hump, preferential parking, or closed off to traffic, it goes on and on," English said of the numerous residential parking and traffic requests that the council has had to vote on recently. "It's at the expense of individual's time and resources. I really think we need to take this back and review how we're going about this."

Vargas added that, "the people who live in the community have spoken. They are having a problem with parking. And every single time we get these silly developments which ask for density bonuses or parking bonuses, they want less parking to build for their apartment complexes."

Councilwoman Olivia Valentine added that

Sunday AM Clouds/ PM Sun 70°/63° "A lot of people have to juggle cars and they're trying to do the best they can to be responsible for those people who need to park on the street but unfortunately there are people who don't make any effort to pull into their driveway," Vargas said. "Everybody is parking on the street. I think the effort needs to be equally dispersed between those who live in apartments and those who have a house."

Mayor Pro Tem Angie Reyes English raised the question of whether the petitions to submit a preferential parking request to the City Council should require a higher number of signatures.

"The reason I'm asking is because I know that time and time again, not all folks are aware that this is preferential parking and maybe they were not aware that in doing this you're now required to register your vehicle with a preferential plate - a sticker, a plate card, or what have you," English said.

English said the issue becomes more complicated when you have visitors who require

preferential parking is one of the issues that would be a part of her suggestion of a strategic planning conference.

"What kind of city do we want to have? What are we looking for as far as parking, as far as traffic? We need to decide that as a council," Valentine said. "This is all part of it because these things are done on an ad hoc basis. The residents on one street want it, then the residents on another want it and when a housing development is completed the residents near there will want it."

Valentine says that the council needs to decide what the city is going to do regarding parking and traffic and state it in a policy document and let the residents know. She adds that the council needs to listen to the residents in terms of what kind of city they want to live in.

Vargas said that he shared English's frustrations regarding the issue.

"This is only a short term solution," Vargas said. "I think after this, we're going to refrain from accepting any more preferential parking until we come up with a strategic plan." •






Check It Out "All Souls Trilogy" By Deborah Harkness

Film Review

'Do Not Resist' is an Unsettling Exposé of Those Sworn 'To Protect and Serve'

On Saturday, Oct. 8, three Palm Springs police officers were shot after responding to a family disturbance call, a seemingly routine operation that ended up being anything but. Jose Gilbert "Gil" Vega, 63, a 35-year veteran who was due to retire in December, and Lesley Zerebny, 27, who had just returned from maternity leave after giving birth four months earlier, were both killed as a direct result of their gun-related injuries. As tragic and shocking as this situation is, officer-involved shootings– from both sides of the gun– are no longer isolated incidents, but instead are becoming more commonplace each day. The pervasive question of "how did we get here" worst in others when they are consistently being trained by those in positions of authority that police are "men and women of violence" and "violence is your weapon." Is it really any surprise then that the first reaction is to turn to military-style protection?

This issue, in general, is a divisive one, and while "Do Not Resist" does side with those critical of law enforcement's tactics, there is no arguing with the facts and numbers it presents onscreen. We see and hear first-hand accounts of police training seminars admiring the reputation of law enforcement in places like Mexico and Russia and acknowledging the use of city-wide CCTV cameras with software that allows the government to track people and objects. It is all extremely eye-opening

is what makes director Craig Atkinson's timely documentary "Do Not Resist" so compelling as he shines a light on the reality of American policing today, the militarization of the force, and the effect it is having on the communities they are sworn to protect.

"Do Not Resist" opens on the streets of Ferguson, Missouri during one of the nightly protests following Michael Brown's shooting death in 2014, where tension and emotions are at an all-time high. Atkinson and his camera become a fly on the wall as hundreds roam the streets chanting "No Justice, No Peace" and "Hands Up, Don't Shoot" while police try to control the ever-growing, increasingly hostile crowd. It's these types of scenarios that raise the question of how to ensure the safety of citizens and the officers themselves. Many seem to think that military-grade weapons, armored cars, and other various equipment will make communities a safer place, and since the federal government has given police departments more than \$40 billion in military-style equipment since 9/11, access to this weaponry is so much easier. But who is this benefitting, really? Atkinson attempts to show how citizens disagree with the choice to accept such high-powered weapons for fear that America will become a militarized war zone and in turn, the rights and free will of citizens will come second to an officer's agenda. "More Mayberry, Less Fallujah" one protestor's sign reads. Then there are those who side with law enforcement, claiming that they need these specific weapons, because "at some point, the state has warranted it." And who can blame the officers for assuming the

and a disturbing reality check of what 21stcentury American police culture looks like today.

It can all be boiled down to the age-old question: Which came first, the chicken or the egg? In this case, are extreme policing tactics to blame for the citizen's distrust of cops and subsequent violent behavior? Or is the out of control behavior of citizens the reason for such heightened and extreme police security? Attacks on and by law enforcement, in general, is nothing new, but the rate at which it continues to happen is shocking. In the Los Angeles area alone, there have been a number of fatal police shootings in South L.A., Pasadena, as well as El Cajon to name a few. However, there are two sides to the story, and director Craig Atkinson gives us a peek into this issue in this Tribeca award-winning documentary.

Directly or indirectly, we find ourselves at a rossroads right now when it comes to trusting the police. New cases of police brutality primarily against black men, some of whom are found to be unarmed and non-threatening, seem to make headlines every other week and only further perpetuate the stereotype of the "crooked cop." "Do Not Resist" does not attempt to answer the question of how to solve this problem, rather, it forces one to become aware of the situation that is unfolding in our neighborhoods, affecting our family and friends, and tarnishing our nation. Just over an hour long (any longer would have been incredibly depressing), "Do Not Resist" should definitely be mandatory viewing. "Do Not Resist" is not rated. 72 minutes. In theaters at Laemmle's Monica Film Center (Santa Monica) and Laemmle Playhouse 7 (Pasadena) on Friday, Oct. 14. •

Hawthorne Rolls Past Beverly Hills In League Opener

Hawthorne opened Ocean League play with a dominating 41-0 win over host Beverly Hills last Friday. Senior quarterback Marte Mapu led the way as he threw three touchdowns while the defense shut out the Normans' offense to secure the win and snap a three-game losing streak.

Hawthorne got on the board after Mapu connected with Justice Powers on 45-yard touchdown to give the Cougars a 7-0 lead in the first quarter. After Beverly Hills turned the ball over on downs, Mapu went to work and found Carlos Jacobo for a 40-yard touchdown.

On Beverly Hills' next possession, Jacobo intercepts the pass and races 30 yards for the score to extend the Cougars' lead, 21-0, in the second quarter. Mapu connected with Jacobo again, this time on a 35-yard touchdown to give Hawthorne a 28-0 lead going into halftime.

Hawthorne put the game out of reach on running back Eric Fosters' 17-yard touchdown run in the third quarter. Foster added a 7-yard touchdown run with four minutes left in the game. The Normans were shut out and drop to 0-6 overall on the season.

The Cougars improve to 2-4 on the season and 1-0 in league play. Hawthorne will travel to Santa Monica for an Ocean League matchup Friday. Kickoff is scheduled for 7 p.m.

ease as they tallied 536 yards of total offense in a 49-20 Ocean League win over Santa Monica last Friday. The Caridinals were led by sophomore running back Jordan Wilmore who rushed for 247 yards and two touchdowns.

On the opening drive for Lawndale, junior quarterback Jalen Hamler hit wide receiver Hunter Williams in the corner of the end zone for an 8-yard touchdown to give the Cardinals an early 7-0 lead. Inglewood (3-3, 0-1) will look to rebound from the loss when they host Peninsula Friday at 7 p.m. \bullet




