## Mayor Pro Tem Awad Addresses Measure HH, City's Dubious Financial Situation

In their final meeting before Election Day, the Hawthorne City Council members voiced their unanimous support for Measure HH and addressed the City of Hawthorne's financial state in the next few years.

Measure HH would raise the total sales tax rate in Hawthorne from 9.5 to 10.25 percent. The tax increase would generate \$8.5 million annually, which City officials have stated would go towards continued funding for the police and fire departments--as well as other services--and also help balance budgets in the near future.

The State of California-mandated tax rate is 7.25 percent while the County of Los Angeles levies a 2.25 percent sales tax. City officials said that under the current structure, Hawthorne sees very little in the form of tax revenue after State and County shares have been allocated. "A lot of the taxes you're paying don't go straight to the City of Hawthorne," Mayor Pro Tem Hadir Awad said. "The County takes a bit, the State takes their share...so a local sales tax increase would balance any impact more generally, but not solely impacting just one group be it residents, business owners, et cetera." Awad added that sales tax increases are one of the very limited options cities have for increasing revenues. On a \$100 sale of taxable goods, the local sales tax would amount to an additional 75 cents on top of current State and County taxes.

Without finding new and alternative methods of income, the City is likely to end up in financial trouble again by 2021. "We have a lot of employees that are doing a lot of work with less staff," Awad said of how the City has managed to bounce back over the past two years from financial collapse. "It is an ongoing problem, though, and something that we have to look into with a deeper focus--because if we

don't take any corrective measures, it's going to lead to some irreversible issues."

Awad said that when California abolished redevelopment agencies, Hawthorne lost \$20 million in investments. Additionally, cutbacks in CBGB funds lead to a loss of \$1.4 million per year in revenue.

Despite measures that the City Council has implemented, Awad said that revenue was still inadequate. He noted that one of the most frequent comments he gets is since Hawthorne has so many manufacturing companies and big corporations, that the City should be flooded with cash. "Yes, we do have some big-name corporations in the city, but they do not generate revenue to the general fund at a substantial level," Awad explained. "Even with these companies which include Tesla, SpaceX, and Costco, they don't even generate part of the revenue that El Segundo is receiving from Chevron."

On a graph that was shown during his presentation, Awad pointed out that the amount that Chevron contributes to El Segundo's general fund is almost double what the City of Hawthorne generates per capita. "The reason I point that out is because I want the residents to understand that yes, we do have big companies and yes, we're getting more retail shops in--but we have to look at other ways of enhancing our revenue stream because they're just not generating enough for us to keep a balanced budget," he said.

The sales tax increase would also be audited annually by the Citizens Oversight Committee, which includes Awad.

The Mayor Pro Tem also gave a presentation outlining the financial situation over the next few years. It summarized that despite a one-time funding spike from the sale of land across the street from City Hall, the City would eventually run out of funds by 2020-2021 if

no corrective measures were taken.

"After that one-time sale in 2018-2019, you see us dip back down to what we normally have-which is an increase, but minimal to around \$63 million," Awad said. "The issue that a lot of people don't understand is our expenditures will continue to increase, and that's something that we have to focus on. These expenditures are out of our control--insurance, L.A. County Fire Department... there's certain things that are not in our ability to control that as costs go up, we have to find ways to enhance our revenues."

Awad added that there are no other assets that the City is looking to sell nor is that a method the Council is considering to enhance income. He warned that at the current state if no corrective action is taken, the City will face a deficit of \$8 million that will require a 30 percent cut in services. "The issue is that this 30 percent cut is going to be to departments that have already taken a substantial cut when we first tried to balance the budget a few years ago when we were facing that \$7.2 million deficit," Awad said.

Awad also pointed out that at the current pace, the City will have to begin using operational funds to stabilize the budget in 2018-2019—and those would be depleted by 2020. "It's something that we have to take a look at quickly because we're almost nearing 2018, so there's two more years of a healthy operation fund--but by 2021-2022, it gets close to around negative \$5 million," he said. "When a city starts getting that close, you're looking at bankruptcy."

If passed on November 7, the collection of Measure HH tax would begin on April 1, 2018 and continue until the tax is repealed by the City Council or by voters. Measure HH was placed on the ballot with a unanimous vote by the City Council on June 11, 2017.

## 3 Activities To Help You Move Safely After Knee Surgery

(BPT) - Most patients undergoing knee surgery want to know when they'll be able to return to a pain-free, active lifestyle and do the things they once enjoyed before knee pain took over. For 58-year-old Kathleen Cohan, this meant a desire to return to mountain biking, hiking and skiing - activities she had always loved to do as a youth and continued to enjoy with her husband in their hometown of Golden, Colorado.

Cohan recently participated in a clinical trial to treat persistent knee pain caused by a meniscus tear. After receiving the NUsurface Meniscus Implant - the first "artificial meniscus" - she completed a six-week rehabilitation program and was ready to return to doing the things she loved.

"The NUsurface Meniscus Implant changed my life. It feels great to not have to worry before I choose an activity about how much pain I'll be in afterward," Cohan says. "My husband and I recently went on a 100-mile mountain bike trip, and I climbed a 14,000foot peak last month and my knee didn't bother me at all. The implant gave me a chance to extend my activity level as long as I possibly can."

Three months after surgery, most patients have completely recovered and are able to return to many activities that were too painful or difficult previously. Once you've been cleared by your doctor, the safest way to restart activity after meniscus surgery is to find activities that avoid placing unnecessary stress on your knee joint. Here are three activities to help you move safely after knee surgery:

1. Walk (don't run!). Experts say walking outside your home three to five times each day is one of the best ways to regain your knee strength. While you may need to adjust the length of your step and speed, you will be able to spend more time walking for exercise once your muscle strength improves.


2. Dance. While you should avoid highimpact moves like jumping or lifts, ballroom dancing and gentle modern dancing are great ways to use leg muscles, engage in aerobic activity and have fun! Just be sure to avoid abrupt movements or twists that could potentially put your knee out of alignment.

3. Swim. Once the wound has healed, many people choose swimming as their exercise of choice as it's not a weight-bearing activity and therefore reduces stress to the joints. If your knee is still a bit tender, opt for water aerobics or pool walking.

Want to mix it up? You can feel safe doing many other recommended activities such as yoga, golf, boating, aerobics or rowing. If you have experience prior to your surgery doing more intense activities, like Cohan, your doctor may give you the goahead to resume cycling, hiking, cross-country skiing and doubles tennis. Whichever activity you choose, remember that rushing into activities before you've recovered sufficiently may put you at risk for complications, so be sure to check with your doctor first before resuming any activity after meniscus surgery.

To be eligible for the NUsurface Meniscus Implant clinical studies, you must be between the ages of 30 and 75, and have pain after medial (the inside of the knee) meniscus surgery at least six months ago. To find a study site near you, visit www.activeimplants. com/kneepaintrial. •

## **New Ways To Comparison Shop For Health Care**

(BPT) - As our nation seeks solutions to help improve the health care system, there is at least one goal we can all agree on: the importance of making health care quality and cost information more accessible to all Americans.

This is an important effort that has the potential to help improve health outcomes and make care more affordable - laudable goals considering the nation's health care system ranks among the least efficient in the world, according to a recent Bloomberg analysis.

More widespread use of health quality and cost resources may be part of the solution. Providing health care prices to consumers, health care professionals and other stakeholders could reduce U.S. health care spending by more than \$100 billion during the next decade, according to a 2014

And people are starting to take action: nearly one third of Americans have used the internet or mobile apps during the last year to comparison shop for health care, up from 14 percent in 2012, according to a recent UnitedHealthcare survey.

These resources are far more accurate and useful than those of past generations, access to market-average prices for hundreds of medical services in cities nationwide.

These resources can help people save money and select health care professionals based on objective information. A UnitedHealthcare analysis showed that people who use online or mobile transparency resources are more likely to select health care providers rated on quality and costefficiency across all specialties, including for primary care (7 percent more likely) and orthopedics (9 percent more likely). In addition, the analysis found that people who use the transparency resources before receiving health care services pay 36 percent less than non-users.

As people take greater responsibility for their health care decisions and the cost of medical treatments, transparency resources are becoming important tools to help consumers access quality care and avoid surprise medical bills. •

## Film Review

## A Twisted Journey of Revenge from Visionary Yorgos Lanthimos

Yorgos Lanthimos set the bar high after the 2015 release of his dystopian romance/ drama The Lobster that landed on multiple "Best Of" lists and was considered a worldwide phenomenon for its originality and satirical tones. The Greek-born director takes the audience down a darker path in The Killing of a Sacred Deer. Rejoining forces with Colin Farrell, Sacred Deer is a destructive psychological thriller born out of revenge. It shows just how easily one's life can turn upside down when put in a desperate situation.

The film opens on an extreme close-up of an open heart surgery and a slow zoom out reveals Dr. Steven Murphy (Farrell) dressed in full-body scrubs. The renowned cardiovascular surgeon is meticulous about his work, both professionally and in his suburban home life. He criticizes his son Bob (Sunny Suljic) about the length of his hair and sets social restrictions for his daughter Kim (Raffey Cassidy) while admiring the perfection of his ophthalmologist wife, Anna (Nicole Kidman). All in all, life is good for the Murphys.


It's no surprise then that with his clout and status, Steven is happy to mentor and befriend Martin (Barry Keoghan)--a teenager being raised by a single mother (Alicia Silverstone) who has shown interest in becoming a doctor. Martin's oddness comes across through awkward social skills, but his intentions seem pure. Martin soon begins to infiltrate Dr. Murphy's life--after showing up at his work unannounced, displaying interest in his daughter, and a string of questionable acts, Steven begins to have reservations about his relationship with Martin. Only by that point, it's too late.

Lanthimos has an artful way of examining complicated relationships in his films, and The Killing of a Sacred Deer pulls no punches when it comes to unnerving visuals. He subtly pushes the boundaries of reality until you realize the absurdity of the situation in which we find the characters. Adding to the eerie surrealism are sweeping one-takes and an observational style of filmmaking that his longtime collaborator, cinematographer Thimios Bakatakis, has perfected.

Colin Farrell makes an exciting return to the big screen in Sacred Deer as Dr. Murphy. His levelheadedness as the protagonist living the picturesque American Dream does a complete 180 at the end of the film, and that transformation is mesmerizing. Acting opposite Farrell is Barry Keoghan, whose slow-boil performance as the brooding Martin is one of the most unsettling and villainous performances of the year. In true Lanthamos fashion, however, mystery provides a thick veil and situations are downplayed on the surface—resulting in a pulsating fear at the film's climax.

Winner of the Best Screenplay Award at this year's Cannes Film Festival, The Killing of a Sacred Deer is another twisted journey through the mind of modern-day visionary Yorgos Lanthimos. It is fantastical and darkly absurd--an uncomfortably hilarious and thoughtful look at relationships and the sacrifice one makes under impossible circumstances. While it may be difficult to overshadow the success of The Lobster, Sacred Deer will have no trouble solidifying itself as a successful entry in Lanthimos' expanding canon.

The Killing of a Sacred Deer is rated R for disturbing violent and sexual content, some graphic nudity and language. 116 minutes. Now playing at the ArcLight Hollywood and The Landmark. •

## LA Dodgers Wave Pennant for the First Time Since 1988 Title Year

The Los Angeles Dodgers are this year's National League champions. A team that has been knocking on the World Series door for quite some time now has finally broken that door down and made their grand appearance on the world championship stage. That's not to say that the Dodgers have necessarily won anything yet. They'll still need a World Series banner to make their magical season turn complete—and by the time this article appears, two games will have already been played and we will have an early idea of how things are progressing towards that goal.

A three-game sweep over their hated rivals from Arizona followed by a 4-1 series victory over a Cubs team that kicked the Dodgers out of the playoffs last season finally gave all Los Angeles players and fans the opportunity that they have been craving for so long now. In just three games, the Dodgers scored 20 runs and showed a very loquacious Arizona team that the latter is nowhere near the level of L.A. Chicago quickly learned that fact as well. Last year's "team of destiny" was quickly removed, as Clayton Kershaw and company made quick work of the Cubs--all while looking extremely powerful in the process.

"Up there with getting married and having kids," Kershaw explained of his team's NLCS victory, as he held back tears. "It's right up there with one of the best days of my life.

Winning the World Series is really all that we play this game for. All the individual stuff is great, but at the end of the day, I just want to win a World Series. If we win, I might retire, so I might just call it a career. It's a special thing, and I know that I'm not taking that for granted."

The sentiments that Kershaw echoed bring to light just how difficult getting to the World Series can be. The Dodgers themselves had been trying for years now, only to walk away at the end of their e postseason runs feeling disappointed and dejected. A loss to the Cubs last year in the NLCS. A loss to the New York Mets in the 2015 NLDS. A loss to the St. Louis Cardinals in the 2014 NLDS and again in the 2013 NLCS. All just mere steps away, knocking on the door. This year, the Boys in Blue finally put it all together and used their experience to knock the door down and become the 2017 World Series favorites going into the matchup with the Astros that kicked off this past Tuesday.

The most interesting part about the Dodgers making it to the World Series is the players on the roster that have helped get the team to this point. Every night, someone different has stepped up to the plate--literally and figuratively--to get the job done. Chris Taylor wasn't on the team's roster to begin the 2017 baseball season. He was a castoff from the Seattle Mariners and didn't play in the outfield until the Dodgers moved

him there. Next thing you know, he was the NLCS co-MVP and a super-utility man who can easily be called the team's engine. The other co-MVP, Justin Turner, was a castoff in his own right. Delegated to the bench in New York with the Mets, ex-Dodgers GM Ned Colletti saw something in Turner. Colletti brought him to the Dodgers, and like many other players on this team's roster have done, Turner honed his craft and has now become one of the best players in all of Major League baseball.

Many of the moves that this Dodgers front office--and ex-front office mates like Colletti--have made were at first unpopular, but have built a foundation for a winning ball club that exhibits all of the qualities of the word "team" to a tee. Dee Gordon, the former beloved Dodger second baseman, was traded for a group of players that included now starting catcher Austin Barnes and the NLCS Game 5 hero, Kike Hernandez. The team traded away much coveted pitching prospect Zach Lee, which at the time was a controversial decision. Who did the Dodgers get back in that trade? Chris Taylor. Moves like those, among others, that may have been unpopular at the time are paying dividends now and have proved to put the puzzle pieces together that have been necessary in forming this year's World Series team.

"We're right where we wanted to be since the start of the year," Taylor said of the team that finished the season with the best record in the MLB. The Dodgers, who had previously lost 16 of 17 games in September, never doubted themselves. Their losing was more of a factor of getting roles set for the postseason than it was of being a bad baseball team. In the same amount of time that everyone began to write the Dodgers off and wonder if they had what it took to be competitive in the playoffs, Roberts and the team learned that they could not trust Pedro Baez and Ross Stripling in high-leverage situations. They learned that they could rely on Brandon Morrow in the eighth inning and bring in Kenta Maeda in the middle innings to get out powerful right-handed bats. Adam Liberatore, Grant Dayton and, to an extent, Luis Avilan all fell off the board while Tony Cingrani and Tony Watson stepped up to form one of the best postseason bullpens baseball has ever seen through the first two rounds.

Every move by this Dodgers team has been calculated from the start with the intent to form one of the best ball clubs in team history that has begun its first World Series since 1988. While Dodger teams of the past may not have had what it took to get the job done, this team can never be counted out. - 2 tablespoons chopped roasted pistachios
- 3 tablespoons crumbled feta
- 1/4 cup roasted garlic hummus



#### **Preparation**

- 1. Preheat oven to 425 degrees Fahrenheit.
- 2. On a large baking sheet, place potatoes, peppers and onions in a single layer. Drizzle with olive oil and sprinkle with seasoned salt and ground black pepper. Toss until evenly coated.
- **3.** Roast for about 30-40 minutes or until potatoes are golden brown and tender, stirring and rotating pan halfway through cooking.

## Looking Up

### A New Era of Astronomy Begins with First Observation of Neutron Star Merger

#### Based on Press Release from The Carnegie Institution for Science, Provided by Bob Eklund

On August 17, a team of four Carnegie Institution for Science astronomers provided the first-ever glimpse of two neutron stars colliding, opening the door to a new era of astronomy.

Along with colleagues from UC Santa Cruz, the team used the Swope telescope at Las Campanas Observatory in Chile to discover the light produced by the merger, pinpointing the origin of a gravitational wave signal less than 11 hours after it was detected. They also obtained the earliest spectra of the collision, which may allow them to explain how many of the universe's heavy elements were created—a decades-old question for astrophysicists.

Their discovery, named Swope Supernova Survey 2017a (or SSS17a), is published in a quartet of Science papers [http://science.sciencemag.org].

Neutron stars are the incredibly dense remnants left behind after supernova explosions. Theoretical astrophysicists have speculated for years about what happens when two of them merge, but until now the phenomenon had never been witnessed. "They are as close as you can get to a black hole without actually being a black hole," explained Carnegie's Tony Piro, the Carnegie team's leader. "Just one teaspoon of a neutron star weighs as much as all the people on Earth combined," he added.

Carnegie's scientists were alerted to the event by the Laser Interferometer Gravitational-Wave Observatory (LIGO), which detects gravitational waves, ripples in space-time, caused by distant cosmic events. In February of last year, the LIGO project announced the first detection of gravitational waves caused by two black holes merging—a discovery that was awarded the Nobel Prize in Physics earlier this month.

While the LIGO black hole discovery marked an important milestone, black hole

mergers do not emit light and are therefore invisible to telescopes. Neutron star mergers, however, have long been expected to produce both light and gravitational waves, so the detection of these events was eagerly anticipated.

"The ability to study the same event with both gravitational waves and light is a real revolution in astronomy," Piro said. "We can now study the universe with two completely different probes, which teach us things we could never know with only one

or the other."

On August 17, LIGO sent alerts for a gravitational wave detection from colliding neutron stars to observatories around the world, firing a "starter's pistol" in the race to spot the source of the space-time ripples.

Working with David Coulter, Charles Kilpatrick, and Ryan Foley of UC Santa Cruz, the team began combing the sky at nightfall for evidence of a never-before-seen collision of neutron stars. "We knew we only had about an hour at the beginning of the night to find the source before it set," explained Carnegie-Dunlap Fellow Maria Drout, who helped guide the discovery, "So we had to act fast."

Despite many large teams across the world working feverishly to find the event, it was the Carnegie and UC Santa Cruz astronomers—a small, young group of researchers—who made the first discovery of SSS17a. "We saw a bright blue source of light in a nearby galaxy—the first time the glowing debris from a neutron star merger had ever been observed," recalled Josh Simon, another of the Carnegie team's leaders on this discovery. "It was definitely a thrilling moment."

Because they were the first to find the event, Simon and Carnegie-Hubble Fellow Ben Shappee had time for additional observations. They quickly set up spectrographs at the observatory's two Magellan telescopes to obtain several spectra of the merger. No other observatories in the world made comparable observations during that first night. •


