## El Segundo Year in Review, Part 2

Last week's first part of the 2018 year-end review focused mainly on matters within the City of El Segundo itself, including department and financial highlights. This edition takes a look at other major news items that made the headlines as well as the top school-related stories.

## The Lakes: TopGolf

**Returns to the Fore** After years of negotiations and various stops and starts, the El Segundo City Council in 2017 finally said no to TopGolf's wellpublicized proposal to revamp the driving range at The Lakes at El Segundo. That sent staff back to the drawing board in 2018 with a request for proposal (RFP) released this past April looking for new bids for site operations, management, improvements and/ or development. Nine entities responded and the new Council narrowed down the candidates to two finalists: TopGolf (with its El Segundo-based partner CenterCal Properties) and the similar-in-concept Drive Shack. After discussions with each of the parties as well as out-of-town visits to both facilities by Council members Scot Nicol and Chris Pimentel, the Council opted to negotiate exclusively with TopGolf-pointing to the firm's proven track record with many successful locations (whereas Drive Shack is new); stronger financial return to the City; and agreement to offer El Segundo resident rates and early access to the driving range plus no-cost access to school groups. Also new to the deal: The inclusion of Billy Casper

Golf to improve and manage the nine-hole golf course.

In other golf-related news, the Council in March approved fee increases for the greens and driving range – the first since 2013 – so those are commensurate with other facilities in the surrounding area.

#### New Pool About to Make Major Splash

After various construction delays, the new El Segundo-Wiseburn Aquatics Center is set to officially open on Jan. 5. The facility includes an Olympic-sized 53.2-meter, 10lane competition pool as well as a smaller pool, along with stadium seating, scoreboard, lighting and a gymnasium. Events leading up to the opening included "A Peek at the Pool" in May and a ribbon-cutting ceremony at the end of September. Also in the fall, the City Council approved facility use agreements with both the El Segundo and Wiseburn unified school districts. Each will get three hours of time at the new pool six days a week. El Segundo Unified will also contribute \$400,000 towards equipment purchase for community and school programming at the Aquatics Center and will kick in 24 percent of the total project cost (not to exceed \$1 million) for the future renovation of The Plunge.

#### School Districts Welcome Newcomers, Continue to Thrive

It was a busy year for local schools. Three slots were up for grabs on the El Segundo School Board, as members Bill Watkins and Jim Garza chose not to run again in November. Out of four candidates, local voters

elected remaining incumbent Emilee Layne as well as newcomers Paulette Caudill and Tracey Miller-Zarneke. El Segundo voters also passed (just over 60 percent in favor) the \$92 million Measure E bond to improve school facilities, equipment, programs and enhance site safety. Additionally, the El Segundo Education Foundation continued its \$1.5 million annual grant to support schools.


The City partnered with El Segundo High School to reestablish Civics Day in which students proposed solutions to local challenges. The Center and Richmond schools were two of 75 campuses nationwide to participate in the Learning Ovations program to bolster literacy achievement.

El Segundo Middle School was one of 22 in the state to earn the 2018 Schools to Watch-Taking Center Stage designation for demonstrating academic excellence, responsiveness to the needs of young adolescents and social equity. It was also one of 10 schools in the country selected for the Dove Self-Esteem Project: Girl Collective.

El Segundo High garnered a Golden Bell Award for the Bio-Medical Science Pathway and a sponsorship gift of \$1,000 from the United Association of California Apprenticeship Coordinators. Four students were National Merit semifinalists and three earned National Merits Letters of Commendations

Superintendent Dr. Melissa Moore was selected as Association of School Administrators Superintendent of the Year Region 14 and Honorary Commander for

## First GPS III Satellite Successfully Launched

The U.S. Air Force and its mission partners successfully launched the first Global Positioning Systems (GPS) III satellite Dec. 23 at 8:51 a.m. EST (14:51 UTC), 5:51 a.m. Pacific, from Space Launch Complex-40 at Cape Canaveral Air Force Station, Florida.

The Lockheed Martin-built satellite, known as "Vespucci," in honor of Amerigo Vespucci, the Italian explorer for whom the Americas were named, was carried to orbit aboard a Space Exploration Technologies Corporation



## Looking Back at the Other Half of 2018 Sports

We just welcomed in 2019 and bid farewell to 2018 and a year that we'll all remember. Through it all, it was another year of sports in El Segundo we won't soon forget. It was filled with cheers and tears and we said goodbye to an El Segundo legend. We made it through another year, so let's look back at the second half of 2018.

#### **Little League International Tournament**

The seventh annual Beach City Baseball Academy International Tournament was another huge success. The 16-team tournament that included Kitasuna, Japan and Little Mountain Little League from Vancouver, Canada and teams from Southern California was a huge success even with the dismal cool weather at Brett Field. After all was said and done, Kitasuna, the defending Little League World Series champions, won its sixth tournament title in seven appearances in the finals. This time, they defeated BC Prospects 14-6 in a game highlighted by four towering home runs.

#### El Segundo Little League's **Successful Season**

The 2018 El Segundo Little League closed its books and schedule by crowning champions in the AA, AAA and Major Divisions. So, 105 days of baseball at Brett Field came to an end. What began on Feb. 17 with the Opening Day ceremonies concluded on a clear, picturesque day. It was classy way to say goodbye to the 2018 season with a bounce house, a Jacob's Ladder, snow cones and cotton candy for the family to enjoy while taking in three great games.

The most exciting game of the day was the AA match between the Indians and Royals. The AAA champions had the best pile-on celebration after winning, and the favorites in the Major Division game played a solid game. Perhaps the highlight of the day was the singing of the National Anthem. Samantha Quevedo's rendition sent chills and goosebumps through the large crowd and prompted the largest ovation of the day.

Sebastian Gomez's walk-off single gave the Indians the championship in the AA game. The Dodgers took care of business in the AAA game. They scored five runs in the fourth inning on their way to a 12-6 championship win that ignited a team-wide dogpile celebration. In the Major championship game, Dylan Garcia pitched his Giants to the championship by tossing a four-hitter and striking out six in their 4-1 win over the Cardinals.

The El Segundo Little League (ESLL) 11-12 all-stars had one of their finest streaks in years. After running the table in the District 36 tournament, they won the Section 4 Tournament to advance to the Southern California Little League all-star tournament. The winner would advance to the Western Region Tournament.

ESLL had a bye in the first round of the 10-team tournament and advanced to face Conejo Valley Little League in the quarterfinal winner's bracket round and win 13-5. In the semifinal winner's bracket game, ESLL faced Park View. The all-star team from Chula Vista had advanced to the Little League World Series twice in the past 10 years and won it once. Park View played flawless defense and took advantage of two El Segundo errors to go on to win 6-0. In the elimination game, James Baldino silenced Quartz Hill's offense and ESLL won 2-1. The season ended when the locals were shut out 13-0 to Huntington Valley (Huntington Beach).

The 9-10-year-old all-stars reached the Little League California State championship tournament. They won the District 36 tournament and the Section 4 tournament to

advance to the pinnacle competition. They fell to Huntington Valley 8-4 in the first round. El Segundo responded with a come-from-behind 6-5 victory over Pasadena American Little League in the first elimination game. The ESLL all-stars continued their winning ways against North Park Little League from San Diego. El Segundo scored three first inning runs and three sixth inning runs to win 6-3.

El Segundo pounded out 16 hits paced by Lincoln Quaintance, who had three hits including a single, walk and a basesclearing triple with two outs to take a 6-4 lead and hold on for the win. El Segundo's run ended with a second loss to Huntington Valley. ESLL all-star play finished with an 11-3 record and was one of four remaining Southern California teams.

#### **Babe Ruth League Crowns Champion**

The Stars and Angels met to decide the 2018 champion. The Stars are no strangers to playing for league championships, but for the Angels this was something new. The Stars were thin on pitching in general, while the Angels' staff was running low on arms due to injuries. The Angels took advantage of seven walks, three hit batters and two errors to win 14-4. For Angel manager Eric Batty, it was his first championship and the first league championship for the team in 10 years.

#### **Nootbaar Signs, While Palmer** and Long Honored

Former El Segundo Eagle two-sport megaathlete Lars Nootbaar was selected in the eighth round of the Major League Baseball amateur draft. Spencer Palmer had one of the best seasons an El Camino baseball player has had in years. He hit .415 with eight home runs, 39 RBIs, a .543 on-base percentage and 38 walks. For his incredible season he was named First Team All-South Coast Conference, First Team All- Southern California and Second Team All-America. Spencer Long was named to the All-South Coast Conference First Team for the Warriors. He had a 4-4 record with a 2.68 ERA and in 47 innings pitched, struck out 40 batters.

#### Football Team Finishes 5-5

The Eagles had made the postseason in 12 of the past 15 seasons, but this year would not be one of them. El Segundo faced five teams that reached the playoffs and three of those played for a CIF title.

The Eagles had defeated Mira Costa in consecutive seasons, but the Mustangs had their number this year. In the final game of the season, the Eagles needed overtime to defeat Santa Monica 22-16. With the score tied 16-16 and 17 seconds remaining in the fourth quarter, the Eagles' 32-yard field goal was blocked and the game went into overtime.

In overtime, El Segundo had possession first. Dylan Phillips hauled in a 15-yard pass where he was stopped short of the goal line. Matt Romero then kept it to get into the end zone for a 22-16 lead. The defense stopped the running game that included linebacker Julian Rodriquez's tackle of Samo's talented running back Zaire Martin-Thomas for a big loss. On fourth and long, the final pass play fell incomplete when the defense pressured both the quarterback and Samo receivers.

It was a fitting ending to legendary defensive coordinator Dan Heck, who retired after the game. Afterwards, Coach Heck addressed the team after being doused with a full cooler of cold water amidst the winning celebration. Fighting back emotions, he said to the team, "I couldn't be prouder of you guys these past two weeks and especially tonight. I'll remember this one and I hope you do too."

## **Local Resident Hopes for a Good** Reality Check on New NBC Series

Thanks to the advent of reality shows, more people than ever get to enjoy their so-called 15 minutes of fame. Some of them flame out quickly, while others parlay the experience into something bigger and better. So is the hope of El Segundo resident Nikkie Neal, who will be



one of the contestants on NBC's new series, The Titan Games, which debuts tonight at 8 p.m. PDT. According to its press information, the 10-episode series "will offer everyday people the once-in-a-lifetime opportunity to compete in remarkable feats designed to test mind, body and heart." The show promises to be widely viewed due to the high-profile presence of executive producer and host Dwayne Johnson, the superstar actor/producer and former wrestler also known as "The Rock." Veteran NBC sports host Liam McHugh and well-known e-sports announcer Alex "Goldenboy" Mendez will serve as commentators providing play-by-play and in-depth analysis of the action from up in the skybox. Broadcaster Cari Champion will be the field reporter down on the floor, conducting interviews with the contestants in the heat of the battle.

While non-disclosure agreements prohibit Neal from divulging in which episodes she will appear, how long she lasted and how she performed – not to mention the particulars of the arduous physical tasks she no doubt faced (filming has already concluded), she did speak about what brought her into this particular spotlight in the first place. "I actually got an email from a friend about it [the show] and they said it looked like something I would love to do," Neal, 26, said. "What you needed to be qualified to be in the running was an athletic background of some kind -- even if it was just a gym rat type of athlete. You had to be true to your story and your beliefs, whatever they may be, and of course know who Dwayne

Neal described the selection process as a "nail-biting experience." She first submitted a video detailing why she thought she could be a Titan as well as footage showcasing her physical strengths. After viewing it, the producers and Johnson agreed that she fit the bill. That bill was part of Johnson's concept to give men and women across the country an avenue to reach their highest potential for greatness. During the series, viewers will see contestants compete against one another in extreme challenges testing not just physical ability but also their overall work ethic and determination as well as their mental and emotional uppermost limits. "I wanted to do this show to challenge myself and to exceed expectations of myself and push myself to be better than what I was," Neal explained. She also felt it was important to show her family what she was made of and to prove she was "just as competitive as her siblings and not live in their shadows anymore."

To prepare for the show, Neal embarked on a rigorous regimen of weightlifting, cardiovascular exercise and increased calorie intake. It was a difficult balance to maintain. "I just overall tried to strengthen while keeping my lean figure for work," she said. "I played volleyball and soccer, and swam. I did all kinds of sports and loved it. They were always my outlet."

The aforementioned "lean figure" is a must for her ongoing career as a model/actress. Neal's resume includes a number of short films, series pilots, background work, commercials and print. Recent appearances included the film I Hate LA and the TV mini-series Chasing Happiness. And she is about to add a stint on The Titan Games.

A self-described tomboy who enjoys any activities you can do outdoors – with jet skiing, snowboarding and hiking particular favorites – Neal is currently single and enjoys spending time with her family. Being in close proximity to family while not straying too far from work calls led to her move to El Segundo a couple of years ago. Born in New Mexico, she grew up in Los Angeles and graduated from Redondo Union High School. "I love El Segundo and the South Bay --- it's an amazing bubble and it has come so far," she said. "Unfortunately, I'm almost never home because I work all over and it requires that I travel a lot."

When Neal does have a break, she loves reading books and also tries to get to the movies once a week. One would suspect that chances are good she will be stopped for an autograph when recognized at a local theatre in the not-too-distant future -- especially if her run on The Titan Games is a long one. With that thought in mind, could she provide her El Segundo neighbors any hint at all on what we should expect in that regard as the series debuts this evening? Neal was predictably tight-lipped about the situation: "Sorry, I cannot discuss anything about the show. You'll have to just wait and see..." The Titan Games debuts tonight, Thursday, Jan. 3 at 8 p.m. on NBC. •

## Film Review

## **Cold War Review: A Masterful Triple Threat**

There is nothing more satisfying than watching a film from a master director. In the case of Polish director Pawel Pawlikowski, it was his 2014 Foreign Oscar winner Ida, that added him to my list of top directors. So when Cold War released, it wasn't a question of if but when I could fit it into my queue, and I'm happy to say that the film lives up

to its predecessor as a brilliant companion to Pawlikowski's previous work.

Shot in a visually distinct, entirely black and white square ratio, we're transported to 1949 Poland within seconds. The war in Europe is over, yet the division between East and West lingers when we meet our first protagonist, Wiktor (Tomasz Kot). An accomplished musician and conductor, Wiktor is part of a program that recruits young village peasants to study traditional Polish music in order to participate in a newly formed musical conservatory. The goal is earnest preservation of Polish heritage through music and dance. Yet as their notoriety grows, they face increased pressure to transition to propaganda-based entertainment over the traditional music of which they are passionate. The resulting tension affects numerous countries...and by tapping into the ultra-specific, it successfully creates something universal.

This is only the starting point. The 90-minute runtime is packed tightly with narrative beats. The larger journey begins when Wiktor takes a liking to one of the conservatory's brightest stars, Zula (Joanna Kulig). Despite their different roles in the conservatory, they fall passionately in love. Over the course of a few years, their love story intertwines with the European conflict at hand, and their opposite personalities make for both passion and often conflict.

What makes Cold War so riveting is the film's delivery of material. Cinematographer Lukasz Zal (who co-shot Ida and was nominated for the cinematography Oscar), gets to use the camera as the ultimate storytelling device. Most films are lucky to have one or two unforgettable shots that get burned into the retinas. Cold War has at least a dozen. Some are like magic tricks in their simplicity or creative reveal of key information. Others are more stunningly beautiful in an Ansel Adams, magnificently black and white styling. None are mundane or incidental. I won't spoil these wondrous photographic moments, as they are worth the admission alone.

These combined forces of story, photography and the angelic quality of the Polish music are what make Cold War a must-see, especially on a big screen. Pawlikowski claims he did not set out to make another film so similar to Ida in aesthetic, and yet the two are as perfect as companion pieces come. They entirely stand on their own, but are complementary as a pair. Whatever Pawlikowski decides to do next, consider my ticket already purchased. In the meantime, I'll be soaking up the emotional experience of Cold War for many days to come.

(SpaceX) Falcon 9 Evolved Expendable Launch Vehicle, after three previous launch attempts on Dec. 18, Dec. 20 and Dec. 22 were thwarted by weather or technical issues.

GPS III's "Vespucci" separated from its upper stage at 10:59 a.m. EST (15:50 UTC, 7:50 a.m. Pacific), approximately two hours and eight minutes after launch. Engineers and operators at Lockheed Martin's Waterton facility will now begin on-orbit checkout and tests estimated to complete in six months. Operational use is expected to begin in about a year.

Vespucci will be vectored to augment the current GPS constellation comprised of 31 operational spacecraft. GPS satellites operate in medium earth orbit at an altitude of approximately 20,200 km (12,550 miles) in six planes. Each satellite circles the earth twice per day.

The GPS III Vespucci team is led by the SMC's Global Positioning Systems Directorate, located at Los Angeles Air Force Base in El Segundo. Lockheed Martin Space Systems Corporation is the prime satellite vehicle contractor. The launch was led by Space and Missile Systems Center's Launch Enterprise Directorate, and was on the SpaceX Falcon 9 launch vehicle at Cape Canaveral AFS.





Los Angeles Air Force Base. Kimberlie Linz came aboard as the new chief business official in December.

At Wiseburn, Dr. Blake Silvers became the new superintendent after the retirement of long-time district leader Dr. Tom Johnstone. At the end of December, the Wiseburn community celebrated the opening of its brand new, state-of-the-art gymnasium facility that includes court space of nearly 24,000 square feet. The space accommodates three full-size basketball courts and six full-size volleyball courts.

#### **Council Tells Bird, Lime to Scoot**

During the early summer, scooters were suddenly everywhere around town. While Council members saw the advantages of the alternative transportation mode, concerns about safety, liability and parking prompted a moratorium in August and within a few days the vehicles were gone. It all started when the company known as Bird without warning dropped 30 of its scooters in the

community in June. A second firm, Lime, brought 50 of its own in July. Initial efforts to develop a pilot program to allow motorized scooters fizzled as the plan hit roadblocks, particularly in the area of insurance. The Council action was not a permanent ban and will allow scooter firms that want to do business here the opportunity to eventually present an operational game plan that works for El Segundo.

## **Local Trash Collection** in Midst of an Overhaul

With the cost to subsidize trash pick-up escalating, the Council asked residents to help pay for the service. The City initiated the mandated Prop 218 protest ballot with a mailer to owners of single and two-unit properties eligible for solid waste collection services. Less than half of those came back, thereby allowing the Council to impose the fee in 2019 if it so chooses. The maximum cost will be \$20 monthly per customer.

Meanwhile, an RFP went out for the City's next trash contract and four bids came back, included one from long-time hauler Republic Services. Staff recommended changing to EDCO Waste & Recycling, which it felt offered the best overall package, and moving from manual pick-up to the more "effective, efficient, cleaner" automated. But given the community's preference to stay manual and its high rating of Republic's service over the last half-century, the Council did not reach consensus on the matter when it came up for discussion in December. The item will return to the agenda on Jan. 15, with additional

public input sought in the interim.

#### Smoky Hollow Ready for Next Step

In September and after making various tweaks, the Council approved the long-awaited Smoky Hollow Specific Plan update designed to facilitate public and private investment in the area and transform it into a creative hub for El Segundo and the region. The amended plan included a pilot parking program for a few blocks on the west side of El Segundo Boulevard, set parameters and conditions for increased building height in exchange for developers providing community benefits, and established a parking in-lieu fee. Big Door Studio hosted a public preview of the plan back in April.

### All Fine with Social Host Ordinance

In September, the Council approved a social host ordinance that will fine persons who are aware of or encourage alcohol or marijuana consumption by minors at large gatherings but don't take reasonable steps to prevent it. Councilmember Pimentel was the lone dissenting vote, calling it a "shortcut around the criminal process" that inappropriately uses regulations. The Council also adopted fines for repeat violators in so-called party houses. The move stemmed mainly from a particular house on the 400 block of Virginia Street that has spurred neighbor complaints for use about noise, littering and other issues. Late in the year, ESPD reported the property owner and a tenant on premises were under indictment.

#### High-Density Housing Creates Complex Discussions

Should El Segundo consider housing east of Sepulveda (now PCH) to accommodate the growing housing demand in town with virtually no stock available? The topic has been essentially taboo in the past. In 2018, the Council declined to accept a \$659,000 Metro grant offer to apply towards a general plan update because accepting the money required a proposed affordable housing study east of PCH. Then in December, Councilmember Nicol broached the subject of high-density housing just west of PCH in a buffer zone area adjacent to Washington Park where previous apartment complexes stood. Councilmember Don Brann was against the idea, but his remaining colleagues (none, including Nicol, actually expressed support for high-density) were open to at least have staff look into the matter to understand the needs of prospective commercial tenants who may choose to move their businesses elsewhere if there is no place in town for employees to live.

#### **Council Adopts Homeless Plan**

To take the next steps in addressing the homeless problem, the El Segundo Police Department (ESPD) hosted a town hall meeting in April to get community input on the issue. It also applied for and obtained grant monies from Los Angeles County to develop a homeless plan approved by the Council during the summer. The most recent homeless head count showed 15 such individuals in El Segundo – down from 25 in 2017. •
