Jane Burrell Leads Push to Have Woman's Club Clubhouse Declared a National Landmark

Jane Burrell is leading the push to have the El Segundo Woman's Club [ESWC] building, located across the street from El Segundo High School [ESHS] at 541 Standard Street, declared a National Landmark.

A quick history of the building: it was initially located on the acreage that is currently Richmond Street School. Circa 1912. The building was initially utilized as a one-room schoolhouse. In the 1930s, the schoolhouse was moved to the land that currently houses ESHS. When the building was deemed no longer necessary at the High School, the Board put the building up for sale. Savvy operatives of the Woman's Club bid on the building, securing it for a tad bit over \$64 in 1936, and moved it across the street. Renowned architect John C. Austin became part of the renovation project. Austin is credited with being a huge part of the design of the Griffith Observatory, the LA City Hall, and the Shrine Auditorium. Burrell and the other members of the Club have circled April 21 on their calendars; that is the date that the State of California's Office of Historic Preservation will release the news regarding whether the clubhouse makes the landmark designation cut. "I will be the most ecstatic person," she said, "if we get this designation." Burrell, who moved to El Segundo in 2008, spent her youth in New York. She lived in the suburbs of Gotham City, eventually nabbing a bachelor's degree in art history and fine arts from Skidmore College and a master's degree in Chinese Art from Brooklyn College.

She said that one of the best things about growing up in the shadows of New York City was her proximity to the museums and art houses in NYC. Burrell said her engineer father was interested in the arts, allowing her to page through his art book library.

When her family moved to California, settling in Manhattan Beach, she quickly scored a position with the Los Angeles County Museum of Art [LACMA] in 1978. Burrell drew a paycheck from LACMA for forty years until her retirement in 2018. "An amazing experience," she said. "I could not be more grateful for my career there." the offensive odors from the Hyperion Plant to asking the school to open the Plunge swimming facility in the summer to allow people to bathe," she wrote.

"In the 1920s, Club members were instrumental in supporting the community's campaign for a high school for El Segundo; before this time," she said, "high school students attended Inglewood High School. [ESHS] opened on December 13, 1927. Members [also] worked to improve children's welfare, and upon establishing a Child Welfare committee, they invited the County nurse for public schools to address one of their meetings. They supported the Children's Hospital's formation and continued assisting the organization through charitable donations. In recognition of their community service, the Chamber of Commerce invited the Woman's Club to become an honorary member in 1924. "In 1935, the Club's executive board voted to use the student loan fund for emergency loans 'with small amounts to students of El Segundo seeking higher education.' They established a committee to select the students and handle the disbursement of funds, not to exceed \$50 per student. In 2022, the El Segundo Woman's Club provided college scholarships totaling \$24,000 to El Segundo High School and Arena High School seniors. "In the 1940s, Woman's Club members supported the war effort by working in the Red Cross canteen, sponsoring dances for soldiers, wrapping bandages, hosting blood banks in the clubhouse, donating blood, knitting, and raising money for war bonds and the Red Cross.

When approached for an interview and *Herald* story, Burrell, also a member of the El Segundo Arts and Cultural Advisory Committee, wanted the story to focus on something other than her, but rather the history of the El Segundo Woman's Club and their historical building quest. "I do not like to be the center of attention," she said.


So here is a bit more of the history of the El Segundo Woman's Club.

From Burrell: "The El Segundo Woman's Club was founded in 1922 to promote civic, educational, and philanthropic interest in the community," she emailed. "The seventeen founding members, many of whom were wives of oil company workers who came from the Midwest to settle the newly formed town, recognized the necessity of fostering civic engagement. The Club remains the only organization of its kind in the City of El Segundo." Burrell continued.

"Immediately upon forming the Club, members became involved in advocating for social improvements from dealing with

The Good Nurse: A Dark Doctor Thriller and Unnerving True Story


A killer nurse's trajectory from doctor's scrubs to handcuffs is depicted in the eerie crime drama *The Good Nurse* (now streaming on Netflix). Based on the true story of Charlie Cullen's 16-year crime spree – which included the murder of at least 29 hospital patients and up to 400 additional victims – the film details the horrific events that led to his eventual arrest. Directed by Tobias Lindholm, whose previous credits include screenwriter on 2021's Oscarwinning film *Another Round* and writing the teleplay for one of Netflix's most binge-able crime series, *Mindhunter*.

Academy Award-winning actor Eddie Redmayne transforms himself into the 40-year-old sociopath Charlie Cullen. Having bounced around from hospital to hospital throughout his questionable tenure as an ICU nurse, he lands on the floor of a hospital in Central New Jersey in 2003. Here, he meets fellow ICU nurse Amy Loughren (Academy Award-winner Jessica Chastain), a compassionate woman and single mother of two whose own struggle with her health is becoming life-threatening. Amy immediately takes to Charlie's sweet disposition and kind nature, and his goodwill extends beyond that of just a colleague. Their relationship quickly goes from co-workers to friends, staying purely platonic but genuinely invested. However, Amy soon discovers that Charlie's projection of being a good guy isn't necessarily true for everyone he meets.

While initially optimistic about Charlie's addition to the hospital staff, his presence is overshadowed by the mysterious death of two patients. These unnatural circumstances lead the hospital's senior staff to involve state police and an external investigation into their causes of death is quickly launched. "Members of the [ESWC] had begun gathering historical memorabilia in late 1957," Burrell said. "Items for the collection were first stored in members' garages. When [their] garages started to fill, the School District donated a small room in the high school administration building for the Woman's Club to display the historical items collected from residents. When the collection outgrew this space, a basement room in City Hall was made available in 1958, and the collection was organized for public viewing by a historical committee." The gathered material now resides in the El Segundo Library History Room and is managed by volunteer members of the History Committee. "The [ESWC] acquisition and judicious renovation of the original schoolhouse reflects the organization's civic commitment to the community. By repurposing this historic building for their clubhouse, the Woman's Club has retained an important representation of the settling and development of Southern California. The 1940 Mariposa entrance preserves a small piece of residential architecture by John C. Austin. Since its renovation, the clubhouse has been used for member and community needs, including serving as a site to administer the polio vaccine in the late 1950s, as a gathering place for local merchants to sell their wares, and as a community rental space for personal and civic events. The revenue derived from Clubhouse rentals has enabled the Club to fulfill one of its fundamental goals: donating

to local, national, and international charities, as well as maintaining the building and providing college scholarships to local high school students."





When a light is cast on Charlie's sketchy employment history and possible involvement, the detectives reach out to Amy to see if they can crack the case, with her help, from the inside. Reluctant to believe that her friend is a murderer, seeds of doubt have already been planted and Amy takes it upon herself to risk their relationship, his future, and her life, to see that justice is served.

The Good Nurse does an especially good job of capturing the essence of feeling unsettled. Masterfully crafted to match the nature of the crimes, the film is deliberately paced so that the audience feels like they're uncovering Charlie's inconsistencies at the same time as Amy. Running just over 2 hours long, the film successfully builds suspense until the pressure cooker of intensity explodes at the very end, evidenced by Eddie Redmayne's remarkably powerful performance. His characterization of a serial killer is subtle yet undeniably haunting. In her role as an empathetic woman who finds herself struggling with mounting internal conflict, Jessica Chastain is the film's emotional vehicle. Her battle is internal yet we all clearly feel her plight, which is further explored through the film's soundtrack by ambient musician and composer, Biosphere.

Sandy was the first female president of the El Segundo Chamber of Commerce in 1989 and became the first woman to serve as Mayor of the City of El Segundo from 1996-1998. She continued as Mayor Pro Tem until 2004. An extremely active member of the community, Sandy served on over a dozen civic and charitable organizations; a founding member of Downtown El Segundo, Inc., the first president of the Library Board of Trustees, a local business owner, and named Switzer Center's South Bay Woman of the Year in 1999.


