City Council Begins Looking into Residential Parking Near PCH

Parking in El Segundo received most of the attention at Tuesday's regularly scheduled El Segundo City Council meeting, with city finances also coming into play. Community Development Director Michael Allen was pleased with the 1,351 responses to a parking survey available from September 25 through December 1 last year, noting that city surveys on the Downtown Specific Plan and Smoky Hollow areas have typically received maybe 100 or so responses. On his first day on the job, New Chief Financial Officer Paul Chung was also introduced to the City Council, as was new Fire Chief George Avery, who was also in his first day of employment for the city. Mayor Pro Tem Chris Pimentel pulled an item on the Consent Calendar about the Library Park pathway and improvements being funded by a grant that requires ADA compliance because he wanted to see a schematic and hear more about where rails would be placed in Library Park. Public Works Director Elias Sassoon assured him that the rails council previously thought not necessary and perhaps unsightly or that would impede or interfere with activities had been removed from the project. The ones that remained were necessary and more in the park's perimeter.

Sassoon also presented the city's need for a new combo jet/vacuum, costing \$667,878,


since the 20-year-old one the city currently has isn't operational. On Tuesday night, the council voted 3-2 to pursue a five-year lease-to-purchase option, with Mayor Drew Boyles saying the city needed to get a lower interest rate than the 5.38 percent Sassoon had been quoted just that day. The other two options presented to the council included purchasing the equipment or using a 10year lease-to-purchase option. The 10-year lease-to-own interest quoted was also 5.38 percent, and Sassoon explained that interest rates had increased since he'd received the 10-year financing terms. With the five-year lease-to-purchase, Sassoon said the city would incur about \$61,000 in interest costs, while he noted that the 10-year option would result in about \$117,000 in financing costs.

During his presentation, Allen noted that the city currently has two parking zones where permits are required and that via the new survey, it was apparent that residents in Zone N had serious concerns about parking in their neighborhood. Fifty-nine percent of survey respondents (you did not have to be a city resident to respond to the survey) in Zone N indicated that they want a parking permit program in their area and that week-day parking is much more of a problem than weekend parking. Zone N is located near Pacific Coast Highway and heads into the

residential areas adjacent to Grand Avenue and Mariposa. Allen told the council that people who work in the area park in those areas, as well as individuals who are visiting businesses (particularly those that don't have parking), people staying at nearby hotels, people who are Ubering to Los Angeles International Airport, leave their cars for the duration of their air travel, Uber drivers, and a nearby car rental agency. Council member Ryan Baldino brought up "the fact that Pacific Commons" has been approved to be built on PCH and that any future parking changes in that area need to take that development into account. The survey also revealed that 337 respondents have three or more vehicles, 632 respondents have two vehicles, 167 have one, and one respondent did not have a vehicle.

In human resources agenda items, Director Rebecca Redyk told the council that two new vacancies within the city had been switched to at-will positions and that one of those jobs - recreation superintendent - was being changed to recreation manager. Other actions involved and approved in the agenda item included "Updated Classification Specifications and Examination Plans for Building Safety Manager and Recreation Manager, and Resolution to Establish the Basic Salary Range for the Recreation Manager."

ESUSD Celebrates Opening of New Richmond Street School Classroom Building

The El Segundo Unified School District celebrated the opening of the new Richmond Street School Classroom Building with a ribbon cutting and dedication ceremony on Friday, January 5.

The ceremony marked the culmination of a years-long effort to ensure adequate school facilities for students in the district.

Richmond Street School Principal Carie Oulashian opened the ceremony with a welcome to all guests and introduction of special dignitaries, including elected officials from El Segundo; Assemblyman Al Muratsuchi; Edward Feves, representing Senator Ben Allen; Jessalyn Waldron acting on behalf of Supervisor Holly J. Mitchell; Scott Houston, President of the West Basin Municipal Water District; City Officials, including Mayor Drew Boyles, Mayor Pro Tem Chris Pimental; Councilmembers Carol Pirsztuk and Ryan Baldino; and members of the Board of Education.

Former board member Nancy Cobb delivered remarks on Measure ES, sharing the history and legacy of the initiative. Then, Board President Meredith Beachly led the building dedication, highlighting the importance of the new construction. Superintendent Dr. Melissa Moore brought the proceedings to a close with concluding remarks, encapsulating the significance and vision associated with the effort.

The new addition, which contains six classrooms, presently will serve the school's second and fifth-grade students. Additionally, the project stands as a prime example of sustainable construction that supports energy efficiency, water conservation, and native plantings, including an El Segundo Blue Butterfly habitat. Student ambassadors were on hand to highlight special building features which included a custom stair panel design, two garage doors in classrooms to promote indoor-outdoor learning, and the most noteworthy Blue Butterfly mosiac is the center showpiece. Parent Chia-Ming Ro, along with other dedicated parent volunteers, spearheaded an effort to re-establish transformational learning gardens for students, as well.

During the 2015-16 school year, ESUSD began the long-range facility master planning process with PBK Architects with the goals of assessing and prioritizing current and future facility needs, and bringing technology infrastructure to current standards. In November 2018, El Segundo voters approved the passage of Measure ES with 63.2% support. This \$92 million bond is the fourth school bond measure passed by the community and the largest, with a comprehensive reach that impacted every campus in ESUSD. The bond targeted three new construction projects, with this classroom building being one of them.

Dr. Moore thanked the community for their support of the district's facilities and building efforts.

"This beautiful new building stands as a testament to the tireless efforts and unwavering commitment of everyone involved," said Dr. Moore. "Together we have built more than just a building—we have built a promise for the future in a vibrant learning environment where our students will thrive and feel seen, heard, supported, and loved for many decades to come."




Film Review

Alden Ehrenreich Crafts a Tight, Tense Debut in Short Film, Shadow Brother Sunday

Any time a well-known actor steps out from behind the lens and into the role of a filmmaker, it comes with an additional layer of pressure. After starring in a string of big-screen hits, including Netflix's Fair Play, Disney's Solo: A Star Wars Story, Elizabeth Banks' Cocaine Bear, and the Coen

Brothers' *Hail, Caesar!*, Alden Ehrenreich proves that his expansion into directing has come by way of learning the tricks of the trade from some of the industry's best. The experience of working with top-tier directors effortlessly translates onto the screen in his short debut film, *Shadow Brother Sunday*. It's easy to recognize that the guy's got talent, and hopefully, this is just the beginning of a very storied and fruitful filmmaking career.

In Shadow Brother Sunday, which Ehrenreich wrote and directed, he transforms himself into Cole, an aspiring musician whose jealousy toward his famous brother seeps into dangerous territory. When Jacob (Nick Robinson), an actor on the rise, returns home to attend the premiere of his latest film with his family, the general mood in the household is celebratory and bright. That is, until Cole enters and brings with him a dark cloud of negativity and gloom. Frustrated with his financial situation and seeing an easy opportunity for quick cash, Cole entertains

6230 West 87th Street Westchester Ca. 90045 the idea of selling his brother's personal information to a gossip site. The decision weighs on Cole; he loves his brother, yet feels entitled to the same amount of success that Jacob is currently basking in. Time is ticking, and Cole has to make a choice: stand by his brother, or sell him out.

Ehrenreich uses the film's 15-minute runtime to craft a concise drama. The pacing hits the right level of tension and ends on a cliffhanger that will hopefully be addressed in a feature-length adaptation (one can dream!). As a filmmaker, Ehrenreich wanted to create as much authenticity for the actors as possible, which is why his performance is immersed in method acting—gaining over 20 pounds to fully embody Cole's uncomfortable physical state. He also set up dinner parties so that the faux family could get acquainted off-camera and organically develop their relationships.

For transparency's sake, Ehrenreich didn't claim to take this project on alone. *Shadow Brother Sunday* is equipped with backing and support that most directors in the short film space only dream of, including Francis Ford Coppola serving as Executive Producer and Elizabeth Banks moderating the film premiere's Q&A. Hollywood legends aside, the film still holds its own.

As Ehrenreich continues down the directorial path with confidence and passion, I believe he could follow a similar trajectory to Bradley Cooper (*Maestro*, A Star is Born). Shadow Brother Sunday premiered at the 2023 Tribeca Film Festival and won a Special Jury Award for Excellence in Filmmaking from the Salute Your Shorts Film Festival. •





You can also bake the mixture in a mini muffin-pan, for egg bites that look great on a brunch board! Or make a batch to freeze for a prep-ahead breakfast!



Ingredients

- 9 eggs

City Council

CFO Chung also presented the Annual Comprehensive Financial Report for the Fiscal Year Ending June 30, 2023, noting that city staff had done the work since Tuesday was his first day on the job. He thanked them for their excellent work and brought on Tiffany Fung, Signing Director with CLA, who delivered a Zoom presentation, stating that her firm agreed that the work was "clean" from a financial perspective. Council member Carole Pirsztuk noted that having the financial documents "clean" and in order bodes well for an upcoming transfer to a new enterprise system. The "clean" rating was the third one in a row that the City of El Segundo achieved. Chung noted that the city finance team worked on the finance audit for six months or less, acknowledging their speedy and accurate work.


