Pension-Finance Plan Endorsed, Could Save City \$61 Million

The City Council returned from a four-week hiatus Tuesday and immediately tackled what Mayor Drew Boyles called the most important financial issue facing the city: paying down \$152 million it owes the state-run pension fund. El Segundo officials believe they've found a low-risk solution that offers considerable savings.

The council heard more Tuesday about the merits of issuing municipal bonds to pay off its outstanding balance of \$152.3 million to CalPERS. Other South Bay cities have explored the idea, too, to take advantage of favorable rates in the taxable municipal bond market. Two council members - Scot Nicol and Mayor Pro Tem Chris Pimentel - brought the funding strategy to the council's attention back in December.

The plan is for El Segundo to sell the bonds while interest rates remain low and to eliminate the seven percent annual interest charge from CalPERS for carrying an outstanding balance to the retirement fund. If the bonds were repaid over 19 years, the savings could fund the city's general fund for an entire year, Pimentel said Tuesday. By paying four percent or less to service the bonds instead of seven percent to CalPERS, El Segundo would pocket the difference, which is considerable on the \$152.3 million sum.

El Segundo, which is new to the municipal bond market, will begin the process of issuing taxable bonds that attract wealthy investors and institutions with a low appetite for risk. El Segundo City Manager Scott Mitnick will contract with a San Francisco-based law firm specializing in pension-obligation bonds for

legal services. And, the city will use KNN Public Finance as its financial advisor for the bond sale.

The city manager told the Herald that the risk of issuing \$152 million in debt is almost minimal to the city. "The cost of doing nothing is too risky at this time," Mitnick said. The amount of savings on its annual pension expenses to CalPERS will depend on the credit rating assigned to El Segundo and whether bond interest rates float higher over the next three months. Any rise in the bond market's interest rates would trim the

city's potential savings. One of the first steps is for El Segundo to apply for a credit rating. The city's financial adviser told the council to expect a favorable credit rating.

It's estimated the city could bank \$61 million instead of paying that amount in interest to CalPERS over the next two decades. The bonds won't be ready to auction before May, and El Segundo can back out of the bond auction if market conditions change. The council unanimously endorsed the pension-financing strategy, ticking off its to-do list

Erin Fagerlind Gives Children and Parents a Community

Have you heard of diastasis recti? When was the last time you talked about cracked nipples, postpartum depression, incontinence, or partner relationships after the birth of a child? If you have kids or are thinking about having kids, these are things you'll want to know. At Happy Baby here in El Segundo, Erin Fagerlind guides parents on their journey from prenatal classes to parent/child yoga, fitness, and dance classes.

Originally a business/intellectual property attorney, Fagerlind began to realize how precious her time was when she had her first baby. She sought an accessible place for parents to talk to each other and nurture their minds and bodies. In the absence of such a place, Erin decided to create her

own, leading to what is now Happy Baby.

"Part of these groups," says Fagerlind, "is having a group of women who are in the same place in their motherhood journey come together each week and use each other as a sounding board...in a very nonjudgemental and informative way." Week to week, experts are brought in, and discussion groups are formed to help teach new mothers what to expect and how to cope with this big life change.

For example, diastasis recti is the separation of the abdominal wall to make room for the baby, and doing the wrong kind of ab workouts after birth can actually prevent it from rejoining, something most women don't hear about because it is considered less of

a medical issue and more of a physical therapy issue. In these classes, both with instructors and guest speakers, she goes through topics like stages of development, breastfeeding and bottle-feeding, pelvic floor exercises, CPR and car seat safety, and baby socialization. Most of all, she explains, these groups are about community.

how to improve themselves and manage their emotions provides balance," says Fagerlind. Though she acknowledges the importance of competitive activities for children, her program provides an alternative.

"Mindful parenting is the core philosophy," she says of her practice. In addition to these

"Trust your intuition, and don't be afraid to ask for help. Community is everything," she says of new mothers. She explains that your "life tribe" is different from your "mommy tribe" and that while both are equally important, they're very different. For better or worse, those without children or with older children often give advice, which isn't always what a new mom is looking for. Sometimes it's just to vent, to hear from people going through the same thing at the same time, and to talk about the current difficulties of parenting. These classes offer the opportunity to meet other moms going through the same stages. Part of what Erin champions in her practice is the ability to sift through information.

classes, she says they have events every year like the annual father-daughter dance, to which moms are not invited, and local professional photographers are hired to cover the dance. She also brings in music teachers to play guitar and teach music to the children, which tends to be popular with dads.

Parents get a community of other parents, children get important socialization and emotional tools, but what does Erin get out of all this? "I get so much fulfillment out of building community, connecting women, watching kids grow," she says, though she says that these days, that fulfillment is harder to get without seeing everyone in her studio all day.

"Knowledge can be power, but you need to be able to filter it," she says. Anyone with even a little anxiety who decides to have a child can easily be overwhelmed by the amount and range of information out there. Something she tries to provide with her business is a place where this information has been filtered through for her clients and can give them peace of mind as they find their own parenting path.

Beyond new parents, she also offers parent/child yoga and dance classes. Toddler yoga classes look very different than adult yoga classes, as she describes them as being much more playful. She explains her classes as "noncompetitive" and "process oriented."

"I think to have an activity that isn't at all rooted in competition, but more learning

Last year, when Covid hit, she, like so many businesses, was forced to close their doors. Wanting to keep her clients' health and safety as her top priority, she began thinking about how she could adapt to keep her program and keep this community available to parents and children, especially now that mental health is being challenged by pandemic isolation.

Though it's not her ideal situation, Happy Baby now offers outdoor classes with groups of limited size, as well as virtual options. Her studio is now being used as an educational pod space for her children, and she hopes to reopen its doors to indoor classes as soon as it is safe. For now, she has created a space where her clients can feel safe to come and can tell soon to be mothers about this amazing group. •

The Magical Retirement Community, And Fantasy Masking Darkness, in ‘Some Kind of Heaven’

Fulfillment, satisfaction, completion, contentment, peace. It’s what we’re all striving to achieve in our lives.

Yet life is hard, and we don’t always stay on this track. Our flaws and insecurities, measured against our boundless imaginations, can make for a hard reality to adjust to if we’re not content with where we’re at in life. Especially living in present-day America, where reality has been proven to be whatever personal construction we make it to be.

And as we make it into the twilight of our lives, our shortcomings become even more magnified. So, wouldn’t a place that offered aging seniors the opportunities to pursue those fantasies be a good thing?

van-living man seeking to get close enough into The Villages to find stability (and a sugar mama); and Barbara Lochiatto, a widowed woman looking to step back into romantic life.

Oppenheim crafts *Some Kind of Heaven* into a wonderfully off-kilter experience, in which the dreamy surrealism of The Villages is seen as being in a magical trance. Captured in 4:3 aspect ratio, the cinematography by David Bloen captures the oddity in the manufactured synchronicity. And it very much captures the illusion of fantasy making our darkness.

Some Kind of Heaven is a must-watch. Its sharp observations make for a documentary that plays like a comedy and a dark drama. And underneath it all is a film about identity.

I’m reminded by a quote from Shantideva:

A new documentary, directed by Lance Oppenheim and executive produced by Darren Aronofsky and The New York Times, shows retired living at The Villages, America’s largest retirement community. This magical oasis offers its local community an unlimited number of recreational activities to do and, with that, an infinite amount of people you can be.

Home to 130,000 residents, the Florida-set retirement community is shown as a place where the aged have escaped to live out their final years, experiencing the fountain of youth (which is what The Villages founder Harold S. Schwartz advertised to baby boomers).

Some of the gray-haired are clearly okay with having a good time, living out their hedonistic pleasures of “nightclubbing” and meeting new singles. But others, who Oppenheim centers the film around, see the falsehood in the proscenium and grapple with the darkness that lingers at bay.

The characters who Oppenheim follows are strong and distinct: there’s married couple Reggi & Ann, who are trying to maintain a marriage under Reggi’s cratering mental state (tai chi and drugs assisting). There’s Dennis Dean, a

one of the most worrisome issues hanging over the city as it starts a new year.

The Space Force turned one year old this week, and El Segundo honored the occasion with a proclamation that served as a birthday card for the newest branch of the U.S. Armed Services. The 2020 Defense Authorization Act created the Space Force to defend and protect the U.S. fleet of military satellites that are critical to the nation’s defense. Air Force Base Los Angeles, located in El Segundo, is home to Space and Missile Systems Center that provides technical assistance to the celestial defense network. The center is a job creator for the region, adding more than 19,000 to the local economy, according to the proclamation.

Col. Becky Beers, who commands the 61st Air Force Group, graciously accepted the proclamation from the mayor and council and thanked El Segundo for its support to the base and the Space Force, which turned one on Wednesday. Five hundred personnel from the L.A. base now work for the Space Force, she told the council via a Zoom link.

“I’d like to thank our incredible community partners from the city of El Segundo for honoring the United States Space Force in this way. We could not safeguard our nation’s space capabilities and take care of our airmen and guardians without your tireless effort and support,” Beers said. “Thank you for this recognition; we appreciate it.”

Beers in July took over command at the Los Angeles base, where she leads five squadrons and six staff agencies. The 61st Air Base Group is tasked with providing technical and personnel services to the Air Force and other locally based Department of Defense staff in the region. She is a cyber-space operations officer who was assigned to the San Antonio-Lackland Joint Base in Texas before her promotion to commander.

COVID-19 cases in El Segundo have surged, along with those in Los Angeles County, and stood at 121 confirmed active cases and three deaths as of Monday. Fire Chief Chris Donovan revealed the case count had steadily risen since Christmas week when El Segundo had 88 confirmed cases

of COVID-19 and one death. Active cases are defined as people who’ve tested positive and are in quarantine for 14 days.

El Segundo has registered 529 cases of the virus, according to statistics updated to January 18. City Hall hasn’t been spared either. Some city employees have contracted the virus since the post-holiday spike across Los Angeles County and much of the state.

Frontline essential workers and anyone 65 years and older are next in line for vaccinations, under a revised order issued Monday by the county Board of Supervisors. Vaccinations for this so-called 1B group are scheduled for February and March. Donovan, who serves as the incident commander for the city’s COVID-19 response, said a lack of communication and coordination had slowed the vaccination effort locally.

El Segundo Fire Station 2 at 2261 E. Mariposa Avenue is designated as a point of destination for the vaccinations, though so far, the shots have been limited to 60 frontline workers and mostly firefighters, he said. All of them received the first dose

of the vaccine.

El Segundo officials expect 100 more doses in February for the police department and are pushing county and state public-health officials to release another 100 doses for Park Vista, the fire chief said. The Forum in Inglewood is a vaccination super site, which could deliver 4,000 shots per day, starting today, to essential workers and people 65 and older. The L.A. County Office of Education in Norwalk is the next closest venue to South Bay.

El Segundo officials continue to advocate for using Fire Station 2 as a distribution point for the vaccine campaign, according to Donovan. Incoming President Joe Biden, who was inaugurated Wednesday, has pledged to get 100 million people vaccinated in his first 100 days in office.

People 65 and older can make appointments online for a COVID-19 shot by regularly checking www.publichealth.lacounty.gov or www.calvax.org/clinic. Or call 833-540-0473. The information will be posted on the El Segundo city website. •

a safer place for children to be free of the exposure to firearms.”

Shannon said that the Crouches relish the opportunities that they have to work locally. “We are really pleased to have more jobs (in El Segundo),” Shannon said, mentioning a remodel that Crouch Construction has done for Mayor Drew Boyles.

Another satisfied customer, Boyles, emailed that “Crouch Construction was great to work with. They were on time and on budget and responsive to our needs.”

Family friend Joanna Bowe chimed in: “Shannon and Daniel are true El Segundoians. They are deeply committed to making this community better, whether they are running their family business to build beautiful homes for residents, coaching sports teams, or volunteering in the classroom. And they are also always at All the Things, living that Gundo lifestyle — every parade, every art walk, every library children’s event, every school fundraiser, every brewery. It’s always a treat to run into their kind and cool family out and about!”

The Crouches are busy building their four-year-old business. Shannon said they aim to be one of the “go to contractors” in El Segundo. “It is fun to have all these projects so close to home,” she said.

Shannon, a 2001 graduate of Manhattan Beach’s Mira Costa High School, attended USC to pursue a music industry major and a minor in business. She received her business degree, which she has put to good use behind the scenes with Crouch Construction.

She had worked for Nederlander productions as an executive assistant and then took a hiatus from the work-world to travel the globe, where she ended up meeting her future husband when they became “flat-mates” in a London domicile while they were both working in and exploring the cultural offerings of the city known as “The Big Smoke” because of the dense fogs and smog which have blanketed the environs for centuries.

The Crouches were married in 2008. When they returned state-side, Shannon transitioned into employment in the digital marketing field, cashing a paycheck as a customer relations manager for Fandango Media. Shannon said that she and Daniel moved to El Segundo for “logistical” reasons because she was working in Santa Monica at the time and wanted to stay in close contact with her mother, a Manhattan Beach resident since 1976. So, residency in El Segundo split the travel difference. She also said she was intrigued by visiting one of the restaurants that used to occupy the space that is now Rock & Brews, noting its “great beer garden. Anywhere that has a really great restaurant and beer garden, we are in,” she said.

Shannon says she relishes her time as a stay-at-home Mom with her three sons, as well as her duties managing the behind-the-scenes activities at Crouch Construction, where her myriad duties include administration, keeping the books, and writing the payroll checks.

Shannon espouses no regrets in toiling as a stay-at-home Mom. She said that while she loved her last full-time job, the hours and the laborious commute took their toll, noting how she would leave her home at 7 a.m. and typically not return home until 7 p.m. She said that when she had her second son, “I really couldn’t go back” to work.

Just to add to her busy schedule, Crouch is taking prerequisite nursing courses at Santa Monica City College. “I have been interested in nursing school for a-while,” she said, calling it a “good, steady career” that will still allow her to continue working in the family business.

Shannon and Daniel love to snowboard when they get the opportunity, she said, and that the family “tries to get up to the mountains as often as we can” and that Daniel and oldest son Kaden like to partake in the local surfing options.

Shannon was at one point a local group co-lead for the LA-South Bay chapter of “Mom’s Demand Action,” which was the brainchild of a mother of five, Shannon Watts, and came to fruition after the Sandy Hook school massacre in Newton, Connecticut, in 2012. Crouch and

a couple of other moms grew the local group, which advocates for stricter gun laws and gun-law enforcement and educating parents on gun safety protocols, from less than a dozen volunteers to more than 100, in their two years building the local chapter of MDA.

With her other commitments, Crouch has “passed the reins” of running the local MDA group to another El Segundo mom but said

it was “a really great experience, I am really proud of it.”

When he is not plying his contracting trade, Daniel donated his time (pre-pandemic) to coaching area youths in soccer and baseball. Shannon also volunteers and is currently a co-room-mom for a third-grade class at Center Street School.
