Barking at the El Segundo Dog Park

It was about 105 degrees in Newberry Springs (near Barstow) that July morning when I traveled from the South Bay to pick up Jesse, a golden retriever, five months young, who was looking for his "forever home". The breeders were very kind and shared with me that he was from absolute champion stock, but seemed a bit too lethargic, so no one had come forward. To that point, Jesse was housed at their premises a distance away, which I would learn was *out in the boonies*.

So, in the early goings, it was clear that Jesse was a country bumpkin. He had no familiarity with common things like car horns or even stairs. At the start, I had to carry him up to our second story for bedtime, and my back paid the price.

The breeders also explained to me that Jesse was named after the *Jesse Tree*, which (at least as I heard it) is a symbol from the Bible of a tree stump from which grew a new tree, similar to the Old Testament, which gave rise to the New Testament. Some will tell you dogs are angels on four paws.

You will hear no argument here. Jesse transformed not just my life but that of my family and others who knew him and spent time with him, not the least of which was my aging mother, who resided in a "facility" that quickly welcomed Jesse because so many there enjoyed his affection and loving nature. He was a therapy dog without any training.

When I brought him home, Jesse weighed 35 pounds. He would grow into an 85-pound, handsome, gentle, sweet, kind, strong, and loving companion. Time after time, people would complement me on how well-behaved he was (not realizing that I had done nothing, that he "came out of the box" that way). And his supposed lethargy turned out to be a common issue, a Thyroid deficiency, which

was and is readily treatable.

One of our very favorite spots was the El Segundo Dog Park on Imperial Highway. It has an area for big dogs and a separate space for smaller dogs. There are several impressive trees (which provide not only aesthetic benefit, but comforting shade).

There are benches, water fountains for both dog and person alike, sturdy fences, pooper scoopers, trash receptacles, friendly people, and ample room for dogs to romp, jump, bark, play, and take in the day. It is a place where you yourself can unwind, where "the human" can take a nice break, while the dog has playdates with all varieties of canines.

Jesse would "high paw" me as we walked into El Segundo's Dog Park (he was so excited and joyful). I always appreciated, and still do, that there was and is no entrance fee. Just come on in and enjoy!

Statistics indicate there are over five million privately owned dogs in Los Angeles County.

Even so, dog parks are more recent than you may expect. The first dates to 1979, known as Ohlone Dog Park in Berkeley, California. Like others, the Ohlone Dog Park started as a community project on public land that came (in time) to be officially sanctioned. While dog parks are common today, getting a dog park opened is no snap-of-the-fingers. El Segundo looked into the idea in 1998, but it was quite a few years later before the El Segundo Dog Park became a reality.

In the interim, a dog run on the nearby beach has never been approved despite considerable effort. This is not to criticize, but instead to remind us to count our blessings. The El Segundo Dog Park is a real find.

For so many of us, dogs are a part of the family.

Self-Care Isn't Selfish

Welcome to 2024! Every year, at this time of New Year's resolutions, I suggest that my clients don't make unrealistic resolutions to start something new (like losing weight) or change a routine (perhaps giving up coffee or some other vice) but instead resolve to cut themselves some slack and take better care of themselves. So many of us worry constantly about our loved ones with dementia that it affects our health. We stress about their care and often take on an unfair share of caring for them.

The demands of caregiving, combined with worry and stress, can tremendously affect your health and well-being. Stress causes cortisol levels to rise, leading to metabolism and weight gain changes. Other effects of cortisol include inflammation, high blood pressure, high anxiety, interrupted sleep, and even diabetes.

Stress and worry are widespread among those of us who are natural caregivers. Our loved one needs help, and we are the one person on the planet best suited to provide that help. In many cases, our loved one needing assistance is someone who raised us or otherwise cared for us in the past. We feel we owe them. Focusing on ourselves means not focusing on them, leading to guilt, a worry that only leads to additional stress.

The trouble is that many caregivers are so focused on their loved one's care that they forget to care for themselves. You might not sleep enough, exercise enough, or eat well. You may also feel depressed or anxious. All of these increase your risk of develop-

ing severe health issues. The emotional and physical demands of caregiving can be very strenuous, even on the strongest person. I often say, "If you don't take care of yourself, who will take care of your loved one?"

At the core of many caregiver's circumstances is a feeling of obligation. I'm not suggesting that anyone abandon their feelings or their loved ones. Caring for the person who once cared for you can create a tremendous feeling of obligation.

However, it's equally important to be compassionate to yourself. You are likely providing the best care and making the best decisions for your loved one, given what you know when you know it. Feeling guilty about not doing enough or about making difficult decisions is where I interrupt. My mantra for over a decade has been to give up the guilt.

Another aspect of self-care is asking for and accepting help. List people you feel can help, including immediate family, extended family, friends, and neighbors. You may not ask them to bathe your loved one, but they may sit with your loved one to watch television or go on walks, giving you a brief respite.

Finally, improvement in your diet can also help put some focus on you. Eliminate fast food and incorporate fruits and vegetables or exercise to reduce stress. A 10-minute daily walk is a great place to start, increasing your walk time weekly. And I can't emphasize enough that you need more sleep to deal with caregiver stress. Make a point of going to bed a half-hour earlier, turning off your phone, and reading a book. Do something weekly for yourself, keep to your routine, and let go of the guilt. •

ESUSD Board Meeting Report

The following information covers the January 9, 2024 ESUSD board meeting and was taken from ESUSD website:

State of the School: El Segundo Middle School

El Segundo Middle School Principal Sarah Davlantis and Assistant Principal Andrea Burke presented the State of the School report to the Board of Education. All the school's hard work is driven by its mission statement: Empowering lifelong learners to create a better world.

Recent highlights from ESMS include:

A school-wide focus on prioritizing both the El Segundo Graduate Profile and the International Baccalaureate (IB) Learner Profile. This year, the school is working on

Profile. This year, the school is working on setting measurable goals related to both profiles' attributes, along with working with 8th grade students to develop personal portfolios representing the various attributes.

Students can earn "Bark Bucks" for positive behavior. Every month, the class with the highest percentage of Bark Bucks receives a class prize.

The school implemented a "Bulldog Den" wellness center to help with students' social-emotional wellbeing. Additionally, it hosted the first of what will become an annual wellness fair with a focus on mindfulness.

Sixth-grade students saw improvements in both English language arts (ELA) and math California Assessment of Student Performance and Progress (CAASPP) scores. The scores for 7th grade students in math and ELA remained steady, but are expected to improve this year with the use of targeted strategies. Eighth-grade students saw significant gains in their math scores, while ELA scores decreased slightly.




Open Throat by Henry Hoke

Designated as one of the best books of 2023 by the Washington Post, and described by the New York Times as a "slim jewel of a novel," Henry Hoke's Open Throat is not to be missed. Narrated by a mountain lion in the hills above Los Angeles, we see humans through the perspective of an unwitting victim to our avarice and selfish destruction of the natural world we profess to treasure and admire. Written in sentence fragments, this wickedly smart and humorous observation of the vapid lives led by a world of influencers and strivers is a joy to read. As our mountain lion declares, "I try to understand people but they make it hard."

On the other hand, it is heartbreaking to witness the cost of human disregard for nature and the wildlife we have continually pushed to the brink of extinction. These animals are driven to increasingly desperate measures to feed themselves. Silently watching hikers pass within feet of him, the narrator drools and muses how long he could feed on a human, fighting his ever present hunger, instinctively knowing it would be the end of him even as it sustains him. "I don't know if I feel good or bad... if hungry is bad then I almost always feel hungry, so maybe I almost always feel bad." Our mountain lions' journey is an adventure of surprising discoveries and narrow escapes.

Sometimes I Think About Dying: The Beauty of Being Mundane



At the intersection of Punch Drunk Love and Office Space lies Sometimes I Think About Dying, a dark comedy about the pains of navigating corporate culture from the point of view of a socially inept millennial. Directed by Rachel Lambert, the film uses subtle humor to show how one woman (Daisy Ridley), stuck at a dead-end job, temporarily escapes the invisible chains of her cubicle by letting her mind wander into absurd territory. Anyone who has ever worked a humdrum 9-5 will be able to relate to the angst our protagonist feels, contributing to a reflective yet hilarious watch. Making its World Premiere at the 2023 Sundance Film Festival, Sometimes I Think About Dying is finally getting its overdue theatrical release on January 26, 2024.

A beautiful harp sequence plays over images of a crisp, foggy morning along the Oregon coast. Idyllic in both soundscape and landscape, it seems like this place is heaven on earth. Pioneer League Schedules **Are Winding Down**

With a week left in January, it means high school league schedules are winding down. The final weeks of the season should determine how our teams are seeded for a CIF Southern Section playoff berth. The girls' water polo team is seeking their third consecutive league title, while the boys' basketball team is one game behind the leaders. The boys' soccer team is just a half-game behind the league leader, while the girls' team is making a run at an at-large entry.

Girls Water Polo Keeps Rolling

The Eagles keep demonstrating how strong they are with their recent lopsided Pioneer League wins and a victory over a Bay League power. In their last ten games, the Eagles are a collective (9-1), including a current winning streak of six games going into this week.

El Segundo got a rare shutout against Beverly Hills and defeated the Normans 11-0. Six players scored for the Eagles, led by Emmie Ramirez, who notched three goals. Ella Lynch and Evelyn Hale scored two goals each, and Kendall Donahue, Sally Gonzales, Valeria Mora, and Natasha Zang scored one goal apiece.

The Eagles had their way against the South Torrance Spartans and won easily 16-2. The score could've been much worse, but head coach Nila Ward emptied her bench early. Sally Gonzalez got the Eagles scoring early when she worked the ball near the net and lobbed it in for the score.

Emmie Ramirez was kept busy by assisting on a score by Evelyn Hale to make it 2-0. Then the senior center-forward scored the next two goals, and Valeria Mora gave the Eagles a 5-0. Trailing 5-1, the Spartans released their goalie to help out on the offense counter-attack, but it backfired. After a shot attempt was saved by Kendall Donahue in goal, the two-time All-League goalie passed to Hale. Hale took the pass and let go of a shot attempt from half the length of the pool for the score. Hale would cap the first quarter score on a breakaway score she





(BPT) - With diabetes on the rise, getting tested and establishing a healthy routine are more important than ever.

The high rate of diabetes in this country comes at a significant cost. If not well managed, diabetes can lead to many complications, including blindness, kidney failure, heart disease and more. Diabetes also increases the risk of developing serious complications or being hospitalized with respiratory illnesses such as COVID-19 and the flu. People living with

Other important tests for people at risk for or living with diabetes include cholesterol and blood pressure tests, routine kidney screenings, and eye and foot exams. In very cold weather, a hybrid heat pump with a gas furnace for backup heat will not only ensure consistent and dependable indoor temperatures, it'll also have lower carbon emissions and operating costs than a heat pump utilizing electric resistance for backup heat.







BUYING A HOME WITHOUT AN INSPECTION IS A MISTAKE

(BPT) - A home inspection is one of the most important steps in the home buying process. - * Be prepared. Bring an inspection checklist and jot down questions to ask the inspector.
- * Check for disclosures. Review any seller disclosures you received before inspection day. Be sure to ask your inspector to look at those areas and verify repairs.
- * Let the inspector work. While you may have concerns, avoid unnecessary interruptions during the inspection process.
- * Make sure there's time to ask questions. Set aside some time with your assessor after their initial inspection to go over any questions you may have.

The home inspection process is a crucial step for both buyers and sellers. It provides buyers with peace of mind, knowing that their investment is sound and free of any major issues. For sellers, it can help prevent a deal falling through by being proactive and identifying problems that may require repair. *



Fran works in a small, nondescript office with nice enough co-workers, yet she stays at arm's length and remains non-receptive to their half-hearted attempts at small talk. New life is breathed into the office when the friendly new hire, Robert (Dave Merheje), joins the team. He voluntarily initiates contact with Fran, asking her for help with simple tasks like ordering office supplies, and doesn't give up engaging in conversation despite her lack of enthusiasm towards him. Their connection isn't instantfar from it, in fact—but over time, Robert begins to peel away Fran's protective layers and starts to understand who the real Fran is

This isn't a traditional love story, but more of a self-love story for the emotionally challenged. When we first meet Fran, she is working through self-doubt and criticism by envisioning all of the different ways she could die, depicted through vivid daydreams. These surreal montages incorporate risky and absurd undertakings, like standing toe to toe with a snake. These images-visceral in nature-seem to give Fran a sense of ownership over her autonomy. She may not have control over many aspects of her life but here, in her dreams, she is the boss. The film dips into this psychological aspect but doesn't linger too long in her psyche. Rather, director Rachel Lambert uses this outlet as a means of expressing Fran's quirkiness and dissimilarity to her peers.

Sometimes I Think About Dying crafts a tender and affectionate story that hits all of the right notes with conviction. The ensemble cast is made up of mostly lesser-known actors and similar in form to Jury Duty, they all have their own amusing quirks, making the group feel more like an improv team than co-stars. Daisy Ridley gives a stellar performance as the apathetic Fran, teetering on the edge of pity and arrogance with such finesse. Her command over the role is impressive, reminding everyone why she deserves to remain a top-billed star.

"It's hard, isn't it? Being a person." This line of dialogue has stuck with me since viewing the film, and I think it is the perfect summation of the overall tone. Sometimes I Think About Dying is a sweet nod to the outsider. While it's not necessarily revolutionary in its execution, it offers a cathartic release for the times when you feel like nothing more than a cog in the corporate machine.

Sometimes I Think About Dying opens on January 26, 2024, at AMC The Grove 14.
