City Council Considers Which User Groups Get Pool Priority

The issue of which swimming and/or water polo groups should get priority time and space at the new aquatics center on the east side of town prompted one of the largest turnouts of public speakers in recent memory during Tuesday night's El Segundo City Council meeting. In all, 30 individuals (including several youngsters) came up to the podium to plead their case. The majority – in order of frequency – represented the youth swim clubs Alpha Aquatics and Beach Cities Swimming as well as South Bay United Water Polo. The above three groups were among nine who sent proposals to the City of El Segundo describing their vision and purpose, experience level, staffing plans, rental needs and hourly lane use rate offers.

When considering who should get dibs, Councilmember Don Brann maintained that the groups with the largest number of El Segundo residents and coaches should move to the top of the list --- and that both swimming and water polo ought to be represented. Using that criteria, he called for the El Segundo-heaviest Alpha Aquatics and South Bay United to get first rights to the pool – and then offer any remaining time to other clubs. Brann also wanted to carve out time for the local masters program (SCAQ), but felt the proposed usage fees would be prohibitive and should be lowered by one-third. "I'm not in this for the money," Brann said.

However, the money was indeed a prime consideration in evaluating the candidates, with the projected annual City costs for the aquatics

center at about \$1.1 million. According to initial estimates, the City expects to recoup roughly \$900,000 the first year and tick up to over \$1 million in years two and three. Recreation and Parks Director Meredith Petit noted that the City figures to operate the facility at a deficit of \$100,000 to \$200,000.

Based on anticipated usage, Beach Cities Swimming and Alpha Aquatics would generate \$160,000 and \$130,000 respectively in annual revenues with additional potential monies from rentals for meets. Staff based the totals on lane rental hourly rates that the Council approved on Tuesday for short and long courses. Other facility revenues will come from monthly memberships, facility rentals, special events and camps.

Mayor Drew Boyles emphasized the importance of the financial side of things, reminding the audience that the City will soon face a structural deficit thanks mainly to escalating pension costs. After a couple of attempts, he achieved consensus with his colleagues (Councilmember Chris Pimentel recused himself because his children are in aquatics programs) on a motion for staff to make a decision. Boyles suggested considering current and future El Segundo residents in making the choice; prioritizing programs that have the greatest participation during higher-revenue peak times; and adding off-peak pricing to accommodate the masters program or other users (to encourage pool time during hours it may otherwise be empty). He also listed diversity of programming and maximizing financial impact as directives for staff.

Even with all of the above, Councilmember Scot Nicol was not ready to provide Boyles with a majority vote. He asked the mayor to revise the motion to guarantee Alpha Aquatics peak-hour time and South Bay United off-peak time. Boyles agreed and the new motion was also enough to sway Brann to vote for the item.

How much pool time the groups in question might receive is another story. Petit explained that the joint-use agreements with the El Segundo and Wiseburn unified school districts provide each with three hours of weekday use. With current scheduling, the pools are in use until 5 p.m. or 6 p.m. most weekdays. While Alpha Aquatics and South Bay United hoped to get four hours of daily time, a more realistic number is in the range of 2.5 to three, Petit estimated.

Also on Tuesday, Finance Director Joseph Lillio presented a lengthy and once again sobering overview of the City's pension liabilities. He detailed current benefits for both safety and miscellaneous employees and how those are calculated. He discussed changing market conditions and the dwindling CalPERS discount rate that has negatively impacted El Segundo and other agencies. Lillio also touched upon the City's unfunded pension liability for employees who no longer work here as well as future "normal cost" payments for those still here. According to estimates, the City will pay out over \$24 million (28 percent of the general fund) towards CalPERS in 2029/30—essentially doubling today's \$12 million expenditure.

To address the problem, the City made ad-

Fire Department to Host Free Business Emergency Plan Class

- 1/2 teaspoon ground allspice
- 2 tablespoons tomato paste

Directions

- Heat the ancho and New Mexico chile peppers in a 4-quart saucepan over high heat for 2 minutes, stirring occasionally. Remove the chile peppers to a work surface and remove and discard the stems and seeds. Place the ancho and New Mexico chiles into a blender. Add the chipotle chile pepper and half the stock. Cover and blend until the mixture is smooth.
- Season the beef as desired. Heat 1 tablespoon oil in the saucepan over medium-high heat. Add the beef in 2 batches and cook until well browned, stirring occasionally. Pour off any fat. Remove the beef from the saucepan, cover and keep warm.
- Heat the remaining oil in the saucepan over medium-high heat. Add the onion and cook for 3 minutes or until softened, stirring occasionally. Stir in the garlic, cumin, cinnamon, oregano, allspice, tomato paste, blended chile mixture and the remaining stock.
- Return the beef to the saucepan and heat over medium-high heat to a boil. Reduce the heat to medium-low. Partially cover the saucepan and cook for 1 1/2 hours or until the beef is fork-tender, stirring occasionally. Season to taste. •

Film Review

Velvet Buzzsaw is High-Art Horror

The term “velvet buzzsaw,” for those who don’t know, is slang for a rich person’s flatulence, and it’s this stuffy, hot air that writer-director Dan Gilroy derides so deliciously in his new film, the horror-comedy *Velvet Buzzsaw* (available to stream on Netflix this Friday). Having last mocked the culture-like culture of tabloid journalism and consumption in his previous film, *Nightcrawler*, Gilroy returns to an arena of ridicule (and once again set in the beautiful but artificial city of LA) to satirize the self-important art world elites whose vanity and greed results in devaluing the meaning of art – if it doesn’t kill them first. It’s business as usual in the art world – with vanity-plagued art dealers, buyers, agents and

critics all “kiss-kiss”ing each other at the latest openings. That is, until the life’s work of an unknown artist is discovered, which shakes the art world for the mind-blowing reason that it actually has “substance” as flamboyant art critic Morf Vandewalt (Jake Gyllenhaal) remarks. Whether or not the paintings from the artist – Dease – should ever have seen the light of day or not (per the late artist’s intentions) means nothing to sales agent Josephina (Zawe Ashton) and her boss, Rhodora Haze (Rene Russo), who immediately look to sell and display the white-hot works. But as they, and the rest of the vociferous art world soon comes to find as each of the pieces are dealt and displayed, spiritual forces begin to haunt and lead each of the greedy superficial socialites

A Championship Week for Eagles

Cam Carlton Leads Eagles

I've literally watched thousands of games over the years. I have witnessed comeback wins, last-minute losses and walk-off victories. In all my years I have never witnessed a game that meant so much to a team, its school and one very special player. The game between the Santa Monica Vikings and the Eagles filled the gym to capacity. No, this wasn't for a league championship or a playoff berth. The standing room-only crowd was there to see Cameron Carlton play his first and last high school basketball game.

To know Cameron Carlton is to love his zest for helping others and his passion to play

basketball. According to Eagle head coach David March, he knew Carlton had been cut as a freshman by the coach before him. Carlton tried out for the team his sophomore year, but was clearly behind all the other players in both skill and talent.

March said, "Cam's passion and enthusiasm showed every day of the three-day tryout. The reality was I had to cut him along with 30 other guys that year, which is always the hardest part of the job."

Shortly after the tryout, March attended a football game with his two sons. He saw Cam standing near the entrance, so he introduced him to his kids. "We briefly talked about basketball and you could see his passion for the game and how genuine he was as a person," March said.

Coach March was looking for someone who could bring the kind of character and enthusiasm into the program that he was looking to interject. He offered Cameron a position as the cameraman to be a part of the team. "I knew right away he not only needed somewhere to belong, but the group needed someone to be inspired by," March explained. "He was great his sophomore year and he never missed any

games or practices. He ran film sessions and he did any errands needed. He was the perfect person for the job with his ability to be genuinely unselfish."

Cam tried out for the team as a junior and again he was clearly behind the others and unfortunately was cut again. March asked to return to the videographer position and he gladly accepted. Cam's passion and dedication showed and he attended each session of practice and games during the fall, summer and spring.

March noted, "The best part was this team really started to rally around him and the 'family' we talk about was starting to develop. We end every huddle after practice with '1-2-3 family' and Cam was truly in the middle of making that a reality."

Towards the end of that season, Cam had mentioned to his coach about making the team as a senior. March told him how difficult that might be. Cam had asked if he didn't make the team would the coach consider playing him in one game with his friends his senior year. The word got out to the team and this real-life Rudy story started to develop. March said, "As this season developed, I knew he deserved the opportunity to be showcased for the school to

see how special he really is."

March kept thinking what he could do to give Cam an opportunity to play. He told his team that the final home game of the season would be called "Cam Night." The players really rallied the student body and during "Senior Night" they were chanting, "We Want Cam!"

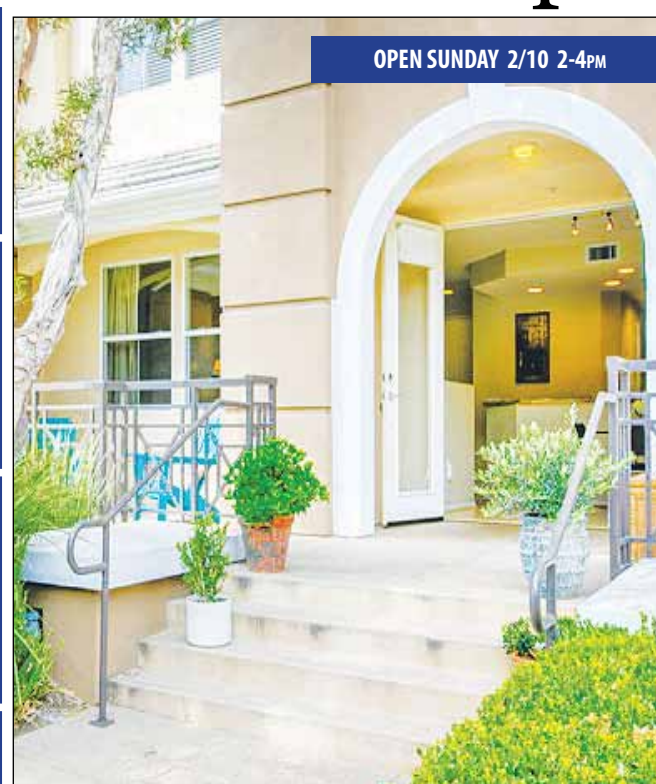

Before long, it’s one death-by-art after another. One of the most deliciously fun parts of *Velvet Buzzsaw* is that, being an ensemble movie, we get so many different zany characters -- all played by an incredible list of actors all portraying wonderful, over-the-top versions of snobby art world elites who meet a bitter end. There’s Russo, who sinks her teeth into the part of Rhodora, former punk rocker-turned commercial art owner. Russo mostly plays opposite newcomer Ashton, who holds her own as Josephina, the agent who discovers the Deases. Toni Colette is a fantastic wit and energy as the gossipy art world advisor Gretchen, and we are also treated to John Malkovich as an artist looking for re-inspiration. But if there’s one person who seems to have the most fun here, it is Gyllenhaal, whose posturing as the flamboyant art critic Morf Vandewalt is a comically caricatured protagonist and a highlight throughout the film.

Overall, *Velvet Buzzsaw* is less a breathtaking horror movie and more a perverse, comic watch, which allows Gilroy to have his fun in voicing the underlying thoughts of how art

loses all meaning at the hands of elites, critics (ahem) and institutions that seek to focus on financial or social opportunity within its aesthetic value. While this also means that we don’t have the same bone-chilling uneasiness of a *Nightcrawler*, we get something that we can laugh at, and then think about long after.

story so much. An anonymous donor stepped up to pay for the other shirts that were already purchased.

Mike Lynch and two former players, Jacob Franco and Ryan Booker, showed up two hours early to work Cam out to get him game-ready.

Never mind that the Vikings, one of the top teams in the CIF Southern Section 2AA Division, would defeat the Eagles by 28 points. It didn't matter to the Eagle faithful because the gym was there to watch Cameron "Cam" Carlton. Before the game Carlton was shooting jump shots. With each one made beyond the three-point line, the student section, dressed in Cam's Night yellow tee-shirts, erupted with praise and thunderous applause. Cam sank seven in a row.

When the starting lineups were announced, Cam was introduced last. Before his name was called, there were 30 seconds of crowd noise at a fever pitch. When he was introduced, "at guard, 6-foot senior guard, number 32, Cam Carlton," the ovation reached a noise level that hasn't been heard this loud in this gym since the 1963 Eagles, led by Kirk Brown, knocked off Culver City for the school's first league title.

During the game, Cam got an ovation with each touch of the ball. The moment was not too big for someone playing in front of a standing room-only crowd there to watch and support him in his first and last game. ditional payments towards unfunded liabilities the last two fiscal years, refinanced several plans, prepaid unfunded liabilities, set up a pension trust fund, and forged agreements with three labor groups for those personnel to pay the full employee shares of their PERS. The combined moves saved the City over \$6.1 million in interest over the long term. Lillio estimated that the unfunded liability should be paid up by 2040. However, the short-term news is less optimistic with budget deficits expected by 2021 and growing to over \$2.5 million by 2023/24. Lillio added that staff will remain proactive and will continue to monitor market conditions and investment returns as well as any CalPERS policy changes. They will also recommend additional payments to unfunded liabilities whenever possible.

Boyles brought forth an item directing staff

to look into the possibility of installing stop signs at the intersection of Walnut Avenue and Sheldon Street after hearing resident concerns about the location. During public communications, several residents who live nearby spoke of the hazards there – with descriptions such as an "absolutely dangerous intersection: and "poor visibility." However, a staff analysis of the intersection in 2017 concluded that Walnut at Sheldon did not meet the criteria for stop sign installation based on the number of annual reported accidents and total vehicle trips. Nicol made an initial motion to approve the installation, but Deputy City Attorney David King cautioned against the move – arguing that it would set the City up for additional liability by having the signs in an area where they aren't warranted. Ultimately, the Council by a 3-2 vote (Nicol and Brann dissented,

deeming it a waste of staff time) agreed to have the intersection studied a second time. Mayor Pro Tem Carol Pirsztuk noted that new townhomes built in that area will add to traffic and could make a difference in the results.

Earlier in the meeting, South Coast Air Quality Management District representative Danielle Soto discussed a Chevron incident last week where a power outage stemming from a lighting strike led to unplanned flaring. The next day, a sour water tank resulted in odors emanating from the refinery. Air samples taken showed no pollutants present in El Segundo, but Boyles reported that some businesses in the general area sent employees home mid-day due to headaches from the odors. The City received about 80 complaints. Soto added that her agency has implemented Rule 1180, which requires refineries to install air monitoring systems at

fence lines. Fire Chief Chris Donovan added that his department will work to increase the speed of communication to ensure the community receives accurate information in the event of such incidents.

And last but not least, the Council issued a commendation to Sue Carter - the longtime president of The Friends of the El Segundo Public Library and Historical Committee founder who also led major fundraising campaigns for the facility remodel and Bucks for Books. She also oversaw the microfilm conversion of nearly a century of El Segundo Herald editions to digital to preserve local news in perpetuity. In her honor, the meeting room at the library will be renamed The Sue Carter Friends of the El Segundo Public Library Community Meeting Room. A ceremony marking the occasion will take place on Saturday, Feb. 16 at 1 p.m. •
