ES Pastor Follows in his Father's Footsteps, After a Few Sidesteps

Kaleb Oh, who is the lead pastor at El Segundo's United Methodist Church [UMC] located on the southeast corner of Main and Mariposa Streets, would seem to have been a natural to follow his father, a pastor in the UMC, into the realm of the Methodist clergy, right?

Not so fast. Oh, who moved to El Segundo in 2021, wanted to chart his own course. When Kaleb was three, his parents immigrated from South Korea in 1990, looking, Oh said, "for better opportunities." Oh said his father was pursuing his ministry and wanted to become a pastor. They initially landed in Claremont, California.

Kaleb's father became a fully ordained minister of the UMC, and the family later relocated to Cerritos.

Said Oh: "I really didn't want to be a pastor and tried everything else [looking into becoming a police officer, a probation officer], but eventually recognized that this is my 'calling'," he said. "What I'm good at and what I'm passionate about. And as they say, our calling is where our greatest passion and the world's greatest needs meet."

Some of the "everything else" that Oh, 36, tried pursuing was toiling in restaurants and starting a clothing line. He attended Cerritos High School and later matriculated to Cal State University, Northridge [CSUN], where he quickly "failed out" and started working in restaurants, trying to find a satisfying career.

He said he was raised by "typical Asian parents who stressed education." But, at that time, Oh said, when he secured his first semblance of freedom, "I just never went to class," garnering a not-so-impressive gradepoint average of 0.23 in year one-and-done

at CSUN. He landed on academic probation and, he said, was eventually shown the door at CSUN.

He eventually landed in Las Vegas, where he continued to work in the hospitality industry. He returned to school, nabbing a bachelor's degree in hospitality management from the University of Nevada, Las Vegas.

He had scored a job working in the Spring of 2012 in Mario Batali's Otto Enoteca Pizzeria in the Venetian Hotel. However, he was "let go" after less than a year on the job, a termination that still seems befuddling to Oh.

With little recourse, Oh decided to move back to California. He started to think that there might be some "divine intervention" working in his life. He spent three months in a "missions program" in Hawaii and followed that up with similar programs in Cambodia and Thailand.

He returned to California, where he met his wife, Abby, a clothing designer. In December 2013, he and Abby started the clothing company Gravity LA, designing shirts and the like, with much of the proceeds helping

Raytheon Spurs Controversy and Action by the Council

The call for live-streaming, recording, and posting the city's Diversity, Equity and Inclusion Committee meetings was once again called for at the regularly scheduled El Segundo City Council meeting Tuesday night as residents once stepped to the microphone one by one during public comment to make the request. In addition, during the public comment portion of the meeting, Corrie Zupo, a member of the city's Environmental Committee, noted that the committee is "here to help" with the ongoing issues the city is currently awash in with the Hyperion Water Reclamation Plant and mentioned that city officials and staff need to be paying attention to the city's resident Chevron Refinery Plant and its recent plant operations and emissions.

And, also during public comment, El Segundo Little League President Jamin Griffiths brought to light the fact that despite an agreement with the city, Raytheon has told the league they can have one baseball field to play on on Raytheon property instead of the two fields they had last year, saying that Raytheon wants to keep its softball field open for employees to use instead of granting its use for Little League baseball. Griffiths then discussed the live-streaming the league would like to do at George Brett Field, noting that the city will be able to use the equipment and that the live-streaming equipment is at no cost to the city. He presented the timeline in which the league has been working with the city to gain approval for the live-streaming at Brett Field. He noted its approval had been pushed back repeatedly on City Council agendas since December. With Opening Day on Saturday, Feb. 25, he had hoped the livestreaming would be in place.

City Attorney Mark Hensley told the council that the agreement between Raytheon and the city allows for the use of two Raytheon fields Monday through Friday from 5-9 p.m. and on weekends 8 a.m.-9 p.m. and that Raytheon employees have priority over the softball field and that he thinks there needs to be a conversation.

City Council member Lance Giroux had a lot to say about the Raytheon situation. "OK, I hate to say, 'I told you so' on this, but 'I told you so.' I knew when Raytheon sat right there (in the audience in council chambers), and we let them out of their development agreement, and they promised they would give us access, and there were to increase the access. I knew they would do it for three months until the shine wore off, and then it was going to happen this year." He noted that little league has to plan the entire season out now. "So, they're doing exactly

what I thought they would do, which is to give it one year, and then once they got what they wanted, it's not so important anymore. This is of no surprise to me whatsoever that Raytheon did this."

Hensley noted that the city does have a binding written agreement, and Raytheon does want to develop more property, and the city does have rights. Aly Mancini, the city's Recreation, Parks and Library director, told the council she has met with Raytheon representatives on the matter once and that Raytheon said that the contract indicates that Raytheon provides two fields and that right now those two fields are for the baseball field and soccer field because Raytheon employees have indicated an interest in using the softball field. Hensley noted that the agreement does say Raytheon has priority over its softball field.

"OK, I get it. Is this a surprise to literally anyone up here right now that this happened this way?" asked Giroux after hearing Hensley and Mancini speak on the agreement. "It's not to me. I knew it would happen when they started talking about it a year ago. (During last year's Little League season, Raytheon provided the use of its baseball and softball fields.) I knew it."

Said Mayor Drew Boyles, "Well, let's give them the benefit of the doubt. Let's hold them accountable and see what they do. And if you're not getting results, let's get the city attorney involved. The spirit was when we did that deal, we were talking about baseball specifically. That was the spirit of the agreement. I'm sure they will want to comply once we escalate that." Mancini said she would attend to the matter with city staff.

The city council also asked for a special meeting to be called before its next regularly scheduled meeting on Tuesday, Feb. 21, so it could address the Little League request, which was approved by the Recreations and Parks Committee in November after presenting it to them in September, to live-stream from Brett Field. City Manager Darrell George said he would handle the request.

Newly elected council member Ryan Baldino asked that the city convene an ad hoc city council subcommittee to address, watch and follow all things related to the city's ongoing issues with the Hyperion Plant, whose sewage spill into the ocean and plant flooding in July of 2021 has caused ongoing issues for the city and its residents. He and council member Carol Pirsztuk will be the two council members on the committee.

At the beginning of the meeting, the council recognized February as Black History Month and presented a proclamation to the

Three Films We Saw At This Year's Sundance Film Festival

Fair Play

Fair Play was one of the buzzier titles that played at the festival. Set in the world of high-stakes investment banking, the film follows a newly engaged young couple whose relationship is put to the test when Emily (Phoebe Dynevor) is promoted to a top position over Luke (Alden Ehrenreich). As Emily climbs the ranks – leaving Luke further behind in the position he believed he deserved - their relationship is strained to the point of danger for each of them. A corporate romantic thriller in the style of Basic Instinct, writer-director Chloe Domont's directorial debut is a suspenseful and gripping watch and will be released by Netflix (who bought the film for a reported \$20 million).

Going Varsity in Mariachi



Water Polo Team Tunes Up for Playoffs





Kaleb and Abby would collaborate on more than shirts; the couple has a four-year-old son, Noah.

Oh "threw [himself] into the business," which meant any religious ministerial aspirations were put on the back burner. Business being business, conflicts arose. Oh, who had been working in different facets of ministry since 2013, with a nudge from his father, Kenny, became intent on pursuing his ministry. "I got called by God to do that," he said.

Although he was not keen on returning to school, Oh entered the Claremont School of Ministry, where his Dad had attended, in 2019 and left with a Master of Divinity Degree at the end of the year. "Going to school," he said, "changed my life. I felt so much at peace, being there."

Oh, like many people, was unaware of the charms of El Segundo. But when the UMC hierarchy asked if he would like to become the lead pastor at the El Segundo UMC, Oh did his research and, discovering that our town was located close to the Pacific Ocean, made a visit and was "blown away," he said, remembering thinking "where was this my whole life?" He started working at the El Segundo UMC in the summer of 2021.

Along his pathway to El Segundo, Oh had developed skillsets that greatly aided his tenure as a church pastor, including mastering software that has helped him to build computers, immersing himself in the 'wave of the [present] and future' implementation of digital streaming services; and developing his "humble yet passionate musical skills with [the] guitar, electric guitar, drums, vocals, and soundboard."

Oh was able to cast off many of the sometimes-pre-conceived notions of the West Coast Mayberry; he said he and his family "loved it. We want to be here as long as possible."

Because the UMC does move around their pastors, there is no guarantee that Oh will be here for the long haul, which he understands. But while he is an El Segundo resident, he hopes not only to spiritually lead his parishioners, but to sate his passion for fishing, a passion that, maybe miraculously, landed Oh a 31 ½ -inch halibut in the past two weeks, snared in the waters of off Dockweiler Beach.

Although Oh was ecstatic with his "catch," he was enthralled with the majesty of the fish and practiced the best policy to protect our wildlife, releasing the mighty fish.

Time to hear from a couple of the local UMC parishioners, but no fish stories. Ellen Russ writes, "I first met Oh over 'Coffee With

Kaleb' at the Blue Butterfly shortly after he began at the Methodist Church.

"He begins every church service with a welcome. Not just a 'glad to see you' but a welcome that emphatically states that no matter who you are, where you come from, what you are going through, how you identify, or even what you believe, that everyone is loved.

"As someone who has some perhaps less than traditional ideas," she said, "I find his welcome like a warm hug."

Adds parishioner Brad Stine: "I have had the pleasure of knowing Kaleb since he became pastor in the summer of 2021. He brings a consistent message of inclusion and grace without guilt. We're accepted as we are without judgment, and we're encouraged to share God's grace as we are able. He does not attempt to make us conform our specific spiritual beliefs to his or anyone else's interpretation. Rather, we're allowed to continue our spiritual growth as we are led.

"Every pastor brings the benefit of his or her background and training, and Kaleb is no exception," Stine continued. "I am impressed with his quiet, deep intellect. His sermons do not seek to impress but rather inspire and, oftentimes to help us see things from an alternative point of view. He'll inform a sermon with the challenges he experiences in his real-life relationships as husband, parent, and child. He's human, approachable, and genuine.

"With Kaleb, we got not only a fine pastor but also a tech wizard. Through his efforts, our church now live streams our Sunday services on the internet, allowing people to attend virtually if they cannot be in church physically. He's started up a class to teach basic computer skills and cyber security to seniors—a real need in our community!"

No matter how long Oh will be the lead pastor at ESUMC, he said, "I have this unique place where I can bring healing, to bring compassion to the people that [might] have been hurt by the Church in the past. To be able to join people in the process of healing, to be by people's sides as they are going through their struggles."

If you want to see Kaleb Oh live on Sundays, the all-inclusive services start at 10:30 a.m. at the church on Mariposa and Main. I believe that you can also access the mass if you can figure out that streaming thing. And, Oh has launched a nascent website, connectionfound.org, that aspires to "help senior citizens reconnect with loved ones through technology literacy."
