Council Agrees to Slow Down the RFP Process for The Lakes Site

More than 10 citizens came to the podium on Tuesday night to urge the El Segundo City Council not to rush through the request for proposal (RFP) process for The Lakes at El Segundo site. The Council majority previously directed staff to aim for an expedited timeline in the hope of releasing the RFP by March 1, holding a pre-bid meeting and site walk on March 12, receiving proposals by April 3, interviewing qualified bidders on April 9 and selecting the preferred proposer on April 17. The last date will be the final public meeting for outgoing Mayor Suzanne Fuentes and Councilmember Mike Dugan. That timeline, described by Recreation and Parks Director Meredith Peitit as "ambitious," became a point of contention despite recent progress made by The Lakes RFP Task Force in reviewing background and historical documents, conducting a community needs assessment survey, and addressing the condition of the nine-hole course, driving range and clubhouse. Petit noted other outstanding items still requiring discussion and direction, including the type of deal structure to consider (a lease agreement versus management contract); a minimum acceptable annual rent/return for the City; and a rundown of capital improvements - as well as to what extent the City might be willing to invest in those improvements.

As one example, staff conducted an inhouse assessment of the clubhouse building that identified areas needing repair such as in the building itself, patio, landscape, restroom and kitchen. But without extra time to hire a third-party expert, the City won't know the true condition of structural systems such as plumbing, roofing and sewer systems.

Also in question is how to figure in the City's \$5.6 million loan to The Lakes that has not been paid back. Additionally, City Manager Greg Carpenter reported that in the case of a lease agreement, the recent tax code changes will result in "a new expense somebody has to incur."

Flight Industries Land Major Vote of Confidence to Stay Competitive

South Bay's space and air defense companies are one step closer to having a state commission to make sure their industry remains competitive and stays grounded in California.

Assemblyman Al Muratsuchi, D-Torrance, introduced a measure to create a California Aerospace and Aviation Commission. Its purpose would be to advise policymakers about what the \$100 billion flight and defense sector in the state's economy needs from state elected officials. The commission would "serve as a central point of contact" for the flight and space mission companies and "support the health and competitiveness" of the businesses -- including those in the South Bay -- that form the backbone of the aerospace and aviation industries in California, according to the bill.

The Assembly voted 75-0 to create a commission dedicated to smoothing the way for the industry's growth as the nation sets its sights toward missions to Mars someday. The 15-member commission would operate without taxpayer dollars and be overseen by the Governor's Office.

"The goal is to bring together the stakeholders and bring together policy recommendations so we can continue to grow and lead the nation and the world in innovation, advanced manufacturing and See Flight Industries, page 14





Kings Make History in Buffalo, but Will They Even Make the Playoffs This Year?

With no disrespect to the people of Buffalo, who could possibly want to travel there in the month of February? Not many are brave enough to battle the 20-degree weather, even if you're used to playing a professional sport on a slab of ice. The Los Angeles Kings were forced into Buffalo last Saturday and instead of simply laying down their sticks, did something that they hadn't done in the last 15 years. They won. Now, with just over 20 games remaining in the regular season, the only question left to be answered is whether or not the team will play well enough to make it into this year's postseason.

Anze Kopitar and rookie Michael Amadio each scored twice for the Kings last weekend when the team acquired its first victory in Buffalo since Feb. 21, 2003. Maybe Amadio is the good luck charm that changed L.A.'s fate once and for all. Or maybe it was the play of goalie Jonathan Quick, who made 33 saves for Los Angeles on the way to a 4-2 victory against the Sabres at KeyBank Stadium. "I don't think we were worried about the 15-year drought in here," Kopitar explained after the game. "We had a three-game slide that we certainly wanted to stop. I thought today we came ready to play."

The Kings can get excited about that victory all that they want to, but it's important to remember that it came on the heels of a three-game losing streak for Los Angeles. That same losing streak saw the Kings lose to two different elite teams who go by the names of the Tampa Bay Lightning and the Pittsburgh Penguins. Now is the time of the regular season when Los Angeles must decide what team that it wants to be. Does it want to be the team that loses to other good teams and drops to fifth place in the Pacific Division standings? Or does it want to be the team that looked almost unbeatable over a stretch of over 10 straight games in October?

While the Vegas Golden Knights may have first place wrapped up in the division, the end of the regular season is going to come down to inter-division play for L.A. As of last weekend, the Kings were in an absolute all-out brawl for playoff positioning with their enemies from Calgary, Anaheim and San Jose. If Jeff Carter can return from a skate injury that has kept him sidelined since the middle of October, the Kings will almost certainly begin to look as good as they ever have this season. Carter's return could prove to assist a team that continues to struggle to score goals and ranks 21st out of 31 teams in the league in that category. His reemergence has the ability to help the Kings finally begin to put some pucks into the back of the net. Also, head coach John Stevens must ask himself the question of how much is too much of Quick. The Kings goalie has looked nothing short of lackluster since before the All-Star break, while his backup Darcy Kuemper has done a more than serviceable job.

It's getting late in the season and it has certainly become clear that the Los Angeles Kings have a lot of work to do if they wish to not only get into the playoffs, but get there and succeed. That being said, Los Angeles has always had a taste for suspense. Even in the Stanley Cup years, the Kings seemingly enjoyed keeping their fans hanging on to watch each and every game intently. This year, it seems that if the Kings want to enjoy more success like in 2012 and 2014, they won't just need to make history in Buffalo. This Los Angeles team needs to score more goals, defend the net better and, most importantly, beat their divisional rivals who always seem to inherently have a thirst for the Kings' throne.







Check It Out Slow Medicine: The Way to Healing

Slow Medicine grabbed my attention immediately from its introduction. The author, Victoria Sweet, a medical doctor, describes

her helplessness as she recalls her father's illness and subsequent journey to the hospital. Her father suffered a grand mal seizure and paramedics took him to the local community hospital, where he was admitted. Instead of the overnight observation and next-day discharge that she reassured her family would happen, she visited him the next day to find him in restraints, attached to an IV and a catheter. He was mistakenly being treated for a possible stroke all because of a small error in his "electronic health record." Even as Dr. Sweet tries to correct the information with her father's doctor, it's not an easy fix. There's more -- much more -- about today's modern medicine and its applications that will enrage and frighten you. As she sums up the experience, "If I, as a physician, couldn't get appropriate care for a family member in a lovely community hospital with well-trained staff, who could?"

This is an interesting book that relates Dr. Sweet's early life and eventual decision to become a doctor. She describes her college years, her time in medical school plus her interactions with patients and her jobs in hospitals, clinics and other medical environments. The cases she writes about inform and some astound. Dr. Sweet guides the reader to her meaning of "fast medicine" -- viewing and treating the body as a machine with the doctor being the mechanic; and "slow medicine – where the pace of care is unhurried and involves sitting with a patient, a step-by-step physical and visual examination. **See Check It Out, page 14**

done for generations by staying hidden away from the rest of the world while mining a rare resource called vibranium. This is an element stronger than steel that the Wakandans put into everything from their buildings to their clothes, and from what his sister Shuri makes the Black Panther costume and gadgets. But little does T'Challa know that vibranium is also being coveted by enemies abroad, including Klaue (Andy Serkis) and the American Erik Killmonger (Michael B. Jordan). It's Killmonger who we learn is more than meets the eye and has more than a bone to pick with T'Challa as he challenges him for the throne and for control of how to lead the nation forward with less than peaceful results.

While Black Panther is the latest superhero flick sandwiched between the rest of the Marvel catalogue, it's not your traditional superhero movie. First of all, there's a new visual identity that director Ryan Coogler (Fruitvale Station, Creed) injects into the movie that keeps the whole thing lively and excitable. And largely, there is a mythos to Black Panther that makes the movie feel even weightier next to its contemporaries. Scenes of T'Challa connecting with his ancestors for wisdom and guidance while he connects with his destiny is a drama more akin to Shakespeare than Superman.

It's all pop entertainment escapism, but it's undeniable that there is political juice in this thing. An interesting point of the movie is that Black Panther must learn how to govern in a political sense and do what's best for his people, which is a discourse that's ever more prescient today. Scenes in which King T'Challa is confronted with how to rule over Wakanda - whether to continue hiding from

The state Senate still must vote on the measure, and the governor needs to sign the bill. The momentum so far in the lower chamber in Sacramento is one small step for California, and one giant leap for a South Bay industry that designs, builds and supports air and space travel.

"The state hears and sees what's happening in the industry and wants to protect it and grow it," Kruger said, adding "it also sends a message outside the state of California."

Texas, Georgia and Michigan are moving forward to create commissions, which the LAEDC says are completely dedicated to growing their states' aerospace industries. The work envisioned for the California body will be to market the state's tax and business climate at industry events where other states will have a presence.

The LAEDC has backed the bill to create a California commission to protect against states looking to "poach our aerospace assets," it says. The bill got another huge lift right after the Assembly voted: SpaceX in Hawthorne successfully launched its powerful Falcon Heavy into space. The company calls its Falcon Heavy the most powerful rocket in service today, able to carry a fully loaded and fueled 737 jetliner weighing 141,000 pounds into orbit.

The Legislature lately has shown a willingness to help defense contractors to be competitive in bidding for federal contracts. Lawmakers in 2014 supported an enhanced tax credit and tax exemption for Lockheed Martin and Northrop Grumman, both of whom were competing for federal Department of Defense contracts.

In 2016, the Legislature again approved a tax measure favorable to defense and aerospace manufacturers. Lawmakers extended a sales and use tax exemption on manufacturing equipment.

Aerospace is prized by state and local lawmakers because average salaries top \$100,000 and contractors and their suppliers create manufacturing jobs -- some of which require a high school diploma. The demand for workers with technical skills is expected to grow in the Los Angeles metro area, according to a recent LAEDC report about the future of work in the region. •

With various items still up in the air, Tuesday's public speakers were adamant in expressing a common message. Planning Commissioner Ryan Baldino implored the Council to allow the task force (which he is also a member of) to "do its job." He also found it "inappropriate" to rush the RFP through so that "it's voted on by the current council before the new one is in place." Lindsey Breeden, a member of the City's Technology Committee, warned of the possibility for subpar proposals and also called out "some on the Council" for wanting to make a decision on the matter before leaving office. While saying he was "happy TopGolf was killed," Chris Busse emphasized that "this [speedy RFP timeline] is not the way to respond to this. It makes it look like it was personal. Let's not set ourselves up for another bad deal." Golf pro Josh Alpert added, "This is the time to get the process right."

Later, Fuentes admitted that she initially wanted to "get this done" before the election. She noted that she attended all the meetings on The Lakes (and TopGolf) for six years. "Who wouldn't want to see what the final outcome is?" she asked. "Yes, I'm invested in this." But in the end, she and the rest of the Council present (Don Brann was absent for the meeting) agreed to defer to consultant Carol Beck -- a golf professional hired by the City to help guide the process. "If anything is worth doing, it's worth doing right," Dugan said. "Let Carol advise us on what a better schedule is."

Even if the Council had chosen to stick to the April 17 selection date, negotiations from that point forward would have still removed Fuentes and Dugan from the equation. "The current council will not make the decision on the use of this property -- it's not going to happen," City Attorney Mark Hensley said.

The Council ultimately issued direction to "cast a wide net" (as requested by Mayor Pro Tem Drew Boyles) to attract as many diverse proposals as possible, embark on a more detailed capital study, and to return with a revised timeline and more optimal schedule. Councilmember Carol Pirsztuk also asked to add criteria to rank the RFPs. "We want it done well and we want it done right," she said. Staff will come back with an update at the March 6 Council meeting.

Also on Tuesday, Petit presented recommendations from the Golf Course Subcommittee and Recreation and Parks Commission to increase fees at The Lakes for the first time since 2013 so those are comparable to other courses and driving ranges in the surrounding area. Proposed upticks for different items are in the \$1 to \$2 range with an estimated annual revenue increase of \$65,000 to \$70,000.

During the public hearing on the matter, Marie Smith opined that the City "is not raising rates enough." She suggested lowering fees for juniors, but going higher on everyone else. Boyles felt a "\$1 increase seems not worth the effort," pointed to continually rising annual costs and that only "5 to 10 percent of our residents use this [The Lakes]." He asked to go back to the drawing board, while Dugan hoped to approve the recommended increases on Tuesday. A compromise brought forth by Fuentes will see the resident fees move up as suggested, but have staff return with proposed lower rates for juniors and higher charges for non-residents.

Public Works Director Ken Berkman provided an update of the Capital Improvement Program, with a summary of \$17 million in key projects (\$4.5 million of work completed last quarter). The list includes fiber optic network expansion, Center Street water main replacement, Main Street lighted crosswalks, annual concrete project, kitchen upgrades at Fire Station #1, a new roof at the police station, annual pavement rehabilitation (that mostly involved east El Segundo streets), and two sewer pump station modifications (the largest ticket item at \$3.25 million). Coming up are a seismic retrofit at Fire Station # 1, catch basin connector pipe screens, ADA ramps, and an engine/pump replacement at another pump station.

City Treasurer Crista Binder and Deputy City Treasurer II Dino Marsocci presented the quarterly investment report. Highlights: The City remains in compliance with its investment policy and has a total invested portfolio market value of \$71.4 million, with short-term yields at 1.23 percent and long-term yields at 1.79 percent. Investment activity from October to February included purchases of 27 securities for \$9.93 million. During the same period, 12 securities matured for \$6.66 million, with total net change in investment activity positive by \$3.27 million. Treasury yield curves jumped markedly during the quarter to the City's benefit.

El Segundo Police Lieutenant Carlos Mendoza spoke of the department's involvement with L.A. IMPACT – a multi-agency crime task force and joint powers authority that targets drug trafficking and money laundering organizations. Mendoza serves as deputy director and noted the large number of investigations, responses and agency assignments. He reported that nearly half the cases involving methamphetamine, which has become an even bigger problem due to bulk importing and lower prices. He also mentioned growing issues with fentanyl.



Marinated Garlic and **Lemon Roasted Chicken**


Recipe provided Nestle's Balance Your Plate

Ingredients

- 10 chicken drumsticks
- 1 large lemon zested and juiced
- 1/4 cup extra virgin olive oil
- 3 whole cloves garlic, chopped
- 1 teaspoon paprika
- 1 teaspoon oregano
- 1 pinch each salt and pepper
- Minced parsley for garnish

HONEY MUSTARD SAUCE

- 3 tablespoons melted butter

- 1/2 cup mustard





Preparation

- 1. In a bowl, mix together lemon juice, zest, olive oil, chopped garlic, paprika, oregano, salt and pepper. Add chicken drumsticks and toss to coat evenly. Cover bowl with plastic wrap and place in refrigerator for at least 30 minutes. When ready to cook, let chicken come to room temperature for about 20 minutes.
- 2. Preheat oven to 375 degrees.
- 3. Arrange chicken on oiled foil-lined sheet pan.
- 4. Bake uncovered for 20 minutes. Flip chicken pieces and cook another 10 minutes until chicken reaches 165 degrees and is no longer pink.
- 5. Make sauce in a small bowl by whisking together the mustard and honey. Add water as needed for a workable consistency.
- 6. With a small pastry brush, brush sauce over chicken and broil 5 minutes until bubbly. Place chicken pieces on a serving platter and sprinkle minced parsley over all.



Congress Finds a New Target to Attack

In all honesty I never thought that Congress would come out one day and pass legislation attacking people with disabilities, but the day has come. The House of Representatives passed the ADA Education and Reform Act with a 225-192 vote. In essence, this act would require people with disabilities to provide a written notice that a business does not provide adequate access to persons covered under the American With Disabilities Act. Through this law, for which there is no version of in the Senate yet, a business would have 60 days to respond to a written complaint, as well as another 60 days to actually begin improving their location to accommodate people protected under the ADA. For 28 years, the ADA has ensured that the public is protected from discrimination "on the basis of disability in the full and equal enjoyment of the goods, services, facilities, privileges, advantages, or accommodations of any place of public accommodation" -- Title III/Specific Construction of the ADA. Why then, does the House of Representatives find it necessary to make this modification? Current and potentially new business owners already know some of the basic requirements (access ramps, modified restrooms, etc...) set by the ADA, so they do not need a written notice. Requiring people with disabilities to give a written notice shifts a business responsibility from the owner to the public for no good reason. Supporters of the bill argue that this will keep money-seeking lawyers from filing frivolous lawsuits against local businesses for ADA violations, hence saving the business money. Well, you know what else would save the business money? If they just complied with the ADA requirements. They've been in place since 1990. How much more of a warning do you need? Are these accommodations expensive? Yes, they are, but we are at a point where these accommodations are part of the business expense. They aren't surprise requirements.

The amendment also requires that a model program to "promote alternative dispute resolution mechanisms to resolve such claims" be created in order to have a method to determine "relevant facts related to such barriers." All this was done with the "goal" of resolving an accessibility issue before resorting to litigation. So not only do these amendments give business owners a way out of complying with ADA requirements, but they place the unnecessary burden of proving that a business is not complying on the people who are supposed to be protected by the ADA. If they are lucky, people with disabilities will see modifications begin happening 120 days after their complain. That's if the model program doesn't kick in to continue stalling. There is no need for this amendment. The ADA requirements have been in place long enough. Maybe some corporate donors become a little more generous and are looking forward to future projects where they can skip meeting these ADA requirements.
